## Councilman wants new garbage code tweaked

FORT MADISON - As the city carts in its new residential waste program, a city councilman wants to tweak proposed ordinance changes to help seniors who may have trouble getting their new carts to and from the pick up location.

At Tuesday's regular meeting of the Fort Madison City Council, councilman Bob Morawitz brought up

the issue during a 2nd reading of the new proposed ordinance changes that reflect the city's new garbage collection system.

Morawitz and city public works director Larry Driscoll engaged in a back-and-forth about language in the ordinance. Morawitz said he wanted language in the ordinance that would allow

Driscoll to not only determine where certain residents can place their new garbage carts on pick up days, but

also where they can be stored.

Morawitz said his concern was rooted in senior or disabled residents in his district who have steep terraces and won't be able to haul their new cart down to the curb and back up again.

Driscoll said there is an option in the code that gives him flexibility, but

## Workforce Development to vacate Lee County office space

FORT MADISON - Lee County supervisors are looking at options to fill space in the North Lee County Office Building after hearing the state's Workforce Development Center will be leaving the building effective July 1.

At Tuesday's regular meeting of the board of supervisors, Supervisor Gary Folluo said he received notice last week that the center is leaving the building due to funding cutbacks, but said he'd like to have the county attorney review the lease to see if their reasoning is sufficient to get out of the lease with the county.

Folluo said the IWD will be moving to the Fort Madison Public Library two days a week on Monday and Wednesday from 9:30 to 4:30.

Larkin said there is language that says the state can get out of the lease if they experience funding hardships, but he said they should be made to prove that hardship.

"We received a letter on that quite a while ago, maybe a month ago, that they were going to be leaving," Larkin said. "They put down the reason for leaving as funding was short. According to the contract, according to funding they could back out of the contract. Well I don't know that the state not appropriating enough money for them means it's not enough funding. They just gave everything else in the tax cut to everyone else, does that necessarily mean they don't have enough funding?"

Larkin said he requested for County Attorney Ross Braden to review the contract between the state and the county.

"I just want to make sure they are following the contract," Larkin said during a workshop session following the meeting.

## Firefighters welcome new pumper truck

*City saddled with \$70K as share of costs of new truck*

FORT MADISON - Driving by the Fort Madison Fire Department in the past few days, residents would

see the newest addition to the department, a new pumper truck that will replace the old 9411 that tipped over into some backwaters south of Fort Madison.

Firefighters are in the middle of training with

the truck, which was purchased from Alexis Fire Equipment Co., out of Alexis, Illinois, for about \$600,000 when the truck and equipment that was damaged in the tipover, are all figured in. The city's insurance carrier picked up all but about \$70,000 of the cost.

As part of the replacement the department

upgraded some of the equipment that was lost including going to battery-powered extrication, or JAWS, tools.

"We're still doing complete training on the pump capabilities," said Lieutenant Chad Han-num. "We're also doing lots of driver training. Probably upwards of 20

Chairman Don Hunold said he was pretty sure the state was following the contract, but said the county needs to look at finding someone else to move into the building to use the space.

Folluo said his first reaction was to move the North Lee County Attorney's office into the county building and sell the current building.

Lee County Auditor Denise Fraise said the county needs to be mindful of the other entities that use the building.

"The only thing is there are people upstairs in that building that we have to provide places for like juvenile probation. I'm not sure how often they are there or how many people are in there, but there are people up there, too," Fraise said.

Other suggestions included offering the space to the Lee County Economic Development Group. Hunold asked the supervisors to keep the idea in mind as filling the space could help the county save money or possibly rent the space out.

# FM girls nipped by ND in team tennis regionals

*Larson gets sought-after win over Keokuk's Hall at No. 1*

FORT MADISON - The Fort Madison Lady Hounds were bounced from regional team tennis action Monday, but took Notre Dame to the limit in the second round.

FMHS took five of six singles games against Keokuk, highlighted by a 6-0, 2-6 (10-5) tiebreaker win by senior Katie Larson over Jakala Hall at No. 1. With only three matches in team doubles competition remaining, Keokuk couldn't have scored enough to catch the Hounds so doubles play wasn't held and the Hounds moved into round two against the Nikes.

The two teams split the singles competition with Miho Shirai winning 6-0, 6-3 over Claire Hackenmiller at No. 2 singles, Larissa Ferrill knocked off Riley Brueck 6-4, 6-2 and Lanie Kuntz beat Katie Connor 6-7 (8-10), 6-1, 10-7 tiebreaker at No. 6.

The Hounds' Kearnstyn Johnson lost in a tiebreaker to the Nikes' MacKenzie Fry 4-6, 7-5 (7-10) in singles action.

With the split, round two win hinged on doubles action, which was interrupted by weather. Head Coach Amy Doherty said the school agreed to move the event to Burlington in case indoor play would be required to finish the event.

"The Notre Dame match was much more of a challenge because we haven't beaten them yet. We got through singles 3-3, which was better than we had done when we played them in a dual so we had re-

newed confidence going into doubles only needing to win two," Doherty said.

"We started doubles at home and our girls started out tough but were starting to falter a little when the rain and thunder came. We quickly decided to move up to Burlington in case we needed to go inside to finish. This gave them a chance to regroup and helped a lot because they came out with more confidence and played more aggressively, all three matches having to go to the third set tiebreaker."

Kuntz and Mercedee Doty won the first set of their match with Kennedy Rheinschmidt and Katie Connor 6-3, but fell in the second set 5-7 and lost the match tiebreaker 3-10.

Larson and Shirai went back in forth in their match with Lydia Becker and Hackenmiller losing 3-6 in the first set and then escaping with a 7-6 win in the second set after a 7-2 tiebreaker at 6 all. The match tiebreaker went to 11 with the Hounds winning 11-9, setting the stage for Johnson and Ferrill to try and save the win.

The two dropped the first set 5-7 but came back to win the second set 6-4 setting up a third match tiebreaker, which they lost 7-10 to end the day for the Hounds.

Regional individual and doubles action begins Wednesday morning at Fairfield beginning at 9 a.m.

"These girls endured the heat and worked hard today. The Keokuk match was nothing more than the expected usual, except Katie finally got a win over Jakayla Hall which was huge for her and something she has been trying to accomplish all year," Doherty said. "I must say though, these girls battled today and left 100% of themselves out on that court. I couldn't be more proud of them and the season they have had this year."

# Bass fishing heating up in southeast Iowa

DES MOINES - The following is the weekly fishing report from the Iowa Department of Natural Resources for southeast Iowa for the week ending May 17, 2018

### Big Hollow Lake

Water temperature is in the upper 60's. Water clarity is good. Largemouth Bass - Good: Bass are still hanging out in deeper water; work the shallows in the afternoons with the sun shining. Bluegill - Slow: The warmer weather should bring the bluegills into shallow water. Black Crappie - Fair: Crappies are moving in shallow.

### Lake Belva Deer

Water temperature is closing in on 70 degrees this week. Largemouth Bass - Fair: The warmer weather should get the bass to more shallow water. Try fishing the shorelines with the wind blowing into them. Black Crappie - Fair: Work the shallow water on the north side. The warmer water temperatures should bring crappies in to feed.

### Lake Darling

Water temperature was up to 70 degrees on Tuesday, after several days of upper 70's degree weather. Water clarity remains good, except turbid above the in-lake silt dams. Black Crappie - Good: Crappies were out in 6-8 feet of water last weekend, but moved back in shallow by Tuesday. Largemouth Bass - Good: Bass fishing in the shallows had picked up; work them pretty slowly. Males are starting to stay in shallow to nest. Channel Catfish - Good: Anglers are catching some nice stringers of catfish, mostly with nightcrawlers. Bluegill - Fair: Anglers are picking up bluegills at a fair pace in the shallows around the riprap.

### Lost Grove Lake

More boats are out on the lake with high river levels on the Mississippi River. Largemouth Bass - Good: Bass fishing continues to improve; work the rocky shorelines where the wind is blowing into. Black Crappie - Good: Crappies are starting to move shallow to feed; concentrate efforts on the North side bays and along the rip rap where the water is warmest.

### Mississippi River Pool 19

Tailwater stage is 12.60 feet at Lock and Dam 18 above Burlington and is rising. River stage is forecasted to reach 14 feet by Saturday. Flood stage is 10 feet at Lock and Dam 18. We have not received any fishing reports for this pool this week.

River stages are above flood stage. Tailwater stages are forecasted to rise the next few days. Main channel water temperature is around 66 degrees. Water clarity is poor. Some boat ramps are closed due to the high water. We have not received much for fishing reports this week. If you have questions on fishing Pools 16-19, contact the Fairport Fish Hatchery at 563-263-5062.

### PUBLIC NOTICE CITY OF FORT MADISON SIDEWALK REPLACEMENT PROGRAM RULES

1. The purpose of this program is to furnish an opportunity for residential property owners to replace existing deteriorated sidewalks and/or to install new sidewalks in front of existing buildings where no sidewalk now exists. This does not include driveway approaches or sidewalks going to the residential unit. It does include sidewalk, which is located within the street right-of-way.

2. The property owner's responsibility will be to remove and dispose of the deteriorated sidewalk or excavate where new sidewalk would go, form the sidewalk to be poured, and place the concrete. This work can be done either by the property owner, renter, or your contractor. The City will not pay for Saturday delivery charges. Work cannot begin before July 1st.

3. The City of Fort Madison will inspect the sidewalk prior to approval of your application, prior to removal and prior to placement of the new sidewalk. The Fort Madison Ready Mixed Concrete Co. will bill the City for the concrete used and the City of Fort Madison will pay for the concrete directly to the supplier. The City will not pay for the additional Saturday delivery charge. If the property owner wishes to have the delivery on Saturday the bill for the delivery will be sent to the property owner. No payments will be made directly to the property owner. The concrete can be ordered by the property owner or your contractor from:

4. The sidewalk shall be constructed according to the sidewalk design specifications which can be acquired at the Fort Madison Public Works Department.

5. Each application will be evaluated based on its condition and how it improves the area for pedestrian traffic. Extra consideration will be given for connection to an existing sidewalk.

6. Applications for this program will be available on May 1st at 8:00 A.M. and will be accepted through June 22nd at 4:30 P.M. Each proposal will be evaluated and you will be notified by July 2nd. The City will fund projects as funding is available. The replacement work cannot take place before July 1st and must be approved by the City prior to the commencement of the work.

They asked if a big tent could be put up by the pavilion so people can eat outside if they want. There has never been a request for one by the pavilion so asked Larry Driscoll about it. He said to put it on the agenda for the parks board to decide on. She researched other cities in Iowa and only found one that had information about big tents/bounce houses and that was Burlington. They charge \$50 extra for big tent/bounce house and require a certificate of liability insurance. Driscoll stated that if it is approved to have big tents at shelters then it will need to be mapped out where they can set up. Pieper stated she does not have a problem with it as long as they obtain liability insurance. Even if they obtain and insurance will the City still be liable. It was stated that they could be. Driscoll stated that he doesn't see how they will be able to erect it due to the irrigation system. Pulis asked if heavy bags could be used instead of stakes to hold it down. Driscoll said if bags were used they could possibly set up on the south side but there is a storm sewer there. Decker shared that there needs to be a stipulation that Driscoll informs where the tent can be set up. It was asked why there should be an extra fee. Driscoll shared because it takes time to map out where the tent should be set up and the use of City equipment to figure it out. There have also been requests about having a bounce house at shelters. In the past, John Luna just told people that they could not have them but more and more people are wanting to rent them. Decker asked how much the fee should be for tents. Driscoll suggested \$100 for the extra work. Wilkerson stated he has no problem with tents as long as utilities are not damaged but feels bounce houses are a liability. Decker stated they will deal with the tents first. Every one agreed with that. Pieper feels \$100 is too much. Wilkerson asked what if someone only wants to put a tent up on green space and there is no shelter. Will the fee still be \$50 to put tent up. And should there be size restrictions. Pieper stated

that the pavilion renters who want to put up a tent should be charged \$50 extra to put up the tent and that they have to meet with Larry to discuss where they can put it then see what happens for future tents. Decker said so we should just vote on this one time and then bring it back.

Pieper MOVED and Wilkerson SECONDED a motion to approve BIG TENT AT RIVERVIEW PAVILION FOR ONE PARTY ON MAY 26, 2018 WITH A \$50 EXTRA CHARGE AND MUST CONTACT LARRY DRISCOLL FOR DIRECTIONS ON WHERE IT SHOULD BE ERECTED. MOTION CARRIED.

Driscoll then asked what the Board thought of bounce houses in the parks. Pieper didn't think it seems to be an issue. Driscoll shared he thinks bounce houses and tents should only be allowed in designated areas in designated parks where there is more space. He stated that Central Park and Old Settlers Park should not need tents. Decker felt there is room in all of the parks for bounce houses but thought it should be limited to certain ones. Driscoll said that he should look at it with David and explore the options. City Manager Varley feels this should be looked into for events, etc.

More discussion and vote on bounce houses will take place at a later date after Driscoll and City Manager Varley has been able to discuss it.

Approved Reoccurring Events:

Parks, Recreation and Docks Board voted, and approved, to grant parks City Staff permission to approve reoccurring events that have been held 3 years or more in a row.

None in April.

Committee Liaison Reports:

A. Pieper: (PORT): meet next week. Glo Run 5k on PORT Trail. Driscoll added that a TAP Grant has been applied for and will know more in April. This will be in the amount of \$500,000. City to pay 20%.

B. Decker: (Old Settlers Association): nothing to report. When it warms up he would like to "tour" the park with Driscoll. There

is a stump that needs to be removed.

C. (RiverFest): nothing reported.

D. (Public pool): Nothing to report. YMCA will be managing pool this summer.

E. Tara Johnson (Board Liaison for Rodeo): was not able to attend. Driscoll shared that the City is rehabbing a trail in Rodeo Park and hoping to do another soon.

Parks Update:

None

Wilkerson MOVED and Pieper SECONDED a motion to adjourn. MOTION CARRIED. The meeting was adjourned at 5:50 PM.

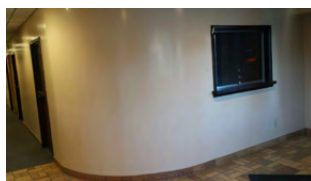

# Morawitz, city staff clash over garbage code

**CODE** - Continued from Page 1

Morawitz said that was only for where to place the cart to be picked up. "We left it general because when we talked it was to address the hills, and how do you address the hills on D," Driscoll said. "You're gonna have to have guys set up a system down there off the curb in the right of way with some type of post the containers are going to have set against because in reality those folks aren't going to go back and forth with that trash can. And I thought that was acceptable with you guys."

Morawitz said that language isn't in the proposed code, and Driscoll said it was, it just wasn't written the way Morawitz wanted it written.

"If somebody leaves their can by the street, can the city have legal grounds to make them move it," Councilman Rusty Andrews asked city attorney Robert Johnson.

Johnson said the city owns the city from inside each sidewalk to the other sidewalk across the street and if the ordinance is clear and understandable and there's a provision for enforcement the city could file a misdemeanor charge.

"The question is whether or not it's clear," Johnson said.

Mayor Brad Randolph advised Morawitz to get with Driscoll and City Manager David Varley to work out the language.

"My advice would be for you to get with Larry and David and come up with some verbiage that allows enough flexibility in the ordinance to address those issues and that can be presented at the next reading."

Morawitz repeated an argument that he has made during the process of rolling out the program, which is that the city bought the carts and started the program without figuring out the logistics.

"We're not going to shoot the ordinance in the foot. It's workable." Randolph said. "Get with those two, come up with additional language that doesn't alter it enough that we have to start over with the readings. And then we would be able to modify that if the bulk of the council chooses to at the next meeting," Randolph said.

Morawitz said he also would like to see something else added to the ordinance to allow for special occasions like birthdays or anniversaries because people were able to buy stickers for those special occasions. He said with the proposed ordinance there is no option for people when they generate extra trash.

"I don't want to be like it is now where you're buying stickers every week because you don't want to get a second can. It's got to be a special

thing where you're limited. Maybe in our bill on Jan. 1 you get two stickers to use for the year and you can use them anytime during the year," Morawitz said.

Randolph said all the changes amount to defeating the purpose of the new program.

"I appreciate your passion, but you're trying to make so many carve outs for it, it's defeating the whole purpose of what we're trying to do,"

Randolph said.

He said Morawitz is not giving residents enough credit for handling things properly, but Morawitz asked why change the trash program if the city can trust people to handle trash properly.

Randolph said it wasn't just the residents, but streamlining the city's trash collection process.

Morawitz voted against the 2nd reading of the ordinance, which passed 5-1, but indicated he would get with Driscoll and Varley to work on the language of the ordinance

for a possible amendment on the third reading at the next council meeting.

In other action, the council: -voted on an amendment to the city's budget for the current fiscal year to accommodate for expenses exceeding the certified budget in 2017, including a \$3.2 million amendment for Community and Economic Development for grants for the Barker Downtown project and for a \$250,000 cash payment for the

Boulders Inn and Suites project from the General Fund. Other smaller expenditures for the Library, Parks Department, Old Fort Reserve Fund, and Marina fund were also amended. A \$12.9 million amendment was also made for several wastewater and stormwater projects with funds made up of state revolving loans, general fund reserves, and a loan.

# Truck customized for pump, rescue work

hours per guy before we put it in service. It may not be 20 hours each, but they need to be proficient.”

He said Chief Joey Herren would have the final say on when the truck is put into service, but he said a company will be coming in to help with pump training.

The truck features state-of-the-art pump technology, an onboard driver-assist computer and metaling cribbing assists which help support weight during emergency extraction.

“This truck is designed to be an engine, which in our terms means it pumps at fires, but it’s also designed for rescue as well. Rescue entails confined space, high angle, automobile extrication so we’re going to have a lot of tools on here,” Hannum said.

The unit will also feature a front bumper line to allow the truck to roll up close on auto fires. On the back of the truck is “Rescue Mater” from the Cars movie. Hannum said the new firefighters wanted a newer character on the truck because newer generations don’t know who Yosemite Sam is.

Hannum said the cab is roomier and has headsets for easier communication in loud situations and the engineer in the truck can keep the headset on to help with communication in the field.
