

# Mayor says city will look at fireworks code

FORT MADISON - After the third straight meeting where city residents addressed city leaders about fireworks in the city, Mayor Brad Randolph said it's time to take another look at the ordinance.

At Tuesday's regular meeting of the Fort Madison City Council, city residents Theresa Dearing and Bonnie Neyens both expressed concerns about the recent open fireworks period in the city surrounding the 4th of July holiday.

State laws changed in 2017 to allow fireworks to be sold in Iowa and set new time frames when shooting fireworks off within the state would be legal.

"I love the fireworks in the park on 4th of July, but the rest of the fireworks going on from the first of June until last night was not acceptable to me," Dearing said.

She said the night she came back from the fireworks at the park was like a war zone in her neighborhood and she could see it in her husband's eyes, who is a veteran and served in Vietnam. She also said her house burned when she was younger, so she has a fear of fire. Dearing asked about the liability if a firework lands

on a house or damages property.

"Who's liable there? That's a concern for me."

Neyens said she also would like the city to review the current code, which runs congruent with the state laws. Randolph said he got to watch the fireworks on Ninth Street in the alley between avenues G and H.

"I came to a quick realization, I thought, boy this a

# FM school board looking for Troxel replacement

Seat could go to voters with petition, or another bond effort

FORT MADISON - While the Fort Madison City Council looks to fill a vacancy on the council, the Fort Madison School Board is now looking to fill a vacancy as well.

At Monday's regular meeting of the Fort Madison Board of Education, the board accepted the resignation of Jillian Troxel effective Aug. 1.

The resignation then kick starts a process for filling the position with either an appointment or a special election.

Superintendent Erin Slater said filling the position by appointment would give the board until Aug. 31 to select someone to fill the seat. District residents would have the option to petition the board for a special election within two weeks of the resignation, which would be Tuesday, Aug. 14. An appointee would fill Troxel's seat until the next regular school board election, where a person would then be elected to fill out the remainder of Troxel's term, which would be Dec. 31, 2021. However, if the district puts another bond election on the calendar, according to state code, the seat would be put up for election at the same time. The district is still contemplating another run at a bond referendum to build a new elementary school on school property

Andrew Troxel, a member of the district Teacher Leadership program and Andy Mitchell, the district's former Activities Director also put in resignations this year. Troxel is going back to his alma mater in Wisconsin, and taking Fort Madison School Board mem-

Brent Zirkel, the school's assistant principal who conceptualized the school's PACK program, is leaving to take a position with the Williamsburg School district.

Zirkel announced Tuesday that he was leaving the district to a position that will allow him to further utilize his bilingual expertise as well as his administrative certificate as an assistant principal at the Williamsburg Junior/Senior High. The school is a 7th-12th grade facility about 20 minutes west of Iowa City. ber Jillian Troxel with him. Mitchell took a parallel job with the Atlantic, Iowa school district.

Zirkel said he is taking fond memories of the district with him and isn't saying so long.

"My phone's just been blowing up all day and I'm telling people this isn't a goodbye. This is just a 'See ya later'. I love this school district and the staff and students I've worked with and I love this community," he said.



# Zirkel leaving just at FMMS gets "running"

#### **RESIGN** - Continued from Page 1

"What draws me there is they have a migrant population for about four months out of the year. My first master's degree was English Language Learners and this position would give me a chance to utilize those skills."

Zirkel was first hired in the district in 2004 as a Spanish teacher and then earned a master's degree in bilingual education. When Greg Smith took over as principal, he encouraged him to get his administration certificate. After earning that certficate and going through an internship, Zirkel was offered the assistant principal's position at the Fort Madison Middle School.

He said he was happy that he had teachers like Ryan Smith and Andrew Troxel to work with at the high school. He also credited Greg Smith with creating an environment where new ideas were no longer the exception, but the norm.

"I was so fortunate to be able to collaborate with Troxel, Greg Smith, and Ryan Smith. They were all very supportive and open to new ideas and that's the only way to get better as an educator," he said.

"You go through training and you learn one thing and then you get where the rubber meets the road on the job. Greg really created an environment where you can take risks and learn from them. By him doing that, I was able to start integrating technology to help our kids use their time more efficiently and effectively."

Zirkel said one of his first impressions at the Middle School was the high quality of the staff.

"You have to have the right people in place and they have that there," he said. "And that's just not the teachers and the principal, but the custodians and the food service staff and other staff. When I came into the position there, it just had that family feel and I felt fortunate to be joining a family."

The district had gone through several assistants before Zirkel got to FMMS and he said he wanted to bring some consistency to the job, and although he's leaving after two years, he said progress was made even after two years, a lot of which started this past school year.

He credits Principal Todd Dirth with allowing him to take some risks and add to what Zirkel calls a "wholistic" approach to educating the students at the school. That approach he says addresses not only educational needs, but social and emotional needs as well.

"One of the things I'm very proud of is there is this wholistic approach



to the student," he said. "There's a compassion you'll find there, and I'd never seen that before where you program to help the kids learn about the social and emotional changes they are going through."

He said the PACK program was designed to ramp up that portion of the educational process.

"The PACK piece is a response to trying to help the social and emotional needs of our students. To help them with character development and expand on those relationships already being built there," Zirkel said. "We also looked at digital citizenship. All of our kids live a good portion of their life online and helping them learn how to conduct themselves. That illusion of anonymity is not how the Internet works, and helping them grow



The construction of the new middle school has resulted in yearly increases in the performance according to the Iowa Report Card which assesses public schools on achievements. But Zirkel said despite the improvements, the state assessments are an ever-moving target and until the state settles on assessment tools and then aligns curricula with those assessments, that number will remain hard to move.

He said he hopes action taken this year will result in better scores for all the districts.

"When they created that report card, it was like the goal line kept moving and there was no alignment. We have common core and even there the standards change year to year or ev-

it should be an aligned assessment and that should be the first opportunity to know where our kids are, compared to what we're teaching."

Zirkel said he looks at the culture to determine a school's success.

"Education is in a weird spot as we move from the industrial age through to the conceptual age. Our systems have lagged behind, but we're moving in the right direction."

He said staff such as Dirth, Stephanie Dobson, Michelle Bentler, and Brian Mendez are the catalyst behind the new culture at the Middle School.

"I call it Progress though Struggle. We were going outside our comfort zone, but it's what we believe is best for kids. As we struggle through it, we find the benefits of it and then keep moving forward. We crawled, then walked, and now they're running," he said. "I don't think our community understands how lucky they are to have the leadership there they have - Stephanie Dobson, Todd Dirth - they are the rocks of the foundation there. They've been laying the groundwork there for 12 to 14 years to enable us to do programming pieces and other things. One of the things I've learned is that you have to do the management pieces before the instruction pieces. Through Todd I've learned a lot of the management so I can get around to the instruction."







# City lends support to PORT trail |

free-for-all down here," he said. "With fireworks going off in the middle of public streets and in areas I didn't think they should be going off," he said.

"I grew up shooting bottle rockets at my brother, and I like fireworks, but there's probably a limit to what's acceptable."

He said after going through the full cycle of the fireworks with them being sold in town and everyone having easier access to them, the council should take another look at the code.

"I think that the city and the council need to take a hard look at what's best for the citizens and the public going forward," Randolph said.

Neyens said people have contacted her since she spoke up at the last meeting about the fireworks issue. She said they had concerns about caring for invalid relatives, people working shifts, people who like to go to bed early, people who keep their yards nice and don't feel they should have to clean up trash in the yard.

Randolph said it would be more a comprehensive look at the law and because the law was passed relatively close to the holiday, the city went with the state's code on the use of fireworks.

He said the sale of fireworks isn't a windfall for the city when you factor in the small sales tax, offset by the costs of emergency services or police responding to calls.

"So be patient with us on that, but let us now take a good hard look at where we're at and what we can do about it."

Councilman Kevin Rink, who represents the area that Dearing and Nevens live, said the city followed the state as a trial and he agreed that the city needs to take another look at the code.

In other action, the council:

• voted 5-0, to approve city support for up to \$50,000 in monetary and in-kind donations to prop up a local match for a \$100,000 grant for the PORT Trail Phase III. City Public Works Director Larry Driscoll said the PORT committee is doing fundraising to pay the \$50,000 match on their own, but Wellmark, the grant issuer wouldn't issue the grant without the \$50,000 support in place.

• voted 5-0, to approve transferring city owned property to Great River Regional Waste Authority for \$1 to clean up some boundary issues that had occurred with past surveying.

said. Hope said the board wouldn't necessarily need to do interviews.

"When I read this, we only need to review what the written application is and then make the appointment during the board meeting. We wouldn't have to interview, we can make it based on what has been provided and we only have to make the appointment within 30 days."

Slater said they could review the materials and then invite the candidates to the meeting and give them three to five minutes to address the board and give a statement about their candidacy.

Young said she would personally like to have the candidates there and speak for themselves.

Wondra said applications should be ready by the end of the week and interested parties should contact the district for information on the application process.

In other action, the council:

• approved 6-0, a threeyear contract renewal for Superintendent Erin Slater effective July 16, with a 1.56% increase over last year's salary and annual pay review. Her new salary will be \$180,776.80 for 2018-19.

• approved 6-0, handbooks for AFSCME and Teamster Units 1 and 2 staff. Handbooks outline what used to be in contracts before the state legislature changed Chapter 20 to just include salary negotiations. AFSCME representative Tracy Leonie spoke to the board about working in collaboration when dealing with state legislatures because it was still AFSCME's stance that the handbooks should revert back to contracts.

• approved 6-0, extracurricular contracts and letters of assignments. Extracurricular contracts are amounts paid to staff already on contract with the district for leading or coaching extracurriculars. Letters of assigments are amounts paid to those not otherwise on contract with the district.
