# **FMCSD wants PLC status 3 YEARS:** District aiming for national Professional Learning Community certification

#### **BY CHUCK VANDENBERG** PCC EDITOR

FORT MADISON - A move to be nationally certified as a Professional Learning Community was unveiled Monday night to the Fort Madison School District's board of directors.

Superintendent Dr. Erin Slater said the district will embark on a 3-year effort to be nationally certified as a PLC district.

"The district is preparing to enter into a 3-year journey to become a model for a Professional Learning Community," Slater said Monday night.

"This is a national selection and an elite section. We're gonna put ourselves out there - what do they say, 'You miss every shot you don't take', so we're going to take this shot."

PEN CITY CURRENT

Slater outlined the criteria for becoming a model PLC district which involves working with collaborative teams with clarified specific proficiency standards.

She said the district also needs to have a process to carefully monitor each student's learning.

"Not only are we doing formative assessments, but also summative assessments. It's really about taking

# POLLMILLER **No warnings** for Pollmiller **Beach water**

County only tests Pollmiller as swimming prohibited at other county waters

LEE COUNTY - With the Naegleria fowleri amoeba the cause of a Missouri man's death last week, attention has been brought on Iowa's swimming holes.

The man very likely contracted the amoeba after swimming in water at Lake of Three Fires in Taylor County in southwest Iowa on the Missouri/Iowa border.

Missouri health officials aren't releasing the name of the man, but the national attention the death has caused has people looking closer at where they are swimming.

Heather Huebner, director at Lee County Conservation said Lee County has only one public swimming area and that's Pollmiller Beach in West Point. She said swimming at other public ponds and lakes in the county including Wilson Lake, Heron Bend, and Chatfield Park is probited.

Huebner said the conservation staff tests Pollmiller Beach weekly.

"We only test Pollmiller as that is our only swimming beach. There's no swimming allowed at any other pond or lake," she said.

"We test weekly through the Beach Monitoring Program and we send the

# Zoom meetings should stay a part of public accessibility

In my day job, I wear the hat of the executive director of the Iowa Freedom of Information Council. This nonprofit, nonpartisan organization has been around for 40+ years.

We advocate on behalf of the public and journalists for government transparency and accountability to the people of this state.

Periodically, I speak to groups of government employees and elected officials. One question that often comes up in those settings and in individual conversations with government leaders is some version of, "How are we doing?"

These days, this is what I tell them if they ask:

In the months after Covid became Public Enemy #1 three years ago, it was impressive how quickly local governments across Iowa and our state government scrambled to adapt to holding their public meetings when the public was hesitant to venture into potentially large gatherings in small-ish spaces.

Officials swiftly began making their meetings available through livestreaming on Facebook or on videoconferencing platforms like Zoom. Meeting notices and meeting agendas told the public how they could watch without having to be in the audience where the meetings originated.

But if anyone asks about my impressions now, I would tell them things have changed —and not always for the better.

Today, too many city councils, school boards and county boards of supervisors have turned their backs on the technology that got them through the early months of the pandemic, before vaccines eased people's anxieties about being in close proximity with large numbers of people.

Today, too many government boards refuse to continue offering the Zoom capability that has become a part of everyday life for many Iowans.

This is ironic, because while some government officials have balked, parents and grandparents and their kids have embraced the long-distance gatherings with Zoom and FaceTime. This technology has made the face-to-face conversations possible from the comfort of their separate homes. They can listen to Mom's piano playing or marvel at the antics of the family dog.

While there still are many city councils, school boards and boards of supervisors that continue to make their meetings available live for remote viewers, too many government bodies have signaled they don't want to be bothered by making remote viewing possible.

These officials are not breaking any law by saying "no" to remote viewing requests. Iowa's open meetings law does not require government boards to provide Zoom access. It only requires that meetings be open to the public.

Common sense should prevail - but too often it does not.

Never mind that having their meetings available on Zoom would allow people with child care responsibilities, or senior citizens, or the disabled, or the person without ready access to transportation to "attend" the meetings of their school board. Never mind that supervisors' meetings typically are held during the day, when many people are at work and cannot get away to drop in on the supervisors' meeting.

Getting more people engaged in their city council, school board or board of supervisors is just good government. I remind government leaders during my presentations that government does not belong to them. It belongs to the people. Government employees and officials are entrusted to act with the public's best interests in mind.

During the pandemic, one member of the Grundy County Board of Supervisors was deployed to the Middle East with his Iowa National Guard unit. He was still able to "attend" the supervisors' meetings using his laptop computer and Zoom. But once he returned home after his deployment ended, the Zoom meetings ended, too.

County officials insisted they were not set up to provide Zoom access from the supervisors' small meeting room. Of course, it's that same small meeting room where officials expect the public to compete for the eight or 10 chairs available for spectators.

The Grundy County board recently considered



officials that he intended to carry the public hearing on the ordinance live on the newspaper's Facebook page.

Officials initially tried to stop his planned livestream. In the end, they relented — and several hundred people watched the hearing live or afterward.

That brings up another objection I hear from government officials when I mention the pluses of having meetings available via Zoom: There really are not many people who want to watch these meetings.

Iowa law does not require government boards to meet in public because those gatherings will be a big ratings blockbuster. The law says meetings shall be open to the public so the basis and rationale for boards' decisions, as well as the decisions themselves, are easily accessible.

These days, many people believe that easily accessible means Zoom, as well as space for spectators in the meeting room.

If officials are not savvy enough to understand that, then maybe the Iowa Legislature needs to get involved next session and "help" officials see the problem with their misguided opposition to Zoom.

**New Business Revise Operations Poli**cies to include administering Narcan:

The director recommended amending the Health Emergencies section of the Operations Policy as follows

(highlights indicate additions, strikethrough indicates deletion):

"911 should be called immediately in the event of any serious problem.

Staff members should exercise caution when administering first aid of even a minor nature because of the safety of the injured individual and the potential liability of the staff member. Without specialized training it is not advisable for staff to undertake more than keeping the sick or injured patron comfortable and protected from needless disturbance until medical help can be obtained. Since each case is unique, staff members should use their own judgment to do what is prudent and reasonable. There is a first aid kit located in a labeled cabinet at the front desk.

With the exception of Naloxone/Narcan, no medication, including aspirin over the counter medications, should ever be dispensed to the public. Staff members who have chosen to receive training on administering Naoloxone/Narcan may administer it following library procedures.

tation to amend library board by-laws to include a section on public comments. The director looked at what the city council and other libraries do. The main difference from city procedures that the director noticed is that other places do limit the total time available for comments. That time limit is found in this draft if it is something that the library board wants to include. The director isn't aware of city council meetings having issues with excessive time for comments. Trustee Welder shared that, on a controversial issue, the planning and zoning board has. The board is in favor of a total time limit for comments and the director will keep that in. Trustee Welder also suggested that people be required to identify themselves. The director will add that the speakers will identify themselves to the board when speaking. Trustee Bartlett inquired if public comments were only allowed during the public comments section. The director replied that the way she has written this is that public comment section would allow for comments on items not on the agenda. There would also be time for comments on individual agenda items. Trustee Welder also said that the other board he is on only allows one person from each group. The director will word the policy to include this.

Discussion of adding community events to the library calendar:

The director is looking for feedback from the board on how they would like to handle adding events to the community calendar as she drafts the policy. The board was not in favor of limiting the number of postings by an organization. The board would like the calendar to be moderated so we will have library staff or volunteers entering events into the calendar. The director has specifically included the following event types, festivals, school performances and sporting events, community and professional performances, community events, and fundraisers. The director would recommend explicitly prohibiting fundraisers benefiting a single individual and commercial events. After talking to the Keokuk Library this would still include things like a Farmer's Market or the Downtown Summer Market. At this time the calendar will only include events in Lee County. The director's recommendation is to limit political events to bi-partisan events, such as candidate forums. Events will not be placed on the calendar more than a year in advance. The director will draft a policy and bring that back to the board at the July meeting.

**Trustee Handbook** Chapters 11 and 12: The board reviewed Chapters 11 and 12 of the Trustees Handbook on effective board meetings and decision making. The director didn't notice anything in the chapters that was problematic for the board and complimented the board on reviewing meeting materials and being prepared for discussion.

# Lake Geode listed on state's swimmer warning list

very low risk of infection. Infection causes primary amebic meningoencephalitis (PAM) which has been shown to be fatal in 97% of the 154 cases ever reported in the United States. The amoeba actually feeds on bacteria, but releases toxins that the body's immune system gears up to fight, which causes a swelling in the brain. The only path to infection is through the olfactory nerve in the nose.

According to a report from National Public Radio, Iowa and Missouri health department officials are working together to determine if any other water sources locally have a presence of the amoeba.

Iowa DNR officials have closed Lake of Three Fires to swimming and have issued 12 other warnings at state beaches. However, none of those 12 is due to the amoeba. Those others are due to high levels of e.coli or microcystin in the water. Lake Geode in Danville is on the microcystin warning list with one other lake. Microcystin is a harmful toxin produced by blue-green algae blooms.

evidence of student's learning and doing something with it."

Other criteria includes a process for responding when students have difficulty learning, a process for enriching and extending learning for students already proficient in standards. She said that criteria focuses on what is happening during the school day and not before or after work sessions to address students struggling or students excelling.

Professional learning communities tend to serve two broad purposes: first, improving the skills and knowledge of educators through collaborative study, exchange, and discussion, and second, improve the achievement, and attainment of students through stronger teaching skills and leadership.

Slater said the district has to show a commitment to the PLC concepts, implement concepts for a minimum of three years, and show clear evidence of improved student learning.

The district has been engaged in PLC learning for the past six years and now they are looking at obtaining national recognition for the efforts over the next three years.
