## City may act on Block

**ABATEMENT:** Settling causes city to vote on emergency repairs Tuesday

FORT MADISON - The Fort Madison City Council will consider action Tuesday night to authorize emergency repairs to a downtown building.

A resolution on the City Council agenda for Tuesday's regular meeting would authorize Mayor Matt Mohrfeld to order repairs to the building to avoid a potential of the west side of the James Block Building, formerly known as the Humphrey building, on the southeast corner of Avenue G and 8th Street.

City crews barricaded all of Eighth Street from Avenue G south to the alley between Avenues G and H last week after additional settling and damage had been noticed by City Building Director Doug Krogmeier and City Fire Chief Joey Herren.

Herren ordered the barricades be placed across the entire street a week ago.

The authorization will allow the city to contract for repairs

## Grassley, Baldwin tackle farmland security issues

WASHINGTON -- Today, Sens. Chuck Grassley (R-Iowa), a lifelong farmer and member of the Senate Agriculture Committee, and Tammy Baldwin (D-Wis.) introduced the bipartisan Farmland Security Act to increase scrutiny over foreign investments in American agricultural land. The legislation ensures that the American people and Congress have the information needed to address the impact foreign investments have on family farms, rural communities and the domestic food supply.

"I've been sounding the alarm on the increase in foreign-own farmland for decades and was the original author of the Agriculture Foreign Investment Dis-

# Carle's appointment to city housing authority on agenda

without having to go through the regular process of advertising and going out for bids on the work.

The resolution reads in part, "an emergency abatement is necessary to provide for the safety of surrounding businesses, and the delay in advertising and a public letting might cause serious loss, injury, or damage to the James Block Building past the point of repair."

Mohrfeld said last week he's trying to get a developer involved in the remediations so as not to jeopardize the marketability of the structure, and not waste taxpayer dollars on something that doesn't fit future plans of the building.

He said a private investor has entered conversations about the building, but wasn't ready to release the name of the individual yet.

Also on Tuesday's agenda is a:

- first reading of an ordinance rezoning 1629, 1633, and 1641 33rd Street to I-1 limited industrial district from the current R4 residential district. The property is owned by Aaron and Bridgette Prado who are looking to expand their business in the area.

- a resolution to apply for REAP grant for the Phase IV 48th Street Trail Connector.

- the second reading of an ordinance adding a \$750 per day fine for on-going egregious civil infractions, to city code.

- the mayor's appointment of Jamie Carle to the Fort Madison Housing Authority for a term to expire June 3, 2023.

## Act looks for enhanced reporting

sure Act. Foreign buyers, especially those backed by governments like China, buying up prime farmland here in the U.S. raises serious national security concerns – and the American people have a right to know about it. By requiring the USDA to report these purchases in real time, we can keep better track of the impact these acquisitions could have on our rural communities. The Farmland Security Act will also help protect domestic food production and our national security interests," Grassley said.

The Agricultural Foreign Investment Disclosure Act requires foreign entities to disclose their purchases of American agricultural land. Current reporting shows that foreign-owned agricultural acreage has nearly doubled in the past decade;

however, the data that has been collected is incomplete and inaccurate. In fact, investigators estimate that the foreign ownership of land is nearly double current figures.

To protect American farmers, rural communities and domestic food supply, the Farmland Security Act:

Requires the U.S. Department of Agriculture (USDA) to report to Congress on foreign investments in agricultural land in the U.S., including the impact foreign ownership has on family farms, rural communities and the domestic food supply;

Requires the USDA to publish all prior-year disclosures of foreign investments in agricultural land in the U.S. on an interactive and public USDA database and make real-time updates to the database as disclosures are filed.

Heying lives and works in Chicago, where she is an artist, material researcher and educator. The Art Center is very excited to welcome Heying and Shifting Matters to the Main Gallery for August where we can visually explore her unique painting and materials talents while considering the deeper ideas her work engages with.

“Matter endures until it doesn’t, and then it becomes something else; we don’t notice until we do, and then what becomes of us?” Heying said.

Shifting Matters is an exhibition of paintings exploring the transience of our surroundings, the fluidity of the stationary, and our ever-human response to change. This body of work investigates the material of paint and the materiality of the world around us as a negotiation of time, space, and energy.”

Heying’s paintings explore place, landscape and surface as records of and containers for human experience. The inherent identities of material, both within the landscape and within the painting process, serve as a reflexive key to unlocking connection between people and place. In her work, the painted surface plays different roles from one piece to the next to mirror the process of perception.

Paint is used as color and form to render pictorial space, it’s accrued to physically evoke textured surfaces, and it’s used in complement to the actual minerals and objects of the land. This varied approach to materiality engages ideas of truth and artifice, nature and construction, and entropy and control as poetic metaphor.

Born in Minnesota, Heying moved to Chicago in 2011. She received both her MFA in Painting & Drawing from the School of the Art Institute of Chicago (SAIC) in 2022, and her BFA in 2015. She was the director of a state-of-the-art facility called StudioLab at SAIC, where she educated students on how to make and use traditional and modern painting and drawing materials for over six years.

She developed education resource collections including a Library, a Material Archive of historic pigments and materials and a Virtual Database of instructional videos. Elisabeth received the Roads Scholarship for Research and Travel in 2020, has exhibited widely in group exhibitions throughout the Chicago area and debuted her first solo exhibition, Ache of Erosion, at SITE Galleries in 2021.
