# News of closure adds pressure to Lee County Ambulance

## **COSBY:** "It's going to impact the ambulance service in a major way."

KEOKUK - Blessing Health in Keokuk informed employees and the community Thursday morning that the facility will not remain open past Oct. 1 in any capacity.

According to a statement from Steve Felde, External and Internal Communications Director the decision was made based on consistent low demand for inpatient and emergency room care.

"The hospital has been in financial crisis for 10 years. During that time, residents of the region have developed new habits and patterns for where they receive their inpatient health care, leading the hospital to average fewer than two inpatients per day and less than one emergency room visit per hour," the release indicated.

ment that could total millions of dollars cannot be made responsibly," the release stated. Blessing Health took over operations of the Keokuk facility in March of 2021.

"We did not want this to happen. This was not our plan," said Kathy Hull, chief of small rural hospitals for Blessing Health.

"We are disappointed but undaunted. When we reestablished our presence in Keokuk last year, we said Blessing was committed to investing in Keokuk's health care infrastructure to revitalize the community and the region to benefit everyone. Blessing has made an investment in the community and will continue to do

so through outpatient care." Hull said Blessing officials have been working with state and federal legislators and regulators looking for a last-minute option to save the hospital, but unfortunately found nothing. "We've made several attempts to find a viable option with regulators and legislators even looking at the possibility of becoming a Criticial Access Hospital, which has a different payment modality for a small rural hospital," Hull said. "We've also attempted to look at Rural Emergency Hospital legislation passed last year at the federal level and tried to speak with legislators about that coming to life in Iowa and it was tabled by them.





# County may have to add two more ambulances

"That would include an ER with a few observation rooms. We had hoped that might be an option for us, but that did not go forward."

Hull said legislators told her even if Iowa did put that legislation back up it would be next fall before it would hit the books and that's just too far away for the Blessing to stay operational.

Hull said Blessing reached out to State Sen. Jeff Reichman and State Rep. Martin Graber about the upcoming announcement and didn't get a response until Thursday.

"We've also been in contact with the Governor's office on several occassions in an attempt to find anyway we could not do this. We just unfortunately didn't come up with anything," Hull said.

She said Blessing would be open to conversations with Lee County around it's ambulance service and how they could help with the increased demand that's on the horizon.

"We have thought of that, but we have not pursued it at this point in time. We have notified them of the closure and we do understand it will be a hardship for them. They are already hardpressed for staffing.," she said, adding that Blessing would initiate conversations with Lee County EMS immediately.

Hull also said no one has come forward to talk about taking over the operations.

"There have been many failed partnerships before and getting another partner to come at this point would be incredibly difficult," she said.

The hospital property will be put up for sale, according to Blessing officials.

Effective with the closure of the facility, residents requiring emergency care will have to call 911 for Lee County EMS services and transportation.

Dennis Cosby, the director of the Lee County EMS said he still hasn't fully got his head around the news.

"It's going to impact the ambulance service in a major way and I just can't tell you all those ways yet. Cosby said. "We're still in the process of figuring out what were going to need to do."

Cosby said when the county was notified of the closure, they were informed that the hospital may not even remain open til Oct. 1 if they can't staff the facility. He said the county is currently trying to determine what they'll need to do to facilitate transports to the closest hospitals.

The closest hospital to Keokuk is now Carthage and Cosby said most insurance carriers require transport to the closest hospital.

"We generally try to follow people's wishes but a lot has to do with the patient's condition, and insurance usually pays to closest facility. Carthage would actually be closest."

That determination would end up costing the

county even more due to the distance back into the county from Carthage, where as a transport to Southeast Iowa Regional Medical Center in Fort Madison would have less cost in restaging the ambulance.

"We'll have to put on a second truck in Keokuk. Not only will it increase costs, but we' won't have a place to put it," he said.

Blessing was also one of Lee County EMS pharmacy replenishment facilities and Cosby said now that will have to change as well.

"This will be a huge change to our operation and we're going to have to immediately add staff. I'm going to need a couple days for sure to get my head wrapped around it," Cosby said.

Lee County Supervisor Garry Seyb, who sits on the Lee County EMS Advisory Board, said this is a huge challenge now for the county.

"This is definitely going to drive dicussion for the ambulance. It almost surely will require expansion of the number of ambulances on any given shift. The only hospital left in the county for emergency is Fort Madison. This will result in more travel time on the road which keeps them out longer.," he said.

Keokuk Mayor Kathie Mahoney said the decision will have far reaching implications.

"This decision is not only a blow to Keokuk, but to rural communities everywhere. Residents will either have to travel for care or wait for local urgent care facilities to open. Even then, quality in patient care will only come from facilities 20-60 minutes away. This also is a loss of quality jobs that will significantly impact families and the community," she said.

In response to the announcement, Mahoney said Keokuk officials have reached out to other providers to begin discussions on ways to provide 24-hour care in Keokuk. Additionally, officials will be reaching out to state and federal officials to determine what assistance is available or what legislation is necessary to assist rural communities in maintaining quality health care for their citizens.

Since it reopened in May 2021, Blessing Health Keokuk Clinic has expanded services with the addition of primary care, occupational medicine and other specialty services including orthopedics. These services will continue – as well as the Blessing Be Well at Work program used by area employers - and Hull says more services could be added at the clinic if demand for outpatient care continues to grow.

Blessing Health Keokuk's 147 employees will be retained until November 4 in a combination of either on-site work or on administrative leave and those interested and qualified to transfer within the system will be given assistance as well in the coming weeks.

# Hawks sweep VB at home

DONNELLSON - A couple big leads to start the first two sets pushed Central Lee to a three-game sweep of Van Buren County Thursday night.

The Hawks downed Van Buren 25-22, 25-12, 25-13 in a SEI Superconference South matchup at at Central Lee.

Freshman Kenna Sandoval opened the night serving seven straight including three aces to get Central Lee a 7-0 lead, But a kill by Van Buren's Ivy Davison stopped the rally and then the Warriors reeled off a run of their own to cut the lead to 7-4.

Back-to-back kills by Mya Lampe gave the Hawks a sideout and a point to make it 9-4, until Van Buren tied it up at 9 when a the Hawks had a defensive let down.

The two teams would trade points for a while until Central Lee pulled ahead 20-16 on a Bailey Schwartz ace. The Hawks would extend the lead to 24-19 on an attack error by sophomore Tessa Sayer.

Central Lee would have trouble finding the final point with three consecutive offensive errors to get the Warriors within two points forcing Central Lee Head Coach Amy Cook to call a time out. The Hawks got the game winner on the next service from Van Buren for the win in game one.

"Yeah, those good starts are beneficial for us, but that's one of the things we need to work on when we get those big runs. We kind of relaxed," Cook said.

Central Lee jumped out to another big lead in the second set going up 9-0. Van Buren wouldn't really get back in that game as the Hawks didn't relax and pushed leads of 14-4 and 21-6 before slamming the door at 25-12 on another Van Buren attack error.

Sandoval who had two blocks on the night got them both at 5-0 and 8-0 in the Hawks' early run.

Central Lee had to work a little at the beginning of the third game but at 3-2 behind consecutive aces from Schwartz, the Hawks got things turned around and raced out to 10-6 lead on a kill from Makayla Morrison to mid court.

Van Buren would cut the lead to three at 11-8 but Central Lee would then outscore the Warriors 9-2 for a 20-10 advantage. A big double block at the net from the Hawks' front line made it 23-13 forcing a Van Buren timeout.

Central Lee would get the next two points on Van Buren errors to wrap up the match. Cook said the girls showed an increase in on-court intensity compared to the tournament

play that started the season last week, including Central Lee's own tournament last weekend. "Compared to how we've been playing in the past tournaments, they're talking and inten-

sity was a lot better. I think they see that now. Hopefully practices will remain like that and future games as well," Cook said.

The tournament play has helped the Hawks going into the main part of the season, she said.

"There were some really good teams here and at Wapello. I've said this a lot, but it only makes you better to play those teams. Wilton and HTC are tough teams and it's good for our girls to play those types of teams."

Morrison had 10 kills to lead the Hawks on offense and was 10/10 serving with two aces. Sandoval had 13 assists. Alix Congdon had 10 digs and was 10/12 serving with two aces. Halle Lampe had four blocks for the Hawks.

Central Lee moves to 4-4 on the year and 1-0 on the Superconference. They travel to Mediapolis on Tuesday.

# HTC struggles to finish as No. 12 New London sweeps

FORT MADISON - Holy Trinity had game point in the first game of Thursday's SEI Superconference South Division match against New London, and couldn't finish.

That's been the story of the season for the No. 8 (Class 1A) Crusaders, who fell 27-25, 25-17, 25-22 to the 15th-ranked Tigers.

Holy Trinity (6-5 overall, 0-1 division) had plenty of moments to gain momentum against New London (2-0, 1-0), but couldn't keep the energy going.

And as the schedule heads deeper into division play, it's something that coach Melissa Freesmeier said has to change.

"We've been struggling since we started this year at finishing," Freesmeier said. "You can talk and talk and talk about it, but you've got to get it done."

That was especially evident in the first game, which set the tone for the rest of the match.

Holy Trinity, which led 19-14 and 20-15 in the game, allowed New London to rally, then fought off game point with a kill from Mary Kate Bendlage. A hitting error by the Tigers tied the game at 24, then Bendlage's ace put the Crusaders one point from victory.

But New London would score the next three points, the last coming from a tip from Camryn Lair, and the Tigers were in command.

"Absolutely it was big momentum there," Freesmeier said.

New London led the entire second game, opening with a 9-2 run. Holy Trinity got to within 12-10, but the Tigers would pull away.

The Crusaders led for most of the third game, but with an 18-14 lead allowed the Tigers to score the next six points. Holy Trinity got to within 23-22 when Presley Myers had a kill and then a block, but the Tigers would score the final two points to finish the match.

Holy Trinity is without junior Natalie Randolph, an emotional leader of the team who is out with a knee injury.

"These kids, they know they have the talent," Freesmeier said. "Natalie's an emotional leader, she is. I'm not here to make excuses, because this team can win ballgames. Yeah, we've been struggling, but we've got to find a way. We've got leaders, so we should be able to get it done."

The Crusaders struggled with hitting errors and mental mistakes — they gave up a point down 20-19 in the third game on a red card because of a substitution infraction.

"I thought we had some kids step up," Freesmeier said. "But we had some hitting errors here and there that you can't do. Our conference is going to be a dogfight, and it's never going to be an easy night. We've got to get it together."

Bendlage led the Crusaders with 14 kills. Myers had eight kills. Kayla Box had three, Brooke Mueller had two and Taegan Denning had one.

Anna Bendlage had 26 assists and was 14-of-16 serving with two aces. Mary Kate Bendlage was 14-of-14 serving with two aces. Denning was 10-of-10 with an ace. Mueller was 8-of-9 and Alexa Dingman was 8-of-9. Laura Mehmert was 4-of-6.

Mueller had 23 digs. Teagan Snaadt had 18 digs. Anna Bendlage had 17 digs. Mary Kate Bendlage had 14. Denning had eight. Myers had three blocks and Mueller had one.
