### CORONATIONS FRIDAY: 101st Festival started Thursday, with royalty tapped Friday

FORT MADISON - The 101st Mexican Fiesta gets underway today at the Mexican village off Avenue Q in Fort Madison.

The festivities kick off today starting at 4 p.m. with the GotchaGames Carnival at 4 p.m. The beer garden opens at 4 p.m. nightly until close.

There are no wristbands this year, so carnival rides are ticket-based and tickets can be purchased on-site.

Bluzillion, the 5-piece band from Southeast Iowa, will be the featured band Thursday night with music starting at 7 p.m.

This year's coronation of the Mexican and American queens will be held as usual starting at 6 p.m. Friday night with an invocation and blessing from Father Joseph Phun and a welcome from Fiesta and city officials.

Cathy Ramirez will sing the national anthem and an honor guard will present the two nations' colors.

## Opponents pounds IUB, Navigator on pipeline

### HEARTLAND-NAVIGATOR:

Supervisors Seyb, Holmes push IUB and Heartland-Greenway on impact to Lee County residents

FORT MADISON - Opponents of a 1,300-mile carbon dioxide sequestration pipeline planned to run through Lee County got another chance to fire away at pipeline and state officials Thursday afternoon.

Representatives from the Iowa Utility Board and Heartland-Greenway met with landowners, public officials, and reporters regarding the proposed pipeline that will run more than 800 miles in Iowa alone.

Just under 100 people piled into the Lee County Fairgrounds Youth Center in Donnellson for the three-hour meeting.

The pipeline is projected to span 58.29 miles through the county with a split northwest of Donnellson off 190th Avenue. It will impact 95 land tracts along the route and 74 property owners.

Lee County Supervisor Garry Seyb told IUB officials Thursday to rely heavily on the risk-reward analysis of allowing the pipeline before making a decision on the pipeline company's permitting.

"We can read all we want into the record, say whatever we want, the county board can file all the letters we want," Seyb said.

"And the landowners can say we're not signing up for this, but the IUB ultimately can say yes or no, even theoret-

## Amtrak reboots Southwest Chief schedule after strike averted

FORT MADISON - It all amounted to much ado about nothing, but it could've been just a bunch of much.

Poor grammar aside, the pending rail workers strike that was looming Friday morning has tentatively been averted, according to an Amtrak spokesperson Thursday morning.

The Amtrak officials said the passenger rail

service's long distance routes will be operational again starting Friday morning, after rail union workers and the railroad industry reached a tentative agreement at about 5 a.m. Thursday morning.

"We plan to operate normally starting tomorrow," the official said. "A tentative agreement was reached yesterday with the rail union."

The rail strike would have been a major blow to the nation's supply chain, and would

have been an equally major blow to Fort Madison, not only stopping rail passenger service, but also closing the BNSF bridge at Fort Madison.

City Public Works Director Mark Bouselot said Thursday morning that he received an email from Iowa Dept. of Transportation Wednesday night that the strike would have forced the bridge to remain open for river traffic, and closing it to all vehicular and truck traffic.

# Holy Trinity falls in tiebreaker to No. 4 West Burlington

Crusaders rally after losing 1st set to force tiebreaker 5th

FORT MADISON - The journey toward the biggest week of Holy Trinity's season began with a loss. But coach Melissa Freesmeier had a message for her team after Thursday's five-game defeat to West Burlington.

"I know it's frustrating when we lose," Freesmeier said. "But we're going to be OK."

The 25-18, 18-25, 23-25, 25-20, 15-6 defeat to the No. 4 (Class 2A) Falcons was a sign, Freesmeier said, that her team is growing.

"I'll tell you what, that team hasn't been here all year," Freesmeier said. "And I'm excited about where we're going from here."

"I think even though we didn't take that win tonight, we got way better as a team," libero Teagan Snaadt said.

"Every day we're growing, we're getting better as a team," said freshman middle hitter Presley Myers.

The Crusaders (7-7 overall, 1-3 SEI Superconfer-

ence South Division), ranked No. 11 in Class 1A, never wavered against the Falcons (16-2, 2-0) until the fifth game.

"I thought we kept our composure," Freesmeier said. "I thought we did great things."

The contributions came from everywhere, a sign that the Crusaders have created their identity.

"We're figuring ourselves out," Snaadt said.

Myers had her best match of the season, coming up with 15 kills, three digs and three blocks. Combine that with the career-high 10 kills from senior Kayla Box, who also had three digs and five blocks, and that was a formidable middle for the Crusaders.

"That takes a lot of pressure off our (outside hitters)," Freesmeier said.

Mary Kate Bendlage had 13 kills and Brooke Mueller had 10 kills from the outside.

Snaadt had her best match, with a career-high 27 digs.

"T is just getting better and better as we go," Freesmeier said. "The trust is starting to come, and that's a big thing. She's running our defense, and doing a great job."

Bendlage had 21 digs. Mueller had 18. Anna Bendlage and Taegan Denning had 10.

Anna Bendlage had her best match as she continues to develop as the Crusaders' setter. She had 47 assists.

Bendlage was to be part of a 6-2 offense with Natalie Randolph, but Randolph's knee injury has taken her out of the equation.

"She's been a rock," Freesmeier said. "She is just getting better and better. She's growing up fast."

The Crusaders have done a lot of growing, and they'll need that confidence going into a week that includes their tournament on Monday, followed by the SEI Superconference tournament on Thursday and Saturday.

"Next week is huge," Snaadt said. "All those teams we've lost to this season, we get a chance to come back and show them how much better we've become."

"This is what we've been working for," Myers said. "We've been working to come back, so we can show them that we can play the game."

The Crusaders showed Freesmeier they can play. "I'm telling you, this team is ready to battle," she said. "I'm just excited for what we're going to do later."

"It's a big week. If we can continue to build on what we did tonight, good things will happen."

# Washington to test Fort Madison tenacity Friday

FORT MADISON - The climb of the mountain continues Friday night for the Fort Madison football team Friday.

A solid and historic Washington Demons team comes to Fort Madison to challenge the Hounds' 3-0 start to the year.

Fort Madison is coming off a 16-13 win over Fairfield in another slobberknocker in the bowl at Fairfield. The 2020 trip up went to double overtime for a Bloodhound win.

Head Coach Derek Doherty said the feel on the sidelines is changing with a team who has trailed in all three games so far this year.

"I was an assistant coach here for years and the body language and feel on the sidelines is different now than it was. We would get scored on and the wind would be out of our sails," Doherty said.

"Now our kids bite down and chip away and that's been on display for three games now."

The Hounds' work ethic is built in the weight room, something not new to Doherty who has been a key part of the Fort Madison Athletic Enhancement program.

"A lot of it's through the weight room - you see adversity all the time in the weight room. Two-fifty is two-fifty every day, it doesn't matter how you feel. It doesn't care if you're tired or sore," he said.

"Our kids are learning a lot of fight through the weight room That's where it starts."

The Hounds work adverse situations in practice, but Doherty said the message is that the season is an uphill sprint every day.

"It's not for everybody and we're glad we have the

guy we have, because they accept that."

Aiden Boyer, the Hounds senior signal caller, has thrown for four touchdowns and rushed for another and found a special relationship with junior Nathaniel Swigart, with two TD hook-ups last week.

Doherty said Boyer is maturing as the weeks progress and starting to really breathe in the offense.

"He's spreading the ball around and making his reads. He has good info coming back to the sideline, too. He's in our ear telling us what he's seeing and that shows his maturity," Doherty said.

"He's looking for open receivers and doesn't really have a safety blanket. He told me last week that he said he was lazy in the pocket and that's very mature for a kid to see that on film."

But the athleticism and determination of Swigart on the TD catches impressed Doherty as well.

"Nattie had one heck of a night. Making a guy miss, that's something we're big on. We don't go down on first contact and he didn't. He had a 'now' screen and the move he put on that kid - we all just kinda froze."

Henry Wiseman leads the Hounds with 172 yards in catches and a TD. Sixty-eight yards came on a long haul from Boyer in week 1 at Keokuk. Swigart is now over the 100 yard mark with a couple scores.

Teague Smith did a yeoman's job out of the backfield Friday with 81 yards on 23 carries. He has 233 yards and 2 TDs on 50 carries. Boyer is closing in on 500 yards through the air completing 68% of his passes.

Defensively, junior Hayden Segoviano leads the Hounds with 19 tackles. Tanner Settles and sophomore Cory Arnett are next with 14.5 and 14 respectively.

Doherty had special praise for Arnett adding the underclassman was under the weather Friday night but wouldn't let the team down.

Washington (2-1) comes in with senior Ethan Patterson as a dual threat quarterback, something the Hounds have encountered the last several weeks. Patterson has 200 yards through the air and 198 on the ground accounting for four touchdowns.

Senior Tayven Stuart handles the majority of the work out of the backfield with seven touchdowns and 351 yards averaging 6.6 per carry.

No receivers have more than 100 yards but senior Jude Brown has seven catches for 98 yards and a touchdown.

Game time is 7:30 p.m. at Richmond Stadium.

# Supervisors express opposition to CO2 pipeline

ically if 100% of the landowners say no. I'm concerned that money, i.e. reward, and risks don't equal out here."

"A lot of people are going to have a lot of money - not around here - not around the line. Maybe not even in Iowa or any state it touches are people going to be the benefactors - so not a lot of people around here are going to see reward, but a lot of people around here are going to see a lot of risk."

Jessica Mazour, a conservationist with Sierra Club Iowa chapter and a lifelong Iowa resident, took the IUB and Navigator to task for not giving proper weight to the risk of the pipeline.

"I'm appalled at how much this company downplays the dangers. You realize you're wanting to put a pipeline in our state that can kill people," Mazour said.

"Some of the people in this room could die and you don't care because you're going to make a lot of money off this."

Pipeline officials said they are doing everything they can to ensure the safety of the pipeline including working with geotechnic companies to evaluate subsurface conditions to find places that are more stable in the event of earthquakes and shifts that could potentially damage the line.

Dan Zigart, a journalist who first reported on the only CO2 capture pipeline to rupture in February of 2020, in Satartia, Miss., was also in attendance and spoke at length about what he saw in Mississippi.

"There was a crater 50 feet deep with frost on it where the carbon had frozen the land. People passed out and were barely breathing... This thing can kill people."

Company officials blamed the Satartia event on poor emergency crew communication and poor preparation on the part of the company responsible for that pipeline, Denbury Resources.

The pipelines carrying the pressured carbon in Lee County will be anywhere from 6 to 20 inches in diameter with incremental safety valves at strategic loca-

tions where flow can be shut off in the event of an emergency.

Mazour has been at several navigator informational meetings and said she's attending a landowners' opposition meeting in Manchester later Thursday night.

"It seems a lot of the owners impacted by Dakota Access are now impacted by this pipeline. That's what happens. Once they get in, the next company tries to do a project adjacent to a previous pipeline which creates a corridor," Mazour.

She told the group that they do not have to sign any letters for right of way or easements.

"This is truly not a public utility. All the other ones you could argue one way or another, but there's no spigot for you to get your fair share of CO2 off this pipeline. We're just a pass through for a company to make a lot of money," Mazour said.

About 10 other landowners talked to the board about the impact of the pipeline on the project.

This is the third time Navigator has held meetings in Lee County. The IUB required another meeting with the public because of changes to Navigator plans for the pipeline in the county.

Advocates for the CO2 sequestration say the service helps pull carbon emissions from the air, which can help with effects of global warming.

Lee County Supervisor Chuck Holmes said evidence shows that pulling the capture carbon dioxide from the air has very little to do with global warming.

"This sequestration enterprise reduces CO2 in the atmosphere by only .04%. An analogy could be made to purifying a gallon of water then dumping it in a lake. The net cleansing of that lake is essentially 0," Holmes said.

Holmes said it would take 25 projects of the same magnitude to reduce the CO2 content of the earth's atmosphere by just 1%.
