**Comp board says 7%** 

## **RAISES:** Board recommends 7% for county officials, 3% for supervisors

LEE COUNTY - The Lee County Compensation Board has recommended a 7% raise for elected officials in the county and a 3% increase for Lee County Supervisors.

The board didn't make the recommendation without hinting that the county needed to listen more to the recommendations.

"Last year was my first year and I was proud to be asked to do it," said comp board member Janet Hissom.

"And the first word out of the supervisors' mouth was 'You can make all the recommendations you want and we don't have to listen to you.' That really put a sour taste in my

#### mouth," she said.

"We had the Black the Blue Mandate, we did what we thought we had to do, and ultimately I still think that's what we have to do. We do have to keep the employees happy."

Garry Seyb, a Lee County Supervisor, said the county has to keep pace with other counties in elected officials' pay and the Back the Blue law brought the county closer to being equitable in the state, but they needed to keep the momentum going.

Seyb said Lee County is 22nd in population for the state of Iowa, and compared to other elected officials, the vast majority of other counties are paid more.

## HTC girls fade in loss to Mepo

**MEDIAPOLIS - Tony** Johnson knew the second half was not going to go Holy Trinity's way less than a minute after it began.

Mediapolis' Payton Bush banked in a 3-pointer on the opening possession of the half, shrugging her shoulders after the shot went through the net.

"I mean, right off the bat, second half, you bank one off the glass," said Johnson, Holy Trinity's coach.

It was that kind of night for the Crusaders, who let a first-half lead get away in a 54-35 loss to the No. 11 (Class 2A) Bulldogs on Tuesday night.

The Crusaders (1-3 overall, 0-3 SEI Superconference South Division) scored just four points in the third quarter after

leading 25-21 at halftime. Holy Trinity's offense was plagued by turnovers in the second half. The Crusaders were either too aggressive or too tentative against Mediapolis' pressure defense, and it cost them.

"We couldn't keep somebody in the middle for some reason," Johnson said.

And it didn't help that the Crusaders lost freshman center Presley Myers late in the third quarter. Myers, who had 14 points, was a big part of helping Holy Trinity break the pressure with her height and presence in the middle of the court, but she went down with a leg injury after being fouled from behind and didn't play the rest of the game.

"Losing kind of a key in the middle, or you can throw it to her over the top of the defense, that hurts," Johnson said.

Myers was having her best offensive game of the season went she went down, and the loss of that punch inside affected the Crusaders.

It's been a year of injuries for Holy Trinity. Guard Natalie Randolph is out for the season with a knee injury, forward Mary Kate Bendlage could return after suffering a knee injury in preseason practice. Myers' injury didn't appear serious she was walking with a slight limp after the game — but it was another piece of bad luck for the Crusaders.

"When you're seven deep, and then you lose one and another one's banged up (center Jenna DiPrima appeared to tweak an ankle early in the second half) and now you're five deep, yeah, you struggle," Johnson said. "That's where we are as a program, but there's no one making excuses. Nobody's making excuses. We're still fighting."

Holy Trinity led almost the entire first half behind Myers, whose scoring inside along with the ability to draw fouls helped counter four 3-pointers from the Bulldogs (3-0, 3-0).

Teagan Snaadt added nine points for the Crusaders, who play Friday at New London.

## Pay recommendations will go to Supervisors next

"Ours should be in the area of 22nd or better. If not, they're not in that sweet spot or average spot. The one that doesn't fit well is the Board of Supervisors," he said.

He said of lot of Lee County's supervisors don't need the salary, but it does inspire others to run.

"I for one, would be happy to have anyone run against me," Seyb said. "I would encourage people to do that and if that inspires them to do that, I'm good with that."

But Supervisor Chuck Holmes, who was in attendance along with Supervisor Ron Fedler and Supervisor-elect Tom Schulz and Seyb, said even if the position was volunteer, he would still serve.

"It makes no difference to me what the compensation is."

Fedler said he's hearing from the public that caution



is in order this year after last year's large increases for county officials and staff.

"They tell me they never got the raises they felt we got and would like us to think really hard about them paying taxes to pay us," he said.

"There are people out there that are hurting and I feel for them."

The board gave 10% across the board raises to county officials and staff, and gave close to 40% to Lee County Sheriff Stacy Weber and the administration tied to his salary.

The move was ushered in by the Back the Blue law that made counties consider the salaries of law enforcement heads from proportionate population areas in making county sheriff salary determinations.

That law is still in place, which requires the compensation board to again consider the average wages of

comparable cities and county populations.

Richard Fehseke, Sr., representing Lee County Sheriff Stacy Weber in front of the comp board, said Weber's salary currently is \$130,907 and the average salary of the cities used in comparison such as Mason City, Cedar Falls, Bettendorf, Marshalltown, and Marion was about \$143,000.

Fehseke said Weber wasn't looking for a makeup to that degree, but a 5% increase to just over \$137,000. That was adjusted to 7% when the recommendation from the board for other elected officials was set at that level.

The Board of Supervisors has final say in setting the pay increases, but by code they have to make any adjustments equally to all officials. As an example, if supervisors cut the recommended raise for county officials by 50%, all adjustments must be cut 50%.

## State has \$19.3M in **Opioid settlement fund**

DES MOINES - The Iowa Opioid Settlement Fund contains \$19,336,358.73 after recent deposits from settlements reached by the Iowa Attorney General's Office.

"Resources are flowing in from hard-won settlements my office has reached with companies who caused or contributed to the opioid crisis," Attorney General Tom Miller said. "Legislators have a crucial opportunity to use this money to prevent addiction, increase access to treatment for opioid use disorder, and save lives."

Under Iowa Code Chapter 12.51, legislators will determine how to spend that money as part of the appropriations process. The money must be used for opioid abatement, such as prevention, treatment, or recovery services, under terms of the settlement. A list of possible uses can be found here.

Local governments have received a similar amount, which is allocated among all 99 counties.

The Iowa Treasurer's Office received payment last week of \$12,239,486.05 from the settlement with Janssen Pharmaceuticals, Inc., and its parent company Johnson & Johnson. The amount equals the first five payments under the settlement. Under the agreement, if a state attains maximum participation from its eligible cities and counties, its first five payments are accelerated.

"Iowa is really benefiting because county and city leaders quickly got on board with the agreements," Miller said.

Also in November, the Treasurer's Office received \$4,626,656.84 from the settlement with the nation's three major pharmaceutical distributors - Cardinal, McKesson, and AmerisourceBergen.

In all, the Opioid Settlement Fund will receive about \$90 million from the two settlements over the course of 18 years.

Money from other opioids settlements is expected to arrive in the future. Miller has recently announced several important updates in negotiations:

In November, Miller announced opioid makers Teva Pharmaceuticals and Allergan would provide \$42.6 million to the state of Iowa and local governments. His office led negotiations with the two companies.

Also last month, Miller said a settlement with Walmart will provide more than \$19.9 million to Iowa.

Miller confirmed that promising negotiations were also underway with Walgreens and CVS. The parties continue their efforts to achieve those agreements.

In August, Miller reached an agreement in principle with Endo International plc and its lenders that would provide up to \$450 million to participating states and local governments.
