### Capital Campaign for Burlington's Capitol Theater underway

BURLINGTON – The Dream Behind The Curtain Capital Campaign for The Capitol Theater is seeking donations to begin construction on the 2nd Floor of the Theater's Annex. This project will provide much-needed space for youth programming,

college classes, and a 120-seat black box theater. In addition, it will upgrade the existing spaces with sound improvements, and energy efficient lighting, as well as pay off debt and build up the theater's operating fund to hire the appropriate staff.

To begin renovations The Capitol needs to reach \$1.5 million of their \$2.5 million goal in donations.

Currently, \$810,000 have been donated.

## Lady Hounds move to 5-0 with rout

### Kruse leads the way with 17; defense holds Trojans scoreless in 1st quarter

FAIRFIELD - The Lady Bloodhounds are starting 2022 close to the same way they started 2021, rolling to five straight wins to start the season.

The Lady Hounds rolled Fairfield on the road Friday night 67-17 with three players in double figures.

Camille Kruse again led the Bloodhounds with 17 points and seven rebounds. She doled out five assists.

Freshman Dayonna Davis added 13 points, four steals, and two blocks while Irelynd Sargent had 11 points, seven boards, and eight steals in the win.

Taylor Johnson had seven points, seven boards, and blocked two shots. Senior Molly Knipe had six points and three steals.

Fort Madison held the Trojans scoreless in the first quarter with some smothering defensive pressure racing out to an 11-0 lead. They would extend the lead to 36-11 at the half behind Davis' 10-point second quarter.

The Trojans were able to hold Kruse to just five points in the first half, which allowed Davis and Sargent to get open. The two combined for 17 first-half points.

Fort Madison went to work again in the second half, holding Fairfield to just six total points. The Hounds made some adjustments at halftime to get Kruse more open looks and the senior poured in 12 points in the half.

Ashlyn Lisk had nine points for Fairfield (0-5).

The Lady Hounds travel to Keokuk to take on the 2-2 Chiefs Friday night and they play in the River Rivalry Classic at Clark County on Saturday afternoon, and West Hancock at John Wood Community College.

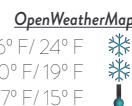

## Schiller, Weirather excelled in respective sports

Inductee Lon Spurgin served as a coach at Central Lee for over three decades. Over his career, he coached girls' basketball, volleyball, and baseball. Spurgin's career highlights as the girls' basketball coach include leading the team to a second-place finish at the state tournament in 2000 and coaching the team in the 1999 All-Star Game. He was recognized for coaching girls' basketball throughout his career, being named the 3A Coach of the Year in 2000 and Burlington Hawkeyeland Coach of the Year in 1985, 1993, 1998, and 2000.

Spurgin also made an impact on the baseball team, leading them to fourth in the state in 1977 and coaching the All-Star Game in 1987. He became a member of the 300-win club and was named district coach of the year in 1987, assistant coach of the year in 1992, conference coach of the year in 2005, and Hawkeyeland Coach of the year in 1997, 1984, and 1985.

Also inducted this year is Rick Schiller, who had an unmatched athletic career during his time as a student-athlete. He was the first person to receive first team honors in three sports (basketball, baseball, and football) in the history of the Blackhawk Conference. He earned first team all-conference in basketball for three years.

Schiller held the scoring record for basketball at Central Lee for 35 years, with 40 percent of his shots made outside of what is now considered the three-point line. Central Lee basketball became conference champions in his senior year, and despite a knee injury taking him out of competition, Schiller and other area basketball players were undefeated in intramural basketball for 20 years. He also received all-conference recognition in baseball and football during his time at Central Lee.

Megan Weirather is a Central Lee Class of 2006 graduate who held 19 school athletic records, including 11 in softball and eight in volleyball. Weirather started on varsity softball as an eighth-grade student and earned all-state honors in softball three times. She received both the Bernie Saggau Award and Army Reserve National Scholar Athlete Award in 2006.

Weirather's career highlights included finishing as a 1,000 point-scorer in basketball, being recognized as academic all-conference between all sports from 2005-2006, and being named to the academic all-state basketball team as a senior.

Families, staff, alumni, and community members are encouraged to nominate individuals for Hall of Fame recognition. A committee then reviews all nominations and determines each year's inductees. Central Lee also has Academic and Fine Arts Halls of Fame.

For individuals to qualify for a nomination, they must have graduated from Central Lee schools or have been a staff member. They also must be at least five years removed from their time in the district. The nomination form is available at <https://bit.ly/CLHOF-Nomination>.
