BUILDINGS: Keokuk firm gives seven buildings and \$400K to Main Street

KEOKUK - Main Street Keokuk, Inc. has accepted a sizable donation from Roquette that includes seven downtown buildings and \$400,000. The gift will allow the downtown revitalization non-profit to move ahead in redeveloping the buildings, located in the 1100 block of Main Street, for commercial and residential use.

"This is a significant investment in downtown Keokuk," said Amy Hobb, Main Street board president. "We're grateful Roquette recognizes the value in these historic properties and trusts our organization to move this project forward."

"We saw how Main Street Keokuk, Inc., was dedicated to

the development and ongoing support of downtown," said Roquette Plant Manager Jennie Rose. "We decided to make this donation because Main Street Keokuk is so well suited to develop the property for the betterment of the Keokuk community."

Main Street Keokuk will utilize the funds provided by Roquette to stabilize the structures, abate hazardous materials such as lead and asbestos, and incentivize a developer who can see the project through to completion.

"We want these properties to be completely rehabilitated, fully occupied, generating income for business and property owners and the city," said Main Street board secretary, Josh

COUNTY NEWS County may divest some properties

LEE COUNTY – County officials are going to take a closer at county properties and where some potential savings can be found.

At Monday's regular meeting of the Lee County Board of Supervisor's meeting, Lee County Auditor Denise Fraise brought up the issue as part of an agenda item to study county-owned properties and

what they are costing and where the county could possibly divest

Fraise recommended establishing a committee made up of county employees Scott Edwards, Kirk Nafziger, Mark Kle-



sner, Roslyn Garcia, Supervisor Tom Schulz, Cindy Renstrom, and Fraise, along with a representative of Farm Bureau.

Several county officials and employees met with members of Iowa Farm Bureau last week to discuss the EMS tax levy and how it will impact farmers. The EMS levy would increase property taxes by 75 cents/\$1,000 of assessed valuation. That measure will be in front of voters on March 7.

Chairman Garry Seyb said out of that 2-hour Farm Bureau meeting came the idea of evaluating county properties, including maintaining two courthouses.

"I attended the farm bureau meeting and one of the questions they had

County moves forward with plans for Keokuk ambulance facility

LEE COUNTY – County officials are moving forward with plans to construct a new ambulance bay in Keokuk.

During a workshop Monday with A.C. Contracting the board discussed the new structure and what it should entail.

Lee County EMS director Mark Long and

representatives of the company agreed to meet Monday afternoon to look at the current facility in Keokuk. Long said ultimately the current facility would need to be taken down, but he'd like to keep that base functional through the construction phase

"After that, I don't know that we'll need it, but that's something we can re-evaluate later," Long said.

"I have some concerns about the struc-

tural integrity of the current building. It certainly can be looked at, but if we're looking at something long-term, I don't think that's the way we want to go. If you shut the walk-in door by the garage, the entire wall shakes."

Board chairman Garry Seyb suggested that a steering committee be involved to

Kruse named co-player of the year in Southeast Conference

FORT MADISON - Camille Kruse is finding postseason recognition after completing her record-setting girls basketball career at Fort Madison High School.

Kruse was named the Southeast Conference's co-player of the year along with Mount Pleasant's Andrea Lopreato. She was also named to the IGCA's All-District teams, along with Holy Trinity's Mary Kate Bendlage and Central Lee's Makayla Morrison.

Kruse, also a first-team all-conference selection, finished as the only Bloodhound girls basketball player to top the 1,000-point career milestone. She started all 23 games this season, averaging 17.7 points. She led Fort Madison with 102 assists and 102 steals, and was second on the team with 133 rebounds.

Kruse was named to the Southeast District's Class 4A team. Bendlage was named to the Class 1A team, and Morrison was named to the 3A team.

Bendlage, a junior who missed the first three weeks of the season with a knee injury, averaged 23.9 points and 4.5 rebounds. She was a 42.1 percent shooter from the field, 31.1 percent in 3-pointers.

Morrison, a senior, averaged 15.5 points for the Hawks. She was second on the team with 117 rebounds and led Central Lee with 64 assists and 43 steals.

Fort Madison's Molly Knipe was a second-team all-conference selection. Knipe averaged five points per game, but led the Bloodhounds with 176 rebounds.

county coffers.

Fraise said they would look at Newberry and Heritage Senior Centers, the county's two courthouses, and properties the county owns that are rented to low-income families through Housing Administrations. The county owns Lincoln Ridge and two sets of apartments in Keokuk, as well as several units in Fort Madison that the Fort Madison Housing Authority manages for them.

The County Attorney's building in Fort Madison is also a property that will be reviewed.

The contract with FMHA is scheduled for review after the U.S. Department of Housing and Urban Development found some reporting issues associated with the agreement.


Board member Tom Schulz said a building inventory is something the county should have been doing on an ongoing basis and with a clear policy.

"We should know what we have, we should know what it's costing us, we should know the services that are being provided so we can make valued judgment decisions on what we need moving forward," Schulz said

Board member Matt Pflug said the county should move carefully when it comes to county seniors.

The senior centers provide social services and meals for the elderly. Supervisor Ron Fedler said they do provide a service and those need to continue.

"This puts it out there for the public domain to look at. I'm sure there will



be articles written about it at some point with the media reporting on it," Seyb said.

Milestone Aging out of Burlington makes the meals for seniors in Fort Madison and Keokuk, the county just provides the space for the services. "I don't think it hurts to take another peek at things," Pflug said.

make sure the construction is best suited for the EMS service and the community.

Wes Ames, of A.C. Contracting, was hired as the project manager for the work after interviews last week. Carl A. Nelson also submitted a bid for the work.

Ames told the board having a project manager as well as the General Contractor for the work will save the county some money, but he asked what bidding looked like for the county government.

Lee County maintenance director Kirk Nafziger told him the architect on the job, which is Poepping, Stone & Bach Associates, would probably handle the bidding requirements.

Ames said he plans on bidding some of the work packages, but said he would be able to save the county money because of their proximity to the project site, and services they could provide within their fee structure as general contractor.

Supervisor Tom Schulz said what he was hearing during Monday's workshop isn't what he understood from the interview process a couple weeks ago.

"This isn't exactly the presentation we had before. The presentation I heard was you would save us some levels because you're the general contractor, but all these bids will be locked in and it would be us opening the bids. If you got it great, but if you didn't get it great. This is not the same conversation we had two weeks ago," said Chairman Tom Schulz.

"We're going to go after parts and pieces of this to try and finish our bid as a General Contractor," Ames said. "But worst-case scenario is if we don't get anything as far as a bid, we're back to a project manager that can save you money."

In an unrelated item, the board approved hiring an administrative assistant position that will be split two days with the Lee County Health Department and three days with Lee County EMS. Despite the county ordering a soft hiring freeze through September, the position was authorized to assist with billing at EMS and administrative functions at the Health Department.

LCHD Administrator Michele Ross said an employee had recently retired so the position would actually be a partial new hire. The position would have to be posted, but current deputy auditor Sara Helenthal is currently functioning in that role for EMS and is paid partially out of the current EMS budget.

Lee County Auditor Denise Fraise said if Helenthal applies and is hired for the position, Fraise would not replace her in the auditor's department.

In other action, the board:

• approved a resolution in support of Fort Madison's RAISE grant application for funding to help offset costs of replacing the one-way pairs at 18th and 20th Streets as part of the Highway 61 project.

• approved a resolution of support for legislation that would restrict plans for carbon capture pipelines.
