FORT MADISON – DreamBuilding is once again underway in Fort Madison.

Fort Madison Partners and the American Small Business Development Center (SBDC) are midway through another year of the DreamBuilder program helping entrepreneurs get business ideas off the ground.

The program, developed by Freeport McMoRan, the parent company of Fort Madison's Climax Molybdenum, is back after a hiatus caused by the Covid pandemic.

Ten students are participating in the program underway again this year with classes taking place at the Southeastern Community College building at the corner of Avenue G and 6th Street downtown.

DESTINATION IOWA

Fort Madison gets \$250K for marina

DES MOINES -- Today, Gov. Kim Reynolds and the Iowa Economic Development Authority (IEDA) announced \$26.88 million in grant funding through the final round of Destination Iowa, a \$100 million investment in quality of life and tourism attractions. In recognition of the high interest in the program, Gov. Reynolds also announced an additional investment of \$15 million to fund Destination Iowa applications from rural communities that did not receive grants in previous rounds.

In all, Destination Iowa awards were granted to 46 projects totaling \$115 million that activated \$480,265,783 in total investment.

"Destination Iowa has inspired communities in all corners of the state to dream big about projects that will bolster quality of life and attract newcomers," Gov. Reynolds said. "The demand is so high, especially in rural areas, that I've extended the program to help more rural communities realize those dreams."

IEDA opened the Destination Iowa program in May 2022 and accepted applications through December 31. Applications were scored based on eligibility, completeness, and the project's ability to meet the program goal of creating transformational tourism attractions. Destination Iowa grants have been open to cities, counties, nonprofits and other organizations through four separate funds: Economically Significant Development, Outdoor Recreation, Tourism Attraction, and Creative Placemaking.

The seventh round of Destination Iowa funded the following 10 projects. For the additional \$15 million, IEDA reviewed applications already submitted by rural communities, defined as 30,000 residents or fewer that are not adjacent to communities of 30,000 or more residents.



FM project gets funds in final round of allotments

Final awards made from the original \$100 million allocation:

The Dubuque Art Museum was awarded \$8,000,000 toward the construction of a new museum and a 10,000-square-foot outdoor sculpture garden. The award represents 20% of the total project investment of \$39,931,512.

The Dickinson County Conservation Board was awarded \$3,500,000 to develop the new Sherwood Forest Park on the former site of The Inn at Okoboji resort. The award represents 35% of the total project investment of \$10,013,197.

The Blank Park Zoo in Des Moines was awarded \$3,280,000 for major upgrades including a new Big Cat Conservation exhibit and an expanded seal and sea lion facility. The award represents 18% of the total project investment of \$18,000,000.

The City of Cedar Rapids was awarded \$3,000,000 toward the LightLine Loop project in the Czech Village and NewBo District. The award represents 16% of the total project investment of \$19,255,775.

The City of Dubuque was awarded \$3,000,000 for the addition of an open-air amphitheater on Schmitt Island. The award represents 19% of the total project investment of \$15,442,961.

The City of Marshalltown was awarded \$2,000,000 for the Linn Creek District development and creative placemaking efforts. The award represents 32% of the total project investment of \$6,251,115.

Story County Conservation was awarded \$1,500,000 to pave a portion of the Heart of Iowa Nature Trail east of Ames, connecting to Nevada and Maxwell. This award represents 31% of the total project investment of \$4,819,000.

The India Heritage & Cultural Center was awarded \$900,000 toward expanding the Hindu Temple and Cultural Center near Madrid. The award represents 23% of the total project investment of \$3,976,023.

The Putnam Museum and Science Center in Davenport was awarded \$900,000 toward an expansion project. The award represents 23% of the total project investment of \$3,965,449.

The African American Museum of Iowa in Cedar Rapids was awarded \$800,000 toward major renovations at the museum and the reinstallation of the Dr. Martin Luther King, Jr.-inspired "Trumpet" sculpture and garden. The award represents 17% of the total project investment of \$4,827,339.

Awards made from the additional \$15 million include:

The Southeast Iowa Sports Commission was awarded \$2,500,000 to develop the Ottumwa SportsPlex Development Project. The award represents 23% of the total project investment of \$10,737,449.

The Midwest Old Settlers and Threshers Association was awarded \$500,000 to improve and enhance existing campground facilities at the Midwest Old Settlers and Threshers Association grounds. The award represents 38% of the total project investment of \$1,312,525.

Jasper County Conservation was awarded \$550,000 for the Jasper County Conservation Environmental Education Center. The award represents 25% of the total project investment of \$2,204,509.

The City of Denison was awarded \$4,500,000 for the Crawford County Wellness and Recreation Center. The award represents 24% of the total project investment of \$18,643,000.

Morrison, Hellige, Bendlage named 1st team

LEE COUNTY – Holy Trinity Catholic's Luke Hellige led the list of SEI Superconference South All-Conference student athletes released this week.

Hellige was the only area player to be named to the 1st team boys' team. Hellige averaged 19.2 points per contest and scored 423 on the season, which was second best in the conference behind New London's Blaise Porter. Porter scored 626 points.

Hellige also had 184 rebounds in his sophomore year for the Crusaders. That was also good enough for second in the conference behind Porter's 209. The Crusaders finished the year 5-9 in SEISC play and 9-13 overall.

Central Lee sophomore Brayden Wyrick was named to the SEISC South 2nd team all-conference along with Holy Trinity's Conner Gehling.

Wyrick scored 347 points over the campaign and pulled down 167 rebounds, both tops for the Hawks. Gehling was the Crusaders' main force in the middle scoring 296 points and pulling in 143 rebounds in his

junior year.

Central Lee's Cory Jones and Owen Swan joined HTC's Nick Fullenkamp and Adam Sobczak with honorable mention honors.

HTC's Mary Kate Bendlage and Central Lee's Makayla Morrison were both named to the girls' SEISC South Division first team All-Conference squad.

Bendlage was second in the loop with 383 points behind West Burlington's Abbey Bence who finished with 525 on the year. Morrison was 5th in the league in scoring with 340 points leading the Hawks to a 6-8, 9-13 record. Morrison was 3rd in the league in 3 pointers with 52.

The Crusaders' Teagan Snaadt and Central Lee freshman Kenna Sandoval were both honored with 2ndteam selections

Central Lee's Mya Lampe and Karlie Pohren joined HTC's Kayla Box and Presley Myers with honorable mention honors.

Clover said the program has generated many new business ventures in the area. And in addition to helping aspiring business owners, it also helps revitalize business sectors like downtown Fort Madison.

"The cool thing is we've had some successes from the past classes," Clover said.

"The nice thing is that we've seen that and that's the whole idea. And then sometimes this results in some revitalization, too."

Clover said guest speakers are part of the curriculum and includes small business owners in and around the area.

Past speakers have included Fort Madison Mayor Matt Mohrfeld who owns and operates Matt's Greenhouse; Nannette Griffin of Griffin Muffler & Brake Center, and Chris Swed of Swed & Co. Coffee was set to speak on Wednesday.

"Normally we have a guest speaker each week to talk about the successes. Tim Gobble and I try to keep someone lined up each week."

Other weekly topics in the eight-week course include marketing, finance, accounting, hiring and interviewing, among others.

"It's really fun to look back and see what people have done with it. I think this is a good way for them to all get to know each other and support each other," Clover

The group will have a pitch contest on April 19 at the end of the session and the top four business pitches will win some prizes geared toward assistance in getting the business off the ground.


Clover is the 2019 winner of the Iowa "State Star" from the national Small Business Development Center.

DreamBuilder, developed by Freeport-McMoRan and the Thunderbird School of Global Management, equips participants with the practical skills needed to start or grow their own business.

While the program was initially developed for female entrepreneurs, all aspiring entrepreneurs can and are encouraged to participate in the program. When community members gain skills, they gain confidence, increase their productivity, mentor others, raise their income levels, and reinvest in their children's education, their family's health, and economic activities at the community level.

Climax Molybdenum reimburses all participants' \$120 entry fee upon completion of the eight-session class.


