# **Speed cameras coming?**

### SUPERVISORS: County mulling over idea of putting cameras on Hwy. 218/27

#### **BY CHUCK VANDENBERG** PCC EDITOR

LEE COUNTY – Slow down on Hwys. 218 and 27. Just start it now.

Lee County is currently in discussions to add speed cameras on that main circuit through the county.

Penalties for speeding would be civil and not criminal, but Lee County Supervisor Chairman Garry Seyb and Lee County Sheriff Stacy Weber said the move is geared to get people to slow down.

Weber has said for most of his five years as sheriff that Lee County needs to do more to save lives on roadways.

"Fifty-two percent of traffic was speeding northbound and I worry for our citizens who live in and have to travel the area around Highway 27," Weber said.

"Motorists passing through ignore our state posted speed limit and endanger our friends and families who are crossing over it every day."

Seyb said it's something Weber has been looking at for some time.

"He reached out and we talked about it. We haven't really put it out there in public space as we were research-driven to start with," Seyb said."

# **HOUSING AUTHORITY FMHA to** end contract with county

FORT MADISON - The Fort Madison Housing Authority has given notice to the Lee County Board of Supervisors that they intend to end a services contract for county-owned apartment buildings.

The move comes as the County reviews its current building inventory with an eye toward divesting itself of properties to streamline revenues and expenses.

Housing Authority Director Michael Dear submitted a letter to county officials on March 16 following a meeting that day of the FMHA board of commissioners.

"At today's regular meeting of the Board of Commissioners of the Fort Madison Housing Authority, the commissioners

A funeral service will be held at 2 p.m., Monday at the Vigen Memorial Home in Keokuk, IA. Burial will be in the Sunset Memorial Park.



# Numbers push FM into 4A with HTC

#### FOOTBALL - Continued from Page 1

Madison football program would be classified as a 3A program without including the nonpublic enrollment numbers of HTC.

"If the enrollment numbers of HTC were to be included in the classification, the Fort Madison football program would be forced into a 4A classification. As a result, FMCSD will not be renewing the sharing agreement with HTC for the football program beginning the 2023-2024 school year," the statement from the district indicated.

Head Bloodhound Football Coach Derek Doherty said the move would impact about five players but only a couple would impact things immediately. He said for the health of the program, it's probably the best move.

"It does suck, because I love those guys," Doherty said.

"I found out earlier today that that was going to happen. It's definitely a double edged sword, We're happy to be playing 3A football because that's where we sit. When you look at BEDs that's where it would have been, so the activities office based that decision on whether to be 3A or 4A.

"But there are really good football teams all the way through. If you look at size of schools, though, we're a 3A."

Doherty said Fort Madison was only getting one or two per year, but last year that number grew and he was seeing more in the Athletic Enhancement program.

"We were only getting one to two a year. Last year we ended up getting six. Adam Sobczak is a

big loss, he's been fantastic, and Conner Gehling was just giving football a shot. Hope that benefitted him in basketball."

Doherty said the shared programs have gone back and forth with different coaches.

"I totally understand what happened. HTC has done that in the past with Coach (Michael) Sheerin because they didn't want the Fort Madison girls on the HTC team, which turned out to be a blessing because Coach (Sebastian) Seifert was able to put our team back together at FMHS and have success."

Holy Trinity Athletic Director John Goetz said, "I talked to Jeff. He didn't give me anything other than that they are in discussions."

"I understand the situation 100%, but I feel bad for our kids who have put their heart and soul into playing football," Goetz said. "These kids get along and it's good for the two schools to do that."

Goetz said he hopes going forward the two schools can continue the positive relationships they've had in the past.

"I would hope we could keep that relationship going. We've had a great relationship with Fort Madison. We've had kids participate in tennis, soccer, football, baseball, and I just hope we can continue with that in a positive way with Fort Madison," he said.

"I don't want it to be negative."

Goetz said he spoke with Fort Madison Activities Director Jeff Lamb Wednesday afternoon. Lamb declined to comment for the article.

## Cameras still need to go to board

"This is going to be coming up before the board to look at because it will involve a contract."

Seyb said initially he wasn't on board with the idea because of the public perception, but since that time he's been paying attention to traffic patterns as he drives to work on the stretch of highway four days a week.

"I do support it at this point. Initially, I had some thoughts about and wanted to take some time to consider it."

He said he feels most reactions to it will be negative, but he's encouraging people to look at the move objectively.

"I would tell taxpayers this will go into the general fund and could help keep the levy down a little bit as well, but the most important thing is that it will save lives."

"Most people will believe this is revenue-driven, but where I came to sit was the safety aspect. We can't afford to hire another officer to be out there 24/7. When I think about the loss of life we've had on our roads in Lee County...this provides that reminder that there is a speed limit. There is a speed limit and we need to slow down."

The contract will include the installation of the cameras, monitoring the cameras, and issuing civil citations, very similar to other cities in Iowa such as Cedar Rapids. Seyb said Cedar Rapids cameras generate over \$1 million annually, but he said

they have many cameras along the Hwy. 380 corridor.

Weber said he'd like to see some of the revenue go to drivers' education programs for the three county schools, as well as helping prop up the Mothers Against Drunk Driving (MADD) programming locally.

Seyb said those allocations will have to be sorted out by the board of supervisors. The agenda item isn't on for discussion during this week's regular meeting, but it could come up during a workshop following Monday's meeting.

discussed at length the feasibility of remaining in the contract with the County for the maintenance and administration of the County housing units. Due to recent objections by HUD, it was determined our agency needs to terminate the contract giving appropriate 60-day notice," Dear wrote.

Dear said the county will be collecting rents on the properties in Fort Madison and any calls for maintenance will be directed to contractors.

"Considering the current climate of how the County is reviewing its own building(s) and operations, our Board is available to work through any disposition of these buildings and assist as we are able under current restrictions with (Housing and Urban Development).

The Housing Authority recently came under scrutiny by HUD for handling of current federal funds in conjunction with county contracts.

Housing Commission Chairwoman Rebecca Bowker said the housing authority would have to take another look at the contracts after a meeting on Feb. 22.

"I think there's been a misunderstanding about what the housing authority has done and what HUD's expectations were. That's the issue with the contract and we're going to look at that."

Fast forward to March 16, and now the FMHA is canceling its contract with the county. The Housing Authority, since its steady operation under Patti Toops, has seen two

directors in the past year and a complete resetting of the board, including bringing back Linda Larkin, who ushered in the Housing Authority decades ago.

A county panel formed to review the properties owned by the county will meet again on Thursday at 9 a.m. to talk specifically about the apartments owned by the county under housing assistance programs and what to do with them.

They will also be discussing the Fort Madison Newberry Center, a facility downtown where senior programming takes place.

# The generosity of two old men

You're position on that stat sheet determined by your ability to pay - private pay, employer-based insurance, Medicare.... Medicaid. Everything moving your position up and down and determining if you get a big room, small room, care to extend your life, or care to ease



its end. If you aren't a student of health care billing,

you go along for the ride. It's the ride that's ticking me off. We needed a test done and the specialist and scheduler both told me the test couldn't be done for seven months. That's no joke. Seven months.

I called BS and said I would take my mom

to Mayo clinic and get it done in a week. They found a spot at the end of the month saying they didn't have the staff to get through imaging tests quicker. Not sure how that became my problem, but it did.

We have to fix health care in this country. Tired of seeing the fear in the faces of my family. Maybe life is more about fear than the value I want to give that emotion.

So to filter out the garbage going through my heart and my head, I took a short trip Florida - one my brother had been pressing me to go on for years.

Due to the generosity of a couple good men, I was able to experience the St. Pete area and Madeira Beach in a way a lot of people don't – from 10 miles out in the gulf looking back in.

I was smart enough to take a couple Dramamine as these waves pitched our cutter 6 to 8 feet back and forth. My nephew and our host threw large hooks of squid into the sloshing gulf pretty much to no success. We moved a couple times and then headed back in to the intercoastal waters where things were tolerably smoother.

We stopped at a pub, a move fairly regular over the trip.

The food was incredibly good all week long. Typically Mahi-Mahi, or shrimp, a variety of slaws, fries, conch fritters, and the soothing company of my brother's family, and the retired owner of a Florida rail construction firm.

This is a sea man right out of a Hemingway yarn. Gray bear, broad shoulders, and the love of life on the water. Always seated at the head of the table, his simple life, too, was rooted in family and spending time with like-minded people. A cigar and a beer were always at his elbow during the down times.

It was these six days that reminded me that people are inherently good. Most people at their core want good company, peace of mind, a good meal, and fresh air.

We got all that and more on this run, but one thing became very clear to me - I am exhausted. Emotionally, physically... mentally. Several times I fell asleep sitting up in a chair at our host's bar near the pool, or at the small table at the apartment we were staying in.

We chose to drive straight through to Florida and straight through on the way back. It was about 18 hours.

On the way back it was my turn to drive and I couldn't stay awake for more than an hour without feeling like I was going to doze off. It was extremely dangerous and after about an hour break for my brother, we had to switch back.

I felt awful, but it hit me at that point - things have to change in my life. The balance is gone.

More time at hospitals, having to strategically manipulate people to get them to do what athey should be doing in the first place, trying to be a better man than I was as a kid, all while the wife lives in Texas, the daughter in New York, and the other daughter on my coffee table.

When everything is pushed aside and you get the time to tuck your hands in a windbreaker standing on gray coarse sand looking northwest into a blood orange sunset, the pressure was supposed to subside.

It didn't. That pisses me off.

The balance will return.

It better - because after a week in the sun, I came home with a wicked burn, some nice memories, and more chaos than I care to sort out... but that's Beside the Point.
