

# **TIPS:** Detectives looking into all leads but coming up empty

FORT MADISON – The search for a military veteran from Fort Madison continues to puzzle Fort Madison police.

Christopher Golliher, Jr., 37, of Fort Madison has been missing since Feb. 3, 2022 and local law enforcement have had several leads and conducted multiple searches for Golliher, but have come up empty.

Fort Madison Police Detective Dakota Worley said he hopes continued attention to the case will turn up some leads that help locate the former marine.

Golliher was reported missing by his mother Michelle Shelton of

Keokuk on Feb. 7, after hearing from his roommates that the man had left his home without a coat, his wallet, or any belongings.

Golliher had been sharing a residence with two other people in the 2000 block of Avenue E in Fort Madison. He served two four-year tours of service in Afghanistan and was on full disability after an honorable discharge from the service.

Worley said police are investigating the leads as they come up. "We canvassed some areas and checked a lot of the creeks," Worley

aid.

He said they cannot talk in depth about the case because of the

# Macomb man charged after Saturday shooting incident

MACOMB, Ill. — A Macomb man has been charged in connection with a shooting near Western Illinois University's campus that left one person dead and 10 others injured.

Donell D. Williams, 23, was arraigned on Monday on a charge of armed violence. Williams was in possession of a handgun and a felony amount of illegal drugs, which led to the charge. Additional charges may be filed, Macomb Police officials said on Monday. Macomb police were called to a house in the 500 block of N. Johnson St., at 1:55 a.m. Saturday after a report of gunshots fired at a party at the home.

Jerman Beathea, 26, of Chicago was found dead at the scene.

Six WIU students were among the

injured, who were transported to Mc-Donough District Hospital in Macomb. All of the injured are expected to recover.

Additional charges could be filed in connection with the incident. Macomb police officials are continuing to investigate the incident.

# Legislators talk pipelines, banned books

LEE COUNTY – Several area legislators spent most of Friday's monthly local update talking about the current status of hazardous liquid pipeline legislation.

The monthly legislative session update was held at the Lee County Economic Development Group offices in Montrose and featured State Reps. Martin Graber (R-Fort Madison), and Matt Rinker (R-Burlington) and State Sen. Jeff Reichman (R-Montrose).

Other topics included rural emergency hospital legislation and bans on books in K-12 settings.

But about 45 minutes of the hour-long session was spent on House File 565 which would require companies proposing hazardous liquid pipelines, to secure 90% of the miles needed for easements voluntarily.

Three companies - Summit Carbon Solutions, Wolf Carbon Solutions, and Navigator CO2 currently have plans in front of the Iowa Utilities Board to construct carbon

sequestration pipelines in Iowa. Navigator's Heartland Greenway pipeline would run through Lee County.

The Iowa House passed the bill Tuesday, sending it to the Senate for debate. Reichman said the bill may have trouble in the senate.

"I wish these people would run these pipelines down the middle of the highways and then we wouldn't have these issues," Reichman said.

"Most of these pipelines are for private use and people don't like it. As much as they're paying, I wish they'd come down to my property and do a U-turn because I have the property to support it."

Reichman said changing the rules now could open to the state to lawsuits due to the investment already made on the project, as well as payments already made to farmers.

"If they change the rules now, a lot of those landowners have had checks that



# Key injuries punch holes in Lady Hounds' plans

FORT MADISON - Carrie Burken started planning for this season within days of last season ending.

But the Fort Madison High School girls soccer coach had to change those plans when she started losing players to injuries in other sports.

Natalie Randolph, the team's top scorer last season with 19 goals, suffered a knee injury in preseason volleyball practice. Irelynd Sargent, one of the team's top defenders last season, suffered a knee injury during basketball season.

"When last year ended, I was thinking about who we had coming back and who we had coming in, and I was like, 'Oh, awesome," Burken said. "Then after Natalie got hurt and Irelynd got hurt, I realized I was going to have to make a different plan."

Still, the Bloodhounds have plenty of talent coming off a 12-4 season that included a share of the Southeast Conference title and a trip to the regional semifinals.

"It's an interesting group," Burken said. "Even with the injuries, we have a lot of the same pieces as last year. Overall, our look is going to be similar."

Sophomore Teagan Snaadt, who had 16 goals and 12 assists last season as a freshman, returns up front, as does junior Taegan Denning, who had four goals. Junior Mary Kate Bendlage and senior Camille Kruse anchor a strong defense that had three shutouts last season. Taylor Johnson is back as goalkeeper after a season of 114 saves.

"It's really important, because with only two weeks of practice before our first game, we're going to really rely on our chemistry," Burken said of her team's returning players. "Having that experience of working together last season, with a lot of the same pairings in positions this year, your skills might be a little rusty, but you still know what you're doing and what your teammates are doing. That's always helpful to have so many players returning."

Johnson, a junior, was steady as a goalkeeper throughout the season and was at her best at the end of the year, and Burken likes the momentum she brings into this season.

"It's going to be nice to have her back in goal for the next two seasons," Burken said.

The Bloodhounds have posted postseason wins in the last two seasons, and last season's loss to Clear Creek Amana on penalty kicks has provided motivation heading into this season.

"It's important for the confidence," Burken said.
"Even with the injuries heading into this season, this group has had success. We know what it takes. We know what (teams) are going to be tough.

"(Last season) let us know how far we can go. And I think we know we can build on that."

# Boys team to rebuild on defense

OFFENSE INTACT: Wellman, Pothitakis return after knee injuries

FORT MADISON - The two weeks of practice heading into Tuesday's season opener have been about finding answers for Fort Madison boys soccer coach Kevin Wellman.

It's been an ongoing search.

"We lost seven seniors, and we're trying to figure out who to put in those positions," Wellman said. "We answer a question, and that produces two more questions that we have to answer. We're still trying to figure everything out."

Fort Madison went 14-6 last season, and swept through the Southeast Conference, winning the title with a 10-0 record.

The biggest rebuild for this team will be on the defensive end.

"We lost three-fourths of our defense, and so that's where we've been really working to try to find answers," Wellman said.

The Bloodhounds will still have a potent offense, especially as Xander Wellman and Jacob Pothitakis continue their comeback from injuries suffered during last season. Both have been cleared to practice.

"We're going to start working them in," Kevin Wellman said. "They've been dealing with some slight muscle pulls, so we're working them in slowly. I don't know what their fitness is going to be like, whether they can go for long periods of time, so we'll take it slow with them. Hope-

fully they're peaking in May, when we get ready for the postseason."

Xander Wellman led the Bloodhounds with 14 goals last season. But Kevin Wellman likes what he sees out of Leif Boeding, who had 13 goals last season, and Henry Graham, who had nine goals.

"Henry has made huge strides from last season," Wellman said. "And Leif has made a jump in his athleticism. He's in his third sport this season, so he's ready to go."

The Bloodhounds will be in Class 3A this season as the sport expands to four classes. They're still in the same class with Pella, which has eliminated them in the substate tournament the last two seasons.

"Pella is still there, and now we're in with Iowa City Liberty, (Cedar Rapids) Xavier, those type of schools," Wellman said. "So we have to be ready."

Wellman expects conference play to be stronger this season, and the Bloodhounds' nonconference schedule includes Tuesday's opener with Williamsburg and a tournament with Pella, ADM and Hudson.

"So we're going to be challenged, but we've always had that," Wellman said.

It's why Wellman said Tuesday's opener is so important.

"We've got work to do. But we've got work to do from Game 1," he said. "I'm expecting to play against a very strong team on Tuesday. We'll have a much better idea on what we look like, what our chemistry is looking like, things like that. You just can't tell with practice."

Menard, Inc. - Menards, Inc. is asking the Board of Adjustment to grant a Special Use permit in accordance with Section 165.11(4) of the City Code to allow for the expansion of a non-conforming use

forming use. At the October 26, 2022 Board of Adjustment meeting, Fry and Flowers expressed concern with the proposed storage extending past the front of the existing building. The site plan for the initial proposal showed the new storage units sitting almost 65' in front of the current Menards storage building. The Board tabled the issue and asked Menards representative. Tyler Edwards, to consider an alternative layout

that would push the new storage units back in line with the current building.

After the October 26th meeting, Menards reviewed the layout and submitted a revised site plan. The plan shows the front-face storage units pushed back and more in line with the front of the existing building.

Due to the location of the detention pond on the north end of the property, the buildable area on the lot is limited. Aligning the storage facility with the front of the building would require the removal of an entire back-to-back storage building and a reduction of 56 units.

The exterior storage buildings are constructed using a single unit with an 8-foot tall exterior wall. The interior buildings are constructed as back-toback units that share a common wall in the middle. When you look at the site plan layout the northern building next to the pond was set as close to the pond as safely possible. Three back-to-back buildings were placed in the middle and one more building was added around the exterior.

The City Code requires a 25-foot front yard set back in a B-2 General Business District. The revised plan still leaves a significant setback from the property line along Agency Rd. There would be 110-feet from the edge of Agency Rd. to the proposed storage building and 82-feet from the building to the property line. Deen pointed out that while the setback requirement in a B-2 is 25 feet, there are no buildings along either side of Agency Rd. that are set that close to the front lot line. Mr. Edwards pointed out that the new location of the first storage building would extend past the front of the existing Menards building approximately 12-foot. This would put the new storage building in line with the side of Walmart's

building which is located further east.

In a letter to the Board, Mr. Edwards stated that there will be some extra topsoil and fill material as part of the project that will allow the creation of a berm between the building and the property line that would screen the bottom of the storage units. Mr. Edwards was not opposed to creating a buffer with landscaping and said they would also consider extending the type of facade used on the current building.

Chairman Crooks, Fry, and Flowers, supported the amended proposal. The Board agreed that they would like to see landscaping or a facade similar to what is on the current building, extended to the storage building facing Agency. The Board decided to leave the decision regarding the type of landscaping or facade to be approved by the City Administrator.

Moved by Crooks, seconded by Fry, to grant a Special Use permit in accordance with Section 165.11(4) of the City Code to allow for the expansion of 247 storage units as presented in the revised site plan submitted on November 8, 2022. A plan for landscaping in front of the new storage units or facade added to the wall facing Agency Road will be required and must be approved by the City Administrator.

# Reichman iffy on eminent domain bill | Case still active

have been paid out, cashed, and spent. If this does get shut down, I would assume the landowners would have to pay that back, and I don't think the state of Iowa could handle the lawsuits of the hundreds of millions of dollars that have already been invested in the project," he said.

"When we were kids and were down on the corner playing kickball or whatever and someone tried to change the rules, if we didn't like it much, we went home. So, we'll see what happens."

Doug Abolt, a property owner in the county, said he's had many farmers have concerns about the pipeline and asked if the legislators would vote for the bill as it stands.

Graber and Rinker have already voted for the bill that passed out of the House.

Abolt asked where the legislators stood on eminent domain and where they stood on protecting Iowa from outside sources.

"When will we tell the feds to go pound sand on this stuff?" Abolt asked.

"The problem is eminent domain has no use for people's private property and that's a freedom we're flushing

He said people should be able to do whatever they want with their property and if they want to option to pipelines they should be able to do so.

"But if somebody doesn't, I think we should protect them to the "n"th degree," he said.

Rinker said the House tried to work with everyone involved to make it the most effective legislation to protect landowners.

"We would love to eliminate the whole project because of the science of it, but that's not what the bill is about," he said.

"If we constrict the ability of eminent domain, then we find ourselves potentially going against a Supreme Court ruling that puts us in a position that it could get challenged."

Rinker said he's heard of farmers getting checks as high as half of a million dollars.

"If the federal government is going to invest billions of dollars in this technology – because they are – I would much rather have them writing checks to Iowans," Rinker said.

"That's the only glass half full scenario I can peel out of it."

Andy Bates, a spokesperson for Navigator, said the company is working in good faith with county residents. He added that Iowa laws are already some of the most comprehensive in this part of the country and new legislation would stand in the way of development of safe carbon sequestration.

"We are committed to working collaboratively with landowners and negotiating in good-faith to secure as much of the project footprint in a voluntary fashion as possible," he said.

"The current process outlined by Iowa law is one of the most comprehensive that exists across the Midwest in terms of landowner protections, and we don't believe that changes are needed. Iowa's ability to manage carbon in a constructive and safe manner will look like the development of pipelines, and this legislation stands in the way of that. "

Graber said 90% of the miles of easement have to be under control of the pipeline company voluntarily. The bill refers to mileage and not a percentage of property owners.

"Personally I think, 'Hey, it's my farm and if you want to come across it, you and I have to make a deal." Graber said.

He said 90% was about as good as the House was going to do and he said the Iowa Farm Bureau was on board with that figure. Graber said the bill also addresses some of the harassment that state officials are hearing is going on with obtaining easements.

Reichman said he's happy about the Rural Emergency Hospital bill, a bill he sponsored in the Senate.

"Rural Emergency Hospitals, we're very excited about that. I was a sponsor on that. We don't have the checkbook obviously to go down there and open the doors, but we've created a vehicle so that someone can now go in there in Keokuk and open doors in some manner."

The bill specifically allows state licensure for emergency hospitals, where patients can be triaged and stabilized and then moved to a full hospital.

"The model for healthcare now is not to have overnight stays. I think they had about 2% bed utilization (in Keokuk). When I was a kid, I used to deliver papers out there and most of those rooms were full. That's just not the model for healthcare anymore," Reichman said.

"For good or bad, most people don't spend the night anymore. It's just a shift and it doesn't make sense to have the fixed costs of all those rooms out there unoccupied."

All three had similar opinions on banning sexually explicit books in K-12 settings saying that Iowa schools have to get back their reputation as the best in the country and those types of books don't fit that agenda.

Reichman said he offered to take the pictures from one of the books to a local newspaper and, if they printed the pictures, he would change his vote.

Fort Madison Superintendent Dr. Erin Slater said the public schools already have systems in place to address parents' concerns over potentially illicit material.

But Graber said that 36 of the books on a list he's seen are currently in the Keokuk school system.

"So to say there isn't any of this in Lee County, is just false." he said.

ongoing investigation.

The Iowa Department of Criminal Investigation is also involved in the search for Golliher.

"We haven't gone over what we can and can't disclose publicly," Worley said.

Detective Bryson Hennigar said Golliher's bank account is all accounted for and no activity there is leading police to his possible whereabouts.

A GoFundMe page has been set up Golliher's mother Michelle Shelton. Those interested in donating to the effort to find Golliher can do so by going to GoFundingMe and search "Let's Find Missing Marine".

Shelton said she's trying to raise funds to create a reward for information leading to the location of her son.

"Someone has information and I'm trying to find answers," Shelton wrote on the GoFundMe page.

Worthy said they are still treating the case, which is now in its 13th month, as a missing person.

"Until there's proof of a homicide, it's a missing person. Depending on what's found, it can revamp into a different form of investigation," Worley said. Hennigar said FMPD used a K9 officer in a search but

couldn't disclose where those searches took place. He said something regarding the case lands on their desk about once a week. "I would say that at least once a week, the Golliher case gets

touched. There's obviously other cases, but we're bouncing around a lot of information," Worley said.

Hennigar said he speaks frequently with Shelton about the

"We're not looking for a needle in a haystack," Hennigar said. "We're looking for the haystack. We have no idea where he is, otherwise this would be a totally different investigation."

Worley said Golliher has ties to many communities and there's difficulty investigating across state lines.

Worley and Hennigar both have had communication with other communities in and around the state, but haven't gotten anything concrete. Hennigar is asking everyone to check any vacant buildings or abandoned properties for anything evidentiary that might help with the investigation. Police are encouraging anyone with information to contact Fort Madison Police or contact CrimeStoppers at 319-376-1090.
