FORT MADISON – A former Fort Madison student has gone on the attack against past personal issues and is getting ‘revenge’ of sorts.

IUB

Sinclair fined \$200K for 28 years of alleged violations

LEE COUNTY - The Iowa Utilities Board (IUB) Friday issued separate orders assessing civil penalties against two pipeline companies that have been operating hazardous liquid pipelines and underground storage facilities in the state for years without obtaining permits from the

IUB.

One of those companies, Sinclair Transportation, has been maintaining a pipeline in Lee County near Fort Madison and is facing \$200,000 in fines.

The IUB is taking this action as a result of a 2022 review of hazard-

ous liquid pipelines and company applications (petitions) to the IUB for renewal of expiring HLP permits. In its review, the IUB discovered Enterprise Products Operating, LLC, did not have a current permit

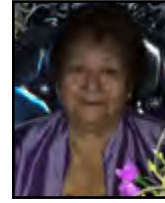

State readies for flooding

DES MOINES - The Iowa Department of Homeland Security and Emergency Management (HSEMD) is actively working with counties along the Mississippi River to ensure communities have the necessary resources to prepare and respond to projected major flooding expected in the coming days.

"Counties all along the Mississippi River are gearing up for potential floods as water heads down the Mississippi," said John Benson, HSEMD director. "HSEMD is coordinating with our county emergency management partners to ensure they have the resources they need to protect their citizens and communities, including pumps, sandbags, up-to-date flood forecasts, and planning and technical assistance."

Iowans who live along the Mississippi River are urged to prepare for possible flooding by having a plan to evacuate if necessary, packing an emergency kit with supplies for several days, staying informed about flood forecasts for their communities, and following information and guidance issued by local officials.

Pipeline near FM had no permit

for approximately 750 miles of its operational hazardous liquid pipelines located throughout Iowa, and Sinclair Transportation Company did not have a permit for its 11.8-mile hazardous liquid pipeline located in Lee County, Iowa.

Friday's orders assess civil penalties against Enterprise for not obtaining permits for seven hazardous liquid pipelines and two hazardous liquid underground storage facilities and against Sinclair for operating its hazardous liquid pipeline without a permit. The companies have 30 days to pay the civil penalties.

Sinclair is arguing that a recent acquisition of the company by Holly Energy in March of 2022 should negate the company's responsibility, however the board is arguing that as a subsidiary of Holly Energy, Sinclair was still responsible for the permitting, and has been in violation since 1995.

In 1995, in response to an Eighth Circuit Court decision, the Iowa Legislature enacted Iowa Code chapter 479B to specifically regulate interstate hazardous liquid pipelines. This code chapter requires all interstate hazardous liquid pipeline companies to obtain from the Board a permit for the construction, operation, and maintenance of a pipeline.

Under Iowa law, the IUB can assess penalties of up to \$1,000 per day, per violation; however, the law also caps the assessed amount at

\$200,000 for each related series of violations. All penalties collected pursuant to Iowa Code (section) 479B.21 are designated for the Low-Income Home Energy Assistance Program and Weatherization Assistance Program, administered by the Iowa Department of Human Rights.

The IUB became aware of these Iowa hazardous liquid pipelines via the National Pipeline Mapping System, which is run by the Pipeline and Hazardous Materials Safety Administration (PHMSA), part of the U.S. Department of Transportation. Both companies confirmed their specific pipelines had not been issued the necessary permits required to construct, maintain, or operate a hazardous liquid pipeline in Iowa.

Enterprise and Sinclair, as well as the previous owners of these pipelines, have been in violation of Iowa Code chapter 479B since its enactment by the Iowa Legislature in 1995. Enterprise and Sinclair have since filed new petitions seeking a hazardous liquid pipeline permit, and those applications are pending with the IUB.

Documents regarding the civil penalties are available for review in the IUB's electronic filing system under Docket Nos. SPU-2023-0002 (Enterprise) and SPU-2023-0003 (Sinclair).

The companies' applications for permits are under review in Docket Nos. HLP-2023-0002 and HLP-2023-0001, respectively.

This process story is no fun at all

But I have to say this week was one of the roughest weeks I've had in this business. To write about something that was difficult for my friends was trying to say the least. I've supported and traveled to support Fort Madison and HTC athletic programs whether they were shared and not.

The coaches, parents, and players have been tugged and twisted as this acrimony played out in the media and in the Fort Madison School Board.

People, including the Fort Madison School Board and even some of the coaches, will now do a double take when I walk the sidelines - unappreciative of the process story that unfolded in front of us all.

But what they can't forget is that it's a process.

I went to a soccer game on Thursday afternoon and there were a lot of Fort Madison school employees and advocates, and it was just a little chilly. Not just the cool northern winds, but the look-for-over-shoulder chilliness that comes with someone who just doesn't quite agree with the premise.

I'll say this has not been fun for me, despite what many others may think.

I've been on both sides of things for more than week. My initial battle was the process. No vote = no action.

As I worked my way through the process, including a one-on-one with Iowa Gov. Kim Reynolds, I realized that it wasn't just a process story.

The Fort Madison "Community" School District has a responsibility to the community. It's not equitable, and as I've said multiple times, it probably never will be. But they are the community school, therefore their responsibilities spill out of the four walls - out into the community that's part of their name.

For the first time in a long time, providing those services is without a doubt much more equitable than it's ever been before when considering the \$355,200 that is expected to run to the district from state coffers as part of the new Students First Act.

I've said multiple times, and sometimes it flies over people's heads, but the gold is in the mud. You have to work to find it. Since the gold rush of 1849 where my great-great-great grandfather Harold Brooks headed west to try his hand at panning in the streams of the west, there can be found big chunks of gold sorting through the mud.

As of Friday night, all three of the school districts in north Lee County have come back to the table to discuss a more equitable shared program. That's the gold, folks.

The Superintendent can be upset with us and the board can be upset with us. That won't matter in two weeks, two months, or two years if we can put these agreements back in place.

So Luke Hellige can pitch on a team that he wants to, not one he has to. Jacob Shottenkirk can play on one of the very best soccer teams in the state, just because it's there. Teagan Snaadt and Hadley Wolfe can pressure the goal together, because we thought as a community and not as entities.

It's not lost on us that some will not be happy with what compromise comes about because they had to give in... again. One of their most stringent

and legitimate arguments is that the public district will always have to give more. But the weakest part of that is they believe they've never had to. Well, we believe that's not the case because if they don't - then who does. They are the Fort Madison COMMUNITY school district and they have a heavier load to carry. Whether they like it or not.

And accepting that role makes them somewhat of the hero and not the villain. Jeff Lamb, Dr. Erin Slater, Josh Wykert, and the rest are nowhere near the enemy. It's the opposite, they are trying to do what's best for the kids of FMCS D, they are just saddled with propping up other programs because it works best for all the families in the district.

At the end of this all, and whatever these newest talks reveal for the next year's shared programs (if we're lucky enough to get another round), we have found new heroes on all sides. If Central Lee, HTC, and FMCS D come up with an agreement that works even for another year, that's at least one more year.

When that happens, we can all celebrate what community truly is - a collaboration that culminates with Derek Doherty's Bloodhounds on Friday nights. A program on a meteoric rise, but now without HTC players. But I'd bet a \$1,000 contribution to the Bloodhound Boosters that HTC students are in the stands for every Friday home game.

It's also just like Fort Madison kids sitting at the SportsCenter table for HTC basketball and volleyball games. We don't think twice when we see Xander Wellman of Fort Madison and Nik Fullenkamp of HTC sitting next to each other cheering on the Crusaders.

This isn't a figment of our imagination, these kids want to be together, and we need to foster that environment. Not everything in the world is equitable, and it never will be.

But seeing past the money and looking at the intrinsic value and hope in the eyes of all our children, is about as fair and beautiful a thing as you will find.

We can and should do this, and it looks like our better angels are once again overpowering the perched demons that move us in unfavorable directions.

One of the other great things I saw this weekend was a group of dedicated volunteers working the sides of streets, parks, and all around the county on Earth Day to keep our little corner of the world clean...together. But that's Beside the Point.

"It could be anything and I wanted that to resonate with everyone else."

Reynolds also offers online physical coaching, but he said he's recently discovered he wants to take his love for fitness and combine it with a love of clothing.

"Clothing is my main focus right now. In the past, it was personal training, but this will be my baby moving forward," he said.

Reynolds said the attire is a mix between streetwear and fitness.

"It was inspired by a brand I like called Iron Will. All their designs are geared toward the gym, but also for the club or the bar and stuff like that. Honestly, we have some cool designs and they are all available online," he said.
