Supervisors give stark warning

BUDGET FORECAST: Schulz says dept. heads need to get "houses in order now"

LEE COUNTY - County supervisors gave a stark warning to department heads at Monday's regular board meeting.

"Get your houses in order."

Supervisor Tom Schulz said during a discussion on budget amendments that department heads need to take a hard look at their annual budgets because without ARPA funding given to the county by the federal government in 2021, the county would certainly be looking at budget and personnel cuts.

"We need to be cognizant that those departments that rely heavily on the general fund and general levy for funding, need to get their houses in order and get them in order now," Schulz said.

"If this tax bill does what I think it's going to do to us, your budgets next year are not going to look anything like the budgets you have this year. The size of things like the health department may not need to be as big as we have right now."

Chairman Garry Seyb said he agreed with Schulz's assessment of the new property tax cap law that was signed at the end of the 2023 legislative session by Gov. Kim Reynolds.

"I would echo Tom's concerns and thoughts. Tom's going through the budget line by line, as we all should be, and looking at them and I want to make sure everyone is doing due diligence,"

Gregory shines in win over Hillcrest

DONNELLSON – Central Lee keeper Hunter Gregory has been playing soccer for less than two years, but his instincts for the ball on Monday night were something a seasoned player would admire.

Gregory fought off a flurry of shots on goal in the final two minutes to help the Hawks to a 2-1 win over Hillcrest Academy in the first round of Class 1A District 6 Substate soccer action.

The win avenges a 2-1 loss on April 18 that the Ravens won in a penalty kick session, and it sets up a Monday, May 21 matchup at Pella against No. 14 Pella Christian.

The Eagles are 6-8 on the year but own a win over Class 1A No. 3 Des Moines Christian back on April 10. The Eagles have also played nine of their 14 games on the turf at Pella Christian High School.

But the Hawks are looking for the upset after getting a win over a Hillcrest team that Central Lee Head Coach Justin Schau said was a better team than the version that beat the Hawks in April.

Dante Merschman scored both goals for the Hawks, the first at 22:49 on a combination assist from Ayden Krehbiel and Landan Lowenberg. Merschman took a ball on a pass across the middle and fired in a shot from the line into the left side of



"We wanted to make it home in regular time. We switched up our lineup and were focing on playing our wings and hoping to stretch them out a bit, and then go back to the center."

He said the Hawks will be the underdog on Monday.

"They're good and they'll always be a powerhouse, but we got to go up there with the mindset that you never know what happens. We have to think we can win and then you never know what happens."

Hillcrest would counter quickly with a goal from sophomore midfielder Jesse Blossom who scored from a scrum in the front of Gregory just :35 seconds after the Hawks' goal.

That would be all the scoring in the affair that eliminated the Ravens from the post-season.

Gregory, who said he's trying to become the best keeper the Hawks have had, said he tells himself to be the best player on the field.

"This whole season has been a blur for me because I'm a brand new keeper. I tell myself that I'm the best player out here and I may not be, but when I think that way, I play that way. It's a mental test for me," Gregory said.

When the Ravens were firing at Gregory in the waning moments of the match, he said his mindset was just to put himself in the best place to try and make a play.

"I just put myself in good enough of an angle, so it creates a smallest angle as possible. I like to push them outside and if they do get off a shot, I'm in a good place to block it."

Freshman Colton Taft gave Gregory a little breathing room late when he snapped off a kick save on a Raven shot out of a corner kick with 1:56 left in the game. After the save and a clear, Hillcrest would push the ball back up but wouldn't get off another shot on goal before the Hawks cleared to their end of the field.

Gregory had eight saves on the night.

Schau said Gregory shows great athleticism down the stretch when he dived to get the first save in the last-minute flurry of shots. The junior then bounced to his feet and was able to slide over to block the next shot

on goal off the rebound of his first save. The Hawks were able to clear it out of the box following the second save.

"That comes down to him making the first good save and being alert enough to get back to his feet where he could recover and make the second save instead of staying on the ground," Schau said.

Playing on turn on Monday isn't something that concerns Schau.

"It'll be a faster game, and this is a quality team we're playing. We'll go up there and play the best soccer we can, and I'll say honestly that we didn't play our best soccer tonight," he said.

"We still had the effort, though, and that's a product of being young. We get lost in the hype and then end



up just kicking the ball."

Schau moved Landon Crank around on defense to provide a bit of a mixup for the Ravens to look at, but it was working so he didn't change it back. Then the defense stepped up and shut down Hillcrest the rest of the way,

"The football analogy of bend don't break came into effect. We were bending pretty hard, but we were able to win the second balls," Schaus said.

New property tax law could pinch county budget

Seyb said.

"I've reached out to several people to try and explain the new tax bill to me. I haven't found anyone yet that can do that."

Seyb said it appears from first blush and after talking with local legislators, that they are trying to reduce the amount counties can levy and also the amount the assessments can go up.

He said restrictions on both ends will result in less money for the county.

Budget Director Cindy Renstrom said it looks like the county will also have to eat the costs of homestead tax credits.

"They're not going to refund us anymore," she said. Seyb said tax cuts in those areas are good in the long run, but short-term will result in less money for the county.

Lee County Auditor Denise Fraise said the assessed value of the county will go down \$16.2 million the first year the law is effective and it could double the second the year.

Schulz said he's had several people try to explain the bill to him and each one has explained it differently.

Fraise said changes in bonding for counties could have an impact on the county's ability to take advantage of the urban renewal district that was created for the new Lee County Health Department.

Fraise and Renstrom have been in talks with the county's bond agents to see how the new law will impact the county's ability under the district.

Renstrom said the current fiscal year amendments include additional expenses in several departments including: Sheriff's office \$186,007, Lee County Ambulance \$220,288, Community Housing \$15,000, the Lee County Health Department, \$331,581, Secondary Roads \$450,000 which will be a transfer from capital projects, and the Auditor's office \$8,500 due to an added election that wasn't budgeted.

The Board of Supervisors will be transferring \$2.5 million

from America Rescue Plan Act (ARPA) funding to General Basic to get the county general fund through some lean times. The current operating fund is at just over \$1 million. That leaves the county's ARPA fund balance at just over \$1.1 million.

Seyb said that remaining balance can't be totally allocated to the new health department because some of those costs have to be used to pay half of the county's grant writer/ ARPA fund administrator position and some funds are still allocated to the county's IT department.

"I just want everybody to understand that just because the total ARPA budget may have \$1 million plus in it, not all of that \$1 million plus will go to the health department," Seyb said.

The Lee County Health Department has currently \$975,000 from USDA Rural Emergency Health Care, plus a \$600,000 potential Community Development Block Grant, potential funding from a Lee County Charitable Trust effort, and approximately \$1 million in the remaining ARPA balance. That provides about \$2.5 million toward the projected \$5.5 million Lee County Health Department/ EMS building.

Congresswoman Mariannette Miller-Meeks has selected that project as one of her 15 appropriations that will be taken to Congress, but decisions on which of those projects will get funding won't come until later this year. Lee County Grant Writer Chuck Vandenberg said the application for the appropriations was just under \$2.5 million.

If that appropriation would be approved, it would give the county approximately \$5 million of the \$5.5 million project. The rest would be made up from any funds garnered in the charitable trust and then potential bonding, if necessary. The county can currently bond for up to \$750,000 without an election, however the new property tax law that was passed puts additional guidelines on governmental bonding that could have an impact on that project.
