County starts Keokuk urban renewal area

EMS FACILITY: Designation will help county borrow funds for ambulance bays

LEE COUNTY – As Lee County continues to rebuild the County EMS ambulance service, facilities again were on the agenda Monday.

Supervisors voted at their regular meeting to have County Auditor Denise Fraise begin to look at designating property in Keokuk as an urban renewal district to allow for additional bonding to generate funding for the project.

Supervisor Tom Schulz said preliminary estimates on the proposed building were in the neighborhood of \$1.4

million, but he said work is underway to reduce that estimate substantially.

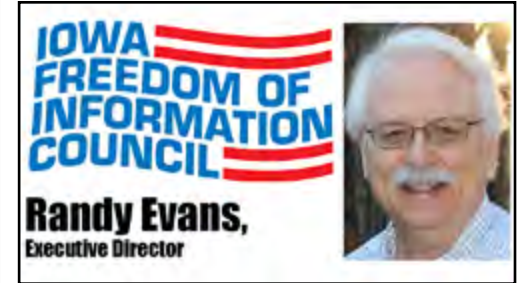
The building is scheduled to be constructed on the property where the former facility was. The county earlier this year purchased two additional lots to build the structure.

Creating the urban renewal district is a step the county also took with the property donated by the Glen Meller family for the new Lee County Health Department.

The move allows the county to bond without going to a full election. Changes in Iowa property tax laws signed

Honoring grad and Robert Ray

Sue and I were in Washington, Iowa, last month. The purpose for our trip was a high school graduation.

It was a special occasion because the people we joined with in honoring young Cameron, the newly minted Washington High School grad, have been our friends for almost 44 years.

It is important to know that while family and friends gathered to celebrate this milestone in the young man's life, there was one noteworthy person close to the family's heart who was there in spirit, because he truly made this wonderful day possible.

That person was the late Robert Ray, Iowa's former governor, who died in 2018. He is a revered figure in the lives of Cameron's extended family and in the lives of thousands of immigrant families.

Forty-four years ago, on a Sunday morning in October 1979, Cameron's father, Cameron's paternal grandparents and the handsome young man's aunt and three uncles, first set foot in Iowa. A chartered jumbo jet brought them and nearly 230 other immigrants halfway around the world from their former homes in Laos.

Cameron's dad, Tou Vongpanya, was just 4 years old then. Cameron's grandfather, Oth Vongpanya, carried the little boy down the steps from the jet. All the family's possessions were tucked into one suitcase and one cardboard box.

Maschmann wins Lee County Speedway AIRS feature

DONNELSON - A busy weekly night of racing took place at the Lee County Speedway in Donnellson, Iowa on Friday, June 2nd, with Darkside Tint & Graphix helping to bring all the action. When the final checkered flag waved at 10:10 PM, one driver claimed his first career win, three driver's earned their first of the season at the track, and three driver's won for their multiple times at the track.

First to take to the track was the 15 lap American Iron Racing Series (A.I.R.S. Cars) feature, with Owen Hayes and Tyler Maschmann drawing the front row. Hayes took advantage of his draw to grab the lead on lap 1 over Maschmann and Dan Thompson. Maschmann would try to work under Hayes, with Hayes holding him off each lap. That was until lap 4, when Maschmann finally got under Hayes for the top spot. Disaster would strike Hayes three laps later, as he spun in turn 2 and collected Doak Allen to bring out the caution. On the restart Maschmann jumped back out front, with Brian Gade and Dan Thompson battling behind him. While the rest of the cars battled for the runner up spot, Maschmann would go on to lead the final laps to score his first win of the season at the track. Gade won the battle for 2nd, Domanic McNabb came from 10th to finish 3rd, Dennis Etten was 4th, with Thompson holding on for 5th.

Up next was the 18 lap Donnellson Tire & Service IMCA Stock Car feature, with Chad Krogmeier and Dakota Simonsen leading the field to green. Simonsen used his front row starting spot to his advantage, by leading lap 1 over Derrick Agee and Krogmeier. The lead for Simonsen only lasted for a lap, as Agee got under him for the top spot. One lap later Jeremy Pundt and John Oliver Jr. got by Simonsen for second and third, as both those driver's went to work on Agee for the lead. The lead trio would battle two and three wide for the lead over the final several laps. Agee however would hold off all the challenges to claim his second win of the season at the Lee County Speedway. Oliver Jr. was 2nd, Pundt was 3rd, Simonsen was 4th, with Krogmeier coming home 5th.

Fisher Reese and Jesse Belez made up the front row for the 18 lap J&J AG Auto and Truck IMCA Modified feature, with Belez grabbing the lead on lap 1 over Daniel Fellows and Reese. Just as Belez started to pull away the first caution of the race appeared on lap 5, as Reid

Sammons spun in turn 1 to bring out the yellow. On the restart Rex Widmer spun in turn 4 to bring the yellow light back on. The following restart saw Belez jump back out front, with Jadin Fuller and Fellows following. While Belez paced the field out front, ninth place starter Austen Becerra would move into the runner up spot on lap 9 and then went to work on Belez for the lead. Becerra would use the momentum off the top of the track to edge out Belez at the line to take over the top spot on lap 13. Then just after the lap was scored complete Widmer would spin in turn 4 to bring out his second yellow to end his night. On the restart Becerra jumped back out front and then went on to score his fourth win of the season at the track. Fuller was 2nd, Fellows was 3rd, Belez was 4th, with Bill Roberts Jr. finishing 5th.

The 25 lap Iowa Corn Growers Association IMCA Late Model feature was up next, with Ed Hollenbeck and Blaire Barton leading the field to green. Hollenbeck would jump out into the lead on lap 1 over Ray Raker and Sam Halstead. As Hollenbeck worked the bottom, Raker went to the top to try and get by. On lap 8 Raker used the momentum off the top of turn 4 to grab the top spot away from Hollenbeck. The action was slowed on lap 15, when CJ Horn spun in turn 4 to bring out the yellow. On the restart Raker jumped back out front, with Jason Oenning and Jeremy Pundt close behind. Just after the lap was scored complete Frank Mason spun in turn 4 to bring out the yellow. On the restart Oenning grabbed the top spot away from Raker, and then held on over the final laps to score his first career win. Pundt was 2nd, Tommy Elston came from 8th to finish in 3rd, Dennis Woodworth started 9th and finished 4th, with Raker coming home in 5th.

Cole Gillenwater and Brandon Lambert made up the front row for the 18 lap Roberts Tire Center IMCA Northern SportMod feature, with Gillenwater jumping out front on lap 1 over Matt Tucker and Logan Cumby. Gillenwater would hold the top spot until lap 4, when Tucker got under him for the lead. The lead for Tucker only lasted for three laps, as John Oliver Jr., who started 7th, slipped by for the top spot. Oliver Jr., who worked the bottom, Cumby, who worked the middle, and Adam Birck, who worked the top, raced three wide for the top spot. Cumby would edge out front on lap 14, only to Oliver Jr. take the top spot back on lap 16. Oliver Jr. then held off Cumby on the final lap to claim his first win of the season at the Lee County Speedway. Birck was 3rd, Sean Wyett finished 4th after starting in 8th, with Tucker finishing 5th.

Up next was the 15 lap Sonny's Super Market Sport Compact feature, with Doug White and Tim Schnathorst leading the field to green. But it was fourth place starter Kimberly Abbott who grabbed the lead on lap 1 over Brandon Reu, who started 6th, and Schnathorst. Reu would work past Abbott on lap 3 to take the top spot away. While Reu pulled away from the field, Chevy Barnes, who started 8th, and Jason Ash, who started 9th, were working their way towards the front. But without a caution to bunch the field up there was no catching Reu, as he cruised to his first win of the season at the track. Barnes was 2nd, Ash was 3rd, Chandler Fullenkamp was 4th, with Luke Fraise completing the top 5.

The final feature to take to the track was the 10 lap Mini Hauler Trucks, with Don Wood and Sheldon Brockett drawing the front row. Sheldon Brockett took advantage of his draw to jump out into the lead on lap 1 over Wood and Tim Wagner. Wagner would overtake Wood for the runner up spot on lap 3 and then went to work on Sheldon Brockett for the lead. Coming off turn 4 to complete lap 7 Wagner was able to get under Sheldon Brockett for the top spot. Wagner then held on over the final lap to claim his third win of the season at the Lee County Speedway. Sheldon Brockett was 2nd, Jim Ruble was 3rd, Wood was 4th, with Roger Brockett coming home in 5th.

Traffic camera ordinance gets second reading OK

by the governor this year move all bond elections to the November general election. Any bonding done for county property goes on the county's debt service levy which is paid for out of property taxes.

"We had always planned on bonding for a portion of that. However, the law doesn't allow us to bond for a portion and pay for a portion without a citizens' vote unless it's in an urban renewal district," Schulz said.

Schulz said they don't have a firm number on the cost of the project, but the county can bond up to \$950,000 under the new law without going to a vote of the county residents.

Supervisors Matt Pflug said the doesn't like to take the voter out of the equation.

"However, this is something that's gotta be done," he said.

Budget Director Cindy Renstrom said starting July 1, the county has to send out a letter with the bond question to every voter in the county, which she said would likely double the cost of the election in November.

Schulz made a motion to allow Fraise to work with the county's bond counsel to get the urban renewal proj-

ect underway. The motion passed 3-0 with supervisors Chuck Holmes and chairman Garry Seyb both absent.

In a related issue, the board approved replacing two part-time EMTs and one part-time paramedic to offset rising costs of overtime in the ambulance service.

"We have part-time EMTs positions that are open right now that we've been putting off filling," said Mark Long, EMS Director.

"We're to a point where we're paying more in OT to full-timers."

He said it's about \$3 per hour cheaper to have a part-time paramedic fill a position than an EMT. The positions are not new positions, but replacement positions.

Supervisors also approved a second reading of the traffic enforcement ordinance to allow speed cameras to be placed on county highways. Along with that was the second reading approval of a related ordinance setting how revenue collected from the speed cameras will be allocated.

Both measures need one more vote and approval before the ordinance takes effect and the speed cameras can be mounted.





Ray was a pillar when it came to immigrants

The Vongpanya family — five siblings, ages 4 to 14, and their parents, Oth and La — was allowed to come to Iowa because Gov. Robert Ray invited war-weary refugees from Southeast Asia to start new lives in this state, in places like Bloomfield, Fairfield and Ottumwa. No longer would these refugees have to fear communists might kill them in retaliation for working for the United States government during the Vietnam War.

Sue was among a handful of Bloomfield residents who greeted the Vongpanyas that morning and escorted them to their new home in Bloomfield. Decades later, the Vongpanya kids still express their gratitude for the way the community rallied around them, finding them a home and stocking it with furniture and clothes, helping Oth line up a job, providing tutors to help the kids learn English, and above all else, treating them with dignity and compassion.

They know the people of Iowa, and Gov. Ray, gave them a life-changing opportunity — and hope. The Vongpanyas have worked hard since that fateful day in 1979 to be worthy of the blessing this state provided to them.

I am confident Gov. Ray would be proud of what Oth and La and their kids have achieved. All five of the kids graduated from high school. They earned college degrees. They have married and started their own families. They have purchased houses, been gainfully employed, and served in the United States military. They have been on community boards and all are U.S. citizens.

Advanced age kept Oth and La from the celebration in Washington. When you uproot and relocate half a world away, family takes on extra-special importance. So, all five Vongpanya siblings were there in Washington. So were spouses and kids, aunts, uncles and cousins. This scene will be repeated in the coming years, because Tou and his wife, Pam, have two boys younger than Cameron.

The Vongpanyas were beaming over the recent announcement that Gov. Ray's grandson is getting married this summer to the daughter of another refugee who came to Iowa in the 1970s.

The Vongpanya story is as old as the United States. Whether we want to acknowledge it or not, this is a country of immigrants. My own ancestors came from northern Europe years before the Declaration of Independence was signed

247 years ago. My family eventually settled in the gently rolling hills of Davis County six years before Iowa became a state in 1846.

Although the Evanses have been in the United States for a very long time, my ancestors came for the same reasons the Vongpanyas and immigrants throughout our nation's history have arrived here: We have all wanted safety and security, food for our families, education for our kids, jobs, and a chance for a fresh start so we can live lives that are more secure and a little brighter than our forebears.

The emotions were palpable that recent afternoon in Washington when the Vongpanyas talked about those times decades ago in Iowa, when Oth worked as a custodian and tended to people's lawns and snowy sidewalks to provide for his family. The kids talked about working hard to live up to their parents' high expectations for them.

Through Gov. Ray's leadership, Iowa welcomed roughly 10,000 refugees from Southeast Asia in the 1970s and 1980s. Before his death in 2018, Ray often said of those immigrants, and it certainly applies to the Vongpanyas:

We are proud of all you have achieved. You have enriched our lives and strengthened our state.

Demons dump Hounds twice

FORT MADISON - Jared Rehm didn't have to go deep into Fort Madison High School's softball history to convince his team that there is still a long way to go in this season.

The Bloodhounds' losing streak reached six games with Monday's Southeast Conference doubleheader loss to Washington at the Baxter Sports Complex.

Fort Madison fell to 2-6 overall, 0-5 in the conference.

But it is still early June, and Rehm reminded his team about last season, when the Bloodhounds lost four of their first five games and then went on to win the conference title.

"We went on a tear, won the conference, all of that good stuff," Rehm said. "So yeah, everything's not over yet."

Washington won the first game 10-7 and the second game 16-4, but the Bloodhounds had leads in both games. Fort Madison had a 4-2 lead after four innings in the first game and was up 4-1 after the first inning in the second before the Demons (10-4, 5-0) used big innings to take control of both games.

"We got up in the second game and I don't know why we couldn't keep that going," Rehm said. "Maybe they adjusted better than we did."

Washington had 15 hits in the second game, scoring four runs in the second inning and three runs in the third and

fourth innings. The Demons were helped by four Fort Madison errors.

"We did give them some opportunities, defensively, that can deflate you as well," Rehm said.

Fort Madison had the bases loaded in the second inning, and two runners in scoring position in the fourth and sixth innings, and couldn't score in the second game.

That mirrored the first game, when the Bloodhounds left seven runners on, including two in the seventh inning when they had the tying run at the plate with one out after scoring two runs and couldn't complete the comeback.

"That's what we were contemplating right there," Rehm said after the Bloodhounds' team meeting after the second game. "We're trying to figure out that part right there, how to get over the hump and stay over the hump."

"We have to stay up during games, not let things get us down. Some of the players were talking about that, how we just can't get down on ourselves. Just erase whatever bad happened and move on."

Fort Madison had 10 hits in the first game. Elle Ruble had a two-run home run and also had a run-scoring double. Neeley Rehm had two hits and scored two runs.

The Bloodhounds had seven hits in the second game. Lauryn Helmick had an RBI single in the first inning and Elizabeth Tanner followed that with a two-run single. Helmick had two hits.
