Local teen killed in collision on Hwy. 16

CENTRAL LEE: School held counseling, memory event on Sunday

LEE COUNTY - A 16-year-old Donnellson girl was killed in a two-vehicle accident Saturday in Lee County

involving a garbage truck.

Kodi Moeller, 16, a student-athlete at Central Lee High School, was driving in the area of Hwy. 16 and 205th Avenue when a waste hauler and her vehicle collided at around noon. The collision occurred about a mile east of the Hwy. 16 and Hwy. 218 intersection, just north of St. Paul.

According to a report from the Iowa State Patrol, the truck was driven by Levy A. Whaley, 21, of Mt. Pleasant

and Moeller was driving a 2003 GMC Envoy. Whaley was hauling for WEMIGA Waste Management of Mt. Pleasant, Iowa. The report indicated Moeller was traveling northbound on 205th Avenue and Whaley was headed westbound on Hwy. 16 when the two vehicles collided. Whaley's vehicle struck Moeller broadside on the passenger side.

Lee County Sheriff's deputies, Lee

Diabetes chat reminds me we need a cure

Every now and then I have a conversation as part of this job that sets me back just a bit.

I had one of those conversations on Friday with a 16-year-old girl whose life was flipped upside down 10 years ago.

She flipped it back.

Her name is Lucy Arevalo and she has Type 1 Diabetes. The same freaking autoimmune disease that tackled my daughter and killed my father.

But this girl who plays golf, participates in show choir, and is in leadership training at Diabetes Camp for children not only refuses to let diabetes define her, she's going to Washington to advocate for more funding in the fight for a cure.

Lucy and her mother Allison sat across a large walnut dining room table and Lucy flopped out her Tandem insulin pump, that talks to a Dexcom glucose monitoring system.

The two pieces of wonderful equipment talk to each other through algorithms, in essence becoming an artificial pancreas.

The pancreas is the organ that produces insulin. Insulin unlocks blood cells to process sugar in the body. When those cells stay locked, the sugar builds up in the body and a girl like Lucy can go into what's called Ketoacidosis. In essence, the body poisons itself because the damned pancreas refuses to produce insulin.

Type 1 diabetics have to inject insulin, or infuse it through the pump, because the stubborn pancreas won't do its work. It has a lot to do with T-cells and the body attacking itself, but we don't need

Ranjan shores up museum

NEW OWNER: Indian man purchased company 11 months ago

FORT MADISON - The Sheaffer Pen museum seems to be in pretty good hands. So is the Sheaffer brand, says its new owner.

Nikhil Ranjan, the owner of William Penn an India-based stationary and specialty gift company, purchased the pen brand about 10 months ago from A.T. Cross Company and was in Fort Madison with his parents this week to learn about the city and its history as the birth place of Sheaffer pens.

Ranjan and his parents Ashvani and Shashi met with past employees of the Fort Madison Sheaffer facility at the museum in downtown Fort Madison Friday afternoon.

On Thursday Ashvani and Shashi toured the city with FM Partners Director Tim Gobble holding conversations with business owners about the city and the impact of the pen company on its history.

Nikhil Ranjan hired a marketing firm to come through the town with the family to make a documentary about the company's history in Fort Madison.

Ranjan said it's a priority of the company to preserve the heritage of the Sheaffer family and the history of the company.

"It's in our interest in keep the museum up and running. We want to keep this a vibrant place," he said.

"We will start with promoting the museum on social media to make

sure the people who are visiting the area will make visiting the museum a priority.

"We're also going to get products back here for visitors to buy at a discount compared to elsewhere. And then down the road we'll look to see if we can do more to make sure the museum is thriving."

Ranjan said after starting William Penn he quickly realized that writing instruments were very popular func-

 Pairings for all five classes were released by the Iowa Girls High School Athletic Union on Friday.
 Holy Trinity will play host to New London in a Class 1A Region 8 first-round game at 7 p.m. June 30. The winner of that game plays at No. 8 Sigourney in a quarterfinal on July 5. Regional semifinals are July 7, with the regional championship game on July 10.
 Other regional first-round games are Winfield-Mount Union at Wapello, Lone Tree at Highland, Keota at Moravia and Hillcrest Academy at Tri-County. Twin Cedars and English Valleys have byes into the quarterfinals.
 Holy Trinity has defeated New London twice this season, winning 13-0

Lady Hawks capture first conference title in 44 years

DONNELLSON – Several ladies from the Central Lee 1979 softball team had big smiles on their faces Friday night at the Lady Hawks’ softball field.

The group was honored with the 2023 Central Lee Hawks as the last team and the most recent team to win a conference softball title.

The most recent being this year’s Lady Hawks that are a perfect 11-0 in SEI Superconference.

First year coach Jason Hawk said the difference in past years to this year is the work ethic he sees.

“They’ve been working hard. They’ll beat me here to the cage. They come when they don’t have to and they take a lot of pride in what they’re doing,” Hawk said.

“We all came on Saturday and spent four hours here. The whole team. Nobody missed. These girls are doing it as a team.”

The Hawks did it as a team again Friday night in an 11-0 win over Mediapolis that probably should have been over in

the fourth inning, save for a double play to end the bottom of the inning.

With the bases loaded and Bailey Schwartz standing at third, Alix Congdon lifted a fly ball to short center where the Bulldogs’ Anna Ford made the catch and fired home to catch a tagging Schwartz by about three feet.

Mediapolis tried to extend the game in the top of the fifth, getting two runners on, but Hawks’ starter Everlee Harvey got a ground out back to her to end the game.

Freshman Kenna Sandoval hit her second home run in the last two games with a 3-run blast to left center in the bottom of the first inning to get the Hawks going.

Sandoval said the team is playing well and not getting wrapped up in the past or the future.

“I feel like we’re more relaxed when we face teams so we’re not dwelling on things and getting anxious about this team’s record or that team’s,” Sandoval said.

“We’re just focusing more in the cages and on

the field right now.”

She said it was good to bring a conference championship back to the school.

“We’re finally conference champions.”

She would add a single and a double on the night, going 3-3 with three runs scored and 4 RBIs.

The Hawks would add four more runs in the second and three in the third. Mediapolis would get out of the inning unscathed in the fourth before Central Lee put the game away.

Schwartz went 2-2 and Simmons was 2-3 in the win. Schwartz and Shanna Buford both had two RBIs.

Buford’s batting average is tops in Iowa in Class 3A at .593 and ninth in all classes. Sandoval is fifth in home runs in 3A with nine.

Harvey went all five innings, giving up just two hits while striking out six. She also had several put outs playing good defense at the mound, including one throw out from her knees at first.

Hawk said winning the

conference was one of his expectations.

“Honestly yes, I told everybody that our goal was to win conference and go to state. We’ve met one of them,” he said.

“There’s a lot of expectations here and we’ve always been worried about West Burlington, but that’s one thing I’ve never done with these girls. It doesn’t matter who we play, we always go out

and do what we do.

“Before any game, nobody’s looking forward to tomorrow. If we play the No. 1 team in the state, nobody’s thinking about that today, they’re doing what I ask them to do in that moment.”

The Hawks have won 9 of their last 10 with the only loss coming to Washington 14-4 Tuesday. Central Lee drew the Demons in the first round of Class 3A

regional quarterfinals on July 6 to open post season play.

Hawk said he’ll be spending time with that stat sheet over the next 10 days.

“I take a lot of the blame in that loss. I had some people in the wrong spots in the field, but we keep a pretty good score sheet and I’ll be spending a lot of time with that over the next few days.”

Arevalo headed to D.C. for diabetes forum

to go that deep.

If you have Type 1 diabetes, you know all about it.

Lucy's a top-notch student and holds office in her class. She has been accepted to be part of what's called the Juvenile Diabetes Research Foundation (JDRF) Children Congress of 2023.

These kids can't eat a freakin' ice cream cone without figuring out how much insulin they need to counter the carbs in the dessert. A necessity that I can personally guarantee is taken totally for granted by every non-diabetic family in the world.

And diabetics are families. Make no mistake about that. It's a family disease because it usually hits children.

Parents will see children losing weight, urinating in their sleep and sometimes when they aren't asleep, consuming excessive amounts of water, complaining of headaches. Doctors' visits for children not feeling well with those symptoms usually end up with a transfer to the University of Iowa and a diagnosis of diabetes.

Then there is a new normal. Checking blood sugars through finger sticks 6-8-10 times a day if not more. Try that with a six-year-old, or a 10-year-old. Then giving a shot of insulin in the arm or abdomen or on the top of your hip. Making sure you move it around so you lower the chances of scar tissue which can reduce the affect of the insulin.

So after the family is trained on administering insulin and the usage of a glucagon injection for when blood sugars go so low the child goes unconscious, they then have to figure out the finances of disease.

The price of insulin is one of the biggest shams in the medical industry. Drug makers are using that much-needed insulin as a profit pad because of the demand of the drug.

While families, some not so well off, have to decide on what dollar goes to what need, they have to make the difficult decision of whether to buy insulin or the food that makes it necessary.

Artificial insulin is produced quite inexpensively, but the markup is massively out of proportion.

So Lucy and about 25 other kids are going to Congress to talk about continuing to fund the Special Diabetes Program, a program under the National Institute of Health that channels federal dollars into research that has produced current things like insulin, insulin pumps, on-board glucose monitors, as well as future weapons like nanotechnologies, inhaled insulin, and phones and watches that just read blood sugars through the skin – without a poke.

Arevalo is part of a special annual trek to Washington to meet with State Rep. Mariannette Miller-Meeks and U.S. Sens. Charles Grassly and Joni Ernst. Some of the students will actually speak to a Congressional committee about continuing to help fund research that will inevitably save lives.

I don't know. Sitting with Lucy and her parents, Alison and Alfonso who own Rev Fitness in downtown Fort Madison, it freshened my mind about the battles these families face. The wonderful technology has taken a lot of the brain drain out of the disease, but it's still around-the-clock monitoring to stay as healthy as possible.

It took me back to the social discernment for those who have to take a shot before eating and how some just don't understand.

What Lucy is doing may not impact you right now, and then again it might. But one thing is for sure, they've got the right girl going to D.C. – But that's Beside the Point.

tionally and as gifts. He reached out to pen brands throughout the world including Sheaffer. Sheaffer didn't have a distributor in India so he had to buy directly out of the United Kingdom.

"India grew into the largest Sheaffer pen market in the world in 2017-2018. In 2022 we had the opportunity to buy Sheaffer and we couldn't pass that up," he said.

In July of 2022 William Penn went to work securing the supply chain following the impact of covid, and upgrading the market. They also started looking at some new products which spawned some new finishes for existing products.

Now their top priorities are to appeal to younger audiences who Ranjan said will see a convergence of digital and analog technologies bringing pens back into functionality.

"Writing in the physical form is not as popular and relevant, but that's evolving.

"We can't change the habits, but we want to ride the wave that's already there. We're going to be there as young audiences are looking at writing in the future."

He said there will be worldwide marketing for the pens, including North America. William Penn has a base in Long Island, New York. He said Sheaffer Pen is also a well-known name as a specialty gift item.

Products will be available in retail outlets and on line.

The majority of the production is being done in China. Nikhil said they are looking at other places however production will not be local.

Russell Sheaffer, the son John Sheaffer and great-grandson of W.A. Sheaffer, the founder of Sheaffer Pens, was also on hand at the museum with his wife Vicki.

Sheaffer said he feels very good that the museum will be taken care of.

"I think it's in good hands and what's exciting to me, and the City of Fort Madison should be excited as well, is that they are all in on supporting the museum - keeping it here and keeping it intact," Sheaffer said.

"William Penn has a huge social media following and they are looking at ways to connect the museum to those platforms as well."

Sheaffer said William Penn has been a long-time distributor for Sheaffer Pens and the acquisition makes sense and is strong for his great-grandfather's legacy.
