Teacher rings board's bell

LARSON: Elementary teacher says 2022 concerns ignored by Superintendent

FORT MADISON - A retiring Fort Madison school teacher took a couple minutes Monday night to ask the school board to look into concerns the teachers' union had forwarded to a school official last year.

Fort Madison Elementary teacher Julie Larson spoke during the open discussion agenda item Monday and told the board that concerns the teachers' union had related to the culture of the district have not been addressed by Superintendent Dr. Erin Slater.

"Last year (Fort Madison Education Association) FMEA presented Ms. Slater with staff concerns. The concerns were related to climate and culture and have not been addressed or acted on," Larson told the board.

"Teachers feel micromanaged by not being allowed to teach reading and math in ways to best meet student needs."

Slater responded via email to Pen City Current writing that the district provided a total of four release days for two FMEA leadership staff to talk with teachers in each building to get input and feedback regarding things that were working well in the Dis-

SUPERVISORS Keokuk Mayor asks board to clarify turbine situation

LEE COUNTY – Keokuk Mayor Kathy Mahoney is pumping Lee County Supervisors for help in quashing discontent in the city of Keokuk over a turbine donated by Ameren.

At Monday's regular meeting of the supervisors, Mahoney spoke during the public comment section of the agenda asking the supervisors to explain that it was their decision to approve the turbine being located in Estes Park, a park in the middle of the city that is actually owned by the county.

Supervisor Chair Garry Seyb said he was on the board several years ago when the decision was made by supervisors to not oppose putting the turbine in the park.

"There was a lot of caution there," Seyb said.

"I talked to the mayor (Tom Richardson) and he didn't have a problem with it. Main Street wasn't in favor, but they said if the Dam Museum wanted it there, they would step back from it. I talked with several officials and there wasn't a whole lot of pushback."

Seyb said any contention that the county wanted the turbine in the park is not accurate, but that supervisors weren't opposed to putting it in the park after speaking with city officials about the donation.

"We're two years into it and I don't think we're at a place now to back away from that," Seyb said.

FMHS students could see more lenient dress code

FORT MADISON - Fort Madison High School students can expect a different look in the district's dress code this year.

Co-Principal Patrick Lamb told the Fort Madison School Board at Monday's regular meeting that the district may have a little more lenient stance with student attire. Lamb said he and Co-Principal Adrian McKay spent more than 30 hours going over the current dress code trying to make the policy easier to understand and enforce. "It's hard for me to justify that clothing

is a distraction to education unless its egregious," Lamb said.

"We're looking at being a little more lenient. As long as you're not showing parts of your body that shouldn't socially be

middle of Estes Park so it's not in the corner near the streets.

"Now that we're getting ready to do this, apparently there are those that didn't pay any attention to things two years ago," Mahoney told the board.

"I'm asking the board of Supervisors, since Lee County owns that property, to put an article in the paper; step up; at least say something to the citizens of Keokuk on why you want it in that park; don't want in the park; why it was put there in the first place - just something so that the citizens realize that you, as a board of supervisors, chose for it to go there."

The county has offered to turn Estes Park over to the city, but that has been rebuffed in the past, and

Mahoney confirmed that sentiment Monday.

"The city doesn't own that, they don't want to own the property, this is your park and if there is a compromise that's great, but we would ask that you guys take a little initiative to say that this is a Lee County and Dam Museum project and not the city of Keokuk project," she said.

Mahoney asked if the county would consider moving the turbine's planned location to a more central area of the park so it wouldn't be considered an eyesore by some.

"I'm wondering if it couldn't be located more centrally in the park. I know there is a gazebo there, but I also know that there may be a little leeway to set it some other place on that property so that people who think it's an eyesore - it's not."

Mahoney said people think it's the city's project and would like it clarified as to why the turbine was placed in the park.

Work crews are ready to start digging into the ground to create the foundation for the turbine display, however Seyb said he doesn't believe the turbine has been delivered yet.

Mahoney said there could be a compromise, saying she spoke to Ameren and getting the turbine to Riverfront Park is an option.

FMHS to move on attendance policy

shown. Come to school with marijuana leaves, we'll ask you to change. If we can see your bra, we're going to ask you to change."

Lamb said the high school spends too much time dealing with dress code violations.

"I struggle to see why we are as restrictive as we are. It results in kids being referred to the office for things that aren't egregious," he said.

"Adrian and I spent 30 hours on dress code issues alone. It's not a good use of our time."

Lamb said school officials are still putting limitations on what students can and can't wear, we just aren't looking at being as restrictive as we once were."

In a related issue, Lamb said he would like to put pre-Covid attendance policies back in place.

He said the average daily attendance is at 90%, which is 5% below the district and state goal of 95%.

"When we had the policy in place, we were at 95% and then Covid affected us and attendance rapidly fell off," Lamb said.

Now that we're no longer in a pandemic, we'd like to return to the policy."

Prior to Covid, any student with five unexcused absences would be dropped from a class with a failure.

Lamb specified that those are unexcused not excused parent-notified absences.

"These are unexcused, not those where you call in due to being ill as long as you haven't exceeded those allotments," he said.

In other action, the board:

• approved, 6-0, the 2023-24 insurance program with the Iowa Association of School Board's Safety Group Insurance Program with a premium of \$482,147.96, an increase of \$4,550.21.

• approved, 6-0, the renewal of the district's agreement with Southeast Iowa Regional Medical Center for athletic training services.

•approved, 6-0, new meal prices for the 2023-24 school year, including continuing free breakfasts for all students. Lunches for PreK through 6th grade will move to \$3.25 from \$3 and students in 7th-12th grade will pay \$3.50 per lunch. Milk will stay at .45 per carton, while adult meals will go to \$5.00 from \$4.25.



trict, and areas that needed improvement.

"That data was then utilized at monthly follow up meetings during the school year that included myself and FMEA leadership," Slater wrote.

"We used that time to collaborate, to learn together, and to put actions into place to keep improving the District." Larson said the curriculum resources provided to teachers are scripted and don't allow freedom to teach students in ways that are engaging and thought provoking.

"In addition, the scripted curricular resources do not need to waste teachers' time intentionally planning," Larson said.

"Teachers are the ones building relationships and making connections and know students. Teachers should be trusted."

Slater said the District has adopted evidence-based curricular resources that are used to teach the priority learning standards.

"These priority learning standards are identified by teacher teams who have determined what is needed for student success in each grade level and course," she wrote.

"The job of a teacher is very difficult and challenging. We value and appreci-

ate our teachers, our support staff, and all of the employees of the Fort Madison Community School District."

Larson listed 10 concerns including regular shifting of principals from one building to the next, creating unpredictability for staff and students. Other issues included lack of communication; not all administrators attending PLC meeting or IEP meetings to support staff and students; and called the lack of discipline procedures "astounding".

Larson also cited a lack of cleanliness in the schools, calling the conditions "deplorable".

"I wonder if you have considered the many staff who are departing and have asked them why they are leaving?" Larson asked.

"I hope that each of you would be willing to pull back the curtain and take a good look at how to support students, teachers, and staff at FMCSD.
