SPECIAL NIGHT: Hall of Famer Tallman makes trip back to C.E. "Eddie" Richards Arena to call Chute-Out

FORT MADISON - The Tri-State Rodeo kicked off with the flare and pyrotechnics that have become part of the draw of the Chute-Out.

This year Jim Baier Ford and Dodge Ram picked up the tab for the event after CINCH Jeans stepped away from a long run as the Wednesday night All-or-Nothing format's sponsor.

MC Boyd Polhamus was joined by veteran rodeo announcer and former TSR front man and Hall of Famer Bob Tallman for the Chute-Out Wednesday night at C.E. Eddie Richards Arena to open the 75th Anniversary of the event.

General Chairman Chuck Kempker said her

reached out to Tallman months ago.

"We knew it was the 75th and we tried to get as much as possible as far as personnel for the show. He was able to come in for Wednesday night and I have to say he was more than pleased," Kempker said.

Tallman used to call the rodeo prior to Polhamus and the arena was very different at that time.

"He was here in the past. I called him three or four months ago and had a little discussion and got him. It was neat having him here. Back in the day we had a larger arena and the older VIP. But he got the WOW factor. He sat in the new section where everyone could see him and he could see everything. Then he and Boyd just got after it. His knowledge of the cow-

JOAN F. HINRICHS

Joan Foster Hinrichs passed away on Thursday, August 13, 2023. She was 86 years old and had been a resident of River Hills Village for the past five years.



HINRICHS

Born in Keokuk Iowa, she was the middle child of five siblings to William Theodore Foster and Lorene (Rader) Foster. Her father, after enlisting in the Navy, was tragically struck down by Nephritis when she was only nine years old. Growing up near Rees Park, Joan attended Lincoln Elementary and Keokuk Middle and High School. She would leave the city for Wartburg College, part of a new wave of first-generation post war college attendees. It is at Wartburg that she met Harold "Harry" Hinrichs, marrying him in the Second Presbyterian Church on South 7th Street, nearby to her childhood home. She left Wartburg after two years and received her two-year diploma in Parish Worship to support Harry in his career as a theologian and founder of Caring Community.

Over the next thirty-two years she made home-making her ambition, the impeccable pastor's wife

to two congregations with three model children. She had a gift in the kitchen, always making and baking for others as well as sewing and gardening. Moving from Iowa to Oregon, California, Massachusetts and finally to Chicago initially to support Harry's theological training. Chicago was the first city she could call home. After Chicago it would be Green Bay, then Minneapolis and finally Milwaukee.

Joan worked as an executive assistant first with the University of Minnesota Hospitals and Clinics followed by working with Caring Community Incorporated, the Next-Door Foundation, Inc. in early childhood development, and the Milwaukee School of Engineering-School of Nursing, and finally at Luther Manor in the department of Community Service. Divorced in 1989, she considered a return to Keokuk, renewing her childhood friendships. The past twenty-five years saw her retire and then make a try at living in Los Angeles while visiting her accomplished children in places like New York City and Italy, before finally returning to the city of her birth, to live at the Hotel Iowa on Main Street.

Living in Green Bay would make Joan a lifelong Green Bay Packer fan and stock certificate holder.

But her experience living on Chicago's south side from 1962-1969 was more defining, showing her to be a woman of moral purpose, social responsibility, and resolve as she intuitively stood up to racist taunts during the riots that shook the city. Her daughter, Renata Hinrichs, memorialized a scene from Joan's life in her play, "Random Acts".

Joan is survived by her three children, Renata Hinrichs (Todd Johnson), Erika Hinrichs-Biehle (Frederick Biehle) of New York City, and Harold Hinrichs (Felicia Beanum) of Los Angeles; three grandchildren, Lincoln Hinrichs, Zora Hinrichs and Calder Biehle; as well as her four siblings, Eloise McWaters, Theodore Foster (Dorothy), Milton Foster (Linda), and Louie Foster (Beverly).

Her former husband Harry Hinrichs predeceased her on July 8 of this year.

The Family is planning a Celebration in Keokuk, Iowa, early summer 2024. The family will be sending invitations to family and friends for the event.

The Vigen Memorial Home in Keokuk, Iowa is assisting the family with arrangements.

Bloodhounds take on Big Red machine in Centerville

FORT MADISON – The Fort Madison Bloodhounds will try to go 3-0 to start the year for the third time in the last three years when they take on Centerville Friday night in Centerville.

The Big Red made it to the quarterfinals of the Class 2A playoffs last year and, despite their 1-1 record to start the year, Centerville will bring a test for the Hounds.

But Fort Madison (2-0) has been exposed to tests this year, having to come from behind to win both games.

Last week the Hounds needed some late scores and a couple momentum-killing plays to stay unbeaten on the year with wins over Burlington and Fairfield.

Head Coach Derek Doherty said the Hounds have to get out of their habit of starting slow, especially against a potent offense like Centerville's.

"That was the feeling Friday night, no sense of urgency and we've had some practices like that. We're prodding at these kids to get them going and find out what makes them tick," Doherty said.

"We are extremely proud of our kids. Impressed at times with their resilience and how they find ways to make stuff happen. I've said it before, that mental shift and change here has been a breath of fresh air. In the past, we've found ways to lose games like that, but now we're finding ways to battle and win."

Doherty said the coaching staff doesn't want to have to rely on those heroics to get the W.

"There's a sense of urgency inside the coaching staff and we're pushing that down to the players to figure this out. We can't rely on 'hey this is just going to happen.'"

The Bloodhounds got a different look at junior quarterback Marcus Guzman who ran more physically out of the run-pass option Friday against Fairfield and is starting to build confidence.

Guzman has no problem letting go of the ball at the last moment in the RPO and has done so to a bevy of Hound receivers, but on Friday he ran for a tough 46 yards and a score while throwing for 182 yards and two touchdowns. He also threw his second interception.

Doherty said Guzman ran hard and at Trojan defensive backs, but he would like to see a cut and his quarterback get vertical.

"You never want to change who an athlete is. That's who Marcus is, but we do point out that if he planted a foot and got vertical, there's more yards there for him," Doherty said.

"He's gaining confidence and, right now, he's seeking con-

tact. He's running the ball hard and we like that."

Guzman has found five different receivers on the year for 275 yards and three touchdowns. Senior Henry Wiseman leads the catch corp with 90 yards and a score. Caleb Bolander has 73 yards and Brody Cashman has 45 yards and a touchdown on a single catch out of the backfield.

Fort Madison continues to be led on defense statistically by Jamarkus Kline with 15 tackles.

Doherty said Kline is better than he knows and is playing a solid role created by the attention that Ike Thacher, Cashman, Teague Smith, and CJ Arnett attract in the Hounds' defensive mix.

"And getting a lot of our kids to understand that is the hard part. They want the stats, but getting them to understand systematic football is successful football. We have in the past spilled a lot of runs to linebackers that allow them to get their name in the paper, but it's really the guys with their hands down in the dirt that are getting the job done."

Senior Teague Smith has a dozen tackles, Wiseman has 11, including a potential game-saver Friday night catching a Trojan from behind late in the fourth, and Cashman has 10. Ben Ramatowski has two picks and Wiseman has an interception, his coming late in the fourth quarter Friday, as well.

Centerville comes at you full force with a dual threat quarterback in Landon McGrann. The junior has five touchdowns on the ground and another three through the air, and has

accounted for 684 yards of offense.

McGrann likes to throw to senior Ryan Sinnott who has 183 yards and a score on 13 catches. But freshman Makoa Kaleponi could be the bigger all-around threat. He has five catches but is averaging 31 yards a snag and has two touchdowns, one an 83-yard hook-up.

"Centerville is a great team. That staff has stuck together for a long time and they made it to the state quarterfinals last year so they will be a tough test," Doherty said.

"Ultimately, if we want to be who we say we want to be, these are the teams we have to play. And we have to find not only ways to compete with these teams, but beat these teams."

These teams include Williamsburg at home next week and the, Davenport Assumption on the road in week 5. Williamsburg is currently the No. 1-ranked Class 3A team in the state and the Knights are a top 5 team. Fort Madison was ranked 12th in the last AP poll according to votes cast.

"Our schedule from week 0 all the way to the end is tough. We don't have cupcakes on our schedule. That's fine because we've done all the work in the offseason. The fine-tuning the engine and finding who we are is going to be the important thing and I feel like that's been us these past few years."

The Board opened the meeting by reciting the Pledge of Allegiance.

Seyb amended the agenda, omitting item number 5, Iowa Land Records Annual Report. Moved by Fedler, seconded by Pflug, to approve the amended agenda. Motion carried.

Public Input: Don Hunold, Donnellson, gave the Board some information regarding the carbon pipeline. Holmes told the Board that County Auditor Denise Fraise will be retiring at the end of the year. The Board will
