CONSERVATION DISTRICT LCC touts successes of past year

LEE COUNTY - The Lee County Conservation district is celebrating a year of large accomplishments, but also gazing toward the future.

At an annual report to Lee County Supervisors Monday, LCC Director Heather Huebner talked up the accomplishments over the past fiscal year and what the board is looking forward to in the future.

She said they have finished the Places to Play campaign that was started under former Director Nathan Unsworth so they are finished with playgrounds for the time being.

But she said the other major accomplishment was finishing the Pollmiller Trail rehabilitation project.

She also wants to show off the new trail with an event possibly this fall. Seeding is still being done and the conservation district is looking at doing a Halloween-themed run on the new trail.

"We're almost through to completion on that project," she said. "And we haven't put out a press release or anything yet, but we are working with the high school to put on some type of Zombie Apocalypse run out there in the future."

Supervisor Ron Fedler, who lives in West Point and represents that district in the county, said people are already taking notice of the improvements.

"A lot of people have already complimented how nice that is," Fedler said.

Huebner said she just finished a walkthrough with Jones Contracting and is happy with the work, including the widen-

County sees increase in camping revenue

ments in property and people are also on the rise.

"We continue to increase our public footprint. We have increased followers on Facebook and social media, and we've added a few events. We've sent our ranger to the academy, so we are investing in our people and that is starting to show," Huebner said.

The district's environmental team is heavily engaged in all four school districts in the county as well as field trips around the county. Huebner said more than 70 students come out each week for mussel field trips.

"That schedule is completely full and it's a good problem to have, but they may even have to pull back a little bit," she said.

Expenses for the year were down due to the trail project not being completed and a piece of equipment not getting purchased before the end of the fiscal year, but those costs will be realized in this fiscal year, so the expenses didn't disappear.

The board is in the middle of finalizing a 10-year strategic plan after touring all the county conservation properties. They have had several workshops around the plan and are close to approving it.

"That will provide a nice living document for our staff as we plan projects," Huebner said.

Revenue from county parks and associated rentals, admissions and sales has increased from \$57,000 in fiscal year 2014 and 2023, a period of 10 years, has increased to \$155,500 almost 300%. Chatfield Campground has experienced growth closer to 500% over the same time frame.

Supervisor Chairman Garry Seyb said even he's been surprised at the attraction the park has garnered over the past several years.

"I'm hearing a lot of great things about conservation, especially about camping," Seyb said.

"These facilities are what's going to draw people in. We camp down in Missouri and we're hearing about Lee County in our banter back and forth. They said we've got nice camping in Wilson Lake and they talked about Chatfield."

Huebner said she saw at the beginning of the spring that Chatfield was selling out before Wilson Lake.

"That's unheard of. So that really makes us proud," Huebner said. "It goes to the 'If you build it, they will come' mentality."

The Lady Hounds took second place with 43 points. Washington won the event with 39 points.

Fort Madison's Paetyn Wiegand took third in a strong finish, getting past Keokuk's Hannah Karre in the final 30 meters.

Other scoring runners for the Fort Madison girls were Addison Rump, Allison Lamb, and Charley Huebner. Addison Rump finished 7th with a time of 21:13.3. Lamb came in 15th at 22:48.6 and Huebner placed 17th at 22:55.6.

Other runners were McKayla Schinstock (22nd) and Hadley Wolfe (23rd).

Avery Rump said she's been battling some illnesses early in the season, but is starting to feel better.

She passed out during the first race and then didn't run at Keokuk last week. Her first race was a 5K in Illinois and she ran at Washington in the latest meet.

"I was a lot faster today than in Washington. I really wasn't feeling great before the race at that race either. It wasn't a good day," she said.

Rump and Iris Dahl of Washington have been chasing each other the last couple years. Rump said the competition between the two sophomores is fun and friendly.

Her 19:48 is 13 seconds slower than her freshman year run in 2022 when she navigated the course at 19:35.

Wiegand said she's running well after missing half the season last year in her junior year.

She said motivation along the trail helped her find another gear toward the end.

"I heard coach, I heard Tim Lamm, and I heard somebody else and I just said, 'I gotta go," she said.

She attributes the success this year to her teammates and coaches pushing her.

Weigand said being back this year and feeling better is "amazing".

She said her goals for her final year running for the Bloodhounds focus on the team.

"If I make it to state individually that would be fun, but my goal is for the team to go to state," she said.

The boys also captured second-place behind the Demons. Washington scored just 28 points with four top-six finishes and 14th place to make up the scoring. Fort Madison had 63 points.

Nolan Guzman led the Hounds with a 4th-place mark, making up three spots in the final 400 meters.

Holy Trinity rebounds from 0-2 start to knock off WB

WEST BURLINGTON — Wins like these, Mary Kate Bendlage said, can pay off in October.

Holy Trinity's five-set comeback against West Burlington on Thursday night felt like the crucible of the postseason, but it was just another night in the SEI Superconference South Division.

And the Crusaders keep finding ways to turn these nights into victories.

The 18-25, 24-26, 25-22, 25-21, 18-16 triumph was a marathon of momentum shifts, and one of survival for Holy Trinity.

"Down the road," said Bendlage, a senior outside hitter who led the Crusaders with 20 kills, "it shows us we're capable of anything."

The Crusaders, ranked No. 3 in Class 1A, were at times hot and other times sluggish in the first two sets, and West Burlington, No. 10 in Class 2A, took advantage of that inconsistency.

The Crusaders led 7-1 in the first set, and let it get away. They were up 24-23 in the second set, and gave up three consecutive points.

"I thought we were kind of on a rollercoaster those first two games," Holy Trinity coach Melissa Freesmeier said. "We came out hot, and then we kind of let them back into it. You can't do that — you've got to press, keep the gas on."

The Crusaders were pounding the ball, but the Falcons always seemed to be in the right spot.

"We were just playing sloppy, not playing Holy Trinity volleyball," Bendlage said. "I think we were a little nervous coming into it, knowing they were scrappy and that hitting the ball was going to be a lot harder because they dig everything up."

Holy Trinity outlasted a West Burlington rally in the third set — the Crusaders were up 19-11 at one point — and the shift in fortune could be felt.

"We knew we had to have it," Freesmeier said. "We had some great plays down the stretch.

"We're down 2-0, their crowd was a lot louder than ours and they had a lot more momentum," Bendlage said. "But we got them down early in the third set, and they couldn't come back from that. That got our crowd going and it really helped us push through."

West Burlington led 9-3 and 15-12 in the fourth set before the Crusaders took control. Anna Bendlage's ace gave Holy Trinity set point, and Holy Trinity closed out the set on a serving error by the Falcons.

The fifth set was its own twisting road course. A tip and two kills by Presley Myers gave the Crusaders three match points, but West Burlington had every answer until Holy Trinity got the final two points, one on a kill from Adalyn Kruse, to finish the win.

"We definitely picked up our communication, and came together as a team," Mary Kate Bendlage said. "That shows a lot about us."

"I thought in games 1 and 2, it looked like maybe we had quit a little bit," Freesmeier said. "But I told them, 'You know what? You didn't quit. You didn't quit in 3, 4 and 5.' I'm proud of these kids tonight. It's been an emotional week for us, so, it's a great win."

The dig totals for the Crusaders were impressive. Teagan Snaadt had 40 digs. Mary Kate Bendlage and Taegan Denning each had 27 digs. Natalie Randolph had 19 digs. Myers had 14 digs, and Anna Bendlage had 12.

Holy Trinity also had strong defense up front. Myers had nine blocks. Kruse had four. Mary Kate Bendlage and Randolph had three.

"I thought they pulled together (defensively)," Freesmeier said. "We dug some balls. We had a little bit of the problem with the tips early on, they found some holes. But we were better defensively."

Myers had 19 kills. Randolph had 10 kills and 32 assists. Kruse had nine kills. Anna Bendlage had seven kills and 20 assists. Denning had five kills.

Kruse, a freshman, was especially effective serving, going 23-of-23 with four aces. Myers was 22-of-22 with three aces.

"I knew this was going to be a dogfight," Freesmeier said. "I was hoping we wouldn't be down 0-2, but that's what it was. "And the end result was great."
