#### **FUNDS SHORT:** Inflation has PAW officials short about \$1.5 million

FORT MADISON – The first step into the new PAW Animal Shelter is jaw-dropping.

The \$6.5 million project is on track to be completed by the end of the year, but Director Sandy Brown is hoping to have the dog kennels and runs in before the weather gets too cold.

Schickedanz Construction is managing the construction with about six local contractors.

Project manager Pebbles Schneider said everything is on track

to have the facility completed structurally before January, just a bit behind schedule.

She said cost overruns are typical on a project like this, but construction is coming along according to bids on the work.

"It's going to be a little bit longer than we expected with lead times on materials and getting things scheduled. We had some delays in the beginning, but we're moving along especially with the big dog runs in back," she said.

Officials are hoping to have those runs done soon so when

## Climax rolls out upgrades to logistics

Manufacturer opens new truck scale and concrete entry way for drivers

FORT MADISON - Logistical improvements and a new state-of-the-art scale were part of an unveiling Wednesday morning at Climax-Molybdenum in Fort Madison.

General Manager Javier Guevara told a group of about 60 dignitaries on hand for the ribbon-cutting that safety and efficiency were at the heart of the improvements.

The project began about a year ago and could be seen daily with work being done along the southside entry to the facility.

"We needed to replace our old, inground truck scale as part of our infrastructure replacement program, yet at the same time we wanted to take the opportunity to eliminate the safety risks around truck congestion at the entrance to our plant," Guevara said.

"Going forward, semi-trailer trucks will no longer have to back-up in front of incoming traffic. Light-duty and heavy vehicle traffic are now separated entering and exiting our production site and we have been able to increase the number of truck parking spaces from seven to 14.

The new scale is above-ground and longer than the previous one. Guevara said the scale is more accurate and will no longer require integration truck axle weights.

The weighing process has been improved and simplified and the reliability of the system and scale electronics exceeds industry standards," he said.

He thanked interior and exterior personnel for their help in getting the project to completion, including the Fort Madison plant and construction workforce, contractors, and vendors.

"It took a lot of collaboration and

patience from all of us to ensure that we completed a project of this magnitude with no safety incidents and, for that, we are extremely proud," he said.

Climax Molybdenum President Mike Kendrick said it's been the company's pleasure to be part of the community for the past five decades.





## Hounds face No. 4 Mt. Vernon without Wiseman

FORT MADISON – Fort Madison will take on the No. 4 team in the state in Class 3A Friday a little banged up.

The Hounds will be without junior Brody Cashman who's sidelined with an ACL injury, and now senior wideout Henry Wiseman is done with an ACL injury.

The Hounds take on Class 3A No. 4 Mt. Vernon on Friday night on Youel Field at Fort Madison High School down the two Bloodhounds. They are still limiting senior Teague Smith to defense only as he suffered a knee injury during wrestling season last winter.

"I don't know. I've spent a lot of time researching that for (Athletic Enhancement). I even had my students do research on it. That's 150 kids looking into what's happening," said Head Coach Derek Doherty.

"I just don't know why this is happening to those boys. You can't replace a player like Henry Wiseman. You can't replace any of them. It's heartbreaking.

"But he was back out there at practice talking with the kids. That's just the kind of kid he is."

Fort Madison has been snake bit by knee injuries in the past couple years. They lost Xander Wellman last year as a senior when he blew out his knee playing soccer for the Hounds two seasons ago as a junior. Jacob Pothitakis had the same injury for the Bloodhound soccer team the same year about two weeks before Wellman.

The Bloodhounds are 4-2 on the year with three games left. They are 1-1 in district play and are currently ranked 20th in the Class 3A Power Rankings. Playing in one of the toughest districts in Class 3A could have playoff implications even with a loss on Friday.

Doherty said his team is 0-0 and looking to be 1-0. That's the mantra of the Hounds all year. They got that done last week with a last-drive win over Keokuk in the annual county rivalry.

Mt. Vernon comes in with an efficient offense led by Joey Rhomberg who's completed 62% of his passes

for just about 1,300 yards and 12 TDs against three INTs. Cooper and Jackson Hird have combined for about 600 yards on the ground and three scores. And the Mustangs' Evan Brace is dangerous downfield with 528 yards and five scores.

With all the potency, it may be the defense that is more to be feared. The Mustangs come into the game with 34 sacks on the year. They are not afraid to blitz from both ends and up the middle and keep quarterbacks off balance.

That much pressure does make teams a bit susceptible to the run and that's how Mt. Vernon suffered their only loss of the year. The Mustangs gave up 28 points in the second quarter to Solon which was too much to overcome, but the telling stat was the 218 yards and three TDs they gave up to Solon sophomore Conlan Poynton.

Doherty said that kind of pressure up front will make it critical for the line to do their jobs.

"At the end of the day, it's our 11 vs. their 11. We just have to do our jobs. But what people aren't seeing is that our offensive is getting better and better by the week," he said.

That was evidenced on the last drive of the game last week when the offensive line and wideouts opened a huge hole for quarterback Marcus Guzman to rip off an 18-yard run on 4th and 7 to set up the Bloodhounds' game winning score.

Wiseman was lost for the season on that drive.

Guzman's thrown for 1,064 yards and eight scores, but has also thrown eight picks. He's also rushed for 263 yards and seven scores.

Guzman's completed passes to eight different receivers this year and he'll have some different faces out there as Noah Swigart, Henry Morris, and Caleb Bolander will rotate in with Cade Denning and Leif Boeding as wideouts. Senior Hayden Segoviano has also racked up some receptions out of the backfield. He has 244 yards but has yet to find the endzone. Boeding has 220 yards and one score.


## IWD names new division director

# Facility could be open by the start of the new year

colder temperatures set in, the dogs have an indoor facility to allow them to get out of the cold Iowa temperatures. Brown said the big dogs like Huskies and St. Bernards, which thrive in the colder temperatures, will still be able to be outside.

The current facility is 1,800 square feet, but the new facility will be more than 20,000 square feet.

Brown said that increase in size is coming at the right time. She said pet adoption has bottomed out over the past six months as a result of the economy and post-COVID.

"A bag of dog food has gone through the roof. The cost of everything is going up and pets are no exception. Adoption has just bottomed out and we have a lot of animals right now," Brown said.

"We come in and say is it big enough, then we come again and say, 'Oh, this is really big,' then the next time...is it big enough. It's going to be a beautiful building and they are really working hard to get it done," she said.

The new facility will have indoor kennel runs on the south side of the facility with outdoor dog areas in between each kennel run. Those runs have 32 kennels per run giving them more than 100 kennels. The north side of the facility is reserved for cats and cat runs.

There is also a surgical suite included for spaying and neutering and other medical needs. Every room in the facility will have a floor drain for easy cleaning. Brown said the plumbing and HVAC work accounted for more than \$1 million of the construction budget. She said the kennels and dog runs were also more than \$1 million to build.

"In animal shelters, that's where the money is spent. It isn't spent on niceties, it's the infrastructure and animal safety that gets the attention," Brown said.

There will also be meet-and-greet rooms for potential pet owners to sit with the animals to see if they are a nice fit. There is also room for expansion on the west and north sides. Brown said she'd like to build an outdoor pet park where people could take animals they are thinking of adopting to a "park" to see if a good relationship exists.

She said the new facility will bring a

richer sense of individualism and professionalism.

"We'll have greeting rooms where you can sit and interact with the dog. People won't be coming and going and the phone won't be ringing. It will be more professional and way more comfortable," she said.

"Right now, we have so many animals and it's so noisy inside that we just take people outside to talk. We sometimes even have to go outside to take a phone call."

Prior to the pandemic, Brown said the shelter had raised enough money to complete the project. Now with procurement issues and costs escalating, funds are coming up about \$1.5 million short.

"We may have to go to some banks and tell them this is where we're at. We're looking at doing a few more fundraisers to try and wrap it up," she said.

"We felt we were very good stewards of the people's money. We wanted it to look nice and be timeless so we went with materials that will last a long time. We didn't want it to look like a Morton building and the designers did a good job with that.

"Eventually after we're done here, we've talked about our own dog park on the west side where potential pet owners could take their dog out for a walk and interact with the animal. Not for the public, but for people looking to get a feel for the animal."

Brown said the facility will probably be one of the top five facilities in the state with the Animal Rescue League facility in Des Moines being the largest. This project has been downsized by about 10,000 feet.

Brown even took painters' tape and taped off the size of the kennels, brought tables in to represent the walls and then got down on her hands and knees and crawled around to see if the big dogs would have enough room.

"I'm visual. I have to see it. I made them do that twice because I wasn't sure. So a lot of thought has gone into this. Pebbles and Schickedanz have been great.
