BHS bounces Lady Hounds

SENIORS: Head Coach Knustrom says it will be tough to replace seniors

FORT MADISON - Kelly Knustrom didn't want to say goodbye to her seniors.

The Fort Madison High School volleyball coach tried holding back the tears after Tuesday's three-set loss to Burlington High School in a Class 4A Region 8 quarterfinal at FMHS.

But as hard as Knustrom tried, she couldn't do it.

"Yeah, it was tough," Knustrom said of the defeat.

The 25-21, 25-16, 25-13 loss to the Grayhounds (18-22) wasn't like the two previous matchups this season. Fort Madison won a five-set match at Burlington on September 26, then followed that with a two-set win in the Southeast Conference tournament.

Burlington, which advances to play at Oskaloosa in Thursday's semifinal, controlled this match from the beginning. The Bloodhounds challenged Burlington in the first set, but the Grayhounds had long runs in the second and third sets to control the pace of the match.

"I feel like they made some adjustments since the last time we played them, and it worked out," Knustrom said. "I thought we were a little tight, maybe. Kudos to Burlington. They came into our gym

Internships bring fresh eyes to GPAEA

Few details released in Oct. 8 stabbing incident at prison

FORT MADISON - Few details on an Oct. 18 stabbing at Iowa State Penitentiary in Fort Madison have been released by Department of Corrections officials.

According to reports, an air MedEvac helicopter was dispatched to the east side of the prison grounds to take an offender to Iowa City hospitals with

injuries sustained in the altercation.

Nick Crawford, a spokesperson for the DOC, confirmed the incident late last week but provided few details.

"I can confirm there was an altercation that took place Sunday evening between two inmates," Crawford wrote in an email to Pen City Current.

"One of the two involved was taken to the University of Iowa Hospitals and Clinics for further treatment and evaluation and has since been released back

to the institution."

Crawford said the altercation was quickly brought under control by security staff and no staff members sustained injuries as a result of the incident.

Crawford declined to comment on the exact time of the incident and what type of weapon(s) were used in the altercation.

The incident remains under investigation.

Grow your Event grants offered

Applications are being accepted until Oct. 31

BURLINGTON - Need Help Hosting an Event in Greater Burlington? Applications are being accepted for the Greater Burlington Convention & Visitors Bureau's Grow Your Event Grant, previously known as the Community Event Funding Grant. Completed applications for events in 2024 are due by October 31, 2023.

Since 2008, over \$300,000 has been awarded to support events in Des Moines County. Events supported by this grant draw visitors to Greater Burlington and customers to area hotels, restaurants, and stores. More than a few new residents have cited local events, and their contributions to quality of life, as major factors in choosing Greater Burlington as their new home.

The Convention & Visitors Bureau

sets aside a portion of its budget each year to offer financial assistance to area events. This funding is acquired through the collection of Hotel/Motel tax dollars.

All area events are eligible to receive free services offered by the Convention & Visitors Bureau. These services include assistance with planning tours and special activities, securing room blocks, bid proposals, Greater Burlington community information, and pre-event planning assistance. USDA surpasses \$1.7B in CRP payments

WASHINGTON, Oct. 16, 2023 - The U.S. Department of Agriculture (USDA) has issued more than \$1.77 billion this year to agricultural producers and landowners through its Conservation Reserve Program (CRP), a critical piece of the Department's efforts to support climate-smart agriculture and forestry on working lands. Right now, CRP's more than 667,000 participants received payments from USDA's Farm Service Agency (FSA) for their voluntary conservation efforts on more than 23 million acres of private land. Since 2021, CRP has grown by 21 percent in terms of acres enrolled, testament to the Biden-Harris administration's program improvement efforts.

"Through the addition of tools to sequester carbon, reduce greenhouse gas emissions and better quantify these efforts, while also bringing into the fold more Tribes and underserved producers, we've made the Conser-

vation Reserve Program better for our nation's natural resources and for our agricultural producers and landowners," said Agriculture Secretary Tom Vilsack. "These producers and landowners voluntarily place their land under contract and, in the spirit of stewardship, agree to establish and maintain prescribed conservation practices for the life of contract. We're grateful to all CRP participants who are making a tremendous difference by proactively addressing climate change and conserving natural resources now and for future generations."

It started out as an emotional night for the eight seniors, including Irelynd Sargent, who was in uniform after missing the entire season while she recovered from a knee injury.

“I was getting texts today from the kids, wanting her to run out with them at the start,” Knustrom said. “She 100 percent deserves it. A lot of kids would have just said, ‘I’m good.’ But she was here at every practice. There’s something about Irelynd. She brings a spark.”

Fort Madison finished the season 6-32, but the Bloodhounds were at their best in the five-set matches, going 4-0.
