# Nothing left behind

The tears and hugs were for the cruelty of the finality. Holy Trinity's three-set loss to Ankeny Christian in Thursday's Class 1A state volleyball championship match set off sadness for the Crusaders.

Not because of a lack of effort or a failure of execution, but more from the reality of the postseason.

Forty teams in five classes showed up at Xtream Arena for the state tournament. Thirty-five of them left with a loss.

Those are never good odds in the crucible of the postseason, but hopes grow with each step, and the Crusaders took every step but the last one.

That, junior libero Teagan Snaadt said, was something to appreciate.

"It hurts," Snaadt said. "But we worked hard all year, and we can't dwell on what we didn't do great today, but what we did (all season)."

The Crusaders won 33 matches overall. They did not lose a match in the SEI Superconference South Division, an impressive zero in a division loaded with talent.

Their postseason run was almost perfect until the



championship match — only one set lost in the four regional matchups and in the first two rounds at the state tournament.

It was an efficient, surgical stretch — some of the wins were dominant, others were by a strategy of steadiness, keeping pace with an opponent until a weakness could be found to exploit.

And then the final round came against an opponent that had lost only three times this season and was looking to repeat as champion.

Ankeny Christian's defense was a blanket that seemed to get to every Crusader shot. Holy Trinity had just 29 kills in the three sets, unable to cut the lines of power to the Eagles' hitters, who produced 45 kills.

Photographing Holy Trinity's run through another state volleyball tournament opened my eyes to many things this year. Yeah, we've all been there and done that, but these people in cobalt blue t-shirts are some of the most positive people I've met.

I hung around with many of them prior to Tuesday's, Wednesday's, and Thursday's matches and the mood was always one of excitement. They've been here before and done that, too. But the pitch of energy is high every night.

Despite getting swept in the finals by Ankeny Christian and the tears that come with it, there was a very positive message – from a lady who's almost camouflaged on the sideline.

Karen Becker has been on the sidelines for HTC volleyball for more than two decades, and her husband Darrell was always tucked away about four rows up in the home stands.

Darrell died unexpectedly on Sept. 13 from a massive heart attack. Karen was returning from work and found him on the floor unresponsive.

One might think the last place in the world she would want to be is in the one



After a very long season and her tragedy, this woman still hollers encouragement to her Crusaders - a sentiment not lost on head coach Melissa Freesmeier.

"She's our star, our superstar," Freesmeier said wiping tears from her cheeks. "She knows these girls better than anyone and has been there for them for a long time. It's been a very hard year for her and a difficult year for the girls. But she's a star. And we're not who we are without her."

Sitting with Becker following Thursday's loss. She carried the same sweet smile and a twinkle in her eye that clearly was where she carried Darrell.

"There were 122 teams in the state that started this at regionals. That's about 1,850 girls. To end up being in the final 30 girls. That's a huge accomplishment and they need to know that," Becker said.

"We'll still be there to support each other.

"Anna and I are really, really close. We don't argue much, we get along super well on the court and we lean on each other a lot after one of us makes a mistake. There's a lot of chit-chat that goes on between us that I don't think people realize that bond that no one else has on the team because they don't have siblings who are out there on the floor. So that's something special."

# City could save \$500K on latest portion of Hwy. 61 project

FORT MADISON – The Fort Madison City Council will hold its regular meeting Monday night so as not to interfere with the city's School/City general election on Tuesday.

The Council will consider a change order to the Hwy. 61 reconstruction project from 10th to 18th Streets. But the change order will actually reduce the contract by close to half a million dollars.

Fort Madison Public Works Director Mark Bousselot teased the council two weeks ago about a change order that could reduce the overall project cost.

According to a report filed with the council on Friday, the fourth change order on the project will reduce the overall cost of the project by \$492,722, a rare occurrence in city projects over the past six years.

The original cost of the project, which was awarded to Jones Contracting of West Point, was just under \$8 million at \$7,956,777. Previous change orders bumped the contract up slightly to \$7,962,267, or about \$5,500.

The new total contract amount will be for \$7,469,545. A report from HR Green Inc., the city's engineer on the Hwy. 61 project, a quantity reconciliation that balances the amount of quantities actually used on the project resulted in the adjustment.

The council will also be considering a change order on a separate project. The Fort Madison Marina's asphalt paving. The council originally approved a contract in the amount of \$525,216 with Norris Asphalt Paving Co, on June 6. Due to a change in the projected square footage of asphalt to be put down, a change order in the amount of \$227,712 will be considered for approval, increasing the cost of the project to \$752,928.

The city has a 25-year lease with the non-profit Southeast Iowa Aquatic Restoration Group, Inc. As part of the lease agreement, the non-profit reimburses the city for the cost of the asphalt paving.

In other action, the council:

- will consider a second reading of an ordinance amending the city's code with new language implementing the International Property Maintenance Code as part of a new Dangerous Buildings Chapter.
- will consider the final reading of an ordinance rezoning property north of 2205 48th Street from R-1 to I-2 General Industrial District to accommodate the new PAW Animal Shelter.
- will consider a resolution to accept a bid for city property at 1730 Avenue H, (the former Jiffy Lube) from Kapo Realty, Ltd., in the amount of \$155,000 in the event that no other acceptable bids are received. Bids should be submitted to the city by Dec. 8 at 1 p.m. Bids will be presented to the City Council on Dec. 19.
