# Council can't reach consensus on city manager

## Three hours of closed sessions result in another review of candidates

FORT MADISON – The search for the next Fort Madison City Manager has come to a reboot of sorts, according to Fort Madison Mayor Matt Mohrfeld. After three months of framing the search, which resulted in three candidates and three different closed sessions of the Fort Madison City Council, no consensus has been reached on who should be the next City Manager. Fort Madison Mayor Matt Mohrfeld said Wednesday the search isn't going to back to square one per se, but going back to the pool of candidates that was generated from the search isn't out of the question.

"We're not going back to square one, but we will be taking another look at the candidates we have, and we may bring another two or three to consider," he said.

Mohrfeld said he couldn't violate the privacy of the closed session meetings, which included department heads, select community members, the city council, search firm members, and the city attorney. Because a decision has not been made, and, according to city closed session agendas, the candidates requested the meetings be held in closed session per Iowa Code Chapter 21.5 (i), the names of the candidates were



brought into town on Friday and escorted through the Wine & Beer Walk Friday night, and then were involved in morn-

not made public.

Three candidates were

with all the members of listed above in a rotating format. The council then held a closed session Saturday following the interviews to consider the candidates. That process spilled over to another closed session on Monday, which carried over to another hour-long closed session on Tuesday.



# City manager search in secret OK - for now

There were rankled moods this past week as the city council went about their due diligence in finding a new city manager.

There's some in the city that don't feel like we need a city manager. That we can rely on department heads who are trained to do what they do to handle the city's day-to-day affairs. There's some legitimacy to that argument, but the biggest argument is that it would save the city about \$150,000 a year in salary and benefits. But, there's a bigger concern to take into consideration –

Image. Image is everything. Especially when you're trying to recruit 1,000 people to the city in the next four years.

You need a professional face on your organization. An unelected professional face.

The person that makes the trip to Des Moines, and Washington, and attends the local economic development meetings, and understands state and federal government codes... all the while respecting transparency at all possible turns.

David Varley did a decent job. He was conservative and had an old view of government financing. He carried the belief that you had to have more money coming in than going out and that extended to debt service, as well. He railed against debt spending, but executed the direction of the council. He got emotional about his role because he was hired to usher the city in the direction of fiscal responsibility and progress. One thing he did that didn't sit too well was engaging in a little bit of misdirection when it came to the media. The Old Fort scenario comes into play with

After Tuesday's session, the council came back into a public format with no consensus reached on the candi-

## City could see additional costs in search

dates.

"We are in the process of tyring to hire a city manager. At this time we did not reach a conclusion and we are not extending an offer to a candidate at this time. We will continue to search," Mohrfeld said during Tuesday night's City Council meeting.

He said the additional search will likely come with a slightly higher price tag based on the city's contract with Hinson Consulting Inc. of Mason City, but he didn't anticipate a substantial increase in cost to the city.

The city has been working with Southeast Iowa Regional Planning Executive Director Mike Norris and the Hinson group throughout the search process. They are replacing former City manager David Varley, who resigned from his position in May.



# **Task force makes arrests** on felony drug charges

WEST POINT - The Lee County Narcotics Task Force reports the arrest of a West Point man and woman on felony and misdemeanor drug charges.

According to a release from the LCNTF, Richard Edward Huffman, age 60 and Peggy Ann Huffman, age 59, of West Point, IA are both charged with; Manufacturing marijuana, a class D felony; Possession of marijuana with the intent to deliver, a class D felony; Possession of 3,4-methylenedioxymethamphetamine (MDMA) with the intent to deliver, a class C felony; (4) counts of Iowa tax stamp violation, each count is a

of cocaine,

The charges came after

the Lee County Task Force executed a search warrant at a residence in West Point. There it is alleged that both Richard and Peggy Huffman were in possession of controlled substances and drug paraphernalia.

The Lee County Narcotics Task Force was assisted by the Fort Madison Police Department, the Lee County Sheriff's Office, and the Lee County Attorney's Office.

The defendant's in this case are presumed innocent until proven guilty. The Lee County Narcotics Task Force is funded in part by the U.S. Department of Justice and the funds administered by the Iowa Governor's Office of Drug Control Policy.

# Selection of city manager requires heavy discussion

information released before the city was prepared to release it. Then a 24-hour run-pass option on what the media was told.

But, as we observe the process being undertaken to hire the next city manager we watched with a wary eye as the city council invited community members, department heads, the city attorney into closed sessions to evaluate the qualifications of three candidates recommended from Hinton Consulting out of Mason City.

Many, including those on the council, were concerned about the number of people in the closed session. We would assume that members of the public would be just as concerned with that dynamic.

However, it's legitimate. The council can, per Iowa rules, invite whomever they want into closed session. We, as a news organization, watch that closer than anyone.

We are content. In this one instance, we are content.

It's imperative the city get the right one person to lead the progress that's being undertaken. The one person that gets that sometimes you have to deficit spend. It should be rare and when absolutely necessary to make something happen when it can't happen later. When interest rates, or bonding capabilities, or markets, or sheer public need dictates that now is the time to act, you need someone with insight in that moment.

Clearly, that isn't the only litmus test for a good city manager. Someone with proven communication skills, negotiation skills, abilities to work within multiple departments and balance multiple projects at the same time. The ability to work with politicians, residents, economic development officials, business leaders, and yes, the media, sometimes all in the same day.

The exposure to the media in Fort Madison is somewhat diminished compared to larger metro areas. But there are several reporters locally now that push for transparency and following rules set out in Chapters 21 and 22 of the Iowa code.

These closed meetings were necessary to allow an open and frank conversation around who is the best candidate. As long as the conversations are focused on qualifications only, not gender, race, or religious preference, but qualifications.

Let's not be confused here. You can have those frank discussions in open session, but the people having them have to feel comfortable doing that in public. That, very rarely, is the case.

So having an evaluation of a potential employee in closed session is legitimate. It becomes even more legitimate if that person is applying unbeknownst to his/ her current employer because that's where the threshold of the "irreparable harm" language of the chapter 21.5 (i) could be reached.

So instead of protesting the closed session, which we regularly do, we're going to sit and watch this one. We may ask for recordings of the sessions following the selection process for the candidate who is hired as the irreparable harm language would be negated, but we may not.

The bottom line is the city is doing the right thing in assuring they get the most raw conversation with potential candidates they can get. The process could very well be the story, but in the interim, we will continue to monitor the situation with a watchful eye.

That watchful eye is also looking at other potential items, like a proposed wind generation field where the companies interested weren't sure if they had to go through the Iowa Utilities Board, or whether they would use eminent domain for land grabs. We're here and watching, but That's Beside the Point.

# Siemens outlines plan to fix wind business by 2026

HAMBERG, Germany - At its third Capital Market Day in Hamburg, Germany, Siemens Energy presented a strategic outlook to analysts and investors. The Executive Board outlined a clear path to create shareholder value along three priorities: Deliver on profitable growth, fix the wind business and maintain a solid financial foundation.
