## Drug abuse survey coming

LEE COUNTY – Lee County has assembled a committee to look into how to spend more than \$1 million it is projected to receive in the next 15 years.

The county has received about \$245,000 in settlements from manufacturers and distributors of opioid pain killers that have become a focus of the nation in regards to substance abuse. The settlements have come from potential lawsuits that lay the blame of the nation's fight with opioid overdose at the feet of the manufacturers, distributors, and pharmacies that have downplayed the addictive nature of the drugs.

The county joined the national class action lawsuit against the companies in 2022. In addition to the \$245,000 as part of the National Opioid Abatement Trust, the county is scheduled to receive an additional \$900,000 over the next 15 years in current settlements.

The panel consists of nine members with Brian DePriest representing Keokuk Police, Darren Ranck representing the non-incorporated communities in the county, Michele Ross, Lee County Health Department Administrator, Lee County Sheriff Stacy Weber, and District 8B Judge John Wright.

## Seniors to play big role for Hounds this season

Cresswell, Rashid, and Boeding lead athletic group of Bloodhounds

FORT MADISON - Fort Madison boys basketball coach Ryan Wilson has seen how quickly things can turn around with experience.

Wilson's 2020-21 team went 8-12, then, with almost everyone back the following season, went 18-5.

Last season the Bloodhounds went 6-16, then brought almost everyone back for this season.

It's a long way from now until February — Fort Madison opens the season Friday with a home game against Southeast Conference rival Fairfield — but Wilson has confidence his team can have another big turnaround this season.

"They're all back," Wilson said. "They know our system, they know our defense, they know the out-of-bounds plays. We're putting in a new offense, but there are some similarities to what we did last year. So to have that experience back, it's pretty important."

Fort Madison brings back four starters — seniors Hunter Cresswell, Carson Rashid and Leif Boeding, and junior Julian Dear. Combined, the four started 83 games last season.

"Those four, together, bring back a lot of experience, because they basically started every game last year," Wilson said. "They worked out together in the summer, played AAU ball. They've had some time to play and come together."

Cresswell led the Bloodhounds in scor-

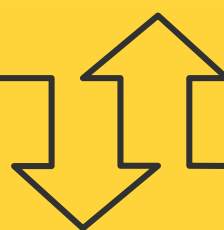

Gary Dean Eilers, 81, of Keokuk, passed away on Monday, November 27, 2023, at Blessing Hospital in Quincy, Illinois.

Gary was born on August 7th, 1942, in Quincy, Illinois, the son of Arnold "Capp" and Darleen (Ehman) Eilers. He was baptized at Trinity Lutheran Church on August 30, 1942, in Golden, Illinois, and was confirmed there on March 25, 1956. He attended grade school in La Prairie, Illinois, and graduated from Central High School in Camp Point, Illinois, on May 27, 1960. He was active in school sports and received the student of the year award.

After graduation, Gary worked with his father at the family's farming operation. In November of 1961, he joined the United States Army, serving for six years in active duty and the Army reserves, receiving his honorable discharge on October 31, 1967. On December 27, 1975, he was united in marriage to Donna Jean (Fecht) Marshall of Keokuk, Iowa, welcoming her children Greg and Sherri.

He remained an active member of First Lutheran Church.

Gary took so much pride in his grandchildren. When they were younger, he spent every weekend playing their pretend games and teaching them how to play cards. He was notorious for his yearly Easter egg hunts for the grandkids that typically ended with some missing eggs found later that year. As they got older, he enjoyed sharing his love for baseball with them while playing pitch and catch in the backyard and could always be found supporting them at their sporting events; Kaelie with her softball pitching

and in high school, her pom-pom routines; Megan playing volleyball and softball and Siarra playing softball and running cross-country. He was their biggest fan. ## Committee will start work on countywide assessment

**SURVEY** - Continued from Page 1

Michele Ross said it's good there are representatives from all parts of the county, but she said to make a dent in the misuse, the county needs to have a strategy.

"You can't say, 'Oh I'm gonna try this, or we're gonna try this,' we really need to have a comprehensive county plan of how we can all work together as partners, not just those of us at the table."

She said the focus has to be on prevention, treatment, and recovery and not just one or the other.

"You also need people with lived experiences telling their story and helping guide what works and what doesn't," she said. "If you have someone incarcerated there and then they are released and what happens. They go back to using."

She said building strategies around helping the person from incarceration into treatment and then recovery, and then staying recovered.

Lee County Supervisor Tom Schulz said a rough outline of a comprehensive strategy would allow the panel to evaluate how applications for funding would fit into the strategy.

Ross asked if the county should do a needs assessment and define areas of concern. She said one of those is the waiting period for treatment, which is as long as three months currently.

"By the time you get someone into treatment, they've either used again or have no interest in going," she said.

Ross said she would take the lead on putting together a coalition to start looking at how to get a community needs assessment around substance abuse started.

Chuck Vandenberg, Lee County's Grant Writer and American Rescue Plan Act funding administrator, is secretary of the committee and said the county could be in line to see more funding come in as other settlements work their way through the court system.

He said the county has already signed on to settlements with Teva/Allergan, Walgreens, Wal-Mart, and CVS, which should generate a similar stream of funding to help the county deal with opioid abuse.

"He's very athletic, plays some more on the perimeter now, can go inside or outside," Wilson said. "There's a dynamic to his game — his skill set is pretty strong."

Rashid led the Bloodhounds with 33 3-pointers last season. Boeding led them with 57 assists, and Dear was second with 55.

Junior Dayton Lamar returns after playing in 21 games last season with one start. Lamar had 103 rebounds, second on the team. Nolan Guzman played in 17 games as a freshman.

"We've got a lot of guys who can do different things for us," Wilson said. "I like our balance."

Wilson also has two foreign exchange students on his team, with one, Jan De Gracia Hernandez from Spain, getting a start in one of the Bloodhounds' scrimmages.

"He's a nice little guard," Wilson said. "You can definitely see the European ball skills, the European basketball, in him, from how he passes the ball, how he reads things. He can knock down open shots, and he's a really tough defender."

Defense, though, will be the key for the Bloodhounds.

"If we can play defense, not get beat off the dribble, make our opponents really work the shot clock, and then finish the possession by rebounding the ball, it will be big for us," Wilson said. "There were times last season when we didn't do it, and it hurt us. But if we can do that, we'll be a much better team this season."

# Hounds suffer rare dual loss

FORT MADISON – It was rare air at the Hound Dome Thursday night.

Fort Madison's boys' wrestling team was overwhelmed by the Quincy Blue Devils in the season-opening dual 48-24.

Twelve of the Hounds points came on forfeits at 106 and 175, the other twelve came on pins by Logan Pennock and Nolan Riddle.

Fort Madison Head Coach Ryan Smith, who rarely minces words or makes excuses for losses, said the Bloodhounds have some work to do, but it's still early in the season.

"I expected us to fight back better. We let them come in here and represent. That's all there is to it," he said. "We can either pout about it or get better. Those are the two choices."

Pennock was the most aggressive Hound wrestler on the night, jumping all over Quincy's Austin Ragar. Pennock snapped Ragar to the mat quickly. Ragar worked his way around Pennock's wrestling style, but Pennock snapped him back down to the mat 50 seconds into the first period and then got the pin eight seconds later.

Riddle had to do a little more work to get his pin, but had control of the match and Quincy's Gunnar Derhake most of the way, getting the pin just a second before the first period expired.

The night got off to a rocky start when 5th-ranked Teague Smith couldn't shake off Bryor Newbold. Newbold basically rode Smith for two-and-a-half periods, but Smith couldn't get to his knees to get to the offensive part of his game.

Head Coach Ryan Smith said that could have had an impact on momentum in the opener.

"It shouldn't. It could have, but it shouldn't," Smith said.

"There's a lot of wrestling left. We just got to get better," Smith said. "I applaud those efforts (of Pennock and Riddle) but I'm not in it for just two guys, I'm in it for 36 guys."

"We've all got to get better, varsity and junior varsity. Everybody's got to get better. This is not what I want to see out here as a product, obviously. Quincy is a good team, but we didn't put forth the effort to make it a better battle."

One of Fort Madison's other ranked wrestlers, Ike Thacher, was in street clothes and a left arm sling.

Caleb Bolander was the closest to getting any additional points for Fort Madison, but fell in the final seconds 8-7 to Cale Mixer at 138 lbs.
