# Reichman reacts to Sand

### **OCI DEAL:** State Sen. says Auditor, Dems out of touch on Iowa Fertilizer deal

#### BY CHUCK VANDENBERG PCC EDITOR

DES MOINES – Local State Sen. Jeff Reichman responded to comments made by Iowa State Auditor Rob Sand, a Democrat, about the pending sale of the Iowa Fertilizer Co. to Koch Industries earlier this week.

Sand said there wasn't anything political in his stance against the sale citing his role as the state's taxpayer watchdog. But Reichman said it's entirely political.

Koch has offered OCI Global \$3.6 billion for the facility and the deal is making its way through government regulations pertaining to the sale. OCI received more than half a billion dollars in state, local, and federal tax incentives about 10 years ago when the facility was constructed. It's been fully operational for the past seven years. Lee County agreed to a 20-year PILOT program, (Payment In Lieu of Taxes) where the fertilizer company makes an annual payment to the county instead of being on the property tax rolls.

That agreement started with \$370,000 payments for the first five years starting in 2015. It increases in five-year increments to \$600,000, \$1,000,000, and \$1.3 million for the final five years ending in 2035. That totals \$16.35 million over the

## Ollie man charged in murder of missing man near Ottumwa

KEOKUK COUNTY - On February 1, 2024, investigators with the Iowa Division of Criminal Investigation (DCI), Ottumwa Police Department, and Keokuk County Sheriff's Office served a search warrant at 21891 Highway 78 near Ollie. The search warrant was part of an effort to locate 40-year-old Craig Smith, who was reported missing on January 20, 2024.

During the search, investigators found the remains of an adult. The condition of the remains is preventing law enforcement from making a positive identification. Evidence and statements collected during the investigation have led investigators to tentatively identify the remains as those of Craig Smith. The State Anthropologist, the Office of the State Medical Examiner, and the DCI Crime Lab are working to make a positive identification.

# **Reichman: Ivory tower liberals object to OCI sale to Koch**

#### 20-year agreement, or about \$817,500 per year.

Sand characterized the proposed sale a "terrible thing" for Iowa and he was "up in arms" about the deal. He penned a letter to the Federal Trade Commission and the U.S. Attorney General's office in opposition to proposed sale.

But Reichman said Democrats have lost touch with southeast Iowa.

"Des Moines Democrats again prove they've lost touch with southeast Iowa. Rob Sand is so beholden to the crazy coastal liberals obsessed with Koch Industries, he had to pander to them by opposing the sale of the Fertilizer plant from OCI to Koch Industries," Reichman said.

"In the process he showed he's just another run-of-the-mill liberal despite his attempts to cast himself as something different. Only ivory tower liberals would object to an American company purchasing a plant from an Egyptian company. I know he's looking for something to do since he legally cannot perform his job."

Reichman said Dems have always opposed the fertilizer plant because they want to put government first no matter how many jobs the project created.

"It has generated massive amounts of jobs in southeast Iowa and has been a huge success. I think their opposition to the construction and permanent jobs created by the plant has contributed to them losing every legislative seat in southeast Iowa since construction started."

Reichman said OCI has been an "amazing and generous partner" in the community and southeast Iowa "will recognize the full benefits in the near future".

"I am personally excited about the sale and I share the excitement with Southeast Iowa Regional Planning, Greater Burlington Partnership, and Lee County Economic Development about the possibilities of expansion and investment. Koch Industries has a history of growth and investment that should be cause for excitement in southeast Iowa, not a grandstanding event for the auditor and an attempted slap in the face to southeast Iowa by Sand."

# Gehling gets game-winner

WEST BURLINGTON — Holy Trinity's boys basketball team was built for the closing moments of Saturday's SEI Superconference Shootout game against WACO at Loren Walker Arena.

Down by six points with 3 ½ minutes to go, the Crusaders scored seven, the last coming on Conner Gehling's layup with two seconds left, to take a 54-53 win.

Holy Trinity (15-4) extended its winning streak to seven games by making one final run against the Warriors (14-5).

"This year, we're battle-tested, and I think it showed there at the end of the game," Holy Trinity coach John Hellige said. "Huge win for us."

WACO led 53-47 after Reece Oswald's 3-pointer, but wouldn't get another point against the Crusaders. And when Holy Trinity forced a shot-clock violation with 15 seconds left, there was one last opportunity.

After a timeout, the Crusaders worked the ball inside, testing the defense against Luke Hellige, who was double-teamed. Hellige passed the ball out front, and Maddox Rung was able to deliver the perfect bounce pass to Gehling along the baseline.

Gehling sped right past WACO's Connor Leichty for the layup he called "the biggest shot of my life."

"Once I caught it baseline, I knew I had an opening to go right, and I just took it," Gehling said. "Great bounce pass from Maddox there, all credit to him. And then I just got up and scored.

"I saw some bodies go up with me, so I tried to elevate over them and finish, and I did."

"We were trying to get something down low to Luke or Conner there, and the ball found Conner's hands, and he made a great shot to win it," John Hellige said.

WACO led by seven points midway through the second quarter, by four at the end of the third quarter, and seemed to be in control after a 3-pointer from Clayton Miller with 4:10 to play, followed by the Oswald three.

"Basketball is a game of runs," Gehling said. "They're going to make runs, so we've got to get our own runs too. We've got to get some stops, too, and I think that's what we did there at the end."

"Sometimes this team forgets that it's 14-4, 15-4," Hellige said. "I'm like, 'Guys, we have to play with poise and confidence out there.' I think we showed at the end of this game that we've become a veteran team, a poised and confident team."

Gehling led the Crusaders with 24 points. Luke Hellige had 16 points, and Rung had nine.

WACO's defense was concentrating on Hellige, who averages 23.4 points.

"Luke's an amazing player, an all-star type player," Gehling said. "Once Luke is double-teamed or whatever, all of us have to step up as a team, and we did that tonight."

# Bloodhounds secure the 6th straight conference title

BURLINGTON – The Fort Madison Bloodhounds gave boys' wrestling coach Ryan Smith a final dual meet to be remembered with a 51-24 win over the Grayhounds at Clark Field House Thursday night.

Smith captured his 16th conference championship and 267th overall win in front of a crowd of Burlington and Fort Madison fans who gave the coach of almost three decades a standing ovation.
