# City resets event fees



The Fort Madison City Council met in regular session Tuesday night to discuss a number of issues, including a hike in city special event fees.

### **SOME UP, SOME DOWN:** Parks Director lays out new fee schedule for events in city

FORT MADISON - The Fort Madison City Council is trying to recoup a little bit of the costs of helping put on special events on city property.

At Tuesday's regular meeting of the council, Fort Madison Public Works Director Mark Bousselot presented a new cost listing that would charge event organizers for things such as delivery of picnic tables and electrical or water usage fees.

Other fees include a non-refundable \$25 application fee. On top of that are fees for barricades and traffic cone rental from \$3 each with a \$50 minimum. No parking signs would also cost \$3 each with a \$50 minimum.

Water and electric meter charges are \$75/meter per connection and city green space rental will be tallied at

In the parks and recreation department, shelter house rentals will vary and be billed separate from the \$25 special event permit fee. Picnic tables will be \$30 per table or \$150 per trailer load of eight. Garbage can delivery has been set at \$60 for six cans and a tent or bounce house inspection is \$30.

# Keokuk High adds agriculture program to CTE tract

KEOKUK, Iowa - The Keokuk High School will now offer Agriculture as a pathway for students as part of Career and Technical Education (CTE) after the School Board approved it on Feb. 5.

"Agriculture programs work so well within the community, it is

not just about the kids that live on a farm, it is a lot about leadership," Nathan Harrison, KHS principal, said. "You don't have to be a farmer to be in the agriculture business, the benefits to students are endless."

The addition was proposed based on the results of a recent interest

survey conducted with students in grades ninth through twelfth at KHS, and the results showed a high interest in agriculture. The board also discussed the scholarship opportunities through FFA and

 $\mathbf{T}$  he beeping of the vitals' machine I was attached to was annoying. It started beeping when my pulse dropped below 40 beats per minute (normal is 60-100). I watched my pulse drop...38...32...29. Plus it would skip a beat now and then. Uh,

That was the reason I was in the hospital at Southeast Iowa Regional Medical Center in Burlington. I had gone to a physical therapy session at the hospital. I was doing physical therapy for a balance issue I was having. And the therapists seemed to be making progress curing my light headedness and wobbly legs. However, on this day, when I reported in, feeling dizzy to start with (they don't like the term "dizzy" or "vertigo"), the therapist checked my pulse. It was 36. "Yikes," she said. "No wonder you're feeling woozy. I'm calling cardiology."

I've always had a low BP and pulse due to my aerobic exercise. But not that low!

Much to my embarrassment, I was wheeled to the emergency room and admitted to the hospital. My ER Doc was a person I knew from church, Brandon Beauchamp. It was comforting to see someone I knew and liked. Small world. The heart doctor, Dr. Lazar, was friendly and radiated confidence. After studying my echocardiogram, he said, "Curtis, you need a pacemaker. Would tomorrow fit your schedule?"

"It would," I said, "but call me Curt, please." And that was that.

Ginnie just missed seeing the doctor because she had to have her hair appointment before coming to see me. She likes to maintain that "Uma" look from Quentin Tarantino's, "Pulp Fiction." Fine by me.

Doc was small in stature, yet he was a larger than life rugged commercial fisherman that could weave a tale with incredibly colorful language. He knew every bend and current of the river, every secret spot and every trick to catch more fish. He was a man who faced the dangers and uncertainties of the river with courage and faith. He never gave up, never backed down, never lost hope.

ROCKHOLD Later in his tenure, Doc had the honor to serve as the President of the Illinois Commercial Fisherman's Association, working alongside lawmakers to ensure sustainable livelihoods of the profession for generations to come, while balancing conservation of nature's resources. Doc was a proud Korean War veteran with the US Army.

Those closest to Doc know he truly enjoyed being around people he loved most in life. His endless stories with his brother Jeff, Tom Maynard, or your pick of one of the Gilpins was always a riot, especially if he worked in a joke or two in right after. Doc was an avid race fan that loved Dale Earnhardt (not his "bonehead kid" though"), Kyle Larson, and 2002 Daytona 500 winner Ward Burton.



Above all, Doc's greatest source of pride was his family. He and Peggy often took trips to places like Louisiana and Galveston, Texas and had the time of their lives. They danced, ate the types of food the notoriously picky eater Doc was would never try back home, and Peggy would even get him to fish with a pole and line — blasphemy! Doc always loved when his boys Sam and Shawn would come home to visit or when they'd call to check in. He constantly gave everyone updates on them, as you would expect of a proud father.

# City OKs police, fire deals

The picnic table and garbage can delivery will only be available for events held on cityowned property or right-of-way.

There will also be a \$15 per day food vendor license or \$40 for 3 days and carnival fee of \$25 per day or \$100 per week. A liquor license will be allowable and varies. Police security will be billed at \$70 hour/office and fire permits will cost \$20.

With the addition of some fees, the city has also eliminated fees that are associated with the number of participants. Currently, the scale is progressive and increases by \$25 up to 10,000 participants. Those fees are now no longer applicable.

The delivery of picnic tables and garbage cans has tripled under the new schedule. The food vendor and carnival fees, security and fire permit fees are all remaining the same. Prior to the new fee structure, the city didn't charge a special event fee.

The city passed an ordinance for special events in 2023 and that ordinance allows for organizers to approach the city council and ask for fees for special events to be waived for the benefit of the community.

Bousselot said when the council passed the ordinance for the special event application, the new code required the city to see fees for the events by resolution and that was what he was presenting.

"Matt (Mohrfeld) is probably going to say that we shouldn't be charging special event fees because they bring money into our community," Bousselot said.

"But we still have to have a fee associated because each time I'm charged for a special event, that money's coming out of something and we've talked about it coming from hotel/motel tax funds."

Mohrfeld said councilman Rusty Andrews, who wasn't in attendance, was charged by the mayor with evaluating the fees said Andrews' opinion would very likely be the city shouldn't be charging anybody for anything.

Councilwoman Angela Roller said she had concerns about the city possibly charging one group a fee or fees, but then waiving fees for another event.

"My issue is if we do it for one, we have to do it for all. Then it comes back to why do we have the fee? I don't want to sit up here and say one event has to pay and another doesn't," Roller said.

Bousselot reiterated that the current code allows people to come to ask for the fees to be waived.

"You're getting into it based on that ordinance we passed," Bousselot said. "You're going to have people coming and asking, guaranteed. You had it before the ordinance was in place and you're going to have it now."

Roller said she understood but she reiterated that she had trouble waiving it for certain people or groups and not others.

Bousselot said they have to have a fee so they know what to take out of hotel/motel taxes to pay for the services, or the group would have to pay.

"Think about it. We're taking it, loading it up, we're hauling to whatever site, and going back to pick it up again. There's labor associated with that and vehicle wear and tear," Bousselot said. In other action:

- the council approved signing off on a Federal Recreational Trails grant to help with Phase V of the PORT Trail on 48th Street, The grant will help reimburse engineering and design fees.
- the council entered into a continuing agreement with Alliant Energy for Interruptable Service at the water plant in exchange for a discount on rates charged to the city.
- the council approved contracts with the city fire and police department unions for two years. The agreements allow for a 5% annual increase with no health insurance premium increases.
- the council approved appointing Melinda
  Blind to the Fort Madison Housing Authority,
  Adriene Jenkins to the
  City Library Board, and
  Savanna Collier to the
  city's Planning and Zoning Commission.

# Divine intervention lands author in hospital

The surgery was simple. Only a local anesthetic and light sedation were used. The pacemaker is about the size of the crystal on my watch. It was inserted in a "pouch" just under the skin by my left collarbone. Wonders upon wonders, my pulse straightened right out, tacking along at a cool 72 bpm, with no skips. They're telling me I will feel a lot better and have more energy. Yippee!

I'm somewhat amazed that I have heart issues, considering all the aerobic exercise I've participated in over the years: running, biking, swimming, which included marathons and triathlons. Most recently, when I kept stumbling and falling while running, I switched my morning workouts to the elliptical machine. I was convinced I was living a heart-healthy life style. Shows-to-go me.

But my low pulse problem, wobbly legs and light headedness were not from any inner ear problem, arterial blockage or heart weakness. It was an intermittent blockage of the electrical signal from the atrium to the ventricle. My 75 year old heart was losing its conductivity and needed a little boost, or jump start.

So, if you're creeping up there in age, and having light headedness, and wobbly legs (50% of elderly do), see your doctor. The first thing my doctor did was order a CT Scan of my brain. Then he had me do a neuro-cognitive evaluation along with physical therapy. It was at physical therapy where the low pulse rate (bradycardia) reared its sluggish head, but put me on the path to recovery.

Looking back, it's a good thing this happened while I was at physical therapy, just a wheelchair ride from ER. I was lucky. Or was it Divine Intervention?

At home, I'm supposed to take it ez with the exercising for the first month. I've never been a nice-and-easy kind of guy. It's usually all-or-nothing. But, it is my heart, the only one I have, and I have mellowed with age. Besides, I need to keep Uma happy. I'd rather have a pacemaker than a widowmaker. February is Heart Month.


# Task Force gets another arrest in Keokuk on drug charges
