DES MOINES – The Fort Madison Bloodhounds wrestling team was upbeat after the first day of wrestling at the IHSAA Boys State Wrestling Tournament Wednesday at Wells Fargo Arena in Des Moines. And they had a right to be.

The Bloodhounds went 4-2 on the first day of wrestling with Noah Riddle going 2-0 on the day at 157 lbs., scoring pins in both matches and advancing to the quarterfinals. Both Riddle and Ike Thacher are one win away from making the top 8, guaranteeing a spot on the podium Saturday night.

Cory Arnett (10th seed, 285 lbs.) went 1-1 on the day and moved to consolation wrestling after falling

to North Scott's Dawson Rheingans (7th seed) in second-round wrestling. He downed Clear-Creek Amana's Vinnie Keller by fall 30 seconds into the third period in a bout marred by medical timeouts.

Joe Hartman (19th seed, 165) lost by fall in the first period and was moved to second-round consolation wrestling Thursday. Hartman fell 1:10 into the match to Linn-Mar's Barrett Meiras after giving up a takedown 20 seconds in.

Hartman said he was disappointed in his effort the first time on the mat at Wells Fargo, but said he was blessed to be in the tournament and was looking to Thursday's matches.

"I still have tomorrow and I'm going to make the most of that. I feel just blessed to be here," he said.

## More bills take aim at rural Iowa

DES MOINES — U.S. Representatives Zach Nunn (IA-03) and Wiley Nickel (NC-13) today introduced bipartisan legislation to improve access to housing in rural communities. The Promote Affordable Rural Housing Act will improve the U.S. Department of Agriculture (USDA) Section 524 loan program by extending the term for rural housing site loans and expanding the use of these loans.

"Our country is suffering from an affordable housing crisis, especially in rural areas," said Rep. Nunn. "This is a growing challenge that must be addressed now to prevent it from getting any worse. Modernizing the USDA rural housing development loans will help incentivize new construction and bolster affordable housing options in rural Iowa."

Across the country, there is a shortage of 7.3 million affordable and available rental homes for low-income renters. In rural Iowa, 10.6 percent of the population lives in poverty, and the average household income is more than \$10,000 less than the national average. Nearly 40 percent of renters in Iowa spend nearly one third of their income on housing.

The USDA Section 524 loan program provides loans that can be used to purchase and develop housing sites for low-income and moderate-income families. Currently, the program only allows for a two-year loan term at below-market rate. The program offers loans to non-profits, municipalities, and tribal governments who have difficulty repaying the loan within a two-year period.

"We must take immediate action to increase the supply of affordable housing and to lower the cost of living for working families," said Rep. Nickel. "I'm proud to partner with Congressman Nunn on this bipartisan bill that will encourage the development of housing sites for low-income families in rural communities in North Carolina, Iowa, and across the country."

The bipartisan Promote Affordable Rural Housing Act would extend the loan repayment window from two years to five years, increasing flexibility for borrowers. The legislation will also allow these loans to be used to fund necessary development projects including surveys, architecture design, and engineering.

## State legislators introduce new Clean Water for Iowa Act

DES MOINES — Amidst mounting public pressure to bolster transparency and accountability for Iowa's worsening water pollution crisis, Representative Art Staed introduced the Clean Water for Iowa Act (HF2354), with the endorsement of Food & Water Watch and Iowa Citizens for Community Improvement.

The proposed legislation requires that all medium and large concentrated animal feeding operations (CAFOs), also called factory farms, obtain water pollution permits. Although water pollution permits are standard requirements for industrial polluters, nearly 4,000 factory farms currently operate in Iowa without such permits. A Food & Water Watch analysis of USDA and EPA data found that Iowa's factory farms produce at least 108 billion pounds of manure every year, all without the oversight necessary to prevent contamination of surface and ground waters. The Act seeks to, for the first time, require these facilities to monitor for waste released into waterways and reduce such discharges where necessary to protect water quality.

Representative Art Staed said: "Voluntary approaches have proven that Iowa's corporate agriculture industry will not regulate itself. We must act urgently to rein in factory farm pollution and clean up Iowa's water. I am proud to introduce the Clean Water for Iowa Act, a mandatory approach to keeping waste out of our water."

Food & Water Watch Iowa Organizer Jennifer Breon said: "For too long, factory farms have been given a free pass to pollute our precious water. Today's spiking cancer rates, algae-choked rivers, and skyrocketing water bills are the result of decades of see-no-evil legislating in Des Moines. Enough is enough. The Clean Water for Iowa Act will finally bring desperately needed transparency and accountability to our worsening water crisis."

# Miller-Meeks makes another effort to secure school safety bill

WASHINGTON, D.C.— U.S. Representative Mariannette Miller-Meeks (IA-01) reintroduced the “Securing Our Schools Act,” legislation that would clarify that states have the flexibility to utilize unused State and Local Fiscal Recovery Funds to be made available for school security measures.

“Every child deserves a safe and secure environment to learn and grow,” said Miller-Meeks. “The Securing Our Schools Act, will allow States to utilize unused, expiring State and Local Fiscal Recovery Funds to invest in security measures on campus, as well as hire and train more school resource officers. I urge my colleagues to join me in support of this legislation and ensure that our children and teachers can remain focused on learning, while feeling safe each day in the classroom.”

Background:

Under this legislation, school security measures mean any of the following:

An evidence-based strategy or program to prevent violence, which may include the use of appropriate technologies, including the placement and use of metal detectors and other deterrent measures and emergency notification and response technologies.

Training to prevent student violence against others and self, including training for local law enforcement officers, school personnel, and students.

The development and operation of an anonymous reporting system for threats of school violence, including a mobile telephone application, hotline, or internet website.

The development and operation of

a school threat assessment and intervention team that may include coordination with law enforcement agencies and school personnel; and specialized training for school officials in responding to mental health crises.

Coordination with local law enforcement agencies.

A security assessment.

Security training of personnel and students.

Acquisition and installation of technology for expedited notification of local law enforcement during an emergency.

Reinforcing or replacing classroom doors, locks, or window panels.

Constructing fencing, bollards, planters, curbs, walls, or any other entry control measure to create a single point of entry to the campus.

# Davis leads Bloodhounds into 4A Region 1 semifinals

**RALLIES:** Fort Madison girls will get one more crack at Keokuk Saturday

FORT MADISON - Dayonna Davis had to be helped back to Fort Madison's locker room after the Bloodhounds' 50-41 win over Burlington in a Class 4A Region 1 quarterfinal on Wednesday night.

"Just got hit in the thigh," said Davis after she left the locker room with not as much of a limp. "I'm OK."

That's a good thing for the Bloodhounds (14-7), who advance to Saturday's semifinal at Keokuk (18-3).

Davis led Fort Madison with 17 points, playing a big role in the Bloodhounds' 18-0 run in the second quarter that gave them a 27-17 lead.

"It's just trust in myself," Davis said. "Having confidence, really."

"When she plays with confidence, she's a great basketball player, right up there with the best in the area," Fort Madison coach Landon Bentley said.

Davis was injured when she crashed to the floor after being fouled on a layup attempt with 6:03 left in the game. She made one of two free throws to give Fort Madison a 45-33 lead, and then came out of the game and left the gym with the assistance of a trainer.

Fort Madison would score just six points the rest of the game after Davis left, but kept Burlington (11-10) from getting much of a run going.

"Losing her at that point in the game, after her taking over, it was a little nerve wracking," Bentley said. "But I trust in our seniors to rebound, close some things out. We had a little cushion."

The Bloodhounds didn't score for the first three minutes of the game as Burlington built an early 5-0 lead behind a 3-pointer and a 15-foot jumper by Mylee Stiefel. Fort Madison battled back to tie the game at 9 before Stiefel's 3-pointer with 43 seconds left gave the Grayhounds the lead to end the quarter.

"I think we just settled down, just ran our offense better," Fort Madison sophomore Halle Menke said.

Stiefel's shot started an 8-0 run that seemed to have Burlington in command before the Bloodhounds took over. Ajia Jenkins and Irelynd Sargent hit back-to-back 3-pointers to ignite the crucial run, then Davis got going. She scored Fort Madison's final nine points of the quarter and the Bloodhounds led 32-22 at halftime.

"She had a mismatch," Menke said. "We would pound it inside, and she would score."

"I thought we strung some things together, pulled ourselves back, started playing Bloodhound basketball," Bentley said.

"Mylee and I are good friends," Menke said. "She's really shifty and she can shoot. I love to play her."

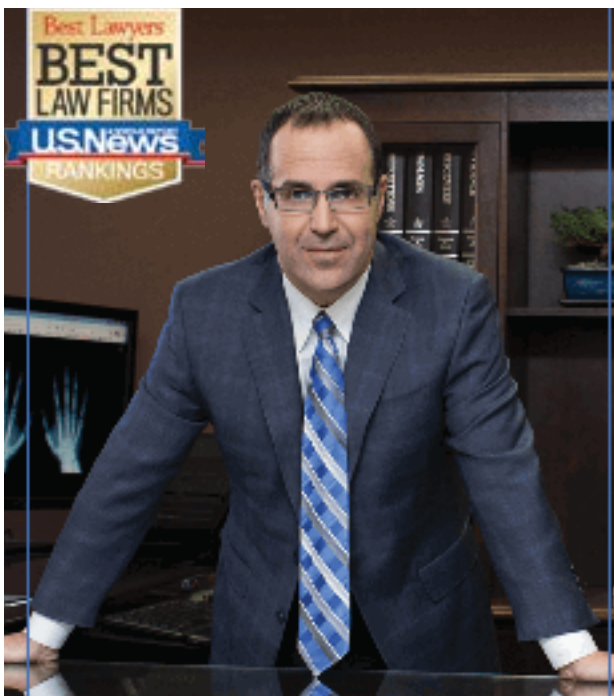
Bentley was happy that his team was advancing.

## LETTER TO THE EDITOR

### State auditor Sand responds to Sen. Reichman's comments on IFC sale

Dear Editor:

When a politician tries to convince you that someone in the other party is an extremist because they took a position that one of the politician's own party leaders agrees with, check your wallet and check your job to make sure they are still there.

On January 30, I stood up for Iowa taxpayers and farmers against powerful interests by stating I agreed with Terry Branstad, despite he and I belonging to different parties: competition in the fertilizer industry is good, and protecting competition will work against the price hikes that we are all suffering from. Specifically, I sent a letter to the Federal Trade Commission and the U.S. Justice Department's Antitrust Division saying they should deny Koch Industries' attempt to buy the OCI Iowa Nitrogen Fertilizer Plant in Wever for those reasons.

I'm worried also that jobs could disappear. It isn't uncommon for the biggest player in an industry to buy something from its competition and shut it down, because if you decrease supply, prices go up. Will Koch Industries, the biggest player in the industry, do that with the OCI plant? Why take the risk: deny the sale. All those jobs could be lost.

Now, I thought by stating I was in agreement with folks in the opposite party, namely former Governor Terry Branstad, would prevent others from turning a simple issue into the "partisan politics" that most of us are so tired of. I guess I was that foolish because I grew up in Decorah, Iowa, which is about as far

away from Des Moines as Lee County is. I was raised with a healthy skepticism of political partisanship. It's one of the things I hate about politics and why I stand up for people in the other party when they're right—even as I called out people in my own party for wrongdoing. Neither party has a monopoly on good ideas, and a broken clock is right at least twice a day. That's part of why when you first elected me State Auditor, I named as the two most senior deputies in the office two people who didn't belong to my political party and in fact had both contributed to my political opponent. I've also regularly defended Governor Reynolds when it was the right thing to do. Some want to scream right versus left to get you angry; I want to talk right versus wrong to get problems fixed.

So State Senator Jeff Reichman proved my hopes too high when he attacked me personally for taking that stand. This is after last year, when he voted to gut our Office's ability to find misspent tax dollars. He even celebrated that vote to reduce oversight of government by noting that I couldn't "legally" do my job. Sometimes you just have to laugh at it all.

I've invited Senator Reichman to both of my an-

nual Lee County townhalls every year, but he's never come. So, not knowing him well, I can't say what caused his angry attacks. It could be because Koch Industries' owners are among the biggest donors to his party. Maybe that's why they are now turning against the position that former Republican Governor Terry Branstad and I share. Or it could be that some politicians instinctively feel the temptation to oppose anything someone in the other party says or does.

Either way, I'd like to remind us all of President Lincoln's quote: "I don't like that man, I must get to know him better." We make a point of inviting every local elected official and state legislator to our official town hall meetings because our shared constituents sent all of us to work for them, together. Senator Reichman, you are still invited. With tax dollars, prices, and jobs at stake, the issues are too important to just sit and sling mud. I hope you'll join me next time I'm in town.

## Bloodhounds have high expectations for Thursday

Riddle said he felt a little underseeded in the tournament, but said none of that matters now. He set out to prove that he was under-seeded, rolling CC-A's Trace Robertson in the first round, scoring a fall in the third period, while racking up a 16-0 lead before getting the slap.

"I think I was underseeded coming into here. But everybody goes for an underdog story and we're going to see where it takes us," he said.

Riddle, the No. 7 wrestler in 3A at the end of the season according to Iowa Wrestle, then got a pin over Cedar Rapids Prairie's Wyatt Vlasek. Riddle got in a scrum with Vlasek off the horn resulting in both wrestlers trying to roll out of takedowns. Riddle would give up a takedown 30 seconds in but would quickly score a reversal at the end of the circle near the scorers' table. Then, starting from the bottom, would get an escape in about one second with a sit-and-roll that he converted to a takedown and two nearfalls for a 10-2 lead before securing the pin with 20 seconds left in the period, moving him to the quarterfinals Thursday.

The senior Hound made it to state last year, but was eliminated on the second day. This year he said his mentality is clearer.

"I knew this year coming in I had to wrestle, and if I find myself in a bad position, I just have to keep wrestling and sooner or later they'll break," he said. "One time I got into that, but I kept wrestling through it and he broke."

Riddle said this year is all about his offense.

"Offense, offense, offense. There's a lot less nerves. My mentality has changed a lot. I was scared last year, but this year I'm just going out there and doing what I want to do."

He'll need that offense Thursday afternoon as Riddle will start with the state's No. 2 157 lbs. wrestler in Linn-Mar's Grant Kress. The senior is 31-1 on the year and is the top-seed in the bracket. Kael Voinovich, who got the best of Riddle at Saturday's districts, is ranked at the top wrestler at 157 in the state and seeded 5th overall. He's also in the top part of the bracket with Riddle.

"It's good not that he's just winning, but he's putting points on the board. He's putting people on their back, he's going for the fall. That's what is gonna get these guys to where they want to be, not just winning a one-point match. You can get bit in the butt there."

Ike Thacher, wrestling at 190 and seeded 7th, recorded

a second period pin over Isaiah Kellow of Indianola. Thacher said he'd never wrestled with Kellow prior to Wednesday but said he knew he was a good wrestler at 25-10.

Thacher scored the only points of the first period about halfway through when the two took some time getting to know each other with hand fighting and elbow collar holds. However, Kellow scored a takedown in a rolling move toward the edge of the circle, but Thacher would take about 20 seconds to roll out of the hold and convert a reversal that ended with Kellow's back on the mat for a quick slap by the referee.

"I knew he was a pretty decent wrestler. But I just had to go in and get the job done. I knew where my advantages were on top and the bottom and I could feel he didn't really want to tie up with me," Thacher said.

He said having one match on the day with the bye was a benefit.

"I like having that one match and have that one thing to focus on."

Thacher will now go up against Ames' Denarii Mickel (43-2), a sophomore who beat Thacher in 2023 at the Urbandale Invitational, by one point.

"I just got to do the same stuff and do everything I can to get prepared. Now's not the time to be changing anything up."

Fort Madison Head Coach Ryan Smith said Thacher had a bit of a slow start but recovered nicely.

"He's a dangerous kid and explosive and when he makes up his mind, good things are gonna happen," Smith said.

Arnett's first match with Keller was at 9-0 in Arnett's favor before he scored in the third period fall. He scored a takedown in each period and would likely have had a second period if the horn hadn't prompted the 3-point near fall.

The Bloodhound then faced Rheingans and battled to a 0-0 first-period score. Arnett then popped from the bottom start in period two and scored a quick reversal. Rheingans would escape and then score his own reversal and would ride Arnett to the end of the 2nd period. Arnett would then get Rheingans close to a pinfall with three shots at a cradle in the opening minute of the third, but the Lancer would fend off the attacks and force an escape. When Arnett took the offensive and tried to pull Rheingans back down, the move countered and Rheingans came down on top for another takedown that turned into 6-2 decision, sending Arnett to consolation wrestling.

"He was right there. The first three minutes was a great job of keeping pressure on and a good job on the bottom exploding up and getting the reversal," Smith said.

"Maybe he took his foot off the gas... maybe, but he did have a couple three shots at a cradle and, if he gets those locked up, it's over for the other guy."

"Now he knows he can hang with the big boys. But he needs to get over the hump and keep the mindset for six minutes. He had it for three minutes, but he needs to now focus on six."

Arnett said he felt good in the first match, but the second match he lost his energy.

"The first match, I knew I was dominating the whole time. It felt great and I just kept pressure on the kid. But the second match, I did that for the first three minutes and somewhere in between that, I lost my energy," he said.

"Now that I've wrestled against a guy of his stature, I know what I'm capable of. I can still place here and I intend on doing that. Going into tomorrow I feel bad for the people I'm going in against. I'm going in for some vengeance."

Arnett will now face Andy Crowder (24th-seed, 11-14) in the second round of consolation wrestling. The best wrestlers can do coming out of consolation wrestling is 3rd place.

Hartman will tangle with Pella junior Logan Bruxvoort (13th-seed, 20-5).
