


Tough opponents: Riddle, Thacher draw No. 1 and No. 2 seeds in quarters

DES MOINES – It was a rougher second day of wrestling for the Fort Madison Bloodhounds at the IHSAA State Wrestling meet in Des Moines.


After going 4-2 on Day 1 wrestling, the Hounds were just 1-4 on Thursday where two of the four Hounds were eliminated.

Junior Cory Arnett made easy work of 24th seed Andy Craw-

ford of Carlisle in his first match of the day in 2nd round consolation wrestling at 285 lbs.

After about 20 seconds of hand fighting, Arnett shoved Crawford to the circle for a restart and then grabbed him around the shoulders with an arm pinned back and twisted him to the mat for a pinfall 45 seconds into the bout to advance to third round wrestlebacks.

County to hold public hearings on bonding for LCHD, EMS facilities



LEE COUNTY - The Lee County Board of Supervisors has set public hearings to borrow money for construction of the new Lee County Health Department and the new Keokuk Ambulance bay.

The issue prompted a lengthy discussion Monday at the regular meeting of the board.

that is authorized under Iowa code in urban renewal areas. The county authorized the urban renewal area for the Keokuk site, where the current ambulance garage is located in the 1500 block of Blondeau. Those funds can be borrowed unless a petition is filed by taxpayers. Petitioners must get signatures equal to 10% of the total votes cast in the county for the last general election for President or governor. In 2022, the total votes cast in Lee County for the governor's race was 11,465, which means a petition of 1,147 valid signatures would be required to either have the county abandon the bonding, or put it up for a special election.

That bond would fall upon the county's debt service, which has a couple current bonds ready to expire, including the jail and the conservation building construction. The second public hearing is for the Lee

Riddle, Thacher need a win to guarantee spot on podium

But his last match of the day didn't go as planned against Zach Conlon of Dubuque Hempstead. Conlon came into the tournament seeded 15th to Arnett's 10th seeding.


The two engaged in the typical pushing and shoving, and hand-fighting to start the match, but Conlon would record a takedown with 30 seconds left in the first period. Conlon would take the down start and record a quick escape. The two measured each other up again for another minute before Arnett tried a toss on Conlon that backfired with Conlon landing on top for another 2-point takedown. He would work that into a near fall at the left side of the mat, but the horn saved Arnett from a potential pin, saddling him with a 7-0 deficit which would hold up through the third period.

Arnett finished his junior season with a 26-12 record and his first ever trip to Wells-Fargo.

Joe Hartman left everything he had on the mat in his consolation loss to Pella's Logan Bruxvoort. Hartman had several opportunities to wrench the Dutch to the mat but Bruxvoort was always able to muscle out of Hartman's grasp. The Fort Madison senior battled through the match without giving up the pin, but fell 12-2 to end his Bloodhound career with a 29-20 season.

Nolan Riddle, wrestling at 157, got through his first two matches on Wednesday only to be rewarded with a bout against Linn-Mar's Grant Kress, the No. 2 ranked wrestler in 3A at 157 and the top-seed coming into the tournament. Riddle held his own with Kress appearing to wear down the senior. Kress was able to grab Riddle's leg about 40 seconds into the bout and was able to twist his way to a takedown, but Riddle got an escape after 30 seconds of rolling and twisting out of Kress' grasp. Kress would score a reversal halfway through the second period, after Riddle had him compromised several times in the tussel off the second period whistle. But no points were awarded because the Hound started the period in the top spot. There was little action in the third period as both wrestlers took a passive approach to the final period.

Ike Thacher (190) got a bye in the first round of wrestling Wednesday, then won his second round match, and then found himself up against 2nd-seed Danarii Michel. The two battled to a 0-0 tie after the first period. Michel started the second down and was able to escape in eight seconds for a 1-point lead. Thacher was cautioned for stalling on two different occasions in the second period and then Michel was awarded a 1-point penalty when Thacher dodged a shot at the circle and went out of bounds, prompting the penalty point. The match would end with Thacher getting a penalty point after Michel shoved him

for a second time after the whistle. Michel also gave

Thacher a shove at the head after the second period horn

had sounded. Both Riddle and Thacher moved to consolation wrestling starting tomorrow. The best they can do now is third place, but a win tomorrow afternoon in their first match will put them on the podium with at least an 8th place finish.

Thacher will take on Wyatt Young of Cedar Rapids Washington (11th seed, 29-8) with the winner advancing and securing a minimum 8th-place finish and the losing wrestler being eliminated. Riddle will take on Dominic Tigner of Norwalk (12th-seed, 33-10) with the winner advancing and the loser being eliminated.

Wrestling Friday again is in the afternoon session. All place wrestling will take place Saturday with consolation finals in the morning session and finals in the evening after the Grand March.

LCHD bond could be paid off by grants, ARPA funds

County Health Department facility and would authorize bonding of up to \$6 million for construction of the new facility on property donated by the Glen Meller family where the old Iowan Hotel was located in the 5000 block of Avenue O in Fort Madison.

This bond would be for a construction loan to secure funding to go out for bids on the structure. This money would be supplemented with ARPA funds of about \$1,000,000; funding from the Lee County Community Foundation of at least \$500,000, a state Community Development Block Grant of \$600,000, a USDA Rural Emergency Health Care grant of \$974,000, and a potential congressional appropriation through the USDA for an additional \$2 million. Without the appropriation, the county has secured just over \$3 million for the project that was designed at a cost of \$5.5 million. Supervisors believe that cost will be more like \$6 million with estimated increases in costs since the project was designed in 2023.

The county has been told by Congresswoman Mariannette Miller-Meeks office that there could be action on the appropriation by March 1. The project made it through to the House bill that was to go before Congress, but it suffered such deep cuts through negotations in committee that Miller-Meeks herself voted against the appropriation that was part of the larger Ag Bill.

If that appropriation is funded at even 90%, the county would see about \$1.8 million additional taking it to \$4.8 million. Supervisor Chuck Holmes has indicated that the community foundation could be larger, but people are waiting to see money in the bank before they commit to additional funding through the foundation.

"That's a minimum. I think we should be optimistic about it being considerably more than that. I've spoken to Roger (Ricketts, the director of the foundation) a few days ago and he doesn't want to make any promises until the money is in the bank," Holmes said Monday. "He's talked to several donors who are willing to make what he calls substantial commitments to this project but they want to see it on the ground."

All of the funds except the county's remaining ARPA funding and the Community Foundation funds are reimbursable funds. In other words, they are last-in funding and are paid when pay applications are submitted by the general contractor. The CDBG is paid at 11% reimbursement on invoices until the grant is used up. The USDA funding, both the REHC grant and the appropriation, would also be last in funding and reimbursed after the project is complete.

That dynamic is what is prompting the county to secure a construction loan so USDA can begin moving forward with authorizing the project to move ahead.

"We're to a point where we're paralyzed. At the point we move and actually get in the ground and start going and they start seeing movement out there, then you're going to see more people commit to some donations," said Chairman Garry Seyb.

He said the county has already spent about \$370,000 on the project at that location in drawings and fees.

"At this point, it's a foregone conclusion in my mind. In my mind, it's going there and that's what we're budgeting for."

Supervisor Matt Pflug asked at what point does the county move on from the \$2.1 million appropriation that was authorized but never passed by Congress.

"That's why we're moving ahead with the bonding authorization," board member Tom Schulz said. "The worst-case scenario is that we may have to cover that \$2.1 million."

Pflug again brought up the facilities in Keokuk that he thought were move-in ready, and were offered for sale to the county. He said the buildings were sold to the Keokuk Community School District for \$230,000. He said Blessing said the county should make an offer of \$400,000 to \$500,000. He said the KAME building next to it also sold for \$231,000.

"That's two buildings for less than a half a million dollars. The taxpayers want us to be fiscally responsible. I felt really bad we missed that boat. We probably could have cashed that project. Was it ideal as a location for the Health Department...it would have worked."

Seyb responded by saying that he got a call from someone in West Point talking about the Ivor Fowler building and he said both locations didn't address the Fort Madison ambulance needs.

"Additionally, we received a piece of property valued at about \$700,000. So we got that donation of ground contingent upon us putting a health department there and putting their name on it," Seyb said.

"It's right next to the hospital and we've got the other issue of the ambulance in Fort Madison. 1/3 of our calls come from Fort Madison, 1/3 out of Keokuk and 1/3 out of the county in general. We couldn't have put the ambulance in either of those two locations."

He said if the county doesn't move and get bids in front of contractors then the county is looking at another year for bidding and construction and much of the funding has to be spent by the end of 2026.

Schulz said not building the facility on the former Meller property could violate the county's agreement with the family and then the county would have to go out and look for another place or piece of property to buy, and that would jeopardize a lot of the funding that's already in place because plans have already been submitted for that funding assistance.

Pflug said the petition is a real possibility.

"It takes quite a few signatures for that to happen, but with everything that's going on with people getting their tax bills, we could see that happen and that's a concern I have," Pflug said.

"If that does happen, and I hope it doesn't, because it's a bad move for the taxpayer financially, what's your next step?" Holmes asked if the county could keep the bonded amount closer to \$5 million since the county already has \$1.5 million of the funds. Seyb said if the bids come in higher, then the county would have to start over to get additional funds to finish the project, which would result in additional costs for bonding.

Sports HTC boys advance to district title for 1st time in 13 years

FORT MADISON – It's been 13 years since the Holy Trinity boys' basketball team has been to a district championship. That mark was reset Thursday night as the Crusaders overcame a sluggish first half to knock off Moravia 55-29 in the Class 1A District 10 semifinals.

HTC will travel now to Ottumwa's Evans Middle School Tuesday night against North Mahaska (18-6). The game was originally slated for Oskaloosa, but will now be played in Ottumwa beginning at 7 p.m.

The game was fast-paced in the first half with just two total fouls called, one on each team, and lasted a mere 21 minutes with the Crusaders holding a 1-point lead at 19-18.

The second half was a whole different story as Holy Trinity went on an 8-1 run to open the 3rd period highlighted by a couple 3-balls from sophomore Layne Rung.

The Crusaders started the second with some light zone pressure just to throw a different look at the Mohawks and then got some really good inside-out work going on offense.

Moravia, which had its only lead at 2-0, tied things up to start the third period on a freethrow by sophomore Declan DeJong. After that the Crusaders slammed the door, going on a run that extended to 19-4 when Luke Hellige, who led all scorers with 20 points, hit a 3-pointer from the left baseline.

Rung hit his third 3-pointer of the night in the run and senior Conner Gehling took a two-step around the Mohawk defense on the baseline and slammed a two-handed dunk to bring the Crusader faithful to their feet. Gehling would score again inside to give the Crusaders a healthy 40-23 lead heading into the final period.

Rung sent a quick message with backto-back threes enroute to his 15 second-half points to push HTC's lead to 21 at 46-25.

Head Coach John Hellige said Rung missed a couple shots in the first half, but he told him to keep shooting.

"The first half he missed a few and sometimes being a sophomore it's like 'should I be shooting or should I not be shooting', and we just told him at halftime if we're going to pull away from this you gotta shoot otherwise they'll just suffocate the other guys," Hellige "And once he hit that first one, he got all the confidence in the world."

Hellige said the Mohawks played really good defense in the first half and proved they are a solid Blue Grass conference team.

Hellige drew double teams most of the game and Moravia used a smaller guard to front up the junior while bigger defenders waited behind him.

"Luke's an interesting matchup. If you put a big guy on him, he's gonna drive around you. If you put a little guy on him, he'll take advantage of that," John Hellige said. "A guy his size he does a little bit of everything, but they did a good job of smothering him and then bringing some help inside, but he had a good game."

Adam Sobczak and Gehling each had eight points in the win. Sobczak still leads the state in assists and had a nice alley-oop to Hellige at the basket from an inbound toward the end of the game.

"My role is just getting people open and finding my teammates. They hit the shots and reward me with the assist," he said.

He said he wasn't concerned about coming back after the tight first half, nor playing the next game on the road for the first time in the postseason.

"We're good on the road, we're good at home. We just play. I wasn't concerned tonight, I knew we would pull it off. We weren't running the court, and our offense wasn't going. We weren't running sets, and then in the second half, we did that almost to perfection."

John Hellige said he isn't concerned about taking the kids on the road to Ottumwa Tuesday.

"I told them in the locker room - we played 32 games in the offseason and 24 now, so we've played 56 games and we've played everywhere from St. Ambrose to Monroe City, Mo. And we've played great everywhere we went. So I'm not worried about it."

Rung said the team is playing with confidence and anyone can put up points at any given time.

"We were confident we could beat this team. (Coach) gave a real good speech at halftime and we had a large crowd and we just wanted to come out and get the win," Rung said.

"This feels great. My brother and Conner are seniors so we want to get the
