Hounds put 2 on podium

CURTAIN CALL: Smith ushers Hounds to 4th, 8th place medals in final boys' state wrestling tournament

DES MOINES - Fort Madison put two Bloodhound wrestlers on the podium in Class 3A wrestling at the IHSAA State Wrestling Tournament this weekend, but both felt they left a little bit on the mat.

The Hounds' Ike Thacher captured 8th place at 190 lbs after finishing fourth in 2023. And Nolan Riddle built on his 2023 appearance at Wells-Fargo Arena in Des Moines with a 4th-place finish at 157 lbs.

Both wrestlers wrapped up their senior season with solid post-season performances. Riddle went 5-2 at the tournament with losses to Grant Kress, the top-seeded wrestler at 157 and Cinsere Clark, the No. 2 seed. Kress would exit the tournament with injury that required him to be taken by ambulance to a nearby hospital Friday night. He suffered that in a match with Iowa City High's Kael Voinovich, who won the 157 division with a 12-3 decision of Jaxon Miller of Carlisle. Voinovich also pinned Riddle in the district title match last week.

Thacher went 3-3 in the tournament and wound up losing the 7th-place match to Johnston junior Kolby Gibbons.

Neither Thacher nor Riddle suffered a pin in the tournament.


Riddle's 3rd place match against West Des Moines Valley's Clark was about as evenly matched as possible with a lot of action. Clark would score first when he was able to throw Riddle from a tie-up at the edge of the circle and jump on his legs on the way out for 2-points before a reset for being out of bounds. Clark took the 2-0 lead into the sec ond period, where Riddle this time was able to get the takedown, but Clark quickly spun back over for a reversal and a 4-2 lead.


The Bloodhound would get an escape and then lunged at Clark who was headed for the outer circle again. Riddle grabbed Clark's legs, but the hold was ruled off the mat and no points were awarded. Trailing 4-3 going into the final two minutes, Riddle started on



John Allen Scott Jr, age 46, of Fort Madison is charged with: Possession of more than 5 grams of methamphetamine with the intent to







Lady Chiefs complete season sweep of FM in regionals

KEOKUK — Landon Bentley showed the emotions from the end of his first season as Fort Madison's girls basketball coach.

Keokuk eliminated the Bloodhounds from the postseason, taking a 43-29 in Saturday's Class 4A regional semifinal.

Fort Madison finished the season at 14-8, a season that Bentley said was an education

"I learned a tremendous amount," he said.

The Bloodhounds, though, ran into a Southeast Conference nemesis. Keokuk (19-3), which advances to Tuesday's regional final against Clear Creek-Amana, won all three games against Fort Madison this year on the way to an unbeaten season in conference play.

The Chiefs took control of this game early, and Fort Madison couldn't mount any offense to answer. The Bloodhounds were down 21-11 early, and the Chiefs kept the lead in double digits the rest of the way.

Bentley lamented the numerous misses of easy shots inside.

"It's been kind of our downfall all season, the bunnies we miss, the free throws," Bentley said. "When you miss three or four layups and you're down nine or 11, it could be a closer game if you make those. But at the end of the day, it wasn't."

The Bloodhounds couldn't mount a fourth-quarter comeback. They held the Chiefs to just four points, but scored only two.

"We fought tooth and nail," Bentley said. "That's all you can ask for. We made a couple of surges when we could have laid over and let it go. That's all you can ask for."

Dayonna Davis led Fort Madison with 14 points. Halle Menke had six points, and Hadley Wolfe had five points. All three are sophomores.

"This is a young group," Bentley said. "We've got freshmen, sophomores, who are ready to go for next year, and we'll work to get them ready."

Fort Madison loses senior captains Ajia Jenkins, Taylor Johnson and Irelynd Sargent, along with reserve Juanita Sportsman.

"It's a great group of seniors," Bentley said. "I'm proud I got to coach them, and I was glad they were part of this team."

Kendra Boatman led Keokuk with 11 points.

Bentley said he's ready to take what he learned into next season.

"Composure was a big thing," Bentley said. "(Assistant coach Kent Bailey) being around has helped me so, so much. People don't understand that experience is everything.

"We built a family in that locker room. We built a family, and I love that group."

Lady Crusaders

First half deficit too much for HTC girls to recover

MONTEZUMA — They had spent the first half seeing their opponent's 3-pointers fall from all sides of the arc, and tried but couldn't contain the post player getting free inside.

There wasn't much time left in their season, and so the players on Holy Trinity's girls basketball team took their coach's advice in Friday's Class 1A regional semifinal against ninth-ranked Montezuma.

"I told them at halftime, 'That wasn't us. Let's go be us," Tony Johnson said.

"Tony said, 'We have nothing to lose. Put it all out there, because this could be the last 16 minutes. If it is, let's go out with a bang," senior Mary Kate Bendlage

"We came out with nothing to lose," senior Natalie Randolph said. "It was just, 'Let's go play, have fun, play our game."

And so the Crusaders did, clawing in an attempt to get out of a deficit that proved to be just too large to overcome.

Holy Trinity's season ended with a 60-44 loss to the Bravettes, who play No. 8 CAM on Wednesday night in the regional final for a trip to the state tournament.

The Crusaders (20-3), who trailed 43-16 with seven minutes left in the third quarter, got to within 47-36 with 5:43 left. But Montezuma hit 11-of-14 free throws in the final 5:10 to extinguish the rally.

"The second half, I felt, we won," Johnson said. "We just dug too big of a hole. We tried to get it down to single digits there, and I thought if we could do that we had a really good chance."

"Throughout the whole season, we've come out against teams in the second half and really put it on them," said Bendlage, who led Holy Trinity with 16 points. "We did that tonight, we just had given up too many points in the first half."

"The second half, we had a lot more drive," said Randolph, who finished with 15 points. "It was an insane first half. We fought back, that's all we could have done."

Holy Trinity led late in the first quarter and only

trailed 13-11 at the end of the quarter. But Montezuma (19-4) outscored the Crusaders 27-5 in the second quarter. The Bravettes hit six of their eight first-half 3-pointers in the quarter, and when Holy Trinity went five minutes without a point, the deficit just kept growing.

And when the Crusaders had the arc guarded, Montezuma center Shiressa Wetering, who had 18 points on 7-of-7 shooting, closed the half with two layups within 37 seconds.

"I just wish we could go back and redo the first half," Bendlage said. "I think the first half, they came out hot and couldn't miss. We struggled to get a hand in their face — we've never played anyone who has four shooters on the outside and then a big who's also contributing.

"It definitely got a little frustrating, especially when we had played great defense."

"We didn't come out how we wanted, at all," Randolph said. "They were making absolutely everything. They're a good team, but if we would have had a better first half, we could have hung in there better, and there could have been a different outcome."

"We had a bad quarter," Johnson said. "They had five or six threes in the corner that just killed us. Some of them were long, they banked one in, and we struggled getting our rotations on defense."

Johnson made sure after the game to point out the accomplishments of the season to his team — a share of the Superconference South Division title, the Superconference Shootout championship, and a 20-win season.

"I told them we accomplished so much," he said. "We won the conference, we won 20 games, so don't hang your heads.

"It was a bad night in the wrong place."

"I'm really proud of this team," said Bendlage, who ends her career as the program's all-time leading scorer. "We accomplished almost everything we wanted, we just came up a little short."

came back to be the team's second leading scorer. "I'm so proud of everyone. We've done great things. I love everyone on this team."

Johnson had one final message to his three seniors — Bendlage, Randolph and Raegan Holvoet.

"I told them, 'Thank you," he said. "Those girls have been with me for four years, played a lot of basketball for me, worked their tails off. I'm so proud of them.

"I can't ever express in words what those senior girls meant to me."

Fort Madison Head Coach Ryan Smith coached his last state tournament this weekend. It had to be bittersweet for him but he didn't show it. The same even-handed approach we've seen for close to 30 years. Full of emotion and unspent adrenaline doing what he loves, and has loved, and will continue to love.

top and Clark escaped. Riddle took a shot that Clark was able to counter and ride the move to the 7-3 win.

"We kept on tying up and we ended up on the end of the mat every time. It came late in the match where I needed to score and I just tried something," Riddle said.

Despite the loss, he was happy with his four-day performance.

"I'd say so, yeah. I pinned my way through the whole tournament besides Kress, so I'd like to say so. I wish I could've ended my last match better. That's my last match I'll have in high school. But it is what it is - you gotta keep going," he said.

"I came in here this time a lot more comfortable, less nerves. I knew the surroundings and the noises and it was more comforting this year."

Riddle said he would like to wrestle in college or possibly attend a two-year college and join a police department.

Thacher, the 7th seed at 190 wound up just missing standing on the podium where he was seeded. Johnston's Kolby Gibbons earned a 3-1 decision over Thacher in the 7th place match so the two flipped steps in the award ceremony Saturday night. Gibbons was seeded 8th coming into the tournament with a 16-2 record on Wednesday.

Thacher said he was upset that he couldn't do more for Head Coach Ryan Smith in his last season.

"He means a lot to me... I love Coach Smith. He's been there a lot for me and it really sucks that I couldn't do more for him in his last season," Thacher said.

The Hound senior said losing to Denarii Michel of Ames 2-1 in the quarters hit him mentally, a problem he's been dealing with all season.

"I've had a problem with that the whole season. When I lose in a tournament, my mentality to go out there and wrestle isn't as strong from that point."

Thacher also said it was tough this time around wrestling without two of his classmates, Teague Smith and

wrestled with and watched build their skills with me didn't get the opportunity that I did. And I don't know, it kinds of sucks that I wasn't able to perform as well as I wanted," he said.

In the match with Gibbons, Thacher scored an escape after a scoreless first period. Gibbons deferred on the flip and Thacher started down to get the escape, but after some time in a tie-up the two ended up pulling each other to the mat, where Gibbons was able to get control when Thacher lost hold of a leg and trailed 2-1 at the end of the second period. In the final two minutes, Both Thacher and Gibbons got a stalling warning with 35 seconds left, and in moving off the caution, Gibbons was able to escape for the 3-1 win.

Smith, who was coaching in his last tournament as a head coach said the emotion of the last matches probably hasn't set in yet.






Senior Ike Thacher gets his hand raised after defeating CR Washington's Wyatt Young Friday night to advance to Saturday consolation finals.

Smith was proud of the way the four wrestlers competed. Joe Hartman (165) and Cory Arnett (285) both were eliminated prior to the consolation finals.

"They're tough kids up here, and this isn't an easy thing to do. They represented themselves well," he said.

"To be on the podium is a damn good accomplishment and we're happy for them for that. There's a lot of top-eight seeded kids that don't make the podium. In the grand scheme of things, you always want a little more, but you're happy, and you know it could've been worse."
