# Closed for repairs

**DERECHO:** 2023 high winds toppled small spire in church, prompting a full-on inspection

FORT MADISON – An iconic part of the Fort Madison landscape is under a thorough inspection after being closed due to storm damage.

The Ss. Mary and Joseph Catholic Church on Avenue E has been closed to parishioners out of an abundance of caution and safety for everyone involved in the Fort Madison Catholic community.


According to Anita Helling, the church's business manager, the entire church is being inspected following a collapse of a small spire during the June 30 derecho that swept through Lee County.

Helling said there isn't a lot of information to be made public, but updates are provided weekly to the congregation who is now holding services at Sacred Heart.

"The church has been closed out of caution and safety," Helling said. "Our engineering firm suggested that ,and our insurance company is going to be cautious. Out of utmost caution and safety we need to be proactive and make sure we keep everyone safe."

Helling said there are no cost estimates for any potential remediation and the inspections are still underway.

## Burlington police identify remains of man found last week

BURLINGTON - Burlington Police have released the name of a man who's body was discovered on March 7 in Burlington.

The Iowa Office of the State Medical Examiner has been able to positively identify the human remains as that of 54-year-old Burlington resident Troy Daughterty.

Daughtery was reported missing to Burlington police in July of 2020.

The cause and manner of death are still being investigated by police, the Iowa Division of Criminal Investigations and the medical examiners office.

Results of an autopsy and toxicology are pending and may take several weeks, according to information released Thursday afternoon.

Officials believe this is an isolated incident and there is no danger to the public. No additional information will be released at this time, officials said.

# Wever set up for high-speed Internet service

• County's ARPA funds, private investment from Danville Telecom about to bring 100/100 service

LEE COUNTY - A \$1.9 million investment in county funds coupled with investments from Danville Telecom is bringing high speed internet to about 100 homes in Wever, and has produced a more efficient backbone of service in the county.

The fiber optic "backbone" Danville Telecom built east of Keokuk between the city and Argyle is physically complete, but still needs some electronics

initiated. The ring creates a redundance of service in the county that not only protects current users on Danville's system, but also is an attractive piece of infrastructure for larger Internet providers to help



build out more rural service for the county.

Tim Fencl, CEO of Danville Telecom, told the Southeast Iowa Regional & Economic Port Authority Tuesday morning the construction is complete and focus has shifted to providing high-speed service to homes near Wever.

"On Feb. 6 we had a Wever town hall meeting with residents of Wever showing up. We had 55 at the fire department where we gave a presentation and talk to those individuals," he said.

"So far we have permission from 63 property owners, residential and business, to install fiber to their home.

Danville Telecom committed to serving 110 homes in the Wever area as part of the \$1.9 million in county ARPA funding that also helped create the redundant loop near Keokuk.

"The June 30th storm caused one of our small spires to come down. The Diocese has recommended an inspection of the entire church and this will be a long process. We have removed the top portions of areas that have been compromised," she said.

"But the entire church is being inspected. The process now is just a waiting game."

Both the Sacred Heart church and Ss Mary and Joseph were both built in the 1800s. The church on Avenue E is the older church.

Helling said the high winds are detrimental to high spires on older churches.

"I don't see our weather patterns changing, either. There's going to be more and you just don't realize how damaging they are."


She said about a month ago a church spire in Connecticut just crashed to the ground.


The back parking lot is completed and striped as construction continues to progress at the Fort Madison High School. Work will continue through the spring and summer with an anticipated opening by the fall school semester.

# Miller-Meeks says Biden SOTU was lackluster

Last week, President Biden delivered a lackluster State of the Union address that was divisive, touted empty policies, and swept the chaos at our southern border under the rug.

I am not surprised that the President failed to mention the decline of our nation during his State of the Union Address, but I am disappointed. I am disappointed that the President prized appearances, the appearance of a strong nation, over the harsh realities that many Americans face.

The President boasted about the economy. Yet, under Bidenomics, job growth has been stagnant, real wages are down by over 2%, and prices have risen

17.9%. Compared to three years ago, Americans spend \$1,019 more on necessary goods and services per month. This is the direct result of Biden's failed economic agenda.

In Iowa's First Congressional District, we have been hit hard by the skyrocketing inflation rates. We feel the impact at the pump and at the grocery store when we, at times, have to put items back on the shelf. ## Channel cats active as waters warm

DES MOINES - The following is a the weekly fishing report of southeast Iowa fishing holes from the Iowa Department of Natural Resources.

#### **Big Hollow Lake**

A few days in the 70's warmed the water into the low 50's. Forecast cooler weather will most likely drop water temperature drop for at least the next few days. Channel Catfish - Fair: If you can be there when the wind is blowing into the dam, you can find a few catfish concentrated there looking to feed; use cut bait. Largemouth Bass - Fair: Work the small islands along the north side towards the lower end of the lake. The shallow water flats around them attract bass early in the season looking for an early crayfish to eat.

#### Lake Belva Deer

Several boats and kayaks have been out this week. Water temperature is in the mid to upper 40s. Black Crappie - Slow: Anglers are picking up a few crappies out from the beach when the wind allows them to slow drift with ice fishing jigs. Channel Catfish - Fair: Anglers are picking up a few catfish along the face of the dam using cut bait. Largemouth Bass - Fair: Bass fishing has picked up with the warmer weather.

Use soft plastics or jigs with trailers with a slow presentation; work the north shore where the sun is warming the water. Walleye - Slow: An angler caught a nice walleye while crappie fishing on March 13; broke his ultralight pole in two, but he landed the fish.

#### **Lake Darling**

Water temperature is in the upper 30s. A few boats out on the lake; very little actual fishing pressure. Channel Catfish - Fair: Not much fishing pressure due to the windy days. March 13 rains filled up the lake to full pool; night crawlers were out. Try nightcrawlers in the wiers in the inlake silt dams. Largemouth Bass - Fair: A few largemouth were being caught along the rocks. Use soft plastics or jigs bounced slowly along the bottom along the rocks. A few crawdads have been seen.

#### Lake Geode

Water temperatures are in the low 50s; expect temperatures to drop with the forecast cooler weather. Largemouth Bass - Fair: Target the long rock mounds at the upper end of the lake where the rocks absorb some of that suns heat. Use crawdad or salamander imitations with a slow presentation.

Lost Grove Lake

Anglers are getting out when the wind allows. Water temperature is in the mid-40s. Channel Catfish - Fair: When the wind is blowing into the dam or into the bays on the northside, using cut bait will give you a chance for some nice catfish. Largemouth Bass - Fair: Bass fishing along the north shore is picking up with the warmer weather. Work next to and over the rocks jigging soft plastics and jigs; work them slowly.

For more information on the above lakes and rivers call the Lake Darling Fisheries Office at 319-694-2430.

#### **Hawthorn Lake**

#### Lake Sugema

Try cut bait for channel catfish along the wind-blown shorelines.

#### Lake Wapello

Use cut bait to catch catfish on the wind-blown shorelines.

#### Ottumwa Park Pond South (Trout Pond)

Trout will be stocked on Saturday, March 23rd at 11 AM. You need a valid fishing license and pay the trout fee to fish for or possess trout.

#### Rathbun Reservoir

The current lake level is 902.79 msl; recreation pool is 904 msl. Surface water temperature is 44 degrees. The Dedication Site boat ramp has reopened; use caution as the lake is still below recreation pool. Docks have not been installed; very little fishing activity. Lake Rathbun has zebra mussels so make sure to properly drain, clean and dry equipment before transporting to another waterbody. Channel Catfish - Fair: Try cut bait on the wind-blown shorelines. Walleye - No Report: All walleye less than 15" must be immediately released unharmed.

#### **Red Haw Lake**

Channel catfish will move into wind-blown shorelines; use cut bait in those areas.

# Grassley joins group in new bill to combat immigrant crimes

WASHINGTON - Sen. Chuck Grassley (R-Iowa), a senior member and former chairman of the Senate Judiciary Committee, joined Sens. Katie Britt (R-Ala.), Ted Budd (R-N.C.) and 31 Republicans in introducing legislation to combat crime stemming from illegal immigration. Companion legislation passed the House of Representatives last week by a bipartisan vote of 251-170.

The Laken Riley Act would require Immigration and Customs Enforcement (ICE) to arrest and detain illegal immigrants who commit theft, burglary, larceny



or shoplifting until they are ultimately removed from the United States. Further, the bill would ensure states have standing to bring civil actions against federal officials who refuse to enforce, or who violate, immigration law. The legislation is named after Laken Riley, a 22-year-old student who was murdered by an illegal immigrant and repeat criminal offender who had previously been detained

"Laken Riley's life was robbed by an illegal immigrant, and repeat criminal offender, who the Biden administration allowed to slip through the cracks," Grassley said. "The Laken Riley Act would ensure criminals who have illegally entered our country receive due justice and would help keep communities safe. We must act now to ensure this terrible tragedy never happens again."

"Make no mistake – Laken Riley's heartbreaking murder was a direct, preventable consequence of willful open border policies by President Biden and his administration. This commonsense legislation would ensure ICE detains and deports criminal illegal aliens, so more innocent American families do not have to face this kind of unimaginable tragedy," Britt said.

"States should be able to protect their citizens from the Biden administration's lawless, open border policies by seeking relief in federal court. That's why I am joining Senator Britt to introduce the Senate version of the Laken Riley Act. We simply cannot tolerate any more senseless tragedies like this one. What happened to Laken Riley should never happen to any American citizen," Budd said.

# Danville to start building high-speed fiber optic service to Green Bay residents

**FIBER** - Continued from Page 1

"I will say it was really enjoyable going to Wever and having that conversation with the people. They are so happy we are coming to town," Fencl said.

"I think I had to repeat at least 15 times that our charge was \$85. They would ask what else, that's it - \$85. What's it going to be next month? \$85."

Fencl said residents stuck around for about 45 minutes after the meeting regarding the service and asked questions about the service and possible price increases.

"I assured everybody that I've been at Danville 14 years and as CEO 12 years and we've raised our prices once. That was six months ago when we went from 3/1 (upload/download mgb) speed to 100/100 and our price went from \$75 to \$85," he said.

"It was a very powerful meeting and we discussed if we need to, we can go back and have another meeting to keep people up on the progress of the work."

Fencl said 14 other homes have also expressed interest that are outside the 110 commitment. He said if costs to run service to those homes comes back reasonable, maybe Danville can extend beyond the original commitment.

The county has to approve the utility improvements and permit the work. Fencl said those applications are in.

He also said the construction is scheduled to be completed by September. Fiber lease payments to SIREPA will begin in December of 2024. The funding for the project was acquired by the port authority through grants and investments and the port authority owns the new fiber optic ring infrastructure for 10 years. Danville will pay lease payments to SIREPA for those 10 years and the funds are to be used to leverage additional high speed "build out" in the county.

Fencl said additional funding is being released by the state and federal governments, but the regulations on the money make it very difficult for smaller companies like Danville Telecom to compete for the grants. However, the presence of the high-speed infrastructure built by the county, SIREPA, and Danville Telecom, position the county well for other investment by larger firms.

In the last Notice of Funding Opportunity (NOFO), Lee County had two of the top 20 projects presented to the state.

Mediacom and Mediapolis Telephone have been awarded about \$20 million combined to extend additional high speed service in the county with the latest round of grants from Empower Rural Iowa's Rural Broadband grant funding. The two companies have planned about \$28 million in Lee County work.

The Mediacom award could serve approximately 700 addresses in southern Lee County. Mediacom requested \$29 million for their multi-county project to serve a total of 4,466 addresses, but the company was awarded \$19.1 million, which could potentially affect the project going forward.

Under the Mediapolis Telephone project, about 850 addresses in an area encompassing the rural areas north of Fort Madison to Hwy. 16 could be served.

"I'm not going to say we should take credit for that, and when I say we, I mean Lee County Board of Supervisors, SIREPA, and Danville Telecom, but I think because we expressed interest and we got the ball rolling, I think it was imperative to those other companies that they claim a stake here as well," he said.

The federal government has a BEAD program, which is a \$42 billion broadband program, where funding is allocated to each state. Iowa's share, according to Fencl, will be about \$400 million.

'We won't know the extent of that program until late 2024. Once that allocation and plan that Iowa puts together is approved, then we will have a better picture of what the funding looks like for Lee County and the rest of the state," he said.
