FORT MADISON - Local and state officials christened the Turnwater Bar and Grill and encompassing Fort Madison Marina Thursday with the facility's opening set for Monday morning at 11 a.m.

About 200 people, including donors, local officials, and media, were invited Thursday to a test run of the facility on a chilly night that didn't allow for a full exposure to the patio and the vista of the Illinois bluffs nestled against the

Mississippi River.

At about 7 p.m. the setting sun bounced off the BNSF Bridge almost electrifying the bridge as a visual spark to the night's events.

Mayor Matt Mohrfeld welcomed the guests in a presentation held in the event center on the west side of the facility.

"We have the nicest bar and grill in southeast Iowa, we have a much needed event center, and 6,500 square feet of patio. We have a convenience store, gas, it's fully staffed,

It was a crazy past week.

Most of the time I like a message in my Sunday nonsense and this week I thought about talking about student loan debt and President Joe Biden's never-ending attempts to wipe out a good portion of that crippling, federal swipe.

I'm not going to do that because it could get political and that's never good for anyone, but suffice it to say the government shouldn't be making billions off putting students through college. That was a private market enterprise and should've stayed that way. It actually helped keep the price of college down, but that's for another day.

"If you come out of this closed session without filing a lawsuit, how do you justify the closed session because clearly litigation is not imminent. The Iowa code the board cited was 21.5(1) c: "To discuss strategy with counsel in



Playground is next on Riverview Park to-do list

with public restrooms and showers. We have opened the door for business in Fort Madison," Mohrfeld said

Mohrfeld said the old marina chased people away, while the new marina will put a pin in the map of the Mississippi River at Fort Madison, Iowa.

"We are now at a point where we do have the best damn marina on the Mississippi River," the mayor said

Lee County EDG Dennis Fraise echoed Mohrfeld's sentiment

"We used to drive down here on this road in the evenings," Fraise said referring to his high school days in the 70s

"Since that time we've lost 25% of our population. Think about that - 1 in 4 people have left Lee County and tonight we're seeing the renaissance that is the new Fort Madison. It's like we woke up one day and realized we had this river. Look at this view. I don't know how far you have to go, but it's a hell of a long way to beat this."

Fraise then introduced Congresswoman Mariannette Miller-Meeks (IA-1) who said the project will accomplish greater goals.

"I do think it will lead toward what we wanted which was tourism, economic development, and attracting new business," she said.

The U.S. Representative for the district congratulated the mayor for the vision of the project.

"I think this is a testament to the vision and the big thinking of your Mayor. You've got the Caitlin Clark of mayors," she said.

"You had a big vision to do something in a town and community that has been struggling and we all know it. What you have done here is nothing short of amazing."

The ceremony moved on with Iowa Economic Development Authority Director Debi Durham saying the facility will help Fort Madison with a problem that's been plaguing the state.

"The greatest challenge in Iowa is still the same as it was pre-covid and that's that we have a population problem," she said.

"We have to create communities. Focus on the community development side of the equation and create communities in which people want to live. We can retain people and, more importantly, we can attract people to Iowa."

Durham said she's in Lee County so much that she should have temporary office space.

"This rivals anything we see in any big city."

She said the marina is catalytic and has been asking

officials what's next, which has included conversations around the new playground, the Old Fort, and the former Sheaffer Pen building across the highway.

"I can't, quite frankly, wait to see what's next,"
Durham said.

Mohrfeld gave credit to Michael Mohrfeld and Wade Knoke for their commitment and detail of the marina, restaurant, and other assets. Michael Mohrfeld is owner of Mohrfeld Electric and Knoke is a project manager with the company, the two make up the for-profit piece of the development.

There is also a non-profit piece that is responsible for maintaining the marina and dock facilities with revenues generated off marina facilities.

The city infused the project with \$1.5 million and leased the property to the non-profit Southeast Iowa Aquatic Restoration Group, Inc., who leased the land for the facility to the for-profit Turnwater Bar and Grill.

According to the Secretary of State's office, Turnwater is registered by Chris Swed, who was originally hired to manage the facility, but that position is now held by Dan Krieger. The non-profit was registered by Fort Madison attorney Rich Fehseke.

The city leases the property to the aquatic group for \$1 per day. The non profit is responsible for all property and income taxes due off the property with the

caveat that the two groups work together to identify abatements available.

Mohrfeld thanked several people by name including Larry Smith for his fundraising efforts, as well as Greg and Ashley Shottenkirk who donated the final \$750,000 toward the project. He also thanked Michael for his continued commitment of resources to get the project completed.

He also recognized the millions of dollars raised out of the community with no return on investment.

The next step in the process is the playground.

You don't build a \$12 million marina and put up a swingset. We had one vision in mind for that - would people drive 50 miles to come to this playground. That's the playground we're gonna build," he said.

"Is that gonna take \$1.5 million? Debi Durham assured me of this – 'we have money for that." But she assured me it would take a little more from us, too."

Hounds send seven to Drake Relays

DES MOINES – Fort Madison will send seven athletes to the 2024 Drake Relays this week.

Junior Brylie Lorence is seeded 18th in the girls shotput and will be the Lady Hounds' only representative at the meet. The cutoff for the girls' shot was 38'6.5" and Lorence had a season best 39'1.5" from the Burlington High School Invitational on Saturday, April 13. Lorence will compete at 3 p.m. on Thursday at Drake Stadium.

On the boys' side, Caden Barnes is seeded 14th in shotput. Boys needed a throw of 55 even to qualify this year and Barnes season-best this year is a 54'1.5" at the Fairfield Trojan Relays on April 9th. The junior is 7.25" away from being in the top 10 in the state. Barnes will throw at 9 a.m. on Friday morning.

Kenden Bowie has come out of nowhere to qualify for the Blue Oval getting a 6'4" leap last Saturday in Burlington. He's seeded 23rd and will jump at 11 a.m. in Friday morning's session.

The Fort Madison boys' 4x100 team of Adam Sobczak, Dayton Lamar, Hayden Segoviano, and Julian Dear currently has the 62nd fastest time in the state at 44.37. The cutoff this year was 44.87. That team will run in preliminaries starting at 10:12 a.m. Saturday with finals later in the day beginning at 4:29.

Keokuk's 4x100 team of Malachi Allison, Lucas Swainey, Ryan Bait, and Drew Campbell are just inside Fort Madison's mark with a 44.35 and also qualified. Burlington's 4x100 team has the same mark as Fort Madison, so those three schools are just .02 seconds apart.

matters that are presently in litigation or where litigation is imminent where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation."

Take "judicial" note if you will that the language does NOT say ... where litigation is likely imminent, it says imminent. Think of it this way, is death imminent? Not necessarily, even though we all will eventually get there. But when you say death is imminent, it changes the meaning to it's coming very soon.

At issue are some drainage concerns at 320th Avenue that have arisen after the construction of the PORT trail up 15th Street to Rodeo Park. The county contends the issues were created with the construction and, according to a 28E agreement, the city is responsible as owner of the trail to

correct any issues. However, the city contends it isn't the construction but poor county drainage systems that are the problem. Either way, it would seem like a problem that a cup of coffee and some compromise could solve. And we're not convinced ultimately that type of thing will lead to the resolution.

Meanwhile, back at the closed session, if there still is no commitment to filing a suit, then the litigation can 't be defined as imminent. Therefore, we feel the closed session was in error. You also have to give consideration to the fact that the county came out of the session and filed in intent to file, giving the city two weeks to react to the contentions of the 28E. If they are giving the city two weeks to react, then, again, the lawsuit is not imminent.

We will be asking for the recordings of the closed session as a "trust but verify" move to protect the public's right to access conversations of an elected body.

Words matter...gram-

mar matters...sentence construction matters, and all this language under Iowa Code 21 is geared to make public bodies conduct business in an open fashion not as a matter of regular business, but as a matter critical to the integrity of the board itself. The margin of error in that judgment to go into closed session is razor thin, and the code was specifically written to reach that thin layer of exemption.

So that was a seriously weird way to start the week and then on Thursday, at a soft-opening for the Fort Madison Marina and Turnwater Bar & Grill, where Congresswoman Mariannette Miller-Meeks called Fort Madison Mayor Matt Mohrfeld the "Caitlin Clark of Iowa Mayors".

Now I was expecting something huge from the Mayor when he took the stage, after all, he doesn't think basketball is a real sport. If it has a ball, it's not a sport. I'm not sure where he gets that, but no one can pass judgment on the validity of his commitment to running and swimming, both sports that do not engage a ball.

The "Caitlin Clark of Mayors". And this is coming from someone who was referred to as a rock star of Economic Development by Lee County EDG President Dennis Fraise.

"I really missed a cue, I should've walked up and said, "I only want to make three points tonight," Mohrfeld said after the event. "But I doubt I've put a whole gender on the map."

Well, maybe not. But we'd be hard pressed to say you haven't helped put Fort Madison on the map.

Throw in some storm chasing on Tuesday night where I would've sworn I was going to get my first twister photo ever and yeah, it was a crazy week. But in the news world, that's what makes it so much fun.

Taking principal at risk of profit, chasing ugly storm clouds, and a "Caitlin Clark" citing made this week's work just a bit more entertaining for me, and hopefully for you – But that's Beside the Point.


