Keokuk man guilty in father's death

VOLUNTARY MANSLAUGHTER: Rockenbach sentencing set for June 17th

On April 26, 2024, Craig Rockenbach, 43, of Keokuk was found guilty of Voluntary Manslaughter, a Class C Felony, in violation of Section 707.4 of the Iowa Criminal Code, by a jury of his peers. The charge carries a sentence of up to 10 years within the Iowa Department of Corrections. Sentencing will be held on June 17, 2024, at 3:00 p.m.

Rockenbach was arrested and charged with Assault Causing Bodily Injury, a serious misdemeanor for a physical altercation that took place with his father Gary Rockenbach, 84, also of Keokuk, on January 22, 2024. Gary Rockenbach later succumbed to his injuries on February 1, 2024, at the University of Iowa Hospital in Iowa City. Craig Rockenbach was then charged with Murder in the Second Degree.

The Keokuk Police Department was the responding agency and lead the investigation on the case. This matter was prosecuted by the Lee County Attorney's Office. Rockenbach is being held at the Lee County Jail.

Gallery during May. Rockwell's exhibition entitled Familiar Figuresopens on Thursday, May 2nd with an Opening Reception from 5pm to 7pm. This exhibit is a series of oil paintings in vivid color based upon old family photos juxtaposed against more recently taken shots.

They are thoughtfully composed records of teachable moments, memorable firsts, and some of the many milestones' families enjoy together. These timeless images could be anyone's family and the resulting paintings are easily relatable. This exhibition will be on display beginning May 2 and continuing through May 30 during regular viewing hours Tuesday through Saturday from 10am to 5pm. The FMAAA Art Center is grateful to Connection Bank for their generous support and sponsorship of this month's exhibition.

Rockwell's early interest in art as a child had led her to become an art teacher. She received her degree from Western Illinois University. Rockwell's career began as an educator and later included school counselor. While raising a family at the same time, painting she so loved was relegated to moments of leisure.

During that period, Rockwell primarily used watercolors as a medium and landscape as subject. She developed an accomplished control and an ability to express her imagery through dynamic washes and intensely colored imagery. After she retired, Rockwell took additional figure drawing and painting courses at WIU.

Of her current art practice Rockwell states, "Though I now work in both watercolor and oil I am drawn to the rich surfaces oil paint produces and love the experimental element of collage I often use with both."

Rockwell further muses about this exhibition, "The paintings in this exhibit are created from black and white family photos taken from my childhood as well as from more current photos of grandchildren. Though the subjects inspire me it is the relationships, the use of colors and textures, that excite me. As I apply paint with palette knives, textures are revealed that seem to create themselves." Janice Rockwell works out of her rural Macomb home studio Earth, Air & Water.

She will be on hand for Lunch ala Art and a gallery talk about her artwork on Friday, May 24 at noon where she will describe her process and artistic ideas in more detail. Later that evening Kent Strabala will be playing during FINALE, a free performance evening, as the FMAAA closes out the main exhibit for the month.

The other two exhibitions this month will be in FMAAA Art Center's new Pop-up Gallery created with the portable display walls. The recent Winter and Spring Plein Air exhibition will be on display from April 26 until May 11 with work for sale from the thirteen artist that participated in this recent plein air event.

The competition was excellent with artists placing as follows: First Place went to Jessica Kirby, Second to Rebecca Vorkapich, Third Kristin Doney, Honorable Mention to Gin Lammert, with overall Best of Show awarded to Deb Baughman.

The public is encouraged to select their favorite with a People's Choice award being awarded to the winner on May 11. The work is produced from visuals within a 30mile radius of Fort Madison leaving it open to the artist to choose landscape, riverscape, architecture, flora or fauna.

There is a wide variety of imagery from landscape to streetscape in an array of mediums. On Wednesday, May 15 a photography exhibition by Beth Steeples, a member and regular volunteer at the Art Center, opens featuring local imagery to fantastic moments found in faraway places.

Registered bidders can access the auction site by going to <u>www.iowataxauction.com</u>. I will, as required by law, offer to the public at tax sale the following described real estate, mobile homes, and special assessments, which at the time of the sale remain delinquent and unpaid.

Hounds get win over Keokuk in boys tennis

KEOKUK – Fort Madison's boys got a win on the tennis courts Thursday night taking seven match wins from Keokuk in Southeast Conference action.

Aidan Benda, again playing at No. 1 singles, won 6-0, 3-6 (10-4 TB) over sophomore Tyce Hoppe to get things going for the Hounds. Benda is 2-6 on the year and 2-5 in set play through Thursday. He's 55-83 in total games this year.

Senior Javean Davis got his second match win in a row with a win over Luke Thompson 6-1, 6-4. Davis, playing at No. 2 singles for the season, is 3-5 in matches while going 8-9 in total sets and is just one game off being. 500 for the year at 73-74.

James Janic lost at No. 3 singles to Keokuk's Jaxton McNally 6-4, 6-4. The Chief's Zach Atterberg knocked off Peyton Howard in a tight No. 4 singles match 6-3, 1-6, (10-6 TB) for Keokuk's only two wins.

At No. 5, Rowan Benda took a 6-1, 6-1 win over Raden Meier and Jack Amandus beat Kole Kepel 6-1, 6-2 to wrap up singles action with the Bloodhounds leading 4-2.

The Hounds would then sweep doubles action with Benda/Davis knocking off Hoppe/Thompson 8-2, Howard and Rowan Benda won at No. 2 doubles over McNally and Atterberg 9-8 (7-5 TB) and Janic/Isaac Mason downed Meier/Kepel 9-7 to set the final at 7-2.

The Hounds lost to Burlington 8-1 on Tuesday and fell 9-0 to Mt. Pleasant on Monday in windy conditions in Mt. Pleasant.

On Tuesday, Davis got the only win at No. 2 singles over the Grayhounds' Patrick Morgan 6-2, 6-1.

Head Coach Dean Hogan said Davis played probably his best match of the year in the win.

"This was a highly skilled, talented battle and Javean did a great job keeping in the point," he said.

The boys travel to Macomb on Monday for a 4 p.m. contest. Then the Southeast Conference tournament is set for Thursday, May 2 at Burlington's Dankwardt Park.

FAIRFIELD — Fort Madison's girls soccer team is facing back-to-back three-game weeks, and the Bloodhounds have given themselves as little work as possible.

Fort Madison won 10-0 over Fairfield on Thursday night, the second game of the week the Bloodhounds have won by the 10-goal rule.

Fort Madison won 12-0 over Keokuk on Monday in a game stopped at halftime. This one ended at the 32:34 mark of the second half on Molly Schulte's first varsity goal.

"Similarly to our game on Monday against Keokuk, I was able to rotate a lot of girls in," Fort Madison coach Carrie Burken said. "It was good to be able to give the starters rest in preparation for games tomorrow and

Monday (against Southeast Conference leader Burlington)."

Hadley Wolfe had five goals for the Bloodhounds. Natalie Randolph scored twice and Reilynn Turnbull and Kara Lake each had a goal.

Turnbull had three assists and Randolph had two. Halle Menke, Macey McLees and Ellie Hellman each had an assist.

"It was fun to be able to watch so many players rotate in and get involved in our offense," Burken said.

The Bloodhounds still have not allowed a goal in regulation time this season — the only goals against them came in penalty kicks in an overtime loss to Burlington.

Goalkeeper Taylor Johnson had one save.



Comments were received from Brent Koller. Koller is President of the Lee County Farm Bureau Board. Two petitions were submitted with signatures asking that the question of submitting bonds be submitted to the registered voters of the County at an election. Koller said he has a wish list for the County. "I wish we had a blank check to fund all of the county needs. I wish we knew if the ag appropriations money would pass giving us another \$2 million. I wish we knew what would happen at the state level with speed cameras. I wish we could say we knew the future of the health department. I wish every person in the county had seen the floor plans and designs of the buildings months ago, much like how a normal bond process is done by counties and school districts. I wish we weren't coming off of a year we publicly told tax payers that the county is broke and we had to use the ARPA money to make it through the rest of the year. I wish we wouldn't have any other needs for ARPA money. I wish we knew if we have

But "few and far between" is another idiom that the gig-economy has stripped us away from. Nothing is few and everything is more and more being pulled together.

So that leaves me with the frustration of just having to go "go with the flow". I hate just going with the flow when I can't control the energy behind the flow.

Our world of digital creation in a tech functional society is at the same time a blessing and a curse. I love the endless opportunities it provides, We saw an upgrade this week that allows us to drop backgrounds on photos in about three key strokes. But then at any time, there can be a "handshake" between platforms that gets clogged for whatever reason and you're screwed.

Typewriters required ribbon and maintenance and white out and way more action than just fingertapping. You had to swipe the carriage back by hitting the carriage return lever unless you got on of those new fangled automatic typewriters. You had the platen knob that rolled the paper through the carriage unless you used the handle and pumped it back and forth.

Ok. I don't miss the typewriter. And I don't miss the fax machine. I like email and I like "copy and paste" and I like photo correction and InDesign and Acrobat and Photoshop.

But just leave my crap alone. I like the way it works right now. I'm not sure there's a whole lot you can do to speed things up for me.

I did see a few apps that convert the spoken word into text, but there's a few issues with that. It doesn't (yet) identify the person speaking so you have to make notes about that. It also doesn't hit every word right so there's that and that's a big issue when you're quoting people. I don't think they've made one yet that works for me. I've messed around with Otter and it's nice for conversions outside the journalism field but it's not hopped enough yet for that industry.

So I'm not that old-school guy that just wants to use a pencil and notebook for my work. I like utilizing technology, but when it punches a hole in my workday, it makes me long for the days when someone else had to do the page design, press operations, sorting, and delivering.

Suffice it to say (yes, that's an English idiom, too), we press on with our tech reliance, and we suffer through the late night hours to bring you some news every weekday. And you have my word, as I watch Da Bears take Iowa's Tory Taylor as the first punter in the 2024 draft, that we'll "press on" and "weather the storm" to do our best to bring you news and sports, and breaking information – whether the "cloud" likes it or not.


