### **BHS DOWNS HOUNDS, LADY HOUNDS:** Conference title hopes wane as FM loses two

# • Fort Madison girls fall 2-0 at home; complete game story inside

BURLINGTON - Fort Madison went into Monday's boys Southeast Conference soccer match a little banged up. They ended a day a little more banged up with their conference title hopes teetering on the brink.

Burlington High School handed the Bloodhounds their third

loss in three days 3-1 and dropped Fort Madison to 5-2 in conference play and 6-6 on the season.

The energy of the game belonged to the Hounds in the opening minutes as they took control from the opening kick and pushed the Grayhounds back to the box. Junior Henry Graham was in a one-on-one situation on the Bloodhounds right side, but a push from behind sent Graham to the ground with a bum knee. He would limp off to the sideline, but wouldn't return the rest of the match.

Fort Madison Head Coach Kevin Wellman said that wasn't

# Lady Hounds fall 2-0 to BHS

FORT MADISON Fort Madison's offense badgered Burlington for the first half of Monday's girls soccer match, but couldn't get any goals.

Then the Grayhounds' offense struck in the second half, and the frustration for the Bloodhounds grew.

Burlington's 2-0 win put the Grayhounds in control of the Southeast Conference title race and left the Bloodhounds lamenting the missed chances.

"We had some good runs, really good opportunities, and we really couldn't finish," Fort Madison coach Carrie Burken said.

Fort Madison (7-2 overall, 5-2 conference) fell to 2½ games behind the Grayhounds (10-2, 8-0) in the conference standings with three conference matches left for the Bloodhounds.

Fort Madison had five shots on goal in the first half, seven overall, but couldn't get anything into the net. Teagan Snaadt, Natalie Randolph and Hadley Wolfe, the Bloodhounds' three leading scorers this season, each had two shots on goal.

When Burlington's Brooklyn Sparrow scored off a corner kick six minutes into the second half, it only magnified the missed opportunities.

"You could see emotionally, there was a deflation, rather than, 'Let's go, let's get it back," Burken said. " I think it's frustrating when you have more shots than they did, and then you give up a goal."

It was the first time all season the

Bloodhounds had been behind in a match. The only goals Fort Madison had allowed to that point were the three surrendered to the Grayhounds in penalty kicks at the end of the April 11 match at Burlington — the Bloodhounds had not given up a goal in regulation time.

And when Burlington's Isabella Ziegler scored with 21:34 to play, the Grayhounds were in command.

"I feel like our communication broke down," Burken said. "We really didn't do a good job of communicating in the first half, but I felt like it got worse somehow. And then I think we got a little disjointed defensively."

Burlington has won four of the last five matches against Fort Madison. But Burken pointed out how the Grayhounds beat the Bloodhounds twice in the regular season last year, with Fort Madison then eliminating Burlington in the postseason.

"If you look at the two games against Burlington, we had our opportunities, we had our chances to win," she said. "We needed to be better in the second half. We needed to connect on passes better, we needed to communicate better, and we need to learn from that."

Fort Madison plays at Mount Pleasant on Tuesday. The Panthers are a game ahead of Fort Madison in second place in the conference after Monday's 10-0 win over Keokuk.

"We have to refocus, because Mount Pleasant is a good team," Burken said. "It's not a given that it's a win. So we have to be ready to play."

# Homeowners can protect themselves against scammers

Iowan who was hit. This is when we need to lean on each other more than ever, neighbor-to-neighbor, and keep an eye out for those who seek to take advantage of Iowans' hardships. Iowans are resilient, but they should not need to fight off scammers while rebuilding their lives. Before hiring a contractor, take your time, do your research, and protect yourself from falling victim to a storm-chaser scam. My office is always a resource to those who suspect they are being targeted by scammers."

Top 8 Tips to Avoid Storm-Chaser Scams:

1. Beware of Aggressive Sales Tactics: Do not feel pressured to immediately make repair choices. Get multiple estimates before agreeing to repairs.

2. Check Contractor Reputation: Before signing a contract or paying any money, check a contractor's reputation through government resources and with trusted family, friends, and neighbors. Resources include:

Better Business Bureau complaint database: www.bbb.org.

To see if a contractor has been part of a lawsuit involving a scam or shady situation, visit Iowa Courts Online: https://www.iowacourts.state.ia.us/ ESAWebApp/DefaultFrame.

Contact the Iowa Attorney General's at consumer@ag.iowa.gov or (515) 281-5926 to check complaint history.

3. Verify Contractor Identification: Request a contractor's driver's license and take pictures of their vehicles' license plates.

4. Get a Written Contract: Avoid large up-front payments and never sign a contract that allows the contractor to exclusively decide on final price, scope of work, or materials.

5. Work Directly with your Insurance Company: Do not let the contractor negotiate repairs with your insurer or let them act as your adjuster. While contractors can advise you, your insurance company is your primary contact.

6. Avoid Risky Payment Methods: Never pay by bank wire transfer, gift card, cryptocurrency, or cash.

7. Beware of FEMA Scams: Know that FEMA

does not charge application fees. If someone wants money to help you qualify for FEMA funds, it is a scam.

8. Know your Cancellation Rights: In most situations, you have three business days to cancel a home repair contract after signing it.

Governor Kim Reynolds has issued two disaster proclamations in recent weeks related to the severe weather. Those proclamations are in effect for Allamakee, Cass, Des Moines, Fayette, Henry, Lee, and Pottawattamie counties. The proclamations trigger state regulations prohibiting price gouging in the affected counties during the period of the proclamation and up to an additional six months.

Price gouging occurs when an Iowan is charged excessive prices for essential goods or services following disaster. Whether a price is excessive is generally based on pre-disaster prices. The law recognizes a reasonable pricing structure for the recovery period that may allow some increase in prices.
