### **GIRLS FIRST:** Lady Hounds 1st, boys 3rd in Division A: Hawks, Crusaders place

FORT MADISON - The Fort Madison Bloodhounds got some good news and some not so good news at the Timm Lamb Invitational Cross-Country meet at Rodeo Park.

The Lady Hounds captured 1st place with 27 points as Avery Rump took second place overall with a 20:29.1, about 45 seconds behind champion Iris Dahl, who took the title with a 19:45.2.

The girls' team continues to excel as a squad, but two-time state qualifier Rump still isn't quite herself after struggling with some heat issues early in the season. Despite the heat Thursday, Rump gutted out the 3-mile course on the northwest side of the park. Her twin sister Addison had another strong showing as her times continue to improve on the year. She took 6th overall with a 20:53.3. junior Mara Smith is running in her first year of varsity cross country and continues to rack up top-five finishes for the Bloodhounds and typically top 20 overall. And freshman Ellie Hellman continues to impress as a top five Lady Hound and top 20

Hellman said she prefers casual running to competitive,

### **UNEMPLOYMENT**

# Jobless rate shows a slight Aug. uptick

DES MOINES - Iowa's seasonally adjusted unemployment rate increased slightly to 2.9 percent in August, ending a four-month stint at 2.8 percent. Driven primarily by retirements, the state's labor force participation rate fell to 66.3 percent from 66.4 percent in July. Meanwhile, the U.S. unemployment rate decreased to 4.2 percent.

"National headwinds continue to cause Iowa employers some collective concern about uncertainty in the U.S. economy," said Beth Townsend, Executive Director of Iowa Workforce Development. "This might explain the sluggish hiring we are seeing now. However, opportunities still exist, as Iowa's unemployment level remains low and there are more than 54,000 job openings posted on **IowaWORKS**. gov. IWD career planners can help match anyone ready to work with those employers who are ready to hire."

The number of unemployed Iowans increased to 48,400 in August from 47,600

The total number of working Iowans fell to 1,635,400 in August. This figure is 2,400 lower than July and 20,300 lower than one year ago.

Seasonally Adjusted Nonfarm Employ-

Total nonfarm employment decreased slightly in August by shedding 600 jobs and lowering the total to 1,609,400 jobs. This loss follows a similar decline of 200 jobs last month and was the result of private service firms lowering staffing levels over the last 30 days. Goods-producing firms, including manufacturing and construction, advanced slightly since July, gaining 400 jobs. Government (a sec tor that includes federal, state, and local political subdivisions, as well as schools, universities, and public hospitals) also added 400 jobs. Hiring was divided between state, local, and federal institutions and now rests up 3,900 jobs annually. Total nonfarm employment overall has gained 20,100 jobs over the past year.



the most jobs since July (-1,800). This sector has now pared 3,200 jobs since June. Administrative support and waste management was responsible for most of the loss, shedding 1,300 jobs. Leisure and hospitality also lost jobs in August (-500). Accommodations and food services was responsible for all the jobs shed and has been trending down slightly since April. Alternatively, construction added 700 jobs since July, erasing a small drop of 500 jobs last month. Firms involved in new building construction were responsible for most of the loss this month. Other services also added 700 jobs and has now gained 1,300 since May.

## Crusaders blow by New London as tough week looms

### **LISBON TOURNEY SATURDAY: HTC**

gets match over in less than an hour to rest up for long week ahead

NEW LONDON — It was best for Holy Trinity's volleyball team to just get in and get out with what's coming up in the next week.

The fourth-ranked (Class 1A) Crusaders needed just 51 minutes to sweep New London 25-9, 25-12, 25-7 on Thursday night.

The Crusaders (5-2 overall, 3-0 Superconference South Division) are heading into a stretch that includes the Lisbon tournament on Saturday, their own tournament on Monday, and the SEI Superconference tournament next Thursday and Saturday. It's a lot of volleyball for a team that hasn't played a lot of matches.

"We're going to be busy in the next week or so," Holy Trinity coach Melissa Freesmeier said. "But that's what we need — playing games against good competition so we can get better."

"We're definitely excited," said junior middle hitter Presley Myers, who celebrated her birthday with a teamhigh 13 kills and three blocks. "I think we're going into it with a lot of improvement from the beginning of the season, and I think we're going to do well."

The Crusaders didn't waste any time against the Tigers (1-9, 0-3).

"I think it was really important to get done early," said sophomore Adalyn Kruse, who had five kills and eight digs. "We can get home early, get some sleep, get some rest, and get ready for the weekend."

Holy Trinity jumped on the Tigers early, scoring the first seven points of the first set on the way to a 13-3 lead.

"We've been starting slow a lot," Kruse said. "I think it was good that we played with a lot of energy."

"Matches like this may not look as difficult as some of the ones we play," Myers said. "But they are just because there wasn't a ton of energy in the gym. We have to work hard to keep the energy up, and I thought we did that. We stayed pretty consistent, had a constant level of

New London had early leads in the second and third sets before the Crusaders went on long runs. They had an eight-point run in the second set and a 16-point run in the third set. That third-set run included 15 consecutive service points from freshman Olivia Bendlage, who had four aces in the stretch.

"We wanted them to be focused and get the job done,"

Freesmeier said. "And I thought we did that tonight."

The Lisbon tournament on Saturday includes the host school, which was in the IGHSAU rankings until the newest one that came out on Thursday, as well as No. 10 (Class 2A) West Burlington.

"We're getting close to regionals, so I think any good competition we see is going to help us," Kruse said.

"We're not going to be practicing, but we're going to be on the court seeing some good teams, so that means we're going to be getting better," Freesmeier said.

"I think we're going to do really good," Myers said. "We're all getting more comfortable with each other. That's what we've been working on, chemistry and communication and stuff like that, and I think we did really good with that tonight. That kind of progress is going to help us."


