Hounds win intracounty tilt

FORT MADISON - The word of the day for the Fort Madison/Central Lee intracounty boys' basketball game was simple - Flush.

Central Lee Head Coach Jonny Swanson just wanted to flush his Hawks' 81-53 loss to a very athletic Bloodhound basketball game.

And the Hounds' Kenden Bowie wanted to flush everything else.

Bowie had two dunks – one off an assist from Nolan Guzman who looked back on a fast break in the fourth quarter and saw Bowie in the trail. Guzman tossed the ball up off the left side of the glass and Bowie flew in for the slam to punctuate the Hounds' play all night long.

"We worked a lot in the summer and got to know each other," Bowie said. "We're playing really well together right now."

Fort Madison head Coach Ryan Wilson said it's nice having the skill set the Hounds have, but its also a matter of making it work.

"It allows you to do some different things. It allows you to play some different defenses and different philosophies, offensively and defensively. On top of that, it makes it a little more fun," Wilson said. "It gives us some different looks, and I like it."

The Hounds trailed just once at 8-7 when Central Lee's Will Hayes hit a jumper just outside of the lane. Senior Brayden Wyrick would hit a 3-ball after the Hawks got a defensive stop in transition at about the 3:50 mark of the 1st quarter. But Dayton Lamar would score inside and then Jackson Guzman would bury a 3-pointer from the right wing after Lamar shot a behind-the-back pass out of the lane all the way to the perimeter to give Fort Madison a 12-11 lead they wouldn't surrender the rest of the afternoon

Fort Madison would push that lead to a 20-16 margin at the end of the first quarter.

Bowie opened the second with a 3 pointer and then Nolan Guzman stole the inbound pass and converted for a 7 point lead. Fort Madison's press would cause Central Lee some problems up the floor, and anoth-

er steal resulted in Dear trying to slash through the lane for 7-0 run. Dear's shot went off the back of the rim and Bowie

Hawk boys knock off No. 6 HTC Friday night at home

DONNELLSON — Every firstyear coach looks for that win, that victory that shows that the effort, the transition to something new, is working.

Jonny Swanson got that win on Friday night.

Central Lee's 55-52 victory over No. 6 (Class 1A) Holy Trinity was a "statement win," Swanson said.

Taking down a team that was in second place in the Southeast Iowa Super Conference South Division and was being considered one of the best teams in the state in its class certainly qualifies for the honor.

"I've been talking about it all year," Swanson said. "That's the position we want to put ourselves in against the Holy Trinitys, the Notre Dames, the West Burlingtons. We want to be in those games at the end.

"It was a gritty, tough win."

Central Lee (5-5 overall, 4-4 South Division) scored just nine points in the fourth quarter, but six of those came in the final two minutes to clinch the win.

Will Hayes' layup with 19 seconds left put the Hawks up 53-52, then Owen Swan's two free throws with 1.2 seconds remaining provided the final margin.

had a nine-game winning streak in the series and had won 12 of the last 13 games against the Hawks, had a chance to tie the game, but Luke Hellige's 3-pointer from midcourt missed.

Swanson had a sense that this kind of game was coming from his

"We had a really good couple days of practice leading up to this," Swanson said. "The energy when we have a team like that in practice is a little bit different. Like, they sense the magnitude of the game, and they bring it every day, and they want to win those games, right? And so I knew they were going to be locked in. I knew they were going to be locked in. I knew they were going to be focused. I knew they're going to bring energy and intensity, and, you know, the rest just kind of takes care of itself."

Holy Trinity coach John Hellige got an opposite sense from his team.

"When you play teams like Central Lee, teams that are really up and coming, really looking for that signature victory, you've got to be laser focused," Hellige said. "You've got to be sharp. And when you're not sharp in practice, and you go through the motions when you get to a game like this, when you try to play at their speed and their physicality, you know you're

going to have mistakes, not going to finish things. And I think it's a good lesson for this team."

Other than two ties in the first 90 seconds of the game, Central Lee led until the 5:29 mark of the fourth quarter, when a 3-point play by Luke Hellige gave Holy Trinity a 49-46 lead. But Central Lee's Caden Swan tied the game with a 3-pointer on the next possession, just another answer on a night when the Hawks handled everything from the Crusaders.

"I thought we would get going," John Hellige said of his team taking the lead. "We had some uncharacteristic turnovers and breakdowns there at the end that really bit us."

"We were close at their place early on in the year (a 53-47 Holy Trinity win on December 3)," Swanson said. "And we kind of been talking all year like, hey, once we see some of these teams at home, with our atmosphere, we shoot the ball a little bit better, they shoot it a little bit worse, maybe things will really start to come together. This back half of the season we play eight or nine more games at home. We have a really good stretch at home."

Swan led the Hawks with 19 points. Hayes had 13.

Luke Hellige led Holy Trinity with 27 points. Koby Jones added

came flying in from the right side and slammed the rebound for a 27-18 lead.

Central Lee wouldn't get a bucket until Ward Fraise buried a 3-ball from the left baseline down 29-20. The Hounds would finish the half on a 10-4 run for a 40-27 lead at the break.

Central Lee would miss five of their next six shots out of the locker room while Fort Madison heated up, going 5 of 8 from the field for a 50-35 lead that they would never relinquish.

Wilson said Bowie is starting to round into form in his first full varsity year.

"He's worked hard in the off season. As a junior, he wasn't able to play a lot but he worked hard in the gym with a personal trainer and honed his craft," Wilson said.

"He got a lot of shots up and, when you got a kid like that that can use either hand and go to the right just as easy as the left, he can be pretty dangerous. But when he's hitting from the outside, we're a whole different team."

Darious Foy had 12 points in just his third varsity game and made an impression.

"When you put a 6'8" kid in the middle to rebound and finish . . . you saw some of the Central Lee kids having to pull up and, when you have him and Dayton in the lane protecting, it changes things."

Bowie said he regrets not being able to get on the floor last year, but he's worked hard over the summer to fine tune his game.

"Obviously, I still want to get in the gym and work on the form, and then everything else kind of comes naturally," he said.

"This feels a lot better than sitting out," he said. "I wish I would have this time last year because I feel like I could've made the same impact. But everything happens for a reason, and this may be my time to break through."

Central Lee Head Coach Jonny Swanson said it's been a rough 24 hours with two games.

"The amount of size they have is hard to match up with. Even their guards are two or three inches taller than us. We played a lot of zone and kind of forced them to shoot well and they did that in the first half."

But Swanson said he was happy with the output of the Hawks and said they have to keep the emotion of Friday's win over Class 1A No. 6 HTC in mind.

"We can't let this take away from the feeling we had last night," Swanson said. "All in all, it was a good weekend. We've still got some stuff to work on, we got beat pretty good tonight."

He said the Hawks have been scoring 50-60 points per game so the offensive output was strong, but Central Lee just couldn't match up very well with the Hounds' height and athleti-

Lady Hawks break 5-game skid against HTC

HOME WIN: Central Lee girls down Crusaders 37-23

DONNELLSON — Taylor Hickey wrote a message to her players on how they were going to beat Holy Trinity on Friday night.

Then Central Lee went out and followed those instructions perfectly.

The Hawks shut down the Crusaders, taking a 37-23 win in a Southeast Iowa Super Conference South Division game.

"I'm going to go back to our defense," Hickey said. "I mean, truly, that was written on the board tonight. If we play all out defense, we'll win this game. I thought tonight, what totally did it for us was our defense."

The Hawks (6-5 overall, 5-3 division) held the Crusaders (8-2, 6-2) to 10 second-half points, and eight of those came in the final four minutes.

Central Lee was playing the exact defense Holy Trinity wanted, yet the Crusaders couldn't capitalize.

"We hoped they would play us in a (man-to-man defense)," Holy Trinity coach Shawn Hopper said. "You want players that want to fight, and tonight our girls didn't seem to want to do that at all. They didn't want to get the ball down the court.

"Pretty disappointed in our effort. But definitely some of the blame has to be on me, too. I obviously didn't have them ready."

The Crusaders were coming off a 69-42 loss to Mediapolis on Tuesday in a battle for the division lead. Hopper was curious how his team would respond.

"We get our first loss at Mepo," he said. "And I figured this was going to go one of two ways. We're going to come out ready to thump somebody, or we were going to be licking our wounds a little bit, and apparently we're still licking our wounds."

Central Lee hit the Crusaders with six consecutive points to open the game, and it took Holy Trinity almost four minutes before it got its first points.

The Crusaders were within 12-9 with 5:43 left in the second quarter, then Central Lee went on a 25-8 run that lasted until late in the fourth quarter.

Kenna Sandoval led Central Lee with 10 points. Sydnie Larson and Lizzy Mason each had eight points.

Teagan Snaadt led Holy Trinity with eight points.

Central Lee snapped a five-game losing streak to Holy Trinity.

"Finally, right?" Hickey said. "I mean, I'm truly proud of them. I've had games where I reflect after, and I just hurt for the girls, because we don't show the two hours basically every day that we're putting in practice out in some of our games, and a lot of that is confidence.

"Tonight the girls, they were all flat out playing as hard as they could. Whoever was on the court, they were truly giving it all. There was no rest time. You can see it in their faces. They were gassed, but, but they weren't going to fold."



Looking for input on the future of news delivery

loss.

I think the base of the conversation starts with reader habits. What are you reading?

Do you take social media as your most reliable source of local news? I don't think you can take it as the source of national news, because honestly, I see some of these news reels, even if they have the news organization's logo on them, and I don't know if its real or not.

We know foreign countries and evil-doers have cloned social media sites. How do you really, really know if that's real or not? And you're seeing more question marks in my writing this week than you ever have before. It really speaks to my state of mind right now.

I just don't know. And that's a little scary. Not that I don't know, I'm not a genius by any stretch of the imagination, but it's scary because we own a company and we don't know what the future holds.

Some of the conversations I've had centered on people choosing news sites on social media based on what they personally want to "hear" on a daily basis. Not necessarily what is actually happening on a daily basis.

Well, what the hell is the business model for that? I thought about having a round table of sorts over some snacks and drinks in a business after hours format, but I'm not sure people would value the conversation over the snacks.

I need information. I need input from our readership to help determine what we need to do as an organization to continue to bring you news that you can trust, while at the same time, keeping you engaged and even entertained.

But I even have stress about that. Is it too late for the community news organization? Are people so "tractor-beamed" to social media for information that they've forgotten that being in the know means being informed. This week has told me that maybe we don't want to be informed, and we want our news outlets to cater to us on a personal level. I think in simpler terms it means we need validation of our beliefs over consumption of what is actually happening.

I don't think that's "just fine" because validity of source and the trust of that source is critical to news gathering, i.e. we have to have your trust. You may not always like what we write, but we need to know you trust us to be fervent in our approach, and accurate in our information. No one is perfect, or as I like to say, no one operates on a plane of perfection. But the body of work has to be valued. So how do you mix that in with the propensity of people to migrate to news that impacts their lives where they live. We want to provide a mechanism where you

consume, and at the core, trust the content despite your political or emotional leanings.

And what about sports??

We're seeing people don't want to read long stories that take you into the game. That used to be why we read. We wanted to know the coaches' reactions, or players' insight, but are we in such a hurry "ain't nobody got no time for dat"? Do you just want us providing local high school sports, or are you interested in locally produced copy about SCC, the University of Iowa, or Western Illinois?

Is it just families and friends reading about kids playing locally and no one else? I'm looking for feedback, but I don't even know the best way to get that feedback. Maybe this week's offering will generate some comments and that would be fantastic. I'm really not looking for likes and dislikes. What I want to know is what you think the future of news is. How do you want it delivered, what are your reading habits, what do you think the future looks like for people who try to bring you news and sports, and information about people who provide you goods and services. I'd even be open to ideas on how to survey for this information. I don't like social media polls because we've seen they can be manipulated and not generate granular valuable information. This is a real throw-yourhands-up moment for me.

In other words, how do you access information about your community, whether it be newsmakers or product makers and sellers. What is the best way to engage, and in many cases, re-engage you in news consumption.

We're going to keep providing the information to you and we're going to keep looking for ways to bring it to you the way you want it. So let me have it - right here if you want. There are no bad ideas or suggestions. I'm interested in everything you have to say. I may re-engage with you and I may not, but the value is in hearing from
