## Murie now facing attempted murder

**COUNTY ATTORNEY:** Review of charges results in more severe charge from assault

Iowa Regional Medical Center for a report of a female victim suffering from lacerations to her head and neck.

Murie was initially arrested and charged with Violation of a No Contact Order, Willful Injury Causing Serious Injury, and Domestic Abuse Assault with a Weapon. Following further investigation, and a review of pertinent information that was unavailable at the time, the charges were increased in severity. He is currently being held in the Lee County Jail.



# Wade shoots 2-over 37 at Washington Invitational

WASHINGTON - Fort Madison claimed 2nd place in the Washington leg of Southeast Conference boys golf action Monday night, their highest finish in SEC play this year.

The Bloodhounds hold 3rd place overall in the series with 876 points behind Washington (792) and Mt. Pleasant (838).

# NASCAR's Kyle Larson working the long game

NEWTON, Iowa — I suppose if I'm going to be in the passenger seat of a Corvette going 100 mph down the short backstretch of Iowa Speedway, I'm going to be comfortable with Kyle Larson as the driver.

The NASCAR Cup Series driver was in Iowa on the series' last off weekend of the season to drive a sprint car at Knoxville Raceway, but made a stop at Iowa Speedway on Friday to promote the August 3 Iowa Corn 350 at the .875-mile oval.

Larson can drive pretty much anything and drive it well — he'll be doing the Indianapolis 500/Coca-Cola 600 double on Memorial Day weekend again this season, and it wouldn't be that much of a stretch to think he could win both races.

Part of the day was spent giving media members rides in the track's pace car, so I took the opportunity to get in a few laps with Larson.

He explained the nuances of the tight track to me in a conversation that was like two guys driving down the highway except we were diving into the turns as he would on race day, albeit at a little bit of a slower speed.

I've done the pace car rides at the track many times before — Regan Smith, Kenny Wallace, Austin Dillon and Elliott Sadler were some of the drivers — and it's an opportunity to a.) see what kind of line they drive and b.) see how close they get to the wall on the backstretch and by the start/finish line.

The acceleration off pit road was a sign Larson wanted to get some speed out of the Corvette, and I was fine with it.

When Larson got done taking all of us around the track, we got some one-on-one time with him, and of course I had to ask him why, less than a week after practically sweeping the previous weekend at Bristol — he won the Cup Series and Xfinity Series races and finished second in the Truck Series race — he was going to be in a sprint car for the World of Outlaws races



at Knoxville. For Larson, it was playing the long game. He wants to win the Knoxville Nationals at the track in August, and although he's been at the track many times before, including last season's victory, he still wanted the education.

"I have a lot of fun, and I love Knoxville," said Larson, who finished second in Saturday's A-Main. "And it was just an opportunity to get ready for the Nationals, which is important. So, glad that we were able to make it out for this and hopefully, hopefully it goes good, hopefully you learn something and get even better."

It's hard to be better for Larson these days. He has two wins and five top-5s in the Cup Series this season as he sits fourth in the point standings.

He's just a few weeks away from attempting the Indy/Charlotte double again. Larson finished 18th in the rain-delayed Indianapolis 500 last season, then by the time he got to Charlotte to at least some of the 600, the race was in a delay that would eventually wipe out the rest of the race.

"There was nothing that really surprised me last year," he said. "I felt like (IndyCar) was very similar to Cup racing. I think just how traffic in the race is different than in practice, maybe that is all that I would be better prepared for this time."

Larson was looking forward to being back at Iowa Speedway for the August race. He finished 34th in last season's inaugural Cup Series race at the track, although he led 80 laps.

What impressed Larson that day was the crowd — it was a sellout, and this year's race is close to being sold out as well, with approximately 200 tickets still available.

"I was just happy to see that (the fans) were happy to have NASCAR racing here once again, especially the Cup Series," Larson said. "So yeah, I got to see a lot of familiar faces from dirt racing fans here, and that always feels good. And then the racing on track was great as well. So yeah, I thought the atmosphere and everything made for a good weekend. Can't wait to do it again."

I thanked him for the fast laps and headed home. A ride down Interstate 80 was still ahead, but it wasn't going to be as fun.

# Greater Burlington Partnership denies partisanship

In their statement last week the group said Collins' record is one of "division, exclusion, and harm". They cited several votes on Collins' record as State Representative including:

- He voted in favor of HF718, which capped tax levies — even those previously approved by voters — slashing funding for critical public amenities like the library, community pool, art center, and municipal band.
- He supported efforts to strip diversity, equity, and inclusion (DEI) programs across Iowa, and backed measures that restrict academic freedom at state universities.
- He voted to remove rights from the Iowa Civil Rights Act — undoing protections that had been in place since 2007 and making Iowa the first state to remove civil protections, a dangerous precedent that could impact all Iowans.

According to a release from the partnership on Wednesday, the organization aligns with values of inclusion and nonpartisanship.

"The Greater Burlington Partnership is not a political entity, and staff roles are not vehicles for political advocacy. While the Economic Development Executive Director may hold public office, his responsibilities within the Partnership are focused solely on advancing economic growth and opportunity across the region," the statement released by Dustin Roth, GBP Director of Marketing and Communication, explained.

"This is a results-driven position, measured by tangible outcomes such as business growth, job creation, and strategic partnerships that strengthen the local economy. Clear expectations are in place, and the position is overseen by the President & CEO and the Economic Development Board of Directors, who are committed to ensuring that all efforts reflect the best interests of Greater Burlington's residents, businesses, and stakeholders."

GBP President and CEO Amy O'Brien said the agency is focused on economic development.

"Greater Burlington is made up of people with many different perspectives, backgrounds, and experiences. And that's what makes this community so strong," she wrote.

"We're proud to serve a place where people care deeply about their neighbors and their future. Our work in economic development is focused on expanding opportunity and strengthening our region, for everyone who calls this area home."

The statement went on to add the partnership remains committed to advocating for the needs of the community and supporting efforts that contribute to long-term economic growth and regional vitality.

"All staff are required to uphold the Partnership's core values: collaboration, integrity, and service to the entire community. We remain open to hearing from the community and working together to ensure our efforts reflect the values and goals of the region we proudly serve."

## Reports show Murie tried to kill woman

investigation. The case is being prosecuted by the Lee County Attorney's Office.

The public is reminded that a criminal charge is merely an accusation. All individuals are presumed innocent until proven guilty in a court of law.

According to records filed in N. Lee County Court, the victim was asleep in the living room the evening of April 11, when she heard loud banging on the door and found Murie standing in the doorway and it being dark outside.

The victim's statement to police indicated Murie and the victim became engaged in an altercation and he had a machete and a hammer, along with a shorter knife and a box cutter in his hand. Murie told her that he was going to kill her and then kill himself.

After a period of physical assaults, the victim reported that Murie began to wake her up to tell her she needed to get in her vehicle to be taken to the hospital, where staff notified law enforcement.

The complaint also indicated that Murie had no weapons or tools on him at the time of his arrest. The victim was stabilized and then transferred to another facility for advanced care.

Murie is being held on a \$20,000 cash only bond.
