FORT MADISON – If Joey Herren had his way Wednesday, he would have gone out the back door of the Fort Madison fire station, got into a personal vehicle with his wife, and went home.

Any other day, that would seem like a relatively normal occurrence, but on Wednesday it was after Herren received a ceremonial call out from LeeComm signifying the end of

his final shift after 27 years fighting fires in Lee County, the last 18 as fire chief in Fort Madison.


As Herren envisioned going out the back door to head home, newly sworn-in fire chief Chad Hannum would exit the front door and climb into the city's fire command vehicle.

Wolter hired as next FMCSD Superintendent

COUNTY SUPERVISORS County gives 2nd OK to energy project ordinance

Regs for solar, wind, and battery energy still need one more OK on reading

LEE COUNTY – The Lee County Board of Supervisors approved the second reading of an ordinance that will govern the installation, maintenance, and decommissioning of energy projects in the county.

The ordinance has been in the works for more than six months and has been posted on the county's website for residents to view and comment on, but still needs one more final vote before it can be published into the county code. The ordinance would also regulate MET or Meteorological Evaluation Towers, that study wind conditions prior to construction of a wind farm.

The board also discussed resolutions that would establish fees associated with the regulations.

Several residents, including Ted Stein and Andrew Johnson of rural Lee County, spoke to supervisors at their regular meeting Tuesday afternoon about the setbacks on the ordinance.

Both men have been regular attendees of multiple meetings the county had to discuss the ordinance with voters with several project companies in attendance.

Stein said he would like the county to consider an additional debris setback of four times the height of wind turbines placed in the county. Several companies, including Tenaska Energy, have started to look at Lee County for large scale wind projects. That project has lost some energy as of late. Supervisor Garry Seyb said he's heard the company has put the project on hold due to lack of interest by Lee County property owners.

Wolter is expected to receive his Ed.S. degree in the superintendency from Northwest Missouri State University in June. He also holds a master's degree in educational leadership from Viterbo University and a bachelor's degree in elementary education from the University of Northern Iowa.

"I'm incredibly honored and excited to be named the next superintendent of the Fort Madison Community School District," Wolter said. "This district and community have played such an important role in my life and career, and I'm grateful for the opportunity to return and serve in this new capacity. Hound boys win Keokuk Relays

LADY HOUNDS 2ND: Central Lee runners post more personal records

KEOKUK – The Fort Madison boys' track team captured 1st Place at the Keokuk Chiefs' Relays Tuesday night behind seven titles. The Lady Hounds finished in second behind Mt. Pleasant as the season begins to wind down.

Nolan Guzman ran a season best in the 800 to take the title with a 1:58.52. That's a top 40 time in the state per Varsity Bound. Guzman was also part of the 4x800 Bloodhound squad that came in first with an 8:49.59 with Peyton Lambert, Mason Mc-Ley, and Riley Tripp.

Fort Madison also got titles from Brayton Schneider 145'11" in the discus, Urijah Brooks in the shot at 54'1". Brandon Klein took three titles in 101, 201, and 401 wheelchair events.

The Lady Hounds got first-place finishes from Avery Rump in the 1500, who just missed breaking the 5' mark with a 5:00.57. Jordyn Marshall was 2nd with a 5:10.33, both season-best times. Addison Rump won the 3000 at 11:21.00, which was her best time of the year.

The girls also won the 4x800 with Marshall, Mara Smith, McKayla Schinstock, and Avery Rump at 10:00.29, which is a top 40 time in the state. The Lady Hounds also won the distance medley with Lillian Gelsthorpe, Davonna Davis, Schinstock, and Mara Smith running a 4:32.40. Other titles for Fort Madison were Brylie Lorence in the discuss at 118'8". She was second in the shotput with a toss of 43'3.5".

Central Lee's boys got 1st-place finishes from Kegan Damico with a 58.14 in the 400 hurdles. That time is his best on the season. The Hawks had personal bests in the 4x400, which finished runner up with Brayden Wyrick, Brett Cook, Riley Salter-Rickman, and Damico at 3:39.15.

For the Lady Hawks, Allison Gruntmeir was 3rd in the high jump at 4'10" and Aubrey Weber was

third in the discus at 105'1".

Fort Madison girls finished 109 points behind Mt. Pleasant's 156. Central Lee had 23.5 for 8th place. Keokuk finished with 89.5 in 3rd place. For the boys, Fort Madison finished with 126, ahead of Keokuk's 122. Central Lee had 43 points for 6th place overall. PUBLIC HEARING West Burlington - Proposed Property Tax Levy for Fiscal Year 2025-2026

Mayor Teater opened the Public Hearing on the Proposed Property Tax Levy for Fiscal Year 2025-2026 at 5:31 p.m.

When the Public Hearing date was set on February 26th, the Council intended for the maximum levy rate to be set at \$10.25, which would allow the Council to approve an increase in the levy from the current \$10.10 up to \$10.25.

Due to changes in the Iowa Department of Management's software, the maximum levy rate was inadvertently published at \$10.10. In a memo to the City Council, Finance Manager Moore explained that in the previous version of the software, the maximum levy amount could be entered directly on the "Max Levy" page, which would then lock the figure. The updated system now requires the property tax levy amount

to be entered on the Property Tax page, which also determines revenue projections for the General Fund and Special Revenue Fund. While working to finalize numbers in preparation for adopting the budget, various levy amounts were modeled to evaluate potential scenarios. At the time of submission, the Property Tax page reflected a levy of \$10.10 rather than the intended \$10.25. As a result, the proposed levy was submitted at \$10.10.

The proposed budget has been calculated using the \$10.10 levy rate. The \$10.25 rate would have increased the proposed property tax levy and corresponding revenue, contingent on Council direction and support. Since the proposed maximum levy rate was submitted at \$10.10, the Council is not able to increase the rate beyond that figure.

To address the shortfall, the council can consider the use of Tax Increment Financing (TIF) and adjust the levy in the following fiscal year as needed. There were no verbal or written comments received during the Public Hearing. Mayor Teater closed the Public Hearing at 5:33 p.m.

Herren has a bug in retirement

retirement...and cake. Although he said the pomp and circumstance were overblown, the retirement is coming at the right time.

"It's time," he said. "I'm good."

His legacy was solidified by not only the 15 fulltime firefighters who stood behind in him in multiple photographs Wednesday, but also by the mandate from Fort Madison voters to build a new fire station. A project that's been in the works for more than 20 years.

"That's the legacy. That tells me they respect the work we do and the fire department we are," Herren said. "We got 70% approval on that and you just don't get that. It tells me we've done a good job. It's a stamp of sorts."

The outgoing chief started his career with the Wever Fire Department as a volunteer and then came to Fort Madison as a firefighter where he worked his way up through the ranks. He said battling budget issues and property tax issues, while trying to provide top-level service to the people of Fort Madison and surrounding areas has been his priority the last decade and a half as chief.

But he said at 62, he's not close to being done.

"I'm going to do something else," he said. "I'm only 62. I covered for my son coaching a t-ball team while he was away a couple weeks ago and, boy, I really got the bug."



Herren has been visible on sidelines and in dugouts for decades and said coaching, or possibly even officiating, may be in his future.

With Herren stepping aside, as quietly as he could, Hannum comes into the position with a new fire station on the horizon and some fairly large shoes to fill.

Hannum was sworn in earlier Wednesday with a crowded house, including his family, at Fort Madison's City Hall. The entire FMFD staff was in attendance as well as representatives from the Fort Madison Police Department, city officials, and friends.

Hannum said he has about 14 years left per mandated retirement formulas and he envisions at least 10 as the city's fire chief.

He said leadership roles have been part of just about every organization he's been a part of and the fire department he joined in 2003 is no different.

"I went into an interview with a panel for the lieutenant's position and I had a cover sheet with Joey's month and year of retirement. I told them my goal was to be lieutenant and then to replace Joey as fire chief when he retired," Hannum said.

"I think that took them back a little, but I've always gravitated toward leadership positions."

One of his top priorities will be to identify resources the department needs and to make sure firefighters have everything they need on a daily basis. He also wants to maintain the level of character already in place.

"That's a credit to the guys that are working the line every day, And obviously for the last 18 years, that's a big part of Chief Herren's legacy," Hannum said.

"With that being said, you know the old saying if it's not broke, don't fix it."

Hannum said he's off and running with staff meetings and looking at different areas of fire operations.

"We're going to do a review and, if things are going well, we aren't going to change it and we'll keep going. The question I will ask of each area is what are we doing well and what, if anything, can we do better," he said.

Redundance in leadership is also something he wants to continue to build on so there are always people in the wings who can do the job if someone has to step away from whatever reason.

The new fire station will create a more modern sense of firefighting preparedness and Hannum is looking forward to walking into that new facility when it's complete. He said the facility has been built multiple times on the tabletop over the past 25 years, but is finally coming to fruition.

"I absolutely love the fire service. I am a Fort Madison guy through and through, and I view Fort Madison as my town to protect. No different than the other 15 guys that are down at the firehouse. I think they all can echo that same sentiment."

The county is looking at a possible additional solar field that will help power a nitrogen facility proposed by GoSolar. The project would help provide energy in the form of nitrogen to the Iowa Fertilizer Co. Rumors are also circulating about a possible data center from the same company. Both projects would be in the Green Bay bottoms area.

Stein said he's read the complete draft ordinance. He said research on debris field from wind towers that have fallen are as much as four times the height of the towers.

He also said the ordinance doesn't address shadow flicker, which is the visual effect of rapidly changing light and dark patterns caused by the rotating blades of a wind turbine casting shadows on nearby buildings or structures.

"They should be able to consider shadow flicker in their design and make sure it's not going to land on occupied structures," Stein said.

In a workshop following the board meeting, Southeast Regional Planning's Jarred Lassiter said regulating shadow flicker is extremely difficult and comes down to enforcement. He said general language that guides project developers to consider the effects could lead to better management of the problem, rather than specific language.

Supervisor Chuck Holmes asked if Stein is wanting a larger setback for wind towers.

"I'm suggesting if we have evidence that debris is landing farther than one and a half or 110% away from the tower, that it should be considered," he said.

Holmes said that could be prohibitive on the project.

"I suppose it would be, but it's not your job to make it easier for them," Stein said.

Holmes also pressed Stein on the legitimacy of four times the height of the tower for a debris field and said no other county in the state has that kind of a setback. Stein said he could produce evidence that shows debris has flown that far.

"If we're the only ones that are right, then we're right," Stein said.

The board will issue the final reading on the ordinance at its next meeting.

In other action, the board:

• approved the 2025-26 fiscal year budget.

• approved an application for opioid funds to be used to hire a counselor at the Lee County Jail. The board is now required to advertise the position that will likely be an employee of the Lee County Sheriff's Department.

• approved a \$44,000 change order for low voltage cabling at the Meller Family Health Center currently under construction in Fort Madison.
