# **Council to talk Block**

## **REPAIRS:** Schickedanz steps up to help with repairs of James Block building

#### **BY CHUCK VANDENBERG** PCC EDITOR

FORT MADISON - The Fort Madison City Council will hear a proposal from city staff to put a quarter million dollars into the James Block Building downtown.

According to a report issued to councilmembers last week, City Building Director Doug Krogmeier and City Manager Laura Liegois are recommending that the council put the money into the building to extend its life and increase the chances for getting the building in the hands of a developer

at some point.

Demolishing the building would cost the city about \$500,000 according to city estimates.

The city has a quote from Schickedanz Construction to repair a side wall and do some roof stabilization for \$165,000. An alternative bid for repairing the wall and then providing a complete roof replacement including removal of the cupola was submitted for \$270,500.

The city has already put \$193,000 into the building and

# **CITY NEWS** Staff to take deeper look at city's financials

City issues 3-year projection showing increased deficit spending through 2029

#### BY CHUCK VANDENBERG PCC EDITOR

FORT MADISON - Fort Madison city officials are looking to start discussions already on the 2027 fiscal year budget due to changes in funding streams impacting the city.

City Manager Laura Liegois and City Finance Director Peggy Steffensmeier will be leading a discussion at Tuesday's regular council meeting about future city budgets.

The discussion Tuesday is what the two called a starting point in a report to the Fort Madison City Council.

"The past two fiscal year budgets have been affected by Iowa legislation with House File 718, which removed emergency tax levels and changed the property taxes that all cities receive," the report read.

"As we have seen, this has had impacts on our budgets for (Fiscal year) 2025 and 2026. During this current year's legislative session, there have been four bills presented on changing how property taxes are figured and directed to local government(s)."

The 2025 Iowa legislative session has gone into overtime as legislators grapple

# Lady Hounds drop first match of the year at Bracewell

BURLINGTON — Fort Madison's girls soccer team found itself in an unusual position.

The Bloodhounds haven't been behind in a match all season, but that changed in Monday's Southeast Conference match against Burlington, and it proved costly to their conference title hopes.

Fort Madison fell, 3-0, in a battle of conference leaders at Bracewell Stadium.

Burlington (9-1-2 overall, 6-0-1 conference) now has a one-game lead over the Bloodhounds (8-1-2, 5-1-1) in the standings — the Grayhounds have two conference matches remaining while Fort Madison has three. The two teams played to a scoreless draw earlier this season.

The Bloodhounds had given up only one goal this season, and that one tied last Tuesday's match against Mediapolis. So when Burlington's Kiara Winski scored eight minutes in, Fort Madison found itself trying to mount a comeback.

"I mean, we haven't played from behind all year," Fort Madison coach Carrie Burken said. "So I think as far as our confidence and just having composure and being able to stay positive, I think that impacted that."

The pressure was really on when Burlington's Hunter Pender scored four minutes into the second half. Isabella Ziegler scored off a corner kick with 14:08 left to seal the win.

Fort Madison's offense couldn't find a solution against the Grayhounds. Teagan Snaadt had the only shot on goal for the Bloodhounds, and Halle Menke and Hadley Wolfe combined for three other shots that went wide.

The Bloodhounds didn't get their first corner kick until 6:40 left in the first half, and only had three for the entire match.

"We couldn't get possession," Burken said. "Normally, we can figure it out a little bit where we can start having success, and we just weren't able to today. And sometimes that just happens. Burlington looked good tonight.

"I don't know if that was me rotating too many people in and, like, too much rotation, or if we just got tired. We couldn't get anything going. That just happens sometimes. And Burlington does that because they're such a good possession team. They make it hard to keep possession, so I think that frustrated us and made it a little bit more difficult."

The two teams, rivals for the conference title in recent seasons, always get matched up somehow in the postseason, and Burken knows the Bloodhounds might get another chance to face the Grayhounds.

"So I think that's just the mindset, knowing that if we do run into them in the postseason, it will be here," Burken said. "I think that's the big thing. But we'll talk as a team tomorrow. I feel like sometimes it's hard to think about what you can learn from an experience until you have time to process it. So that's the biggest thing that we have to do, is we have to figure out how to learn

agement's software, the maximum levy rate was inadvertently published at \$10.10. In a memo to the City Council, Finance Manager Moore explained that in the previous version of the software, the maximum levy amount could be entered directly on the "Max Levy" page, which would then lock the figure. The updated system now requires the property tax levy amount to be entered on the Property Tax page, which also determines revenue projections for the General Fund and Special Revenue Fund. While working to finalize numbers in preparation for adopting the budget, various levv amounts were modeled to evaluate potential scenarios. At the time of submission, the Property Tax page reflected a levy of \$10.10 rather than the intended \$10.25. As a result, the proposed levy was submitted at \$10.10.

The proposed budget has been calculated using the \$10.10 levy rate. The \$10.25 rate would have increased the proposed property tax levy and corresponding revenue, contingent on Council direction and support. Since the proposed maximum levy rate was submitted at \$10.10, the Council is not able to increase the rate beyond that figure.

To address the shortfall, the council can consider the use of Tax Increment Financing (TIF) and adjust the levy in the following fiscal year as needed.

There were no verbal or written comments received during the Public Hearing. Mayor Teater closed the Public Hearing at 5:33 p.m.

# City to look at multiple options to ease budget

• franchise fee increases to 3% which would generate about \$537,000 in electrical revenue fees, and \$125,000 in gas franchise fee revenue.

• cost of services – what services does the city provide that should be charged to residents or have fees adjusted for services.

• review of expenses – what services does the city provide and should they continue doing them internally, contract them out, or cease the service.

• deeper dive into departments where additional savings to help balance the budget could be realized.

Revenues are projected to drop slightly in the 2026-27 fiscal budget year about \$45,000 to \$7.65 million from \$7.70 million. The 3-year projection shows revenues under current funding streams at \$7.86 million in 2027-28 and \$8.12 million in 2028-29.

However, projected expenses show substantial increases with a 2026-27 figure of \$8.22 million, \$8.41 million in 2027-28, and \$8.76 million in 2028-29. All three years show deficit spending of more than a half a million each year. The city is projecting \$38,000 in deficit spending in the upcoming fiscal year. The current budget year is projected at \$422,000 in deficit spending.

The city's fire department budget, with the costs of the new fire department included, shows an increase in projected expenses of 63% when comparing the current budget to the 2028-29 projections. The police fund is projected to increase 36% in the same comparison.

board and superintendent approval.

The contract also includes 25 days of vacation outside of legal holidays with a limit on accumulation of 35 days. Wolter will also receive 15 days of sick leave up to 130 days and full family medical and dental coverage at district cost. Long term disability and a \$100,000 life insurance policy are also part of the contract package.

Wolter currently is under contract with the Colum-



bus Community School District as a secondary principal and taught previously in the Fort Madison system. He also has served as assistant principal and activities director in the Mediapolis Community School District. He began his career in education as a math teacher and instructional coach in Fort Madison, and was named at-large state coach of the year in 2013.

The district emailed the contract to Wolter on Monday and he has until May 19th to sign the agreement.

Wolter is expected to receive his Ed.S. degree in the superintendency from Northwest Missouri State University in June. He also holds a master's degree in educational leadership from Viterbo University and a bachelor's degree in elementary education from the University of Northern Iowa.

Wolter verbally accepted the position with Fort Madison on Thursday.

# City could lose \$100K grant if work not started before May 17

has secured a \$100,000 state grant and a \$100,000 low interest loan from the Southeast Iowa Regional Housing Trust. The rest of the money would come from a \$25,000 DNR grant for asbestos removal and the remainder, about \$45,500, would come from the city's general fund.

The city has also applied for an EPA grant for \$350,000 for repairs on the building, but have had no response to that grant application. That would be used for a complete asbestos abatement of the building and additional environmental work on the structure.

A committee of several city councilmembers and community members was established when a development proposal with Barker Financial out of Iowa City fell through. The Barker group is the entity that finished rehab on the old Lee County Bank building, the Cattermole Library, and several other buildings downtown.

According to the report, the committee is recommending the city move forward with the \$270,000 plan.

The city is up against a deadline of May 17th to show work has started on the building and request a drawdown against the grant. If that is done, the grant can be extended. If the city doesn't move forward with the repairs, the iowa Economic Development Authority will rescind the \$100,000 grant.

The report also shows that Schickedanz has indicated there could be additional needs once the work begins, but they have submitted a bid that will not result in much of a profit margin.

"He does not intend to earn much overhead, rather, he is offering a commitment to community pride with a bid so reasonable," the report indicated.

Other action scheduled for Tuesday's regular meeting includes:

• an update on the Tri-State Rodeo Summer Roundup concert series.

• considering a resolution for a public hearing on May 20th to update the city's fireworks ordinance to reflect current state code that allows fireworks on July 3rd-4th and Dec. 31. The new state legislation supercedes local codes on those three days.

• considering a three-year agreement with Fort Madison Rodeo Corporation for the Summer Roundup Concert Series.
