City addresses Christmas Lighting Traffic

As the calendar flips one month closer to December, people began making that steady incline to prepare for the holidays.

An abundance of holiday commercials infiltrating television screens, neighbors dragging those multicolored bulbs up on their roof and candy canes suddenly being gripped in children's sticky fingers the first signs that the holiday season is blanketing the nation's spirit. And Leavenworth residents have their own signal that the holidays are approaching as the Chamber of Commerce working hard to hang up Christmas lights downtown before the first weekend of the Christmas Lighting Festival begins.

However, preparation goes beyond just displaying the lights and the city of Leavenworth has put into motion action to prepare for the impending traffic.

At the Tuesday, November 13 city council meeting the council approved the traffic and foot patrol needed for the Christmas Lighting Festival for the upcoming month. At the study session earlier that the way people come into town and the big blunt of morning Sergeant Scott Lawrence came to discuss the measures being placed to keep traffic at a flowing pace this year.

"The plan is to have four deputies to assist with traffic control either at site or required intersections," said Sgt. Lawrence. "And the other five will be downtown foot patrols and relief for traffic control positions and just be available to downtown calls."

After a few run ins and threats to run down some officers, there was a push for an incentive to keep cars trekking in from being at a standstill which can result in hostile tourists.

The city incorporated the help of the Chamber of Commerce, the Washington State Department of Transportation, Chelan County Fire District #3 and sheriff's office to help mitigate the influx of visitors and their journey to the Bavarian Village.

"I think the biggest issues were getting people out of town, on the highways after the lightening was done," said Mayor Cheryl Farivar. "It also is however traffic in the early mornings."

This year there will be added routes to help navigate travelers infiltrating the city to celebrate the lights. There will be a traffic plan for the Peshastin route to keep the traffic flowing rather than stop and surging with the light.

The combination of flaggers and the Peshastin route should help lessen the intensity of the traffic. Each flagger will have two officers accompanying them as well.

"We have been working all year to put together this traffic control plan," said Farivar. "We want to manage expectations here," said Farivar. "This should alleviate some of what we experience at Christmas Lighting, but certainly not all."

The city spent a total of \$90,000 - \$70,000 for the traffic control (the flagging company) and \$20,000 for public safety (the officers working).

"This is almost essential to either validate that we can control it (traffic) or can't," said council member Elmer Larsen.

Lodging tax targets pool resurfacing

After a public hearing full of passionate citizens, one rejected .03 cent increase and finally a passed tax levy for the community pool unfortunately the .11 cent property tax still doesn't cover the needed \$150,000 (based on a cost estimate from 2016) to resurface the beloved community watering hole. The city council has stirred some conversation up about the possibility of dipping into the Lodging Tax fund to help alleviate some of the cost. During the Nov. 12 study session, the council and two members of Chamber of Commerce weighed the justification of allowing this one time expenditure.

To preface the argument as to why the pool is of value to tourism, the Mayor noted that there was a large surplus for the Lodging Tax fund for the year. This helped lodge the opportunity to be a wider window for funding the resurfacing of the pool. The 2016 study revealed that a small portion of pool users were in fact tourists or out of the 98826 area code.

"After many discussions and study sessions, the council came up with the idea of using lodging tax to resurface the pool," said Mayor Farivar. "It seemed initially to me to be an inappropriate use of that fund because of the PRSA covering a much greater area of the pool and that tourism is only a small percentage of the use. But Joel (Walinski, City Administrator) put it in a different way, tourism has used it for 20 years, 10-15 percent of attendance of the pool, so a one time expenditure of lodging tax to resurface the pool and preserve the pool seemed to be appropriate. So that is an option on the table for us to consider."

However, with several entities eyeing the lodging tax and each separate entity having their own stake, there needed to be a concrete justification for usage by the pool.

lodging "Using inappropriately, not intended by the legislation, will call a lot of attention on the lodging tax legislation and potentially make it more restrictive," said Farivar.

Three primary groups have a grip on the lodging tax: Leavenworth Area Promotion, the Chamber of Commerce and SEE LODGING TAX ON PAGE B2

City Council Recap

After lively discussion, crossing their t's and dotting their i',s at the study session earlier that morning - the Leavenworth City Council had a busy Tuesday, November 13 City Council meeting. The agenda had ten action items that varied from monetary to a possible relief to the persistent parking problem.

Some of the council members contributed various pieces of information such as: noting that the collaboration with the Public Utility District will not be happening due to PUD not updating their water meters for another 10 years and information about the planned bid in January for the installation of two new HAWK system crosswalks (less disruptive due to syncing up with the traffic light) on Highway 2 and a flashing light down by the Park-n-Ride.

Also the completion of transitioning all of the streetlights with LED lights is near along with the February residential garbage transition to Waste Management.

Though not open to the public, local law enforcement is conducting a tabletop exercise to strengthen ability to help for mass casualty incidents, which will beheld at the Fire Hall and hosted by Chelan County Sheriff's office.

Led by Chantell Steiner, there was a Preliminary Budget Administrator presentation that went in depth on the previous year and upcoming year's funds. Steiner also pointed out how voters and their wallets would be spared.

"The voters did approve the park bond, but the council has to chosen not to add that additional levy to the taxpayers and instead since the city had cash on hand. we are paying for those improvements and just reimbursing ourselves out of the property tax that we did increase a year ago as a temporary fix that dropped this year and then re-bonded with that park bond," said Steiner.

Through that process, the city will be saving voters a good sum of money.


Other accomplishments include the PUD substation location being chosen after a year long study and the city being approved and authorized a \$13.4 million loan that will be used to the Wastewater Treatment Plant upgrades.

The estimated largest revenue sources for the city were lodging, utility, retail sales tax and intergovernmental. 25% of the entire budget was from intergovernmental which is funding from an outside government entity.

"Sales tax, which is generated mainly from our downtown area, is what funds all of our parks, general fund services, streets, snow removal," said Steiner. The final budget public hearing will

· A real friend accepts you for


- best for you · A real friend will not aban-



I've been taking a stomach medicine called Protonix® for nearly 10 years. When I try to go off of it, my heartburn symptoms come back. Am I stuck taking this forever?

Every time you eat or drink, your body responds by releasing digestive juices into your stomach and small intestine. A miniature pump called a proton pump sends gastric acid into your stomach to assist with digestion. Protonix® belongs to a group of medicines called proton pump inhibitors, which act by blocking the action of this pump to significantly reduce the acidity in our stomach. Proton pump inhibitors (PPIs) are the most effective medicines we have for treating excessive stomach acid secretion and are very good at helping stomach ulcers heal. PPIs can even help prevent stomach ulcers when certain medicines are taken together, like ibuprofen and blood thinners.

Over twenty years ago when I was taking the very last capsule of an antibiotic called doxycycline it stuck sideways in my esophagus, and as it dissolved it created an ulcer, causing pain every time I swallowed. I was given a PPI called omeprazole (Prilosec®), which healed the ulcer. Many people have just continued taking their PPI even after their ulcers have healed, even for decades. There is now clear evidence that having decreased stomach acid can cause problems over time. Absorption of vitamin B12, iron, calcium and magnesium depend on stomach acid and people who take PPIs longer than a few months are at risk of becoming deficient in these nutrients. PPIs are also associated with increased bone fractures in men and women, possibly because lower stomach acid levels can decrease your ability to absorb calcium from food. Stomach acid is also one of the most important defenses our body has against foreign organisms. Taking a PPI chronically can lead to increased infections, especially from a particular organism that causes antibiotic-associated diarrhea called Clostridium difficile. You are not



alone in having rebound symptoms of heartburn when trying to stop your PPI. Anywhere from 60-90% of folks who have been taking a PPI for at least 3 months will notice some symptoms of stomach burning if they stop taking it abruptly. Having your symptoms come back when you stop your Protonix® doesn't necessarily mean you'll need to take it for the rest of your life. If you doctor has no objections, you can eventually get off the PPI by tapering the dose down over several months.

How to Successfully Stop Taking a **Proton Pump Inhibitor:**

For best results, don't stop cold turkey! ■ Stopping abruptly can trigger rebound acidity in your stomach, causing heartburn and convincing you that you really can't do without a PPI.

2. Taper the dose of your 111 down slowly to give yourself the best chance of success. If you are taking the medicine twice a day, cut out the evening dose and try taking it only in the morning. If trying this causes you heartburn, don't despair. Go back to your full dose for a week, then try again, but try taking only ½ tablet in the evening and your full dose in the morning. Try that for at least a week before lowering the dose again.

One of my favorite tapering regimens is to only lower the dose on 1 dose per day, for 1 day per week, every week for 7 weeks.

Lodging tax targets pool resurfacing

additional dollars trickle down to the city of Leavenworth to use for various things such as festivals and improving tourist facilities. All three of these groups funnel the allocated money into tourism in different ways.

"I think the lodging tax issue is very stressful," said council member Sharon Waters. "The city is guarding their lodging tax for infrastructure, the Chamber is guarding their lodging tax and LAP is guarding their lodging tax and everybody wants more. And the community, for the greater part, is saying no more." And beyond these official groups, Leavenworth residents themselves keep a

close eye on the lodging tax due to self interest of their community. So all in all, while tourism is a substantial element of the Leavenworth economy, the lodging tax is a big resource for the town itself.

"It's certainly one of those funds that communities look at as extra and in our town tourism touches everything," said Chamber of Commerce member, Nancy Smith. "There are always opportunities to make legislation easier to use or more restrictive to use. It happens every year, As communities, they want a legislative to make it easier for them to use and so you see that competition is always

on the table because of property." The council had to look at dipping in the fund from every angle -Chamber, the residents and LAP. The consensus seemed to surface that the pool does overlap with tourism in several aspects. It seemed the resurfacing of the pool would be in sync with both community and tourism needs and be an efficient use of the fund.

"I think it's an appropriate use and partly because of its location," said council member, Margaret Neighbors. "It's eye candy. It adds to the whole feeling of the town, it's an amenity. I think cause we open it up to our guests, that it makes it more appropriate. It's a more friendly family thing. It's a marketing thing, rather than a sale."

Council member Elmer Larsen voiced reasonable concern that funding the be an inappropriate use of lodging tax money.

Council member Clint Strand echoed this sentiment, but thought a concrete justification would help avoid the possible future twisting of explanation to fund aspects of the city with the lodging tax fund.

"That pool and that area is part of the town's face. I understand Elmer's slippery slope argument, I do think we need to have a good response as to why this is appropriate

(use of lodging tax funds)," said Strand. 'The optics of the dynamic in the city and the business community and the citizens. There is a perception that there is some friction between businesses and residents, 'what have you done for me?". This could be an opportunity, if we use the funds for this (the pool) to pass the message not only are businesses paying for businesses or tourism is paying for tourism, but this is something that benefits everybody.'

A prompt for a sturdy source of justification was brought up by Jason Lundgren.

"I think this calls for have more information to justify or not justify. We need to look more broadly at how we use this money, I think we could use it in much more intelligent way if we had more information."

As of right now, the possibility of using a portion of the lodging tax fund to put into resurfacing the pool is just conversation. However, it is a growing interest for all entities involved - including residents of Leavenworth.




