Rhein Haus Restaurant Goes Über German *Biergarten to Open in Leavenworth this Summer*

SEATTLE -- Rhein Haus, a German-inspired restaurant with two Puget Sound locations, today announced it will open a massive outdoor patio and double-decker dining hall in Leavenworth this August, serving up beers, schnitzels and sizzling brats to residents and visitors of Central Washington's famous Bavarian village. Located smack in the middle of Front Street (707 Highway 2)—next to the Maypole and mini sledding hill—the newly constructed, family-friendly restaurant and biergarten can hold up to 300 guests, making it one of the largest in town. "From visiting each summer growing up to working as a river guide and fundraising for avalanche victims, each of the Rhein Haus owners has a strong connection to the Leavenworth community, making it an obvious choice for our next location," said James Weimann, co-owner of Weimann Maclise Family of Restaurants. "In addition to modern, playful and crowd-pleasing German fare, the deck

is the crowning jewel. It will have heated floors, oversized tables with built-in fire pits, and unobstructed mountain views – the perfect place to enjoy a giant pretzel, frosty Kölsch, and the company of friends."

In all, the 3,000 square-foot biergarten deck will hold up to 170 people, including an 18-person bartop. A row of Bavarian and German flags along Front Street and overhead festoon string

lights complete the outdoor ambiance, and flow seamlessly to the interior.

The 3,700 square-foot two-story indoor space will seat 128 guests and will boast a lodge-like feel. Décor includes pine façades, ceiling and railings, plus a mixture of wood and stained concrete floors. A full taxidermy elk, four mounted elk busts and lighting sconces made from vintage wooden skis add interest. The dining area will have an indoor bar

on each level, plus table-side service at all tables indoors and out.

Channeling the bars of Bavaria, Rhein Haus will offer a carefully curated German beer list with 12 beers on draft including a Rhein Haus lager from Bayern Brewing, Pflugstädter Schwarzbier and Spaten Oktoberfest. Additional offerings include local favorites like Icicle Brewing Company Bootjack IPA and Bad Granny Hard

Cider, along with a full bar.

Backing up the beverage options, Rhein Haus will serve a variety of options, ranging from appetizers and salads to sandwiches and gourmet brats, giant pretzels and classic schnitzels along with a kids menu. Signature dishes include: the Munich, a house-made kielbasa with Beecher's cheddar beer fondue and crispy sweet onions; the Pork Schnitzel, a pork cutlet with a pretzel breading and served with lemon, caper, parsley and shallot sauce and a Granny Smith apple slaw; and the plant-based IMPOSSIBLE burger with arugula, royale dressings, onion, tomato, dill pickle, Tillamook cheddar cheese all on a brioche bun and served with fries.

Like all Rhein Haus locations, the new restaurant welcomes all ages, and can accommodate large groups by reservation, making it a good choice for bachelor and bachelorette parties, work outings, weddings, reunions and more. The first Rhein Haus opened in February of 2013 in Seattle's Capitol Hill neighborhood, quickly followed by locations in

The travel and activity restrictions, put in place by the Chelan County fire marshal, are the highest level of restrictions allowed by county code. Last Thursday, Chelan County Public Works crews installed some 70 signs around the county indicating the extreme conditions.

Under the extreme level, temporary barricades also are placed at 17 county roads for added emphasis and public awareness. The barricades do not mean the road is closed.

The restrictions are meant to help reduce the occurrence of fires that may be caused by recreational, residential, commercial and other activities. Area activity and road travel restrictions include:

- No fireworks
- No outdoor fires or outdoor open flame devices
- Use of charcoal briquettes is prohibited unless used in a commercially made, residential barbecue

The website also has the Chelan County code (Chapter 7.52) and the declaration signed last Wednesday by the fire marshal.

Special Notice: Temporary Target Shooting Banned on DNR lands

In order to help prevent

wildfires, the Department of Natural Resources (DNR) is temporarily banning all target shooting on 3 million acres of DNR-managed lands. This includes state forests, community forests, and forested state lands. Commissioner Franz is encouraging private landowners to consider target shooting restrictions on their own lands. "Current conditions require us to take reasonable steps to reduce wildfire risk," said Commissioner of Public Lands Hilary Franz. "Within days we expect to witness the average number of wildfires that my crews normally respond to within an entire wildfire season. Resources are stretched and we must all do our part to protect our communities and our firefighters."

Shooting at targets poses greater risk in dry conditions as bullets pass through decayed wood, cause sparks off rocks, or break into fragments in dry grass. This temporary rule does not restrict hunting, as firearms are discharged less frequently. Washington is extremely hot and dry, with ninety-six percent of the state in drought-like conditions. Vegetation is very dry and getting drier. On average, DNR responds to 22 wildfires on DNR-managed lands each year caused by shooting – that includes illegal explosive targets and target practice. The temporary ban went into effect Saturday, Aug. 4, 2018. The Washington Department of Fish and Wildlife

is also restricting shooting on WDFW-managed lands beginning Saturday. The DNR target shooting ban is expected to last through Sept. 30, 2018, though may be extended or shortened based

upon ongoing fire conditions. The agency is encouraging target shooters to visit local private and public target range facilities during this time.

Outfitter guide draft decision balances Wilderness; visitor access

For nearly 50 years, outfitter guides have helped visitors access remote, back-country places in the Okanogan-Wenatchee National Forest. However, visitor use as well as aquatic and habitat concerns have each contributed to the need for analyzing how to best provide necessary public access to these areas while protecting Wilderness resources for future decades. A newly released draft decision is designed to balance those concerns.

"At its core, the project is about finding the right balance of multiples uses and natural resources," said Forest Supervisor Mike Williams. "For example, this draft decision both protects sensitive aquatic areas and provides for increased economic stability for outfitters by issuing 10 year permits."

Key draft decision information:

- Aquatic resources will be protected by managing large campsites, avoiding the creation of additional areas worn down to bare soil, utilizing only campsites and trails, minimizing damage to vegetation, wet soils and meadows to reduce overland flows, and protecting riparian areas to reduce impacts to water quality.

- Two non-significant Forest Plan amendments will better align camp standards and party size limitations (12 people/ 18 stock) while providing for non-degradation of Wilderness areas.

- New 10-year permits will incorporate reasonable future demand by approving the highest actual service day use in the past 10 years, plus 25% outside of Wilderness and to the extent necessary inside the Pasayten and Lake Chelan-Sawtooth Wilderness areas.

"We've listened to folks far and wide, reviewing nearly 1,500 letters in 2017 alone," added Williams. "I am confident this is the right path forward at the right time."

Informed by this input, a final supplemental EIS and draft Record of Decision is now available for public review. In accordance with federal regulation the Forest Service will offer a 45-day formal objection period on the final supplemental environmental analysis following the date of publication of the legal notice. A final decision is expected in the summer of 2018. To learn more about the project, read previous comments, or to object, please visit: fs.usda.gov/project/?project=3752. 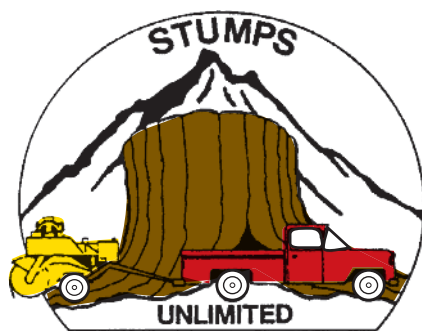

Conservation Groups Move One Step Closer to Saving Nason Ridge

Fundraising campaign now underway to ensure permanent protection of Nason Ridge Trail and the fish and wildlife of Lake Wenatchee, the Wenatchee River and Nason Creek.

In a crucial next-step in the effort to conserve a forested mountainside above Lake Wenatchee and Nason Creek, Western Rivers Conservancy successfully purchased the popular Nason Ridge property from the Weyerhaeuser Company.

The highly visible property was slated for timber harvest and includes much of the 22-mile Nason Ridge Trail, as well as cross-country ski trails and over two miles of Nason Creek, a critical salmon spawning stream and a key source of cold water for the Wenatchee River.

"Conserving Nason Ridge will be a

tremendous win for the Wenatchee River's fish, for wildlife and for everyone who lives, visits and recreates in these mountains," said Western Rivers Conservancy's president, Sue Doroff. "It's a special spot, and we're glad we could step in and negotiate a deal with Weyerhaeuser that will allow for permanent protection of this important property."

The desire to conserve Nason Ridge, which spans 3,714 acres, is deeply rooted in the local community. Wenatchee-based Chelan-Douglas Land Trust has been trying to protect the property for years and is now working in partnership with WRC to raise \$1 million to fund the permanent protection of the property. This crucial phase of the project is now underway.

"We aren't finished yet," said Curt Soper, executive director of Chelan-Douglas Land Trust. "We have to

raise \$1 million in private gifts to fund permanent conservation of Nason Ridge. So we need everyone's support." WRC will own the land until it identifies a long-term steward that shares WRC's conservation vision for the parcel. During its ownership, WRC will allow public access just as Weyerhaeuser has done for years.

"Weyerhaeuser has been a member of the Wenatchee community for decades and we're pleased we could work out a solution with Western Rivers Conservancy that will meet the needs of all involved," said Scott Dahlquist, Weyerhaeuser's senior director of real estate.

About The Project Partners
Western Rivers Conservancy acquires prime river lands along the West's best rivers and streams to conserve habitat, protect key sources of cold water and provide public ac-

cess for all to enjoy. It is the West's only organization dedicated exclusively to saving rivers through land acquisition—an approach that is effective, tangible and permanent.

Its motto is "Sometimes to save a river, you have to buy it."

In Washington, WRC has conserved dozens of miles of river land along the Hoh, Skagit, Columbia, Big Sheep Creek and Icicle Creek. It created Robe Canyon Historic Park on the South Fork Stillaguamish and recently protected a critical hillside above Nason Creek, upstream of the Nason Ridge property.

Recently it was reported in the "Echo" that there is talk of putting in an "Adventure Park" on the corner of Hwy 2 & Icicle.

Q: Are you getting enough Vitamin B-12?

A few years ago, one of my patients, a retired Marine mentioned how he had been suffering from shooting and burning pains in his legs and feet for the last few years, and although his doctor tried several different pain medicines, none had really helped. Then one day his feet and legs stopped hurting so much.

"The only thing I did differently that week was start a new vitamin that happened to have a lot of vitamin B12 in it. Week after week, I kept expecting the pain to come back, but it's been over 6 months and I'm still mostly pain-free. But I still take that vitamin, just in case."

Vitamin B12 is a water-soluble B vitamin that helps your nerves work and also helps your body make new red blood cells, which can prevent a certain type of anemia. A deficiency in vitamin B12 can show up as fatigue, weakness, depression or pain in your feet or hands. The most common factors that contribute to vitamin B12 deficiency are age, diet and medicines.

According to the National Institutes of Health (NIH), vitamin B12 is found mostly in animal proteins, such as fish, meat, poultry, eggs, milk, and milk products.

Most healthy adults get enough vitamin B12 in their diet; those who don't either don't have much animal protein in their diet or aren't able to absorb vitamin B12 very well.

Strict vegetarians may not get enough animal protein in

their diet to satisfy the recommendation of 1 to 2 meg daily of vitamin B12. Others become deficient because they cannot absorb it very well, like the elderly, those who have had gastric bypass surgery and people who take certain medicines.

The most common cause of vitamin B12 deficiency is not being able to absorb enough of it from your food. This can be due to a condition called atrophic gastritis, which affects 10-30% of the elderly. Atrophic gastritis interferes with the ability to absorb vitamin B12 from your food because it decreases secretion of digestive juices such as gastric acid.

Gastric acid is critically important in being able to absorb vitamin B12, which is usually attached to animal proteins like ground meat or chicken. Without enough stomach acid, your body can't break down the proteins enough for the vitamin B12 to be absorbed into your body.

Most people who can absorb vitamin B12 well only require 1 or 2 meg daily. If you are over 70, take medicine for heartburn or an ulcer or have had gastric bypass surgery, you may need more than that. 1000-2000meg daily of vitamin B12 as an oral or a sublingual tablet can overcome poor absorption.

Medicines that can contribute to poor absorption and deficiency of vitamin B12 include acid-reducing medicines such as Prilosec® (also known as omeprazole),

Here are 4 Tips on Getting Enough Vitamin B12?

1. Include fortified breakfast cereals in your diet if you are vegetarian or vegan. Since vitamin B12 isn't found in plant foods, the National Institutes of Health (NIH) suggests including fortified breakfast cereals in your diet as an alternative source of vitamin B12 if you are vegetarian or vegan.

2. Stomach acid helps you absorb vitamin B12 from your food. To avoid becoming deficient in vitamin B12, minimize your use of medicines that work to reduce stomach acid, including Prilosec® (also known as omeprazole), Prevacid® (also known as lansoprazole), Protonix®, and Nexium®, along with

older medicines like Tagamet® (cimetidine), Zantac® (ranitidine), Pepcid® (famotidine) or Axid® (nizatidine).

3. Oral and sublingual vitamin B12 supplements are inexpensive and don't require a prescription. Most people with vitamin B12 deficiency can safely take 1000-2000 meg daily of vitamin B12 as a supplement.

4. Avoid the timed-release or long-acting products of vitamin B12, because they may not be as well absorbed as immediate release forms.

Prevacid® (also known as lansoprazole), Protonix® or Nexium®. Older acid-blocking medicines which also impair absorption of vitamin B12 include Zantac® (ranitidine), Pepcid® or Axid®. Metformin, a common pill for diabetes can also interfere with your body's ability to absorb vitamin B12.

A deficiency in vitamin B12 can show up as fatigue, weakness, depression or pain in your feet or hands. If you are noticing these symptoms, talk to your doctor. Vitamin B12 deficiency can be detected

with a blood test. Your doctor or medical provider can advise you if you need tested, and which supplement would be best for you to take, and how much.
