Student athlete Ryan Rainville diagnosed in the 'Nick of Time'

CHELAN— Rob Rainville longed to help just one student.

The Chelan High School P.E. teacher remembers chatting last spring with his longtime colleague Joe Harris. That particular day, members of the Nick of Time Foundation, a nonprofit organization that screens young athletes' for heart problems, were visiting Chelan to test the hearts of around 250 students.

"I remember telling Joe, 'If we could just find one kid and help them, then it's worth it, right?'" Rainville recalled.

Little did he know that kid would be his son.

Ryan Rainville felt disinterested in being tested. A

three-sport athlete in football, basketball and baseball, he asked his dad to skip the process, but Rob convinced him to attend the free screening before school.

Shortly afterward, Rob noticed Ryan wasn't in his first period class and became concerned. Back in the school's gymnasium, medical personnel had tested Ryan's heartbeat and found some irregularities and wanted to undergo further examination.

"I was pretty surprised because I honestly thought that I've always been a good, healthy athlete. Then everything else happened where I was one of the only kids that had something wrong," he said. "I was kind of just going through the motions."

After school that day, doc-

tors diagnosed Ryan with Wolff-Parkinson-White syndrome (WPW) which, according to John Hopkins Medicine, is a type of abnormal heartbeat that affects 1-3 out of 1,000 people worldwide. Sufferers may experience episodes of tachycardia, when the heart reaches over 100 beats per minute.

The simple screening turned into instant heartache for Rob. Ryan had never shown any symptoms and received a clear physical every year, yet had WPW since birth.

"At first, as a parent, you kind of sink and you're thinking about all the sports and all the things he wants to do and being healthy," the former athletic director said. "All the years of playing high school sports, college sports, pro

sports, I never had an EKG (electrocardiogram). That's not something that's a common practice even though cardiac arrest is the number one killer of student athletes in our country."

Rob remembers wondering: How could this happen?

Darla Varrenti asked the same question on Labor Day, 2004. During a football practice in Mars, PA, her youngest son Nick suffered sudden cardiac arrest. He died that day leaving a hole in his family but, eventually, a legacy of compassion.

In January of 2006, Varrenti founded Nick of Time with her sister Sue and her brother-in-law. They began with sudden cardiac arrest awareness around young people and educated about the impor-

tance of Automated External Defibrillators. In 2010, Nick of Time started screening hearts as a preventative effort.

"After Nick died we started to do research on what this was and how it could be prevented," Varrenti said. "We weren't doing enough as a society to make sure our kids were heart safe."

Her foundation has done just that. Since its inception, Nick of Time has performed over 90 screenings of more than 27,000 youths in Washington alone. The organization has also visited 13 additional states. Over 600 children have needed follow-ups and everyone who's had a heart issue has received treatment to correct it, including Ryan. Sitting down with

Arts proposal strives to bring lake dragon to shore

CHELAN — At the Chelan City Council meeting held on Tuesday, Oct. 24, a special presentation was given by Dan Crandall to update Council on funding efforts toward a rendering of Chelan legend, Tsilly the Lake Dragon.

The total value of this project includes the artist's expenses and donations and amounts to \$46,388. Of that, \$33,813 in donations have been received toward meeting this value and represent those donations from the artist, the Lake Chelan Arts Council, and the community. The balance to pay future estimated expenses amounts to \$12,575.

Sculpturist Jerry McKellar is actively at work on a rendering of Tsilly. Jerry is a Chelan native who graduated from Chelan High School in 1962. After graduation he attended the University of Washington where he received his dental degree. He then practiced dentistry in Colville until 1994 at which point he retired and began to focus more on his art.

Jerry's work on this sculpture was originally inspired by a children's book titled "Tsilly the Monster of Lake Chelan" written by John Fahey. Ashby, Jerry's grandnephew, created a small dragon sculpture influenced by the creature depicted in John's book. Jerry's current rendering of Tsilly is inspired by Ashby's original sculpture.

Lake Chelan Lions Club aims to provide additional health screenings

CHELAN – The Lake Chelan Lions Club hopes to begin providing screenings for pre-diabetes and diabetes to children in the valley and surrounding areas. In sup-

port of this effort, the LCLC recently requested funding from the Chelan City Council in the amount of \$7,500.

The LCLC has been serving the community for over 88 years in various capacities. A consistent effort of LCLC has been to provide

hearing and sight screenings for K-7. Club President Craig Boothe mentioned during their Council funding request that the LCLC had already completed at least 1,400 hearing and sight screenings this year. As a 501(c)(3), grants and

fundraising efforts are the LCLC's primary sources of funding.

If their request is granted, these funds would go specifically toward the provision of A1C [HbA1c or hemoglobin A1C tests] and glucose tests. These tests would aid in

early identification of pre-diabetic and diabetic conditions in youth and allow for subsequent interventional health treatments.

According to a 2021 CDC press release, "Diagnosed cases of type 1 and type 2 diabetes are surging among

youth in the United States. From 2001 to 2017, the number of people under age 20 living with type 1 diabetes increased by 45%, and the number living with type 2 diabetes grew by 95%."

the Rainvilles, she explained her passion to prevent other families from experiencing this type of tragedy.

"She deserves all the credit

because she's had to endure something that us, as parents, would be the worst nightmare," Rob said. "The only way we'd have found out was if he's on the ground with an AED attached to him."

Shortly after Ryan's diagnosis, his mom Jenifer drove

to Seattle Children's Hospital for more testing. Eventually he had a procedure where doctors placed a catheter through his neck and hips into his carotid artery and fixed the extra electrical pathway in his heart. After the five-hour procedure, he was

in recovery and returned to athletic activity a few weeks later.

"We told Ryan that he could just keep doing his thing, that it wouldn't stop him from playing because he'd been playing all along... Our whole hope was, we didn't want to keep kids from being active or being in sports or doing the things that they love," Varrenti said. "As a mom who

lost a child to sudden cardiac arrest, I would never tell them to let their kid go out there and play if I didn't think it was safe to do so."

Through his untimely passing, Nick Varrenti has inspired his family to help hundreds of young athletes like Ryan Rainville. In remembering Nick, Darla didn't canonize him, but spoke fondly of a son with a heart for others.

"He was your typical 16½ year old young man," she said. "He could be grumpy. He could be all kinds of things, but he was very loving, loved his family so much. I think he would be glad that we had not moved on, but that we've found a way to do something in his memory that helps other people too."

Every passing practice and game brings Ryan closer to the finish line of his prep career. While he competes intensely as usual, the experience has broadened his view on athletics.

"I don't want to say I took it for granted, but it definitely puts a different perspective on sports now," the football captain said.

His father agrees. The Rainvilles no longer carry an AED on road trips and Rob, an assistant coach for the Goats, watches his son from the sidelines. He and Varrenti stay in contact as she called the Rainvilles part of the Nick of Time family.

"I'm forever grateful and I told her that," he said, recalling a conversation with Varrenti. "Had you not started this program, who knows what would've happened to my son, now or later?"

For the Rainvilles, that question need not be answered as one young man's story has inspired a legacy of hope and of heart.

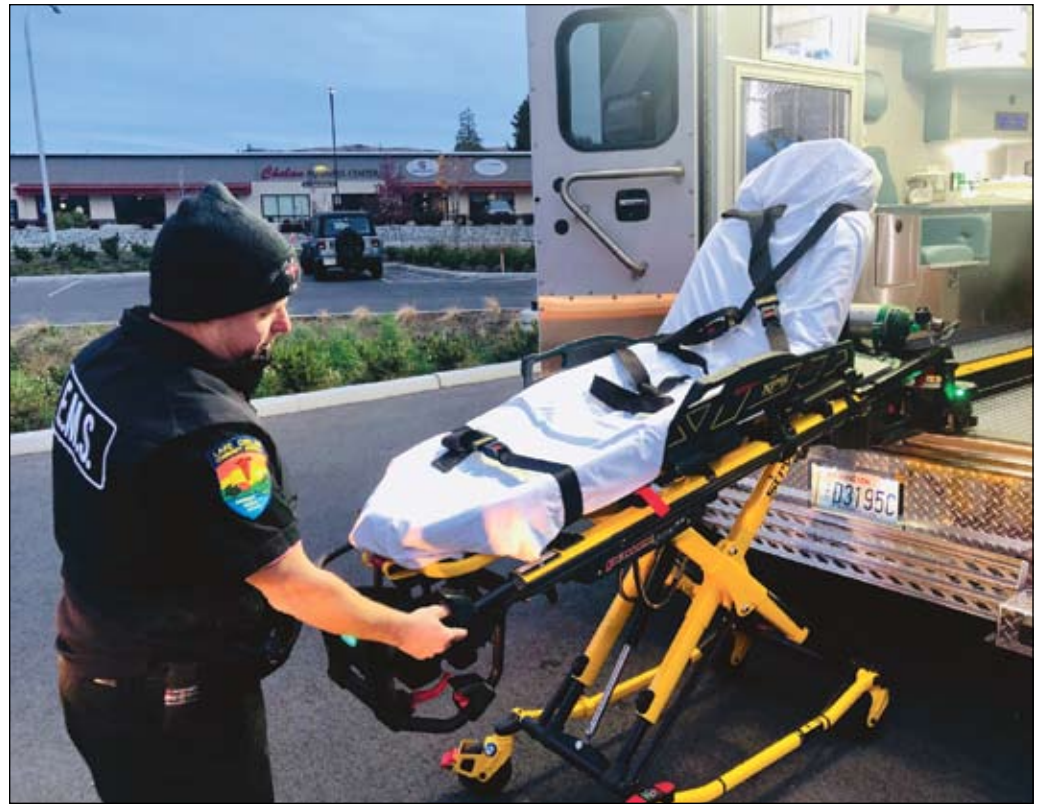

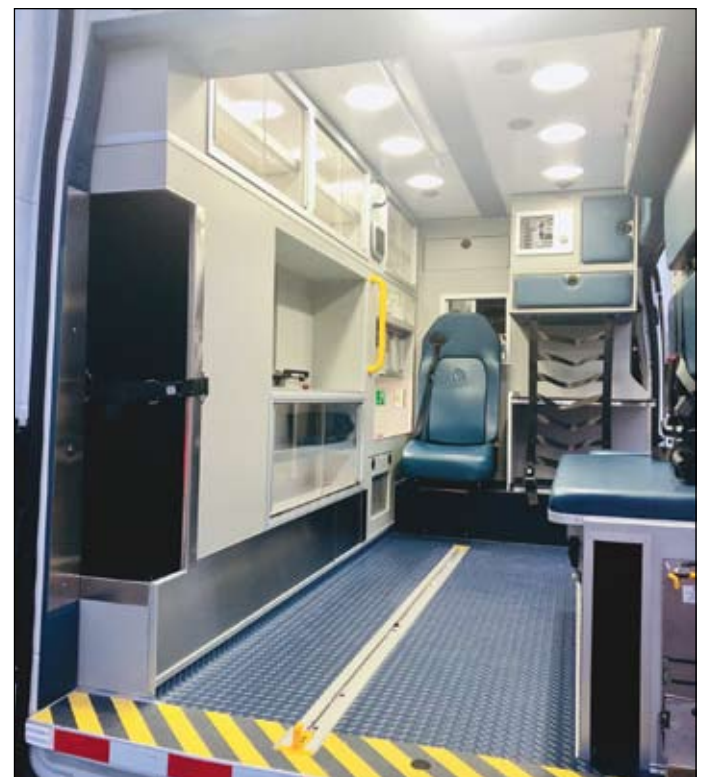

Local diver finds treasure beneath the surface

CHELAN – Black Diamond native Doug Morgan has always found himself compelled by high adventure and helping people. With a recent foray into diving, he's found a true passion in the depths of Lake Chelan.

Morgan moved here full time in 2016 and spends his days working in the tree industry. He has served in the military and as a volunteer firefighter, received his pilot's license last winter, and is an avid outdoor enthusiast, enjoying hunting and fishing.

Together with his wife, he has worked through the years to offer many types of community support. Among these efforts, they work to provide free lunches to community members in summer, and, in the colder months, they donate firewood to those on fixed incomes, as well as money toward taking families Christmas shopping.

Between commitments to work, family, and the generous efforts he's engaged in, his life is full.

Despite a busy schedule, however, he's always looking for new ways that he can be of service. In recent years he's found himself adding yet another giving practice to his repertoire—diving for lost treasures.

Morgan always enjoyed snorkeling and initially felt compelled to learn how to dive to be more active in water, so he sought formal diving lessons from professional diving instructor Van Ford, of Wenatchee.

Then, what started out as just a hobby quickly lent itself as an opportunity to be helpful.

Reflecting on how this began, Morgan remembered first starting out with an idea to try to clean up stray debris from the lake bottom.

"I realized I could go down and clean up underwater and take some garbage bags down with me," he said. "I'll try at least once a day to fill a garbage bag with beer cans, flip-flops, towels, sunglasses, you name it."

Over time, Morgan began hearing people requesting community help with locating items lost in or near the lake, and he decided to be of service.

Morgan has been diving now for four years with a log of over 750 dives—more than 50 of which were for the purpose of trying to find lost items for people. These items vary in nature, but jewelry, glasses, and cellphones are among some of those prized possessions Morgan has helped reunite with people.

"It gives me a purpose for being down there more

than just swimming around and enjoying myself to see people's reactions," he shared. "Finding stuff for people is just another way that I can

incorporate my hobbies into giving back.

While Morgan does not charge for this service, people

often donate toward his oxygen expenses.

Morgan currently dives about 200 days a year span-

ning all months, and dives primarily by himself. There are a number of skilled divers in the Chelan area, and Morgan enjoys diving with others and sharing in the experience as well.

"You're not supposed to dive by yourself. It's really frowned upon in the diving community—but, when you have such a passion to do something... you just end up doing it by yourself," he explained. "I try to be smart about it. I don't go do 200 foot dives. I try to keep my dives shallow."

"I try to wear clothes that if something did happen I'd be found easily," he continued. "I try to dive in areas where there's other people so if something happens there's somebody close by."

turnout at only 47.23%. The low point in the last decade was 2017's turnout at an astonishingly low 38.14%. While we've seen some improvement, our goal should be to consistently engage a majority of eligible voters in the decision-making process.

So, why should we care about local elections? The answer is simple: because they affect our daily lives in profound ways. Local leaders determine how our tax dollars are spent, the quality of our schools, the state

of our roads, and much more. Decisions made at the local level can directly impact our communities, and it's crucial that we have a say in shaping our future.

As we approach the upcoming election on Tuesday, Nov. 7, it's essential to understand the deadlines for casting your vote. To ensure your voice is heard, ballots must be placed in a ballot dropbox or postmarked by 8 p.m. on that day. This is your opportunity to make a difference in North Central Washington

and Chelan County, so don't let it slip away.

Let's break the cycle of low voter turnout and take charge of our future. Local elections matter, and every vote counts. By participating in these crucial decisions, we can build a stronger and more vibrant community. So, mark your calendars, fill out those ballots, and be the change you want to see. Let's ensure that North Central Washington's future is bright and promising, as it should be.

Get to know new firefighter, EMT Stephanie Preheim

CHELAN – Chelan Fire & Rescue District #7 recently welcomed three new firefighters. In this direct Q & A, Firefighter and EMT Stephanie Preheim takes a minute to introduce herself to the valley:

Q: How long have you been in the Chelan area, and where are you from originally?

A: I don't currently live in Chelan although maybe someday in the future I would love to. I was born and raised in Cashmere, and currently still reside there and commute for work. I grew up coming to Lake Chelan almost every weekend in the summer, so it feels just like home when I'm here.

Q: When did you know you wanted to become a firefighter?

A: I joined CCFD#1 (now Wenatchee Valley Fire Department) in 2016 as a resident firefighter. There I graduated from the fire academy and was placed on shift and started working with the career staff. I was not yet convinced that this was the path I wanted to pursue. Not long after, I got my first real fire call, and I'll never forget that shift, it was the shift that changed it all for me. I was able to really see the direct change and impact I could be a part of in making a difference. I was the first firefighter to pull the hose off the truck and get water in the building. And we all worked flawlessly together, like my Captain at the time would say today, it's like "poetry in motion" being a part of a crew, all in service to a common goal. It is a feeling only a few know, and after being a part of that, that's when I knew. I am proud to now serve the citizens of Lake Chelan and surrounding areas.

Q: What made you want to come to Chelan?

A: What initially drew me to Chelan Fire & Rescue was the stipend program and the community. The program allowed me to work alongside the career staff, as at the time I was testing at other departments that had

openings. Pulling shifts with the crews allowed me to build up my skills and qualifications as I continued to test for firefighter positions. They also had a Rope Rescue Program that I could be a part of, and I really enjoy working with Ropes and Knots.

Q: Have you pursued other careers before training to become a firefighter? If so, what?

A: While in high school I attended the Technical Skills Center in Wenatchee and studied video production, which led me to my first job with Voortex Production out of Cashmere, who specialize in cinematic branding and visual storytelling. I struggled a lot with a sit-down job, and needed to be moving, although I still enjoy cinematography as a hobby and art form.

Q: What is your favorite aspect of being a firefighter?

A: I absolutely love this job and everything that comes with it, but I would have to say my favorite aspect of my job is that I work in a profession that challenges us everyday. Men-

tally and physically, we have to at a moment's notice mitigate chaos. We are trained to show up and solve problems, and it is a fulfilling and rewarding thing to be a part of.

Q: What do you like to do in your free time?

A: I spend a lot of my free time outdoors, I really enjoy anything outside but especially hiking, running, climbing, and skiing to name a few things. I also love to read, write, and do leather work for fun. You can also find me relaxing in a hammock year-round.

Q: Is there anything else you'd like to share about yourself with the community?

A: If anyone wants to know more about the fire service or has never stopped by the fire station come visit, come say hello, check out YOUR trucks, YOUR station and come ask us questions! We all love to chat with the community, and I especially love to chat in the bays and talk about the trucks.

Chelan County Fair to crown first rodeo queen

CASHMERE - The Chelan County Fair and Rodeo is gearing up for an exciting change in 2024 as they prepare to crown their very first Rodeo Queen in November.

Applicants will compete in the Nov. 12 pageant at the Tillicum Riders Club House in Cashmere.

Organizers hope to make the pageant an annual event, showcasing and honoring local young women with an enthusiasm to compete for the title.

"Our rodeo is now sanc-

tioned with the Professional Rodeo Cowboy Association or PRCA, so we are hopeful that having a rodeo queen at other events will draw more attention to the Chelan County Fair and Rodeo," said Kristen Mattson, a member of the Chelan County Fair Board and the Chelan County Rodeo Queen Committee.

To be considered, applicants must be between the ages of 17 and 23, attending high school or recently graduated, a resident of either Chelan, Douglas, Okanogan, or Grant counties, have riding and horsemanship skills, and have

attended a mandatory orientation on Oct. 30.

Prospective queens will compete in several segments including personal interviews, horsemanship skills, modeling presentations, speech delivery, and impromptu questions.

A panel of three judges will evaluate contestants in these categories.

Mattson said the judges are looking for someone who is proud to represent the Chelan Fair and Rodeo.

The 2024 queen will be presented with a variety of awards, sponsored items, and royalty accessories to be worn during the year of her reign. She will participate in a year of community events, public speaking, parades, luncheons, and rodeos while serving as a goodwill ambassador for the Chelan County Fair and Rodeo.

In the past, the Chelan County Fair had two local young people, known as Ambassadors, who represented the fair at speaking engagements before and during the annual fair. However, in 2024, the Ambassador positions will be reduced from two to one. The Rodeo Queen and Ambassador will work together to promote the fair and rodeo.

Mattson hopes the new queen shares her knowledge with the community to help people better understand the sport of rodeo and can serve as a good role model for little girls.

"Rodeo has always felt like family to me," she said. "Everyone who I've met through rodeo have become good friends; they are always willing to lend a helping hand when needed. My hope is the rodeo queen is a conduit for sharing that rodeo family and experience with our community."

The 2024 Chelan County Fair is scheduled for Sept. 5-8.

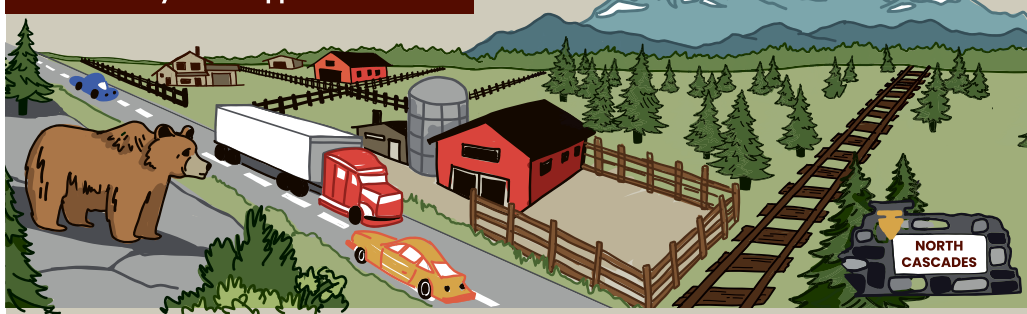

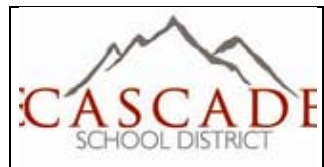
