## Festivities evolve after haunted house closure

MANSON - The Manson Chamber of Commerce is working hard to pivot their Halloween plans after their popular haunted house had to close its doors just weeks before the opening weekend due to safety concerns from the county fire marshal.

"It is with disappointment and even sadness that I share with you the news that Manson's Haunted House (only) has been canceled for 2023," Manson Chamber President Kim Ustanik said in an email announcement.

The haunted house is part of the town's many Halloween-themed events leading up to Halloween. Ustanik stressed that the haunted house is the only part of the festivities that is affected.

Upon inspection of the haunted house, the fire marshal imposed a set of regulations to ensure the safety of visitors and workers in the structure, which is composed of donated apple bins.

"They said they don't want to shut us down," Ustanik said. "That was not their intention. As a matter of fact, the building department even issued a temporary occupancy permit for us for specific days. But there was one of his regulations that there's no way we can make it work with it."

The one regulation they could not make work was that there could not be a cover of any kind over the structure, not a tarp or a raised cover like a party tent. The structure was previously covered with a tarp.

"And as you can see right now, it looks like we're going to have fall this year," she said. "Last year we didn't, but nonetheless, we can't predict when it's going to rain. And we have really quite an investment in furnishings and decorations and electrical equipment and sound and lighting."

On top of the investment in building the haunted house, there are also student and adult volunteers, paid workers, and people buying tickets, Ustanik said.

"And if it gets rained out, it would just be a disaster," she said.

Ustanik stated that safety

is the top concern of all involved.

Instead of the haunted house operating all month, as was planned, it will be disassembled and parts of it will be used for a one-day-only haunted house experience inside a local winery on Saturday, Oct. 28 in downtown Manson.

On that same day, Manson has a pumpkin walk and a zombie dash, and the chamber now plans to push all events to that day and have it culminate with a big block party in downtown Manson. Events will include a silent auction, live auction, costume dance party and more with harvest and haunted events happening all month long at local businesses.

"We are going to have a great big haunted house at Radiance Winery, which is just a fabulous venue and central right there in the downtown area," Ustanik said. "We're going to have entertainment and an auction to try to recoup a little bit of the expenses and to give the community a really fun time, and the people that we can bring in from out of the area. And, if we can, maybe at least, focus some money on the senior class this year."

The haunted house has been a fundraiser for the classes at Manson High School to use for their senior trip. Students earn money by volunteering as actors and to help operate the haunted house. Many of the volunteers and actors in the haunted house are high school students.

Not only is the haunted house a fundraiser for high schoolers but it also brings in tourism to support the local economy.

"It is an economic venture to support our businesses and help make the fall be a season when people from far away want to come and stay here at the Lake Chelan Valley," she said. "We had great promotions for hotels to be able to give out discounted tickets so they could encourage people to come and stay at their hotels, and of course, we do want these people that are coming into our town to go to our restaurants and

## Golden Gate Ventures (Chelan Butte) property development planning continues

CHELAN - Last week, Chelan City Council held a public hearing on Tuesday, Sept. 26 regarding a Boundary Line Adjustment Code Amendment, and passed Ordinance No. 2023-1612.

Raja Venugopal, intended developer, said during the hearing that he wrote an email to the mayor and City Council members last year that he had come to an agreement to purchase Golden Gate Ventures' property.

"Madhu, my wife, and I sent a commitment that we will take this responsibility seriously and develop this property in a respectful and thoughtful way," he said.

Over the last six to seven months, Venugopal said that he and his wife met hundreds of people in the community, [and] dozens of organizations and businesses to understand what was important to them.

Out of those conversations, three priorities emerged. "Number one, that is an iconic piece of landscape of the community. They would

like to preserve it," he explained. "Number two, don't just preserve for the sake of preservation, open it up for the public to enjoy it—so, recreational facilities, all of those preserved.

"Number three, affordable housing is [a] very big need in the community," he added.

Venugopal looked through the code that [the] 2017 Comprehensive Plan provides, and saw that preservation was not at the top of the list.

"It has done for some degree of preservation and recreation, nothing much further...so I went back to my team and told them, 'We need to achieve all those three priorities and we need to make sure the project cancels itself out because it's private land, we are purchasing it. We have to bring the infrastructure, so I asked them to come up with a plan that meets all those requirements.'"

Venugopal and his team will now look at moving forward and continue to cooperate with the city and build the private

## Organic farmers bring saffron to the valley

MANSON - Nicole Beretha and Darush Amiri moved to the Lake Chelan Valley nine years ago, starting Cyrus Saffron farm at their off-grid homestead in 2014.

The farm, named for their 12-year-old son, Cyrus, sits nestled at least six miles off the main road deep in the hills of Manson. Their property is quaint and secluded, the primitive road leading to their refurbished A-frame cabin dotted with barberry shrubs, wild animal tracks, and billowing foliage.

Their land suffered a fire 25 years ago, a catalyst for the creation of its ash-fine, nutrient-rich soil that is ideal for saffron production. A gradual snow melt over spring provides measured moisture, and prevents soil from becoming oversaturated and rotting the saffron bulbs.

Nicole and Darush came to the valley with a dream of giving back to the community with local, natural, and organic alternatives, and to honor their family tradition of saffron farming. Two-time leukemia survivor and third-generation saffron farmer, Darush has significant inspiration for carrying out his family's legacy.

Rich in antioxidants, saffron has been understood to fight cell damage and be a natural aid in cancer prevention. Saffron is also found to hold a host of other potential medicinal benefits.

It may aid in brain functioning, nervous-system regulation, Alzheimer's symptom mitigation, and

can act as a weight-loss aid, premenstrual reliever, anti-depressant, and seizure treatment in some people.

Early saffron use was seen in Greece, Rome, and Persia, and the art of Saffron cultivation is over 4000 years old. Saffron was commonly used as a medicinal plant, perfume, dye, and seasoning. Considered a symbol of great wealth, it was present in the making of royal garments

and paintings. Today, people still employ it for medicinal purposes, though saffron is most used in cooking. It is found in Middle Eastern and Indian cuisines, and famously featured in the Spanish seafood dish, paella.

Darush and Nicole are passionate about growing and providing only the highest quality saffron, its color a pure and deep crimson. Nicole explains, "We guarantee 22-24 karat [saffron]

and a high level of crocin and safranin. That means our saffron is more potent and you can use less to achieve desired effects. We don't include any of the yellow part [of the flower] to our customers, because it adds only weight and nothing else... we also don't sell orange saffron. If saffron is orange it means it is old, or the sun has burned the pistils and it has lost its potency. We are also organic, so no fertilizers or pesticides are used."

They are preparing for harvest, a delicate and laborious process that takes place over a few short weeks in late October and early November. Once the saffron flower comes out from its bulb base in the ground, harvesting must happen very quickly. Ideally, the flower should not open its petals, as sun exposure can burn its delicate stigmas. Each flower bears only three stigmas, each one needing to be

**Apple Stem Networks's 2023 Washington STEM Rising Star, Alexandra 'Natalie' Vazquez**

CHELAN – Chelan High School senior Alexandra “Natalie” Vazquez was recently named Apple STEM Network’s 2023 Washington STEM Rising Star. This program is designed to support young women who show exceptional interest and tenacity in exploring and working within STEM.

She was nominated for this program by CHS science teacher and advisor, April Slagle, a mentor she’s taken much inspiration and encouragement from in her time at CHS.

According to the Washington STEM website, Rising Star Awardees should meet the following criteria:

- Participate in STEM activities in or outside of the classroom (robotics, 4-H/ag science club, computer science group, etc.)
- Develop or create STEM projects in or outside of the classroom (website development, business ventures, STEM related art, etc.)
- Use STEM as a means of service to their community and/or family (tutoring, volunteering with a STEM-based community program, etc.)
- Have a general passion for learning and exploring topics in STEM (exhibits infectious enthusiasm for STEM activities and/or topics)
- Excel academically, particularly in STEM-focused subjects (exceptional grades or evaluations in a STEM course/class or overall)

Washington STEM Rising Star honorees receive not only acknowledgement of their aptitudes and accomplishments, they are also given mentorship and personal development opportunities, a \$500 stipend, and fun STEM swag. Natalie was one of 11 students awarded from around the state, which will come handy as the senior

applies to universities and for scholarships.

Natalie has known she’s wanted to be a doctor since first grade, with her interest in helping people through medicine driving her to achieve at a high level throughout her education. She currently serves as Vice President of Chelan Med Club and president elect of next year’s Med Club.

“When I took biology in April, we worked a lot with microscopes,” she said. “I’ve been interested in what the smallest unit is, and what builds us in a way...I’m also interested in maybe doing some research later on in vaccines, focusing on virology a little bit. I think that’s what interests me the most, coming up with vaccines that are really fun—but I’m not exactly sure yet. It’s just something I’d like to dip my toes into and that I really like so far.”

She hopes to be accepted at the University of Washington, where she plans to obtain a degree in microbiology with a minor in public health before attending medical school.

# Artisans converge in Chelan to create magical museum environment

*Talented taxidermists and muralists wave their wands at Nature's Window*

CHELAN - What could be more challenging than collecting hunter's taxidermy and presenting them in action-packed dioramas that tell a story of dramatic compassion and conservation?

"The mission of Nature's Window museum, also known as Lake Chelan Museum of Wildlife, Natural History & Art, is entrusted to increase knowledge and appreciation of the diverse wildlife of the world," local businessman Shannon Kollmeyer said. "In addition, we want to educate the public about the role art and wildlife management play in conserving these valuable resources."

To achieve this lofty goal, museum founders Kollmeyer and his wife, Cris, searched for the best talents in the country to create their new exhibits in Chelan. For taxidermy, museum design and building layout, the Kollmeyers tapped renowned exhibit designer Stuart Farnsworth, of Monarch Taxidermy of Helena, Montana. He and his team's creative work is exhibited world-wide and he has an avid following with sports hunters across the United States and Canada.

In order to develop colorful dioramas that exude the proper animal habitat that is both informative and entertaining in a museum setting, artists Rich Marks and Becca Allen were chosen to create vivid murals evoking landscapes from Alaska to Africa.

The creative duo enjoys the

challenge of making the museum's murals and settings look seamlessly lifelike. "We strive to accurately portray the habitat, and sometimes the animals, paying close attention to the transition point where the mural meets the 3-D habitat," Marks said. "We want our murals to be artistic, yet simultaneously realistic. Becca offers a similar style of painting, so we have a natural flow."

Marks studied fine art at the Colorado Institute of Art and then desk-top publishing at the Denver Institute of Technology. "Both colleges were invaluable as now I can design all of my mockups on the computer using Photoshop — afterward, I use my fine-art skills to execute the designs on the wall," Marks explained.

"Using this strategy, Becca and I are able to resolve any (design) issues up front," Marks said. "That allows us to paint

with confidence. It's this confidence that makes for a better painter," Marks continued.

Becca Allen is an artist from North Carolina, although she earned a masters in Art Therapy at Florida State University before connecting with Marks. She began painting murals with her colleague in 2021 and they have since completed several large-scale scenic dioramas together.

"It's really an honor to work and learn alongside Rich," Al-

len said. "He has been a wonderful mentor to me and we make a really great team. Part of my job is to match his style and create a seamless painting as if one artist completed it all. It has been gratifying to achieve that goal as well as to bring Shannon and Cris Kollmeyer's vision to life."

"Sometimes even I cannot believe what we are achieving. It really is amazing to see (the museum) come together," Allen exclaimed.

Shannon and Cris Kollmeyer are pleased with the way their wildlife and natural history museum is taking shape. "Our guiding savant is definitely Stuart Farnsworth. He has taken our collection of animals from around the world and has created the most amazing settings," Shannon observed. "He and his world-class team from Montana have managed to blend reality and storytelling into a narrative that is clear and concise. Viewers can learn about conservation, wildlife management and the role hunters play in preserving

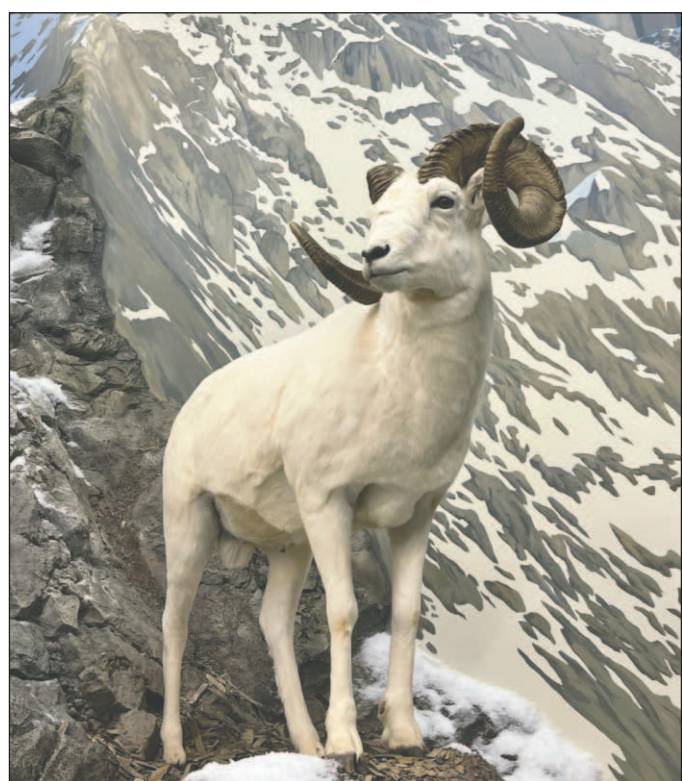
wild places and wild animals for future generations," he added.

THE WASHINGTON OUTDOOR REPORT

BIRD HUNTING PROSPECTS

The Washington Department of Fish and Wildlife has published its hunting forecast for this fall. Here are the highlights when it comes to bird hunting where our readers live:

DISTRICT 1 (Stevens, Ferry, and Pend Oreille Counties):

Grouse numbers have declined in the last 14 years, but hunters should see success similar to recent years, averaging about a bird every other outing. Look for grouse on little-used Forest Service roads, especially ones gated off to vehicular traffic.

Pheasant hunting is pretty much limited to released birds at the Sherman Creek Wildlife Area in Ferry County. Wild turkeys, on the other hand, are prolific in this part of the state, and the Fall harvest of these birds has increased in recent years. Forest edges, as well as grass pastures and

agricultural fields, are all good places to look for turkey.

Waterfowl hunting should be good, especially along the Pend Oreille River from Newport to Usk, for dabbling and diving ducks, as well as Canada geese. Early-season hunters also have the chance to harvest wood ducks in the Bend Colville, Kettle Falls, and Pend Oreille River valleys.

DISTRICT 6 (Okanogan County):

Waterfowl hunting doesn't get much press in a county known primarily for big game. Still, there are a few public places worth hunting near the mouth of the Okanogan River as well as the mainstem Okanogan and Upper Similkameen Rivers. Public hunting access can be found at the

Washburn Island Unit of the Wells Wildlife Area, the Driscoll-Eyhott Island Unit of the Sinlahekin Wildlife Area, and the Similkameen-Chopaka Unit of the Scotch Creek Wildlife Area.

Okanogan County has "robust populations" of grouse, and although the number

of adults in breeding areas this spring declined due to last year's extended winter, brood survival was good for the young birds. Quail populations are also solid in this region, and the spring breeding season for quail was similar to what was seen for grouse here. Hunters should find quail in lower elevation, tree-lined areas, or shrub steppe in state wildlife areas throughout the county. Pheasant populations, on the other hand, are fairly minimal. There will be releases throughout this season at the Bureau of Reclamation's Hegdal and Kline sites and at the Chiliwist Unit of the Sinlahekin Wildlife Area.

The fall turkey season opened up on Sept. 1, and

you'll find good numbers of these birds in flocks throughout the district, especially on private land near agricultural lands. The best places to hunt are in Game Management Units (GMUs) 204, 215, and 239

DISTRICT 7 (Chelan and Douglas Counties):

According to WDFW, Chelan and Douglas Counties offer some of the best quail hunting in the state. In the early season, the birds can be found in good numbers in state wildlife areas. Still, better hunting can be found on private lands, especially around orchards, if you can secure permission from landowners to hunt on their property.

Hungarian (or gray) par-

tridge can be found in shrub-steppe habitats in Douglas County, and in 2021, nearly half of the Huns harvested in the state came out of Douglas County. Nearly 1200 of these birds were harvested statewide that year, about 500 more than average.

Chukar have typically thrived in this part of North Central Washington; on average, 4400 chukar a year are harvested. However, in 2021, there was a dramatic decline in the chukar harvest here, with only 2345 birds taken by hunters. It's thought a heat-wave that year stunted chukar numbers, but with relatively mild weather this spring and summer, we will hopefully see an increase in the population of these hardy game birds.

Grouse numbers and the hunters that go after them have both declined in recent years. However, there are still plenty of grouse to be found in GMUs 245, 246, and 251 within Chelan County, as well as GMUs 248 and 266 in Douglas County. Look for Grouse in forested areas, espe-

cially around stands of aspen for ruffed grouse and above where ponderosa pine grows for spruce grouse.

Pheasant hunting has become difficult in the region, and there are only three releases per season at the Swakane and Chelan Butte Wildlife Areas. The Columbia River provides good late-season duck hunting for dabbling and diving ducks. However, remember you are not allowed to hunt on the river between the George Sellar and Odabashian Bridges.

DISTRICT 9 (Klickitat County):

Turkey populations remains very healthy in Klickitat County, and this should be a good year to harvest a gobbler. The season opened on Sept. 1 and runs through Dec. 31. According to WDFW, 221 turkeys were harvested last Fall with a success rate of 35 percent by hunters. The number of birds harvested has increased significantly from 2019 to 2021, where the annual harvest was between 150 and 164 birds.
