Columbia Valley Community Health risks losing integral funding

CHELAN – CEO of Columbia Valley Community Health, Manuel Navarro, gave a special presentation at last week's City Council meeting regarding the potential loss of federal grant funding for Community Health Centers and the impact this may have on CVCH's ability to provide certain services to the community.

According to the National Association of Community Health Centers website, "Congress needs to act before September 30, 2023, to extend Community Health Center funding. If Congress does not act to extend health center funding before that date, almost 7 million patients will lose access to care and nearly 60,000 health center staff positions could be lost."

The implications of this potential loss would be significant to CVCH's ability to continue to fully serve the community. Navarro states, "The loss of this revenue would reduce our ability to extend mobile clinic and school-based health services through our clinical outreach teams. These efforts are focused on reaching our most vulnerable of populations such as agricultural workers, rural residents, and low-income students." Navarro elaborates, "It

would also hinder our ability to recruit and hire new providers, and to expand services at all our sites. We operate many of our provider training programs for family medicine physicians, dentists, and behavioral medicine psychologists on a very thin (if any) margin. The intent is to train these providers in a rural setting to increase the likelihood of them practicing in a rural setting. All of these programs would be at risk."

In other news, a new ordinance reducing the speed limit on a designated section of SR 97A was adopted. The speed limit revision from 30 mph to 25 mph was requested by the Washington State Department of Transportation to mitigate pedestrian safety and volume concerns. The affected area will be from SR 97A at milepost 233.66 to milepost 234.49, from Stage Stop Antiques on Webster Avenue near Chelan High School to the intersection of Woodin Avenue and Robinson St. (just past Morgen Owings Elementary).

The next Chelan City Council meeting will be a City Council Regular Meeting on September 26, at 6 p.m. in Council Chambers, 135 E. Johnson Avenue, Chelan.

Thrive Teen Center set to reopen in October

CHELAN – Community members excitedly await the October 3 reopening of Thrive Teen Center, a recreational and youth support center located in the basement of The Lake Chelan United Methodist Church. Thrive's website states, "Thrive Chelan Valley is a local 501(c)(3) non-profit dedicated to ensuring that all youth in the Lake Chelan valley have everything they need to reach their full potential," and with the myriad of resources now available at Thrive Teen Center, their presence in the community is playing an especially integral role.

Program Director, Stefani Morgan, shares, "We want kids to feel comfortable just coming in, just being. We do have kids that will come in, and all the kids will be going on, and they'll be under blankets, sleeping. Then, we have other kids that are just eating almost the whole time when they're here. You just can tell they're getting what they need. That's what we're here for."

The space itself, provided at no cost by the Lake Chelan United Methodist Church, Thrive Chelan Valley has fully transformed to truly meet the needs of the valley's youth. Over half of the basement is a large recreational space in which teens can lounge, eat, watch movies, play games, work on crafts, read, and generally socialize. The space also boasts a "take what you need" closet

furnished with community clothing and outerwear donations, well-stocked open snack and essentials pantry, a refrigerator of healthy drinks, a hygiene closet providing full-sized hygiene basics, a single stall unisex bathroom, and a dedicated study space for students who need a quiet place to complete homework.

Thrive Teen Center is able to provide these resources with community support, relying primarily on donations. Thrive Chelan Valley

hosts occasional events for teens. Thrive also hosts a mentorship program, a team of community volunteers who are available to teens to provide opportunities to build healthy, supportive, and trusting relationships with adults. Additional volunteers provide homework help to students. Thrive Teen Center also hosts family-style dinners two nights a week, with area restaurants and residents providing food for typically 20 to 25 teens on each dedicated evening.

Thrive Teen Center serves roughly 25 to 30 teens daily, with 10 to 15 regular attendees. Morgan adds, "We have kids that come in and grab a snack before they go to their sporting event, or that have sports and come after to have dinner with us. It feels very good down here. We're definitely building community and giving them some relationships they didn't have."

Lake Chelan Valley welcomes inspired pasta

CHELAN – An exciting addition to the valley’s culinary scene, Lago Pasta and Casetta Rossa have taken the hearts of Chelan residents with their hip approach to both food and restaurant culture. Lago Pasta, a small European market, and Casetta Rossa, an Italian trattoria pasta bar, opened less than four months ago, though have quickly become beloved.

This market and pasta bar are the creations of partners and longtime friends, Teague Block and Nathan Gottlieb. Block, former owner of Lake Rider Sports in Chelan, and Gottlieb, long-time Italian chef and former part-owner of Pasta Casalinga of Pike Place Market, teamed up this past winter to bring the valley something new, and their quick acceptance has been noteworthy. Block had been working two years to prepare their current location at 510 E. Woodin Avenue with intention to open a market, but it was when chef Gottlieb made the decision to relocate to Chelan in December that their collaboration really began to take shape.

Block describes their bond and vision, “We became two separate entities, but at the

same time, we’re one entity. He’s [Gottlieb] Casetta Rossa, he’s the chef, and I’m in charge

of the market, I’m Lago [Pasta], but we are the same. We’re looking to venture with other people too and bring in other ideas, things that are part of something comfortable, something fun, European, with reasonable prices...we want you to walk in and feel like you’re out of Chelan, like you just walked into little Europe. Every day we strive to provide that because that’s what we want. We just want a place where we can hang out and feel cozy.”

Pasta Lago boasts a myriad of delicacies, wines and various European treats for sale

alongside a deli stocked with their fresh pasta, sauces, seasonal vegetables, and specialty syrups. Outside, Casetta Rossa’s menu features ever-changing pasta dishes and salads, the trattoria honoring a small sampling of dishes rich with seasonal and local inspiration and ingredients. This coming winter they plan to stay open, and have intention to even begin offering take-and-bake options to the community.

Food is not, however, the only aspect of this venture that Block and Gottlieb are impassioned

about. Their commitment to and care for their employees shows in their dedication to creating a supportive and balanced work environment for all. Block articulates, “They [market and restaurant staff] are treated like family here, and everybody has the same position. We all wash the dishes. We all serve food. We all get behind the cook station if we need to cook. We’re chopping onions together. It’s a bit different in that way for a business like this—everybody’s equal.”

New Wildlife, Natural History Museum & Art Gallery readies world-class exhibit for October opening

“Nature’s Window” is portal for learning about conservation and the diverse wildlife of the world

The vibrant Nature’s Window will increase knowledge and appreciation of wildlife from around the world in a unique museum setting. It is slated to open in mid-October near Knapp’s Hill Tunnel.

Roosevelt, along with other sportsmen, was instrumental in crafting the North American Model of Wildlife Conservation in the early 1900’s. The policies of this model created the world’s most successful wildlife and habitat conservation program that has rescued hundreds of

wildlife species from extinction.

The new museum brings nature indoors, providing a sensory journey with unique sounds and sights stimulating visceral responses. Whether it is the howl of an Arctic wolf, the bitter cold wind of central Alaska, or the honk of a Canada goose, nature is recreated using the latest museum technology. Observers are immediately immersed in nature, perhaps rekindling memories of their own adventures in the natural world.

Kollmeyer brought together an exceptional group of specialists to help fulfill his mission to offer an exceptional, world-class museum facility for the Chelan community and the wider region to enjoy. The Kollmeyers and other donors from Washington and Arizona provided the initial collection of taxidermy species in Nature’s Window.

The museum also features an extensive Fire Ecology exhibit with numerous professional photos and explanations documenting the historical fire disturbances common in the Pacific Northwest. This exhibit was designed and installed by John Marshall from Wenatchee, WA. As the collection ma-

tures, more examples of species will be added.

Nature’s Window will be open to the public during the tourist season from April through October, as well as for private functions and special events for community

organizations as a meeting place, reception site, and venue for fundraising events. As an education center, projections indicate that Nature’s Window shall be used for hunter safety lessons, scout meetings, sportsmen’s

clubs, school field trips, art classes, and archery at the facility’s range.

“All of us at the museum strive to teach our guests about the wonder of wildlife and their environment with the merger of science, technology, and art,” Kollmeyer remarked. “What’s more, our artistic dioramas are accurate reflections of actual animal habitats that are also teaching tools of conservation, science, and art. Viewers can learn about wildlife management and the role artists and hunters play in preserving wild places and animals for future generations.”

Humans have been hunters from the beginning of time. Many pictographs, petroglyphs, and other artifacts document the use of animals for their survival. A wide range of pictographs in Central Washington, including Lake Chelan and the Columbia River Regions, captured visual examples of the relationship between early hunters in the area and native wildlife.

“Preserving our wilderness and natural world is more critical than ever and is a responsibility of all citizens,” Kollmeyer said.

Annual swim event garners generous community support

MANSON – Lake Chelan Swim hosted their annual swim on Saturday, September 9 with an overwhelming show of community support. Lake Chelan Swim covers a 1.5 mile long course starting at Willow Point Park in Manson and concluding downtown at Manson Bay Park. The race started at noon with the last participant finishing the course at 2:02 p.m..

Lake Chelan Swim was supported through the efforts of the race participants, community volunteers, and donors. Money raised from this event and on-going donations benefit Lake Chelan Swim.

The event was started in 2011 by long-time lifeguard and swim instructor, Viki Downey and collaborator, Judy Phelps.

This year's event garnered over \$6,000, with donations continuing to come in. Though not a requirement for participation, many registrants collect money through sponsorship. A goal of the organization is to have 100 registrants, and this year they met that goal with 119 registrations, and 92 actually participating in the race. All who participated finished the course.

Swimming and teaching others to swim is a true calling and passion for Downey. She began training as a junior lifeguard at age 11, and has dedicated her life to teaching water safety to children. Currently she is a lifeguard at Manson Bay Park, the only public lifeguard station in the valley. She has been working for the Manson Parks Department for almost 26 years, and lifeguarding for 57. She first learned to swim formally at age 6 when she started attending free swim lessons

provided by her local Red Cross—a model that would inspire Downey in later years to provide a similar opportunity to children. Lake Chelan Swim provides no-cost swimming lessons to children of the valley. This year, they served 521 children, offering lessons from 11 a.m. to 4 p.m., Monday through Thursday, throughout the summer.

Downey asserts the importance of allowing open access to swimming lessons for children, stating, “Kids often struggle when they only learn to doggy-paddle. They don’t learn any safety. They don’t learn how to roll to their back or to tread water without swim lessons or somebody that’s knowledgeable, which many parents

aren’t. I’ve made an incredible amount of rescues over the years up here at the lake. When I first started on July 5 of my first year in 1998, I made nine rescues in two hours. That summer I made 63 rescues. So that’s how it goes. I’m just adamant that kids get some lessons. It has cut down on rescues. We made seven this summer with twice as many kids present, probably even four times as many kids.”
