Lake Chelan School District Board approves 2023-2024 budget

CHELAN - The Lake Chelan School District Board of Directors took action at its June 28th board meeting, approving a general fund operating budget of \$24,113,355 for the 2023-2024 school year.

 $According \,to\,outgoing\,LCSD$ Business Manager Bo Charlton, the new budget indicates a 14-percent reduction from the last fiscal-year's budget as a result of an enrollment decline of 161 full-time equivalent (FTE) students over the last five years. The district is projecting 1,200 FT for the upcoming school year.

Students and families should not see a reduction in services despite the budget decrease because temporary federal pandemic-relief funds are coming to an end. The majority of that money was used to improve ventilation systems and implement post-pandemic supplemental-assistance programs for students.

"Our students continue to benefit from the generous support of the local Educational **Programs and Operations** money levied by our community," Superintendent Brad Wilson said. "Those funds enable our district to offer a very well-rounded educational experience of wide-ranging academic and extracurricular opportunities, while maintaining the safety and well-being of our student body."

It is important to note the majority of district funds come

The annual LCSD budget also encompasses a capital projects fund that supports the purchase of technology for student learning and the completion of maintenance projects such as: major facility repairs, flooring, security cameras and door systems, plus major equipment purchases. The budget also includes separate sections for funding the transportation vehicle (bus) fund and the associated student body activities such as clubs and athletics.

The school district currently does not carry any debt and **Brad Wilson, superintendent**

Lake Chelan School District is collecting the lowest local

levy rate in recent history. On average, the district spends \$17,862 per student based on

2021-2022 data from the Office of the Superintendent of Public Instruction (OSPI).

Established in 1892, Lake Chelan School District serves nearly 1,270 students with 97 percent of its students graduating in four years with more than 50 percent of high school students enrolled in nocost, college-level coursework (OSPI data). "Lord & Lady" is one of the first tenants in the Manson Center owned by Marcus and Trie Smith. "We are in the last stages of an extensive remodel to this historic, hundred year old building. Beside "Lord & Lady" our tenants include Valley Barber, Cheval Cellars, additional spaces are available to rent," Marcus said.

I asked owners, Geff Cerna and Elke Reiter to describe "Lord & Lady". "We are an antique, vintage, collectibles and gift store; a shop of treasures to be found, loved and enjoyed by others. We are not just another retail store, we plan to have many opportunities for community involvement and growth through various ideas and plans including scholarships, internships and community service opportunities for Manson High School students. Much growth will be happening in this small corner of Manson."

Geff and Elke are best friends and business partners. Through family connections, they have known each other for nearly 25 years. Their primary connection is the love of antiques. Both have collected and sold antiques for many years. The idea of opening a "store front"

business, in addition to selling on the Internet began several years ago. With abundant storage spaces for their antiques, moving to a retail space made financial and good business

Geff and Elke grew up on the west side of the mountains, near the Pacific Ocean. Geff graduated from Monsanto High School with Elke attending Aberdeen High School. Both are lifelong learners, Geff just graduated, June 16, from Wenatchee Valley College with a with a degree Criminal Justice. Geff spent most of his working career in the lumber industry. Elke received a degree in Criminal Justice from the Wenatchee Valley College and has worked in the health care industry most of her life. Elke is blessed with eight children, all still living in Manson with three that graduated from Manson High School, and Geff boast of being "papa" to 14.

Changes made to **Confluence Health** facility names

WENATCHEE As of July 1. Confluence Health transitioned its naming conventions for its hospitals and some other locations to increase clarity and allow for smoother services for patients.

Ten years after Wenatchee Valley Medical Center (now known as Wenatchee Valley Medical Group) and Central Washington Hospital affiliated under the name of Confluence Health in 2013, the organization will now transition to a single entity: Confluence Health. This change will result in some of the facilities having new names.

"After being first announced last summer, there has been a lot of work getting everything ready for this important transition," remarked Tom Legel, chief financial officer for Confluence Health. "Bringing everything together has been complex with lots of challenges. We are excited for this transition and thankful to every staff member and provider for helping to make Confluence Health a place that means trust, respect, compassion, and teamwork to the community we serve."

With this transition, Central Washington Hospital and Wenatchee Valley Hospital will become one hospital, Confluence Health Hospital, with two locations. The former Central Washington Hospital will be the Central Campus of Confluence Health Hospital and the former Wenatchee Valley Hospital will be the Mares Campus.

In addition, to better reflect


the services they provide, the Omak and Moses Lake clinics will now be known as Confluence Health Omak Campus and Confluence Health Moses Lake Campus, respectively. Other clinics - such as Confluence Health Cashmere Clinic, will not change their names.

Chelan PUD, YMCA agree in principle to terms redeveloping part of Fifth Street campus

WENATCHEE - What is now a utility warehouse is one step closer to becoming the site of a bustling community hub. Chelan PUD staff presented draft terms of a potential purchase and sale agreement for a portion of the PUD's Fifth Street Campus for Commissioner consideration. The YMCA plans to redevelop part of Chelan PUD's current headquarters into a new, expanded YMCA facility.

Under the draft proposal, the YMCA would purchase a parcel of about 85,000 square

the Fifth Street campus. The nonprofit plans to demolish the existing warehouse, office and shop sometime in the spring of 2024, and prepare the parcel for construction. The PUD would relocate water, stormwater, and electrical infrastructure to enable redevelopment of the entire site, including the future YMCA facility. The PUD will also be responsible for the construction of an internal roadway and sidewalk through the 7.5-acre campus.

Once vacant, the appraised value of the 85,000 square-foot parcel is estimated at \$1.49

feet on the eastern side of million. Chelan PUD will offer a \$1.09 million credit to the YMCA for demolition and site preparation costs. After the credit, the proposed sale price of the property will be

> "The YMCA is grateful to the PUD commissioners and staff for this opportunity. This is one more step towards realizing our goal, vision, and promise to best serve the community for the next 100 years, and we are excited," stated Dorry Foster, CEO of the Wenatchee Valley

> "I'd like to add my enthusiasm for this project as well,"

added PUD Commissioner Garry Arseneault. "This Term Sheet with the YMCA would go a long way towards fulfilling the PUD's commitment to the community and to our PUD customers to provide long-term value and benefit once we have moved to the new Service Center in Olds Station.

The PUD and YMCA began negotiations in February after the PUD board of commissioners asked staff to pursue anchor uses for the 7.5-acre former headquarters. The PUD is also in negotiations with Music Theatre of Wenatchee, which is interested in the PUD's Fish & Wildlife building adjacent to the Riverside Playhouse building on the west side of the campus.

The negotiations with the YMCA and Music Theatre are in line with public input collected early in the process to ultimately provide a development that supports the economic and social wellbeing of the community.

In other news, commissioners:

• Heard a report on new inquiries regarding Level 3 (480-volt) charging stations for electric vehicles in Wenatchee, the Chelan area and Cashmere.

 Heard recommendations to change a policy that allows customers who install utility infrastructure to recover a portion of the costs from customers who connect later and benefit from that work.

· The recommended changes would improve customer experience and align with industry best practices.

• Approved a \$902,000 capital budget revision to complete fiber expansion and distribution system improvements at lower Blewett Pass, for a project total of \$1,788,000.



milestone celebration."

A little bit about our

Grand Marshal Bernice Bernatz (Holmes) and her twin sister joined the ranks of their two older siblings in 1943 when they came into the world in the small town of Okanogan. It was here that Bernice got her first exposure to horses when she was just a toddler. Later, while visiting her family's Oklahoma ranch, her uncle. an old cowboy and skilled horseman, introduced her to several horses on the property sharing how to better understand and connect with them. He even tried to teach her the art of roping. She wasn't yet school age but this experience shaped her love and passion for horses the rest of her life.

When she was 5-years-old, Bernice's mother packed up all four children and moved to Chelan. Chelan became Bernice's home for life and where she still lives today.

Bernice had a natural affinity for horses and while it would be well into her adult years before she owned one, she was involved in horse groups throughout her teens and early adult years where she rode and cared for many that belonged to neighbors, friends and other family members over the course of her youth. It was here that she found solace in trail riding around the hills above Chelan, "seeing the world from the back of a horse". It was around her 20th birthday that she joined the Chelan Rustlers

In 1968, she met and later married her lifelong companion, Joel Bernatz who learned quickly that Bernice was a "die-hard horsey girl". He happily shared this part of her life with her right up until his passing in 2022. It wasn't until sometime after their son, John Eric was born in 1972 that she finally got her very own horse, a quarter horse gelding named El Roja Royale.

Bernice was always looking for ways to share her love for horses and the companionship they provided. For several years, she volunteered with the local 4-H group and then began

serving on the Saddle Club's board of directors holding a number of positions over her 60 years as a member, many of them more than once, including the role of president. At present, Bernice is still on the board of directors.

In 1978, Bernice took on the role of drill master for the Chelan Rustlers Drill Team, an equine mounted precision riding group comprised of 20 horsewomen who performed elaborate drill routines at rodeos, parades, community events and competitions all around the region, even winning a few awards. She's also been on nearly every rodeo and junior

rodeo committee and continues to be a guiding force to preserve the Saddle Club's unique and deep rooted western traditions that have been passed down from generation to generation.

Today, Bernice enjoys spending time with her horse Lola, a 23-year-old quarter horse mare whom she still rides, occasionally.

Her years of dedication to horses and the Saddle Club along with being the club's longest standing member has earned her the privilege of being this year's Grand Marshal as we celebrate 70 years of being part of the Lake Chelan community.







One early September morning in 1977, I hustled up three flights of stairs to the third floor of College Hall at Washington State University in Pullman, for my first pharmacy laboratory session. I carried my brandnew white lab coat, which was mandatory attire for this and all future lab sessions. In my other hand was a pack

My assignment that day was to make a bottle of Gentian Violet 1% solution. The procedure was to precisely measure the required amount of powdered gentian violet, then add it to alcohol and purified water. Just 3 ingredients. What could go wrong?

allergic to ragweed, which

was blooming that week.

Cautiously tapping the iridescent green crystals onto a pale green rectangle of waxed paper, I carefully weighed the pile, making sure I had 100mg. Picking it up, I cradled my precious powder. Returning to my lab station, I avoided bumping into anything or anyone. But as I set the crystals down on the black countertop, disaster struck: I had to sneeze.

I quickly turned my head, somehow avoiding spraying powdered dye across my lab bench. In relief, I promptly added the colored powder to my alcohol and water mixture before another sneeze could strike.

The rest of the morning went smoothly, but that sudden sneeze would haunt me for years. Pulling my lab coat out of the washing machine the following week, I stared in dismay. My pristine white coat was accented with bright purple speckles running across and down its front. Despite repeated bleaching, they refused to fade. I wasn't the only one with colored speckles on my lab coat, but mine was the most spectacularly purplespeckled lab coat for the entire rest of that year and the next.

Gentian violet - a compound that

Gentian violet is compound that is both a dye and a medicine. Discovered in 1861, Hans Gram would report 13 years later that gentian violet could irreversibly color certain bacteria. This proved instrumental in classifying bacteria and became the basis for the Gram stain method of identifying bacteria still widely used today.

Gentian violet (AKA crystal violet) is used in laboratories across the globe to help identify bacteria. However, it's also an effective antibacterial and antifungal agent. Gentian violet can treat infections caused by gram-positive bacteria, which live on the skin, and yeast infections of the mouth, skin, and vaginal tract.

Although mostly replaced by newer antibiotics and antifungal agents, gentian violet is still used in veterinary medicine and in developing countries. With resistance growing to our current antibiotics, gentian violet is getting a second look; not only is it practical, but it's also inexpensive, simple to use, with very few side effects.

Thrush in infants is usually treated with a suspension of nystatin painted on the inside of each cheek 3-4 times daily for a week. At the same time, it takes only one application of Gentian Violet 1%, the exact same product I made over 40 years ago in the pharmaceutics lab, to treat thrush.

The main disadvantage to using gentian violet is the one I had personal experience with: it stains clothing. Although gentian violet will stain clothing forever, treated skin or mucous membranes only stay bright purple for about 2 weeks before fading.

Fluorescein is a dye used in diagnosing eye injuries and damage to your cornea.

Small paper strips are soaked in a fluorescein solution. dried, sterilized, and sealed into individual packets. When the sterile fluorescein strip touches your eyeball, it mixes with tear fluid to create a fluorescein solution that coats your eye.

Healthy, intact corneal tissue won't pick up any fluorescein. În contrast, worn spots or abrasions from contact lenses appear as bright green areas. Foreign bodies show up surrounded by a fluorescent green ring. The mild anti-infective action of fluorescein is also beneficial because injured eyes are very susceptible to infection.

Phenazopyridine is a reddish-orange dye. Sold as a prescription medicine under the brand name of Pyridium® in 100mg and 200mg coated tablets, phenazopyridine is also available without a prescription at a lower strength of 95mg in the products Azo®, Uristat®, and in generic "Urinary Pain Relief."

Originally used treat bladder infections, phenazopyridine isn't very effective against bacteria. Instead, it can relieve urinary urgency, pain, and burning often experienced from a bladder infection, often within 15 minutes. Today, phenazopyridine is prescribed along with an antibiotic to relieve urinary urgency and burning of bladder infections.

When using it, remember that phenazopyridine is a dye. It turns urine deep reddishorange and stains clothing.

Updated heat protections for outdoor workers go into effect July 17

TUMWATER — As hotter, drier weather sets in, farmworkers, construction workers, and other outdoor workers will be better protected from heatstroke and other hot-weather hazards because of updated workplace heat rules that take effect in mid-July.

Washington is one of only a few states with heat protections for outdoor workers, having first put rules in place in 2008. This week, the Washington State Department of Labor & Industries (L&I) filed a formal update to those rules, expanding existing requirements to keep workers safe.

"Excessive heat is a real concern when it comes to worker safety. Heat-related illness can strike quickly, and in some cases, be deadly," said L&I Director Joel Sacks. "Our climate is changing, and these updates to our state heat rules are a major step forward in protecting workers."

The last two summers L&I enacted temporary emergency heat rules to supplement

existing worker protections. These new permanent rules take effect July 17, and the requirements will be in place year-round.

New protections involving shade, cool-down rest periods, and monitoring workers

The rules lower the temperature at which action is required to 80°F for most outdoor work. Temperature-based action levels apply to specific portions of the rule such as drinking water and shade, and include specifics on when and how much shade must be provided. Workers must be allowed to take preventative cool-down periods as needed to prevent overheating. Employers must follow highheat procedures that require close observation of workers and mandatory cool-down periods of 10 minutes every two hours when the temperature reaches 90°F, and 15 minutes every hour at 100°F.

The updated permanent rules also add requirements for acclimatization and exposure to high heat. Under these requirements, which address the need to adapt to working in the heat over time, employers must closely observe

all workers during heat waves and any worker who is newly assigned to working in the heat or returning from an absence of up to 14 days.

Under the rules, employers must also update their outdoor heat exposure safety programs, and train workers and supervisors on the plan and the new requirements. L&I is developing model outdoor heat exposure safety programs and training materials to help employers implement these requirements.

"Outdoor workers can suffer serious health effects from the summer heat," said Craig Blackwood, assistant director for L&I's Division of Occupational Safety and Health. "But, with water, shade, and rest among other protections, employers and workers can prevent the worst effects of heat exposure and reduce traumatic injuries like falls. These updates will require employers to be more proactive."

Washington 211 helpline sees jump in calls

OLYMPIA - A helpline to help people connect with resources when they're in need has seen an uptick in calls to its service. However, funding remains a barrier to serving more people.

Washington 211 can con-

nect people with about 17,000 resources from its database. The helpline's director, Tim Sullivan, said referral specialists determine what a person needs when they

"When somebody calls, they're presenting one need - like housing," said Sullivan, "but typically, there's other needs that are identified during that interview. And then, the information specialist searches the database we have, and then tries to provide up to three resources per need for that individual.'

Sullivan said 211 can provide other resources including for legal issues, utility assistance and veteran and senior services. The helpline partnered with the Washington State Department of Health to provide a COVID hotline during the pandemic. The number of calls jumped from about 250,000 in 2019 to 400,000 in 2020, Sullivan said, and it hasn't come down since then. His organi-

zation asked for \$5 million in this year's budget to expand its services - but the request was turned down.

"So, it's really difficult for us, without getting additional funds from the state, to be able to continue to operate at a level that we need to," said Sullivan, "especially with the new rise in people that are needing assistance." According to its data from the past year, about one third of calls to 211 concern housing.

Sullivan said his organization has also been helping with Ride United Transportation Access, a partnership with Lyft to get people to places like job interviews and medical services.

White-nose syndrome and bat-killing fungus detected in two new Washington counties

OLYMPIA - White-nose syndrome, an often-fatal disease of hibernating bats, continues to spread in Wash-

Scientists with the Washington Department of Fish and Wildlife (WDFW) worked with the U.S. Department of Energy and a bat rehabilitator on recent surveys that resulted in new detections of white-nose syndrome and the fungus that causes it.

"The fungus that causes white-nose syndrome has been detected in Benton County for the first time," said Abby Tobin, bat species

lead for WDFW. "We also it difficult for them to fly. found a bat infected with white-nose syndrome in Jefferson County this year, which is a first.

"It's discouraging to see the disease spreading among local bat populations, but WDFW and our partners will continue our proactive measures to survey for and respond to white-nose syndrome in Washington and test the efficacy of emerging disease treatments," said Tobin.

White-nose syndrome is caused by the fungus Pseudogymnoascus destructans, which attacks the skin of hibernating bats and damages their delicate wings, making Infected bats often leave hibernation too early, which causes them to deplete their fat reserves and become dehydrated or starve to death. White-nose syndrome has caused vulnerable bat populations to decline in many parts of North America. While the syndrome is often fatal to bats, it does not affect humans, livestock, or other wildlife.

The first case of whitenose syndrome in the western U.S. was confirmed in King County in 2016. Since then, WDFW has confirmed over 150 cases of the disease in at least four bat species in the state.

Including these most recent findings, WDFW has confirmed white-nose syndrome in King, Chelan, Kittitas, Pierce, Snohomish, and Jefferson counties. The fungus that causes whitenose syndrome has now been detected in Lewis, Mason, Yakima, and Benton counties. A map showing fungus and white-nose syndrome detections in Washington is available online at https:// wdfw.wa.gov/bats.

WDFW urges people to not handle wild animals, especially if they appear sick or are found dead. If you find sick or dead bats or notice bats acting strangely, please report your sighting on the

WDFW website or call 360-902-2515. Bats flying outside during the day in winter is an example of noteworthy behavior.

Even though the fungus is primarily spread from contact between bats, humans can unintentionally spread it as well. People can carry fungal spores on clothing, shoes, or recreation equipment that touches the fungus. Washington is home to 15 bat species that play an important role in their native ecosystems. WDFW partners with numerous state, federal, tribal, and non-government organizations to proactively survey Washington bat populations for white-nose syndrome and test emerging preventative treatments. Wildfire smoke forecasted to impact Washington again this season

OLYMPIA - As our climate changes, the threat of wildfires looms larger every year. The Washington State Department of Health (DOH) is urging the public to prepare now for smoke that can make air unhealthy to breathe. Smoke Ready Week, observed June 12-16, was an opportunity to take proactive steps to protect yourself and your family.

"We are expecting to have

above normal fire activity in Washington in July," said Kaitlyn Kelly, MPH, Air Quality Policy Specialist, DOH. "We have an outlook for below normal precipitation and that's going to last into fall, so conditions are trending to a long fire season."

When smoke arrives it's important to reduce exposure by staying up to date on the forecast and air quality index, limiting time outside, and keeping indoor air as clean as possible. After sev-

eral days smoke can enter homes and buildings through leaky gaps in windows and doors. Having a way to filter indoor air will benefit your health. It's key to buy supplies in advance because they often sell out quickly when it's smoky out.

Filter indoor air by using a: HVAC system with MERV 13 filter. HEPA portable air cleaner. DIY box fan filter.

"We no longer have smokefree summers in Washington," said Kelly. "It's important to know what is in wildfire smoke and why it can be breathing.

bad for your health." Smoke from wildfires contains fine particles and gases including carbon monoxide. Exposure to smoke can cause a number of health problems ranging from minor to severe. Those with pre-existing conditions, infants and children, pregnant individuals, adults 65 and older, and people with heart and lung disease can be most sensitive to wildfire smoke. Minor symptoms can include headaches, stinging eyes, runny nose, and trouble
