## **Chelan Valley Housing Trust mission:** Providing quality homes to local wage earners

COMMUNITY VOLUNTEER

CHELAN - The Chelan Valley Housing Trust (CVHT), a member of the Manson Chamber of Commerce is a 501-c3 nonprofit housing developer with a mission of providing quality homes to local wage earners in the Chelan and Manson areas.

Why was CVHT formed? It is a fact the Lake Chelan Valley has a housing crisis. Most of our area's workforce can no longer afford to live here. CVHT was formed to help solve this problem through the community land trust model.

Here's how it works. Chelan Valley Housing Trust, under the Community Land Trust (CLT) model, builds a new home, using one-time public or private investment, then sells the home to a local wage earner who has obtained a loan to purchase the home. The CVHT keeps the land, holding it in trust for future generations of home buyers. In return for being able to buy a home at a discounted price, the buyer agrees to "pay it forward" and sell to another income qualified local family, at a price they can afford. The CVHT manages the sale process ensuring that owners increase their wealth building capacity while also allowing another income qualified buyer to afford the home at resale. In this way the one-time investment in CVHT homes makes lasting attainability a reality.

Visionaries for the Chelan Valley Housing Trust were Rachael Goldie, Tim Hollingsworth

and Mike Cooney. They started the Affordable Housing Initiative in 2018 and Chelan Valley Housing Trust was incorporated in the State of Washington and received 501-c3 status. Mike Cooney served as Executive Director until December 2022 then in January 2023 Scott Meyers took over the duties of Executive Director. I recently met with Scott to learn more about this organization.

Scott was born in Seattle and raised in Auburn, near the Muckleshoot Indian Reservation. Scott has an undergraduate degree from Pacific Lutheran University in business administration with a concentration in finance, and a graduate degree from the University of Washington in accounting. Scott and Stacy have two sons Jackson and Archer. The Meyers created and operated Lake Chelan Cheese for over ten years, at the same time Scott coached high school football for Manson. Scott says, "I'm a serial entrepreneur but my background is in accounting and auditing, most recently I worked as a Department of Defense auditor for Deloitte & Touche."

I asked Scott his main goal as Executive Director, "I hope to provide the workers of the valley an opportunity to purchase a home and realize the American Dream. I want to see our valley function well and reduce poverty, which I believe starts with home ownership."

Who can apply? Households earning between 80%-120% area median income (AMI=\$78,800) and meeting other criteria are able to be considered. So far. five units have been built and sold, with another eight units completed in 2023 and over 50 units coming in 2024-2025. For the new home buyer, this is a great opportunity to purchase a home, if you qualify.

Emerson Village, featuring five townhouses was CVHT's first project located at East

**CHELAN RIVER HEIGHTS** 

Chelan River Heights is 9.15 acres surrounded by views of the Butte, Stormy Mountain, and the Chelan River Gorge. The land is owned by Chelan Valley Housing Trust and located at 38 Anderson Road. This property will be developed into up to 45 mixed income homes with a small community feel. While still in initial design and pro-forma phases, CVHTs vision for Chelan River Heights would be to serve attainable home ownership to local wage earners in the Chelan Valley in a setting that matches the agricultural and aesthetic beauty of the town. They will accomplish this by using designs that match the Chelan Valley aesthetic and feel, creating open and walkable space that makes sense for the community, and utilizing public grants. private funding, and community fundraising to reach the target pricing

and East Chelan Avenue, this new community of five townhomes has been built and sold to income qualified buyers to show our community and funders that attainable homes can really be built.

Chelan Avenue and North Emerson Street. Several small projects are on the drawing boards with a huge, 40 plus home development scheduled a year from now on Anderson

Most of CVHT's funding comes by way of private donors. They also receive some funding from the City of Chelan, Chelan County and other publicly funded organizations.

"I would encourage those with surplus land to consider donating and those with extra time and a desire to help, please volunteer. One of CVHT's greatest resources is the quality of the volunteers who have stepped up to serve on our initial Board of Directors," Scott said. CVHT's Board of Directors includes Jolene Baker, president; Clint Campbell, vice-president; Randv Atkins, treasurer; Arlene Abbott, secretary, Tim Hollingsworth, Charlie Guildner, Diane Leigh, Sharon Lukacs, Marguerite Palumbo Elspas, Dr. Jay Waszkewitz and Rachael Goldie, Housing Direc-

## To Christians and other interested readers

In the days immediately following the death of Martin Luther King Jr., the city of Washington D.C. was in chaos. People poured into the streets with their anger, frustration and deep grief. For white people living in the suburbs, as I was, it could have been an opportunity for deep compassion and lament for our African American neighbors. Instead, for many, there was resentment. After all, the anger and the frustration of African Americans we saw

pointing at us. As a child, I heard confounded responses from adults around me. "I never oppressed anybody. I never owned slaves. Why are they mad at me?" Of course, these claims were born of fear and defensiveness. We simply were not willing to enter the deep suffering of our neighbors, especially when we needed to guard our own innocence.

I think of that time because of its similarity with our response to the rise of "Wokeness" in our culture. Wokeness evokes the same discomfort, the same hostility the same defensiveness we felt long ago. What I want to suggest is that in an

era of Wokeness and our discomfort with it, the Church is being given yet another chance to let go of our defensiveness and to come home to a pattern of Christian life that, of late, we seem to have forsaken.

In his very first public pronouncement, Jesus says "Repent! For the kingdom of God has come near." What is the call to repentance except a wakeup call for us to realize that we are missing the blessing of the kingdom by going in the wrong direction, with the wrong assumptions, with the wrong idea of what the world is really like. "Wake up! Turn around." This is the first thing we hear from our Lord, Jesus. Somehow, we have come to think that Jesus' words no longer apply to us. But repentance has always been at the center of the Christian life. And with it, contrition, that feeling we get when we realize our participation in to repent of it at once.

Take Peter. After saving his own skin by denying Jesus, Peter is 'woke' in a most traditional way, by the crowing of the rooster. Hearing it, he wakes up to his own complicity with those who tormented Jesus. This is a painful awakening, driving Peter to go out and weep bitterly. As anyone who has ever had to face their own failings can testify, we would much rather live in denial than to have our failings revealed. But folks, confronting our failings, waking up to our sin is exactly the event God continues to want for us, not for judgement and condemnation, but for mercy, forgiveness and new life, all delicious fruits of the Gospel.

Or take Paul. He was on his way to Damascus to arrest and bring to trial the followers of Jesus. He was going there knowing that he was doing the will of God. But he was awakened from murder by the appearance of the risen Jesus and suddenly realized that what he knew to be God's desire was nothing of the sort. Those he persecuted suddenly became the very neighbors he was called to love. He would say "For the commandments... are summed up in this word: 'You shall love your neighbor as yourself. Besides this you know that the hour has come for you to wake from sleep. For salvation is nearer to us now than when we first believed". Wake up! Love your neighbor! See the salvation that is so near to them and to you, for your salvation and that of your neighbor are inextricably bound together. Thus, Paul becomes the very spokesman of wokeness. Indeed, the rest of his life and ministry is a continual retelling of his wokeness, in all its pain and glory, as a wakeup call to the Church. We think that our neigh-

his dreams of threats and

bors who are calling us to

wake up just want us to feel bad about our history, our culture, our commitments. But no, these are the voices of people who have seen what we have not been willing to see, have suffered what we have not been willing to suffer, have wept when we have not been willing to weep. Such voices echo the scriptural witness that calls us to clarity about the reality of our situation when we are oblivious to complicity in the suffering of others and of ourselves. If we have ears to hear, they are the rooster crowing, the flashing vision of Jesus, the prophet announcing the kingdom. They beseech us to go through the painful process of repentance and contrition to arrive at the joy of mercy, forgiveness and reconciliation. Do not be angry at the voices that call to us "Wake up!" They are calling us to the very heart of the promise of God. They are calling us home.

## Willa Jean Canary

Willa Jean Canary, 90, passed away on May 23, 2023. She was born in Joliet, Illinois on December 8, 1932 to William and Dorothy Redden. She had a sister Beverly and brother Billy.

From an early age, Willa knew that she wanted to teach. After high school, she attended Bowling Green State University, earning a BA in Elementary Education in 1954. Upon completing her



degree, she moved to California to start her teaching career. In 1955, she met James Canary, a naval officer who had also studied teaching and in 1956 they married. During those 17 years, they raised their children - attending baseball games, swimming tournaments, and band concerts - and built their careers as teachers. While working full-time, Willa took night classes, earning her Masters in Education from the University of Alaska. For Willa, the best

part of her job was teaching young children to read – the topic of her thesis. After 17 years of rainy weather, upon retirement, they returned to sunny Chelan. Jim continued commercial fishing in Alaska during the summers, but, when Willa was not playing bridge (she became a Life Master), she created a paradise at her home for her grandkids.

Her kind neighbors, Rita and Don, made it possible for her to remain in her Chelan home for years longer than otherwise possible, but in 2019, she needed more support and she moved to Arizona to be near family. This spring she became ill. After spending time with her children and grandchildren, she passed peacefully from this life knowing that she was loved.

She is survived by her children James Jr., Jon and Jana, grandchildren Aliese, Jacqueline, Tessa and Tristan, and great-grandchildren Hailey and Kendal. Her family plans to gather in Chelan for a private ceremony to celebrate her life.

## 5 key facts about flaxseed, Omega-3 fatty acids

Q: My sister takes flaxseed oil because she can't stand getting "fishy burps" from the fish oil and insists that flaxseed is just as good for you as fish oil. Is this true?

Both flaxseed and fish oil have high concentrations of fatty acids called Omega-3. Eating foods rich in Omega-3 fatty acids helps counteract the effect of another type of fatty acid called Omega-6, which creates inflammation in your body.

Omega-6 fatty acids contribute to arthritis and heart disease, and many of them are in a typical American diet. Omega-6 fatty acids are found in popular foods like popcorn, pasta, potato chips, corn chips, bread, French fries, hot dogs, and many salad dressings, which contain either canola or soybean oil.

Fish oil contains 2 main types of Omega-3 fatty acids: EPA and DHA, which can help counteract the inflammatory effects of a diet high in Omega-6 fatty acids. Flaxseed contains large amounts of ALA, a different Omega-3 fatty acid. Unfortunately, ALA is not active as an Omega-3 until changed into EPA or DHA, and most people can't convert it into its active form.

Although flaxseed is not a good source of Omega-3 fatty acid, it helps lower blood sugar in diabetics, and lowers both high blood pressure and high cholesterol.

Flax is an oily grain grown for its fiber and seeds. Flax fiber can be used for clothing, while the seeds are sold as whole seeds, partially defatted seeds, ground seeds, flaxseed meal, and flaxseed oil. Flaxseed may help decrease your total cholesterol and "bad" LDL cholesterol levels and relieve menopausal symptoms like night sweats and hot flashes.

Flax seeds are an excellent source of fiber, especially soluble fiber. Adding fiber to your diet with flaxseed has been shown to decrease LDL and total cholesterol. Flaxseed's fiber helps you stay regular because it is a bulk laxative, similar to psyllium or Metamucil®. Much of the documented benefits of eating flaxseed can be explained by the beneficial effects of adding soluble fiber to your diet. Taking flaxseed oil has not been shown to lower either LDL or total cholesterol.

Theouter coating of flax seed is a gummy layer that's very high in fiber, especially soluble fiber. Getting adequate fiber in your diet helps lower your "bad" cholesterol (LDL) and total cholesterol levels. These benefits can be found by eating whole seeds or using ground flaxseed meal.

You can add whole flaxseed to your diet by adding it to cereal, granola, or smoothies. Ground flaxseed or flaxseed meal is less gritty and can be blended into smoothies or baked into breads, muffins, or cookies. Because whole and ground flaxseed contains a lot of fiber, they can act as a bulk laxative, similar



to psyllium or Metamucil®. Add flaxseed slowly to avoid suffering intestinal distress such as gas, bloating, cramps, or diarrhea. You should also get plenty of fluids to prevent intestinal blockage.

Most sources suggest up to 40 grams of flaxseed daily (4 tablespoons of whole flaxseed or 7 tablespoons of flaxseed meal) to lower LDL and total cholesterol. Avoid taking more than 45 grams daily (4.5mg tablespoons of whole flaxseed or 8 tablespoons of flaxseed meal) to decrease your risk of intestinal problems.

Flaxseed and oil contain natural compounds called lignans, which contain phytoestrogens. These phytoestrogens can reduce the risk of cancer, especially breast cancer. Flax phytoestrogens block soy's stimulant effect on estrogen-positive breast cancer tumors.

Here are 5 Key Facts About Flaxseed and Omega-3 Fatty Acids:

1. The soluble fiber in flaxseed lowers total cholesterol and LDL (bad) cholesterol.

Flaxseed's soluble fiber is concentrated in its seed coat. Flaxseed oil and lignin extracts do not significantly improve cholesterol levels.

2. Start flaxseed slowly to avoid intestinal distress.

## Newhouse introduces legislation to support Central Washington winegrape growers

### Smoke taint devastates wine industry

Wednesday, June 22, Rep. Dan Newhouse (R-WA) introduced the bicameral, bipartisan Farm Crop Insurance Act alongside Rep. Mike Thompson (D-CA) and Sens. Patty Murray (D-WA) and Alex Padilla (D-CA) to insure winegrape crops from smoke exposure. The bill requires the Federal Crop Insurance Corporation (FCIC) to carry out research and implement a crop insurance product that covers losses due to smoke exposure.

"Washington state's wine industry produces some of the best wine in the nation and we need to keep it that way. Right now, the industry faces billions of dollars in losses from wildfires and smoke exposure," said Rep.

Newhouse. "I am proud to co-sponsor this critical legislation that will ensure our winegrape growers and producers get the necessary funding to be resilient and continue to produce highquality wine

"Winegrapes are essential to economies across our country, and states like California, Oregon, and Washington have been disproportionately exposed to wildfires leading to smoke exposure impacting our winegrapes. Researching the impact that smoke has on our winegrapes and other crops is essential in advancing solutions that will protect these key economic drivers from future natural disasters. Proud to work with Rep. Newhouse and Sen. Padilla to introduce legislation that strengthens crop insurance for winegrowers and helps fully capture the risks associated with growing in these smoke- and wildfire-prone states," said Rep. Thompson.



"Washington state is the second-largest wine producing state in the country, creating thousands of jobs and fueling tourism across the state. Washington is also seeing an alarming increase in wildfires year after year, which creates a serious smoke exposure problem for winegrape growers across the West Coast. Vineyards in Washington state and all the way down to California need a crop insurance policy for smoke-exposed winegrapes, rather than being forced to rely on ad-hoc disaster assistance from year to year, and that's what this legislation will provide. I'm proud that research at Washington State University has played a leading role in studying the impacts of smoke exposure, and this bill takes a critical and needed step to protect our state's vital wine industry," said Senator Murray.

"As climate change intensifies and wildfires become more frequent and extreme, we need to protect winegrape growers and consumers against the damage caused by prolonged smoke exposure. Winegrape growing regions are critical to our economy, especially in California. Growers, vintners, and consumers alike have a stake in the sustainability of winegrowing communitiesthese bills will help growers make informed decisions about harvesting and selling their crops," said Senator Padilla.

**Background:** Winegrapes exposed to smoke from wildfires can introduce compounds into the winemaking process that cause smoky, ash-like flavors and result in wines unfit for commercial sale. These off-aromas and flavors become more pronounced over time as wine ages. The legislation requires research and development of a crop insurance product that provides comprehensive coverage for smoke-impacted winegrape growers. The bill also helps to mitigate future financial losses in these key regions of production.

Rep. Newhouse serves as Co-Chair of the Congressional Wine Caucus (CWC), which protects the interests of our vibrant wine community from grape to glass. Members of the CWC are joined not only by their deep appreciation of wine, but also their understanding of the wine community's significant economic impact. Wine is produced in all 50 states and generates jobs and revenue in both rural and urban areas. The wine community contributes an estimated \$220 billion to the U.S. economy annually and creates the equivalent of more than one million full-time jobs.

In Washington State, there are more than 800 wineries and over 250 wine and grape growers. The wine industry generates over \$9.5 billion in total economic activity with over 14,000 acres of vineyards and 60,000 jobs created and supported by the wine industry. With 14 unique AVAs across the state, Washington's wine industry continues to grow and produce high-quality varieties that are enjoyed all over the world. In addition, Washington State University is one of the country's leading viticulture research institutions and one of only 14 universities in the United States to offer a Viticulture & Enology degree.

## Informational videos increase awareness of financial aid and education options

OLYMPIA—Simple, accurate information provided in an engaging way in an educational environment can help improve student understanding and awareness of financial aid and college or training options, according to a new case study from the Washington Student Achievement Council (WSAC).

WSAC partnered with the North Central Educational Service District (NCESD) to design and develop animated

videos about financial aid and postsecondary education opportunities available in Washington State. The videos were shared with students during the regular school day, and students completed surveys to share their feedback.

The surveys indicated positive results:

Prior to watching the videos, many students could not correctly answer questions about the state's financial aid programs and postsecondary opportunities; however, there was substantial

growth in their knowledge after watching the videos. 87 percent of students surveyed indicated that they learned something relevant for their futures from the videos. 88 percent of students indicated that they learned something new about the Washington College Grant (WA Grant)

program. WA Grant is a flexible option that can be used for many educational pathways beyond high school, including approved apprenticeships, certificate programs, job training or college.

The state of Washington has some of the strongest financial aid programs in the country. And yet, despite the generous funding available, Washington historically ranks near the bottom in rates of financial aid application completion nationally. WSAC believes that people will be more likely to apply for financial aid if they know how generous and flexible the state's programs are.

"Every year, we see families leaving thousands of dollars on the table because they don't know how to apply,

or don't believe they might be eligible for funding, and we wanted to do something to change that outcome" said Dr. Sue Kane, NCESD's director of STEM initiatives and strategic partnerships.

Kane added, "These videos make it so easy to be a part of the collective effort. Check out the videos and share them through social media. Helping someone pursue their dreams could be just that simple."

The case study report shows that adopting an evidence-based approach like informational videos to engage students can increase awareness of financial aid and education options, and potentially influence decision-making about college or career training after high school. ## Outdoor grilling safety

OLYMPIA - The weather in the Northwest has finally warmed up and outdoor grilling has begun in many homes throughout Washington State. Barbeque-related fires may cause significant property damage and burn injuries. According to the National Fire Protection Association, on average 10.600 home fires are started each year and 19,700 patients are sent to hospital emergency rooms because of injuries involving grills.

Last year in Washington State, cooking fires that include open grills totaled 2,121 with a total loss of over 10 million dollars. The State Fire Marshal's Office advises residents to take steps to make this a safe barbeque season.

## **Setting Up:**

· Ensure you check with your local fire agency about any outdoor burn restrictions or bans.

• Both propane and charcoal grills should only be used outside.

 At a minimum, keep grills 10' away from fences, exterior walls of the house, overhanging tree branches, or any other flammable materials.

• Be sure the grill is stable

• Before using the grill for the first time each year, check the gas cylinder hose for leaks by applying a light soap and water solution to the hose and then turning on the gas. If there is a leak, the solution will form bubbles. If you can't stop the leak yourself, have it serviced by a professional

#### before using it. When Lighting:

- · Whether cooking with a gas or charcoal grill always use caution when lighting.
- · Always make sure your grill lid is open before light-
- When using charcoal, consider using a charcoal chimnev starter instead of charcoal
