the spring of 2024. Construction activities at the substation

site this month are: earthwork at the site is complete; main power transformer has been delivered and placed - this is the heart of the substation; concrete foundations inside the substation footprint will be constructed; steel structures (towers to support equipment inside the substation) will be assembled. Construction activities on underground distribution line installation: Underground conduit and vaults are being installed along Highpoint Lane, and sections of Crystal and Westview drives; and wire will be pulled through the conduits and connected to equipment later in 2023 or early 2024. Later this year: transmission tap - a modified transmission pole and a short wire span - will be constructed this summer; and PUD crews will take over work at the site this fall. On underground distribution line installation: after major equipment and trucks are done at the substation site, a PUD contractor will install underground conduit and equipment along Henderson Road from the substation site to Boyd Road; wire will be pulled through the conduits and connected to equipment later in 2023 or early 2024; and underground conduit and equipment installation is expected to begin on Boyd Road, toward the intersection with Hwy. 150 - the schedule for this section of the project will be updated later this year. ## What to do if you find a deer fawn

Editors Note: This information is taken from the Washington State Department of Fish and Wildlife website

Every spring, wildlife managers and wildlife rehabilitators receive calls about "orphaned" fawns lying alone in the woods or in someone's yard. The callers often think these fawns have been abandoned. But unless you are certain the mother is dead or the fawn is clearly sick or injured, please leave it alone.

The mother is usually foraging nearby and will return to take care of her fawn once you move away. For the first few weeks of the fawn's life, the doe keeps the fawn hidden, except when suckling. A fawn will instinctively lie low not moving while waiting for its mother to return.

The doe may feed and bed down a considerable distance from the fawn's safe site. This way, even if a predator detects the doe, the fawn may still have a chance of avoiding detection. Fawns do not give off an odor at this young age and will go unde-

tected by a predator.

When to call a permitted wildlife rehabilitator

Contact a wildlife rehabilitator:

- When you are certain the mother is dead.
- When a fawn appears weak, ill, or injured, or its

mother does not return the following day.

Do not handle a fawn until you have called a wildlife rehabilitator. If you have handled a fawn, rub an old towel in the grass and wipe the fawn to remove human scent. Using gloves, return the fawn to where it was found. Fawns can often be returned to their mothers if taken back to where they were found within 24-48 hours.

TONASKET – A dedication held just prior to Memorial Day designated Highway 20 in Okanogan County as "Vietnam Veterans Memorial Highway." The renaming was spearheaded by veterans from Oroville American Legion Post 82 and Tonasket Post 84 who initiated a signature-gathering effort in support

It's just the latest in a number of similar designations that have been conferred upon sections of highway in this state and other parts of the nation. In October 2021 we carried a story about a campaign to name the portion of U.S. Highway 97 in Washington State "World War II Veterans Memorial

That proposal met with some success earlier this year when the Washington State Transportation Commission (WSTC) named U.S. 97 from Odabashian Bridge near Wenatchee to Beebe Bridge near Chelan "World War II Veterans Memorial

The U.S. 97/WWII campaign originated in Oregon in the early 2000's by the Bend Heroes Foundation, a nonprofit that worked to rename other Oregon highways honoring U.S. war veterans.

# Bus accident memorial updated

The Lake Chelan Historical Society adopted a new project last fall, committing to clean up the area around the bus memorial location. The school bus tragedy of November 26, 1945, claimed 16 lives. Watson's Haverene Resort provided seed money to place interpretive signs at the site that tell about the school bus accident and the search for the students and the bus. Society president Dave Clouse and his wife, Sue, have spearheaded the improvements. Marci Hale, whose two older brothers lost their lives, helped write the story. The Department of Transportation placed historical marker signs on both sides of Highway 971. The site is uplake on the south shore, six miles from Chelan.





# Payroll tax for long-term care program starts July 1

OLYMPIA - The WA Cares Fund, a new state-run, longterm care insurance program, will begin payroll deductions on July 1. Originally set to take effect in January 2022, the Legislature voted to delay the payroll tax by 18 months. For those eligible, WA Cares provides up to \$36,500 for nursing care and other services.

The cost: Most workers in Washington, including parttime and temporary workers, will pay up to 58 cents on every \$100 of their earnings for this new program. That means, for example, someone making \$50,000 per year the new tax will pay \$24.17 monthly or \$290 yearly.

Background: In 2019, the Long-Term Care Act, House Bill 1087, was approved by the majority party and signed into law by the governor. Republicans voted "no" on this

measure for several reasons, including its deep unpopularity with voters.

• Nearly 63% of Washington voters said the long-term care payroll tax should be repealed with Advisory Vote No. 20 in

What about exemptions? Two deadlines in 2021 and 2022, set in state law, were offered for those looking to opt out of the program. If you purchased a qualifying longterm care insurance plan by November 1, 2021, and applied for a permanent exemption from the WA Cares Fund, you are not subject to the new payroll tax.

- The deadline for applying for this exemption was December 31, 2022.
- Although some people could take advantage of this exemption, many others couldn't find a private plan in time, and countless others simply didn't know about the

new payroll tax.

• The Long-Term Services and Supports Trust Commission makes recommendations regarding criteria for determining who is a qualified individual, minimum provider qualifications, service payment maximums, actions needed to maintain Trust solvency and monitoring of agency expenses.

Beyond the private insurance exemption, there are a few, very limited, exemptions that exist in state law:

- · Live outside of Washington state.
- · Are the spouse or registered domestic partner of an active-duty service member of the U.S. armed forces.
- Have non-immigrant work
- Are veterans with a 70% service-connected disability rating or higher.

When the program was originally debated, members of my caucus repeatedly offered amendments to further open exemptions for those unable to meet the deadlines listed above, which were rejected by the majority party. If denied an exemption, this program will force those who want nothing to do with it to pay the payroll tax. It's unfair to lock Washingtonians into a state-run program with no further options.

As a legislator, I understand the Washington State Long-Term Care Act aims to provide a public long-term care insurance program to residents. However, I have several concerns about the viability and effectiveness of the program.

First, the Long-Term Care Act imposes a state mandatory payroll tax for current and future workers, without exemptions, including those

who may not require longterm care in the future or already have private long-term care insurance. This approach places an additional burden on individuals, especially low-income workers, who may struggle to afford the tax.

Second, the benefits provided by the Long-Term Care Act are extremely limited and may not adequately cover the costs associated with long-term care services. The maximum benefit of \$36,500 is wholly inadequate and may give a false sense of security about future long-term needs. This could leave individuals and families with significant out-of-pocket expenses, defeating the purpose of having long-term care insurance in the first place.

Additionally, the Long-Term Care Act does not provide flexibility for individuals to choose their preferred long-term care services or

providers. It establishes a one-size-fits-all approach, limiting the freedom of choice for residents. This lack of flexibility may not align with the unique needs and preferences of individuals and their families, leading to problems with the quality and type of care received.

And finally, and most importantly, the implementation of the Long-Term Care Act raises serious concerns about the sustainability and financial viability of the program. The act's funding mechanism relies solely on payroll taxes, which may not be sufficient to sustain the program in the long run. This could result in increased taxes or reduced benefits in the future, further burdening taxpayers and undermining the effectiveness of the program. In the coming session, I expect several more efforts to amend this

# Governor appoints longtime Wenatchee port commissioner to state Transportation Commission

Will begin term on the board on July 1

OYMPIA - Gov. Jay Inslee has appointed Janet "JC" Baldwin of Wenatchee to fill an open seat on the Washington State Transportation Commission. Baldwin is a small business owner and longtime elected port commissioner, serving on the Chelan Douglas Regional Port Authority since 2005.

Baldwin, whose six-year term starts on July 1, brings to the

commission the expertise of working in the tech sector as chief executive officer and co-founder of GTC Technical Support in Wenatchee. In addition to her experience as a business owner and elected official, Baldwin brings to the commission extensive experience in the areas of public infrastructure and economic development, amassed from service on a range of boards including the state Community Aviation Revitalization Board, the state Public Works Board and the Washington Public Ports Association Executive

Committee. Baldwin said her service with

the Chelan Douglas Regional Port Authority, combined with the other roles she has served in, gives her a unique perspective and valuable insights that will support the development of statewide transportation policy. Among its responsibilities, the commission advises the state Legislature and the governor on transportation policy matters. This summer, it will begin the work of updating the Washington State Transportation Plan, an endeavor taken on every four years.

"Ports serve a critical role in our state's economy, and the

linkage between transportation and ports is undeniable," Baldwin said. "An efficient and accessible transportation system is vital to enabling the movement of freight and goods in and out of ports and will be a priority of mine as I work with my fellow commissioners in authoring the update of our state's 20-year transportation plan."

The commission also serves as the state tolling authority, setting toll rates and ferry fares, and provides annual guidance to lawmakers on statewide funding and fiscal matters.

"I look forward to support-

ing the advancement of viable approaches to creating longterm, sustainable funding for transportation so that our entire statewide system is able to carry our state into the future and meet the diversified needs of our citizens," Baldwin said.

Baldwin replaces Commissioner Jerry Litt of Grant County, who served two terms on the commission for a total of 12 years. She will be one of three commissioners appointed from east of the Cascade Mountains. The other four are from the west of the mountains, per requirements in state law.
