

resolution by John Adams was adopted by the Continental Congress on June 14, 1777, placing our nation's banner in the spotlight as a respected symbol. As new states gained independence and entered the United States, the number of stars and stripes increased. However, in 1818, Congress enacted a law to restore the original 13 stripes and only include additional stars to symbolize incoming states. A century after enacting the Flag Resolution, the first Flag Day was observed on June 14, 1877. While Woodrow Wilson proclaimed a day of recognition for the banner in 1916, it wasn't until 1949 when regulators officially designated June 14 as Flag Day, a national day of observance.




Barton "Bart" Oliver **Shively**

Dr. Richard **Anthony Davis** March 20, 1941-June 6, 2023

Richard Anthony Davis passed on June 6, 2023. He was born on March 20, 1941, in Renton, Washington, the son of Thomas J. Davis and Rena Mae Hodder Davis. His father was a Superintendent of Schools and his mother taught 2nd and 3rd grade. The family moved from Lester to Easton, to Yelm, and finally to Enumclaw, Washington where Richard attended elementary school through the seventh grade. When he began eighth grade, the family had moved to Manson, Washington, where, in June of 1959, Richard graduated from Manson High School.

From 1959 to 1963, he attended Central Washington University where he received his BA in Education in 1963. From 1963 to 1964, he completed his MA in English Literature at the University of Washington in Seattle. During the time he was completing his MA, he married Beverly Jean Morse on May 11, 1963. They had two children: Wyndeth Victoria Davis (1963), and Michael Edward David Davis (1967)

In 1964, Richard was hired to teach English composition and literature at Oregon College of Education (now Wester Or-



egon University) in Monmouth, Oregon. Richard became the advisor for the local chapter of Alpha Psi Omega, the national drama honorary; and on the death of George Harding in 1965, he added speech and oral interpretation classes to his teaching assignment.

Throughout the late 60's he became more involved with theatre at the university, taking on publicity for the theatre season, and in 1968 becoming an official costumer for all theatrical productions. He began directing mainstage plays in 1968 with his production of The School for Scandal. In 1970-71 Richard took a one-year sabbatical leave to complete classwork for the Ph.D.; returning to Western, he completed his dissertation and received the Ph.D. degree in Drama Arts from the University of Washington in 1976. At that point, Richard became Head of the Theatre/Dance Department at Western.

In 1989, he was chosen Chairman of the Division of Creative Arts at the University and served in that capacity for two terms until 1995 when he returned to the position of Chair of the Theatre/Dance Department which he held until his retirement in 2003.

During his 39 years at Western, Richard directed over 80 plays and costumed over 243 plays. He was extremely active in regional theatre activities, serving in the Northwest Drama Conference from 1982-1989 as its Secretary, Treasurer, and ultimately, its President. From 1984-1986, he was Chief Regional Officer representing the Northwest Region on the National Board of the American Theatre Association. He was active in the Kennedy Center American College Theatre Festival, serving as an adjudicator and costume critic, and as host for the Northwest Drama Conference and regional KCACTF on Western's campus in 1981, 1985, and 1993. He was also a member of ATHE, OTAA, Alpha Psi Omega, Kappa Delta Pi, and the National Honor Society.

In 1984 he was the recipient of the AMOCO and Kennedy Center American College Theatre Festival Medallion of Excellence; in 1986 he received the Oregon Theatre Arts Association Melba Day Sparks Award for superior service to

the Oregon Theatre service in Oregon Theatre. And in 1992 he was presented with the Northwest Drama Conference's President's Award (now the Robinson Award) for his work in Northwest regional theatre. In 2002, he was chosen as recipient of the Pastega Faculty Honors Award for Scholastic Excellence and spoke about this life in the theatre at Western.

Dr. Davis was known for his bright costumes and his experimental directing techniques.

Since his retirement in 2003, Dr. Davis has taught one class at OSU (spring 2007), served on Pentacle's play reading committee (spring 2008), done research on a book on the U.S. presidents and theatre, and traveled on the east coast. Dr. Davis was an active member of Christ's Church, Methodist and Presbyterian United in Monmouth and created many colorful banners and wall hangings for its sanctuary. He was also an avid collector of presidential memorabilia and a member of APIC (the American Political Items Collectors).



How to treat a heat rash

Q: I've been battling a heat rash from the hot weather we've been having recently. What's the best way to get rid of it?

Donna, a 75-year-old grandmother, developed redness and itching during a summertime heat wave in her groin area.

"I've tried putting Gold Bond® powder on it for the past 3-4 days, but it's not helping. What else do you recommend, instead?"

Heat rash, or prickly heat, can happen to anyone with active sweat glands. It's estimated that at least 40% of infants will get a heat rash at one point. Heat rash also afflicts people who sweat in the summer heat doing strenuous physical work, performing sports, exercising, even gardening.

Prickly heat or heat rash is caused by clogged sweat glands. When sweat builds up under your skin, it can become trapped, causing your pores to swell and rupture. This creates small red, raised lesions that burn or itch. These reddened bumps may be clustered in small clumps or spread out over larger areas.

Heat rash can occur anywhere that sweat accumulates: your armpits, chest, upper back, belly, and groin. The blockage creates inflammation, pustules, or a yeast infection if it is severe enough.

Heat rash or prickly heat can also happen to people treating dry or itchy skin with heavy creams or ointments. Although soothing in winter, thick creams and ointments can plug up your hard-working sweat glands during hot, humid summer weather.

Keeping your skin dry is one key to relieving the itching and burning of prickly heat. One of the best ways to do that is by maximizing airflow to the skin to discourage sweating. Wearing loose, lightweight clothing during hot weather and using fans to improve airflow is essential. Fevers can cause profuse sweating and should be treated with appropriate doses of acetaminophen to decrease excess moisture next to the skin.

Another key to treating heat rash is avoiding oils, heavy creams, or ointments on areas that perspire heavily. This can include under your arms, your chest, around your groin, behind your knees, and under any skin folds

Avoid using medicated or plain powders on red, irritated, or broken skin when treating prickly heat. Powders can clog inflamed pores and sweat glands, so it's best to stay away from them entirely until your skin has calmed down.

Heat rash can cause intense itching and an almost uncontrollable urge to scratch. Although scratching feels good, vour relief is short-lived, as it will trigger an increase in inflammation and even more itching. Applying cloths dampened with cool water can help, along with non-prescription steroid creams containing 1% hydrocortisone. Hydrocorti-

sone 1% cream is safe for small areas of broken skin or larger areas of intact skin in adults. You should avoid applying medicated creams directly over areas of damaged skin, especially the skin of children or infants.

Finally, avoid using hydrocortisone ointment when addressing heat rash because they are occlusive, which can block or clog your sweat glands.

If these strategies don't help the itching and irritation of heat rash, contact your doctor, as other conditions may look like heat rash at first but need to be treated differently.

Here are 7 Tips for Treating Prickly Heat or Heat Rash:

1. Increase airflow to the affected area.

Wear lightweight, loose clothing or no clothing at all. House fans can help circulate air over your skin.

2. Lukewarm sponge baths increase evaporation, helping to cool and dry the skin.

Avoid hot water for showers or baths, which can increase inflammation. Adding oatmeal or a product that contains oatmeal like Aveeno® to bath water helps soothe irritated skin.

3. Avoid using skin powders like Gold Bond®, especially on broken skin.

The powder can create clogged sweat glands. Avoid applying powders until the acute symptoms of redness and itching subside.

4. Avoid Benadryl® cream or spray. Use 1% hydrocortisone cream instead.

Although Benadryl® (diphenhydramine) capsules and liquid can help relieve itching, diphenhydramine cream or topical spray should be avoided. Benadryl® can be absorbed into the bloodstream from areas of broken skin. Combing diphenhydramine pills or syrup with a skin cream also containing it can result in

drowsiness and confusion. 5. Avoid applying heavy

creams and ointments. Ointments and heavy creams can block sweat glands. Keep your armpits, groin, chest, and skin folds as dry as possible. Tucking a light cloth like a pillowcase between skin folds helps absorb excess perspira-

tion. 7. Cool it before you use

it. Refrigerating your medicated cream or aloe vera gel before applying it can provide additional soothing power.

Career Launch programs are the most intensive programs in the Career Connect Washington Framework, as they prepare young adults to start their careers with a combination of meaningful, paid, high-quality on-the-job experience with aligned classroom learning and a post-high school credential.

The Quincy Data Center Prep program will equip students with the necessary skills, credentials, and work experience to secure highly sought-after Data Center Technician roles, providing them with excellent wages and benefits just one year after high school graduation

"Career Launch programs take considerable partnership and planning to develop, but they are intentionally developed to align to the skills and experiences young people need to be competitive candidates for great local jobs," explained Dr. Sue Kane, Director of STEM Initiatives and Strategic Partnerships for the North Central Educational Services District.

The Data Center Technician Career Launch program commences with a sequence of courses that are offered as part of the Career and Technical Education (CTE) program. The courses enable Quincy High School students to complete their first year of a two-year certificate program while still attending high school. Upon completion, students will transition to courses offered at Big Bend Community College, where they will have the opportunity to participate in a paid internship program with one of the Grant County-based data centers. This comprehensive program ensures that local youth can earn a valuable credentials and become competitive candidates for lucrative Data Center Technician positions.

"At Sabey Data Centers, we're really proud to be involved with the Data Center Technician Launch program," said Shawn Devine with Sabey Data Center. "From my experience, I've found it's been mutually beneficial for the community, the students, and us as a company. As Sabey grows, we're going to need additional talent. This program offers local students an opportunity to work in an industry where they have a bright future."

re a bright future." For years, Quincy has been



fortunate to boast a thriving information technology (IT) presence. The Grant County Industrial Alliance (GCIA) also supported the program development. GCIA represents various local data center employers including Intuit, Microsoft, Oath, NTT DATA, Sabey, Vantage, Verizon Media, and H5 Data Centers, and was established to champion the common interests of these industry leaders. Over the past decade, the demand for IT professionals in the region has steadily increased, leading to a collaborative effort between GCIA and Big Bend Community College to develop an accredited credential pathway that equips the workforce with the precise skills needed to support data center operations. This program has already yielded promising entry-level candidates for data centers and possesses the potential to scale further with additional recruitment efforts.

Parallel to these developments, Quincy High School has diligently expanded its capacity to support students in their exploration of local IT career opportunities that offer family-sustaining wages. Since 2017, in collaboration with Microsoft TEALS, the Quincy School District has been offering introductory computing and programming coursework to provide students with a solid



foundation and awareness of the vast prospects in the IT

Seattle-based nonprofit Computing for All was recruited by the group in 2021 to support the regional partnership in the creation of the Career Launch program. This program offers young adults an aligned path to develop their skills, attain relevant credentials, gain paid work experience, and successfully embark on entry-level IT and data center careers. Furthermore, it serves as a gateway to the Big Bend Data Center AA Degree, ensuring a comprehensive educational journey for participants.

This career pathway paves the way for aspiring individuals to pursue roles such as Data Center Technician or general IT Administrator, wherein they will utilize their expertise in areas such as network and security, hardware and software support, system troubleshooting, and operating systems. The career launch model may be leveraged for the development of other workforce shortages in the region.

The program encompasses 360 hours of classroom instruction across a sequence of 4 courses for high school juniors and seniors, followed by one

vear at Big Bend Community College in the IT Systems Administration Associates/ Certificate/Cisco Networking certificate degrees. Participants will earn 15 dual college credits towards the IT Systems Administration Associates/Certificate/ Cisco Networking certificate offered by Big Bend Community College, along with CompTIA A+ and ITF+ industry certifications. In addition, students will have the opportunity to engage in up to 400 hours of work-based learning during the summer after high school graduation or following the first year of college.

Dr. Nik Bergman, Quincy School District Superintendent, is looking forward to continuing the regional partnership to support students.

"The Data Center Technician Career Launch Program perfectly aligns with our QSD Strategic Plan Goal Five - Pathways to Graduation and Beyond," he said. The program successfully enrolled its first cohort of 13 students in the fall of 2022 and recently received the final endorsement from the State Board of Community and Technical Colleges in April, further cementing its credibility and commitment to providing students with a gateway to prosperous IT careers.

WENATCHEE RIVER IN

LEAVENWORTH OPEN FOR SALMON FISHING The Wenatchee River from he US Highway 2 bridge to

The Wenatchee River from the US Highway 2 bridge to the mouth of the Icicle River is now open for Chinook salmon fishing, thanks to a healthy run of springers heading back to the Leavenworth National Fish Hatchery. The limit is three hatchery Chinook per day through June 30. Bait is allowed but you have to use barbless hooks. No motorized watercraft are allowed in this section of the Wenatchee River.

SUMMER FISHING ON THE

COLUMBIA

Fishing for summer Chinook, sockeye salmon and steelhead opens up on the Columbia River on June 16 and stays open until July 31. The open area is from the mouth at Astoria to the Hwy. 395 bridge at Pasco. The Columbia from Richland to Priest Rapids Dam will also be open during this time. The forecast for Upper Columbia River summer Chinook this year is 85,400 fish, which is about 6,000

more than last year. PATEROS SALMON BAKE

The Pateros Booster Club will be sponsoring a salmon bake on Saturday, June 24 starting at noon in the park. The cost is \$15 a plate which includes not only salmon but also salad, water and rolls from the Sweetwater Bakery. In addition to a good meal there will also be seminars and demonstra-

REGISTER NOW FOR THE WENATCHEE

SALMON DERBY The Peter Flohr Memorial Salmon Derby takes place July 14-15 between Rock Island Dam and Wells Dam on the Columbia River. There will be \$7500 worth of cash and prizes given away at the event for the heaviest boat limit of fish and for the heaviest fish caught by a single angler. Last year that latter winner was Greg Kite who caught a 20.41-pound Chinook salmon. Derby tickets cost \$75 and can be purchased at www. wenatcheesalmonderby.com. Proceeds from the event will go to the Coastal Conservation Association.

SHAD FISHING IS HEATING UP

The annual run of American shad up the Columbia River is building steam. Over a 100,000

shad a day are being counted at the Bonneville Dam fish ladder. Marc Bush, owner of Twisted Waters Guide Service, recently took two clients shad fishing near Beacon Rock State Park and the two, Drew Monsey and his father Martin, caught 104 shad in short order, with Drew out fishing his dad by 11 fish. If you would like to book a trip with Bush you can go to his Facebook page or his website at www.twistedwaters-gs.com.

You don't need to have a guide to have success catching shad. Two great places to fish for them from shore are just below Bonneville Dam and also below the John Day Dam. Simply cast a 1/16-ounce jig or shad dart and use anywhere from ¼ to ½ ounce of lead above it, depending on the current. Then, let it swing downstream

with the current and wait for a bite before reeling in the jig and casting again.

Shad typically run between one and three pounds but they are scrappy fighters and fun to catch. Kids in particular enjoy the non-stop action when the shad run is going strong. The state record for shad is a 3.85-pound specimen caught by Tom Magnuson out of the Columbia River in 2005.

Some anglers will keep the shad to eat but others, myself included, cut these fish in half and use them for crab bait. They are a very oily fish and work very well when it comes to attracting crabs. Shad also work well as bait for sturgeon

fishing and for catfish too.
