Lake Chelan Lions Club continues tradition started by Ruth Pingrey

American flags have decorated downtown Chelan since 1970s

CHELAN - As we commemorate our national holidays, it's important to take a moment and reflect on the history behind the American flags that adorn Woodin Avenue and Emerson Street in Chelan. The tradition began with Ruth Pingrey, a beloved Chelan Elementary school teacher who took it upon herself to decorate Woodin Avenue with U.S. flags during national holidays in the early 1970s.

Ruth discovered a program where U.S. flags were flown over the Capitol building for one day and then made available for sale for projects like hers. Over the years, she collected enough flags to decorate two downtown blocks of Woodin Avenue. Ruth did this for many years until it became too challenging for her to continue on her own. That's when the Lake Chelan Lions Club stepped in to help her.

Ruth would load up all the flags in the back of her car,

and with the Lions Club's assistance, she would drive along Woodin Avenue, putting up and taking down the flags. One of the flags has a brass tag on the pole that commemorates the life of Chelsea Chitty a student of Ruth's at

Morgen Owings Elementary, who passed away in 1996 of cancer at the age of six. Ruth was a stickler for detail, and it was essential to get that flag in the right place.

Eventually, the task of putting up and taking down the flags became too much for Ruth, and in 2000, the Lake Chelan Lions Club took over the responsibility, including storing the flags. They even added enough flags to decorate one block both up and down Emerson Street.

Today, the Lions Club of Lake Chelan Valley continues to participate in raising the flags every major U.S. holiday, carrying on Ruth's tradition. This act of patriotism has become a symbol of unity and pride for our town, reminding us of the sacrifices made to protect our freedom and way of life.

It's an honor to be part of this tradition and receive the thanks of the people along the street as the flags are put up. Wearing the Lions Club vests helps the community identify who is responsible for this beautiful display of patriotism.

As we celebrate these holidays, let us take a moment to reflect on the history of this tradition and the values it represents. We must continue to honor and support our veterans and active-duty military personnel, who work tirelessly to keep us safe and free. May the flags on Woodin Avenue continue to wave proudly for generations to come.



WENATCHEE - Chelan County commissioners awarded \$776,436 in lodging tax dollars to a variety of local agencies that will use the money for capital projects that support tourist-related activities.

The decision comes at the recommendation of the Chelan County Lodging Tax Advisory Committee, which reviewed 17 applications and narrowed those down to 11 projects.

"The county awards grant dollars from its lodging tax collections twice a year. This spring grant round, which focuses on capital projects, is always exciting because of the potential long-lasting impacts the dollars will have on our local tourist industry," said Commissioner Tiffany Gering, who is chairwoman of the committee. "We heard from several great projects this year that will not only build upon our economy but also be enjoyed by local residents in repairs in the downtown core.

11 agencies awarded lodging tax

aside \$560,000 for the capital awards; however, that was raised an additional \$216,000 because of the caliber of the projects, Gering said. The recipients are:

- Cascade Community Markets: \$15,000 to expand and invest in equipment upgrades for the Leavenworth and Cashmere community farmers markets.
- Chelan County Natural Resources: \$50,000 for improvements to the Cashmere Riverside Park boat ramp.
- Chelan County Natural Resources: \$15,000 to develop capital facilities for river recreation in the Leavenworth area on Icicle Creek and the Wenatchee River.

Lodging tax dollars are generated by local lodging establishments. In Chelan County, about half the money generated in a year is allocated to six local chambers as well as the Cascade Loop and TREAD. Another portion is used to operate the county's Visit Chelan County campaign.

Additional dollars are offered twice a year annually in the form of grants to tourist-related organizations, such as festivals and museums. A call for marketing and promotional grants is typically made each fall and a call for capital projects is typically made each spring. May 18

CHELAN - The last of the boys' District 6 1A/B qualifying matches for the state tournament took place at Lake Chelan Shores today.

For Chelan, junior Rylen Moody began the day with a high pressure match vs Charlie Lyons of Cascade which was winner to state - loser out. CHELAN - May 16 was day 1 of the 1A/B District 6 Tournament, which is the qualifier for the WIAA State Tournament. It's an 8 entry doubleelimination tournament, with 4 entries from 1A schools and 4 entries from the NCW Bs. The 1st round pairings were #1s vs #4s and #2s vs. #3 (for example, the #1 seed from the CTL played the #4 seed from the NCW Bs). The top 4

finishers qualify for the state tournament, so it's a typical "win two before you lose two" format. The B schools had a great afternoon on the singles court, while the 1A schools did well in doubles.

For Chelan, #2 seed Rylen Moody opened up with a challenging match vs a scrappy Jasper Burnell of Oroville, winning in comeback fashion in three sets 3-6, 6-3, 6-2. Actually, Rylen was the only CTL player to win in that opening round - a testament to how strong the B singles players were today. In the semifinals, Rylen faced #1 seed Ben Cullison of Manson. I believe that match showcased the best singles of the day, with Cullison coming out on top 6-4, 6-3. On Thursday, Rylen will face Charlie Lyons of Cascade for a winner to state/loser out consolation semifinal.

Also in singles, #3 seed Cray Silva kicked off the day with a match vs #2 seed Rex Torgesen of Manson. Cray got his feet under him in the 2nd set before falling 6-1, 6-4. In his subsequent loser out match, Cray again had a great 2nd set but came up short vs Cascade's Lyons 6-0, 6-4.







May is National Osteoporosis Awareness and Prevention Month

May reminds me of my mother, and not just because of Mother's Day. May is National Osteoporosis Awareness and Prevention Month. During the last 10 years of her life, my mother suffered significant disability from complications of osteoporosis.

People with low bone density have bones that are more likely to break. Nearly 54 million Americans have low bone mass, according to the National Osteoporosis Foundation (NOF), a health organization dedicated to preventing osteoporosis and broken bones through awareness, education, and research.

This silent but devastating disease affects women more than men. Women have a 50% chance of suffering a hip, spine, or wrist fracture during their lifetime, while nearly 30% of men will also experience a broken bone related to low bone mass. If you are female, the likelihood of breaking a bone from osteoporosis is equal to your risk of having breast, uterine, or ovarian cancer.

Osteoporosis-related fractures aren't just painful; they can be deadly. One in four women and one in three men will die within one year of experiencing a broken hip.

My mother broke her left wrist when she was 74, tripping on a curb while trying to catch a bus in downtown Seattle. Four years later, she broke her left hip when getting out of bed in the middle of the night.

She walked on it for 2 weeks before the pain drove her to see a doctor. By then, the bone edges had slipped out of place, leaving her with one leg an inch shorter than the other for

the last 10 years of her life. Although its complications appear in old age, osteoporosis can start in childhood. The thinner your bones are when young, the more likely you'll experience a fracture later.

We build nearly 90 percent of our peak bone mass before turning 20. In middle age, that process begins to reverse. Women lose 1% of their bone mass yearly, doubling to 2% per year during the first few years of menopause.

Last year I turned 65 and had mv first bone density scan. It showed I had already lost bone density. If this bone loss continues at the same rate, I will eventually lose enough bone to put me at risk of hip, spine, or other fractures.

To counteract that, I have faithfully eaten 50 grams of dried plums daily. At a visit with my family doctor last week, I described my five dried plums a day regimen. He told me he had never heard of dried plums for bone health.

"The evidence for plums is remarkably compelling," I told him. "Eating 50 grams of dried plums daily stops bone loss in men and postmenopausal women."

Earlier research proved that 100 grams daily of dried plums stopped the process of losing bone mass in postmenopausal women. That sounds great until you realize 100 grams represents 10-12 dried plums Every day. Yikes!

Recent studies, like the Prune Study, have proven that $50 \mathrm{\ grams}$ of dried plum are as effective in preserving bone mass as 100 grams daily. For more information about

plums (prunes) daily.

Eating dried plums daily supports bone mass in both men and postmenopausal women by changing the balance of bone remodeling to favor keeping more bone

Since dried plums can have a laxative effect, I suggest starting with 2 plums daily. Increase the amount by 2 dried plums weekly until you get to 5 large or 6 small dried plums daily. I have found the size of dried plums can vary, so whenever I start a fresh bag, I use my kitchen scale to measure out 50 grams. My favorite dried plums are the ones carried by Costco.

2. Do weight-bearing activities.

Walking, cycling, dancing, and gardening are activities that keep your bones strong. Exercises like tai chi and strength training like bodyweight exercises and lifting weights strengthen your thigh muscles. It improves your balance, which helps prevent falls.

3. Don't smoke. If you do, quit.

Smoking cigarettes accelerates bone loss. My mother smoked for 68 years, starting at age 18. Stopping smoking could have helped her avoid the fractures which plagued her later years.

4. Track your bone density.

My mother had no idea how thin her bones were until she fell and broke her wrist. Earlier intervention could have prevented her hip fracture and subsequent disability. Talk to your doctor about your bone health.



Individuals who overdose on opioids mixed with xylazine cannot be revived with naloxone

EAST WENATCHEE – Health agencies across the United States are reporting an increase of Xylazine detected in overdose deaths and in seized illicit drug supplies. Regional Local Health Jurisdictions (LHJs) warn the general public about Xylazine risk in opioid use.

Xylazine, also known as tranq, tranq dope, sleep-cut and zombie drug, is a syn-

thetic tranquilizer approved by the Federal Drug Administration (FDA) for use in veterinary medicine. Xylazine causes sedation and is often mixed with fentanyl and other illicit drugs to prolong or strengthen the high or euphoric effect of those drugs. Individuals who overdose on opioids mixed with xylazine cannot be revived with naloxone, an emergency treatment that helps reverse an overdose from opioids. Because there is no medical treatment that counteracts a Xylazine overdose, deaths associated with Xylazine are on the rise. Xylazine also causes tissue necrosis (premature cell death) or rotting skin when injected, later resulting

in the need for life-saving amputation of fingers, arms and legs.

LHJs are actively monitoring local drug overdose reports with regional and state epidemiologists, to follow trends and the anticipated rise in overdose deaths that will come as Xylazine spreads through ongoing drug supplies. Currently, there are few available tests to determine if an individual has been exposed to Xylazine or if a

drug was laced with Xylazine. As with past trends in drug overdoses, our only way of detecting the appearance of a new drug is a change in the pattern of overdoses and deaths.

As we anticipate an increase in Xylazine-containing drugs throughout North Central Washington, the general public should spread awareness of the severity of Xylazine and the importance of avoiding the use of illicit drugs and seeking care for substance use disorders. Individuals experiencing any substance use disorder should be

aware that street drugs will likely contain Xylazine if they do not already.

Treatment for opioid use disorder and recovery services offered throughout North Central Washington are available and are safer alternatives than using drugs that might be laced with Xylazine.

The epidemic of substance use disorders are becoming more complex and more deadly. Our friends, family members, neighbors and community members are likely to be affected and may be in need of help for them-

selves or their loved ones. The best public health interventions are those focused on prevention of disease and promotion of health. LHJs recognize that substance use disorders often result from injury, dependence on well-intentioned prescription pain medications, behavioral health needs and difficulty in accessing resources for wellness and healthy living. LHJs will continue to participate in, and encourage community collaboration in making North Central Washington a healthy and thriving place to live.
