
The 103rd Manson Apple Festival, Luau at the Lake, was held May 12 and 13 under



State Legislature approves capital budget with \$1.7 earmarked for The Community Center at Lake Chelan

Rep. Mike Steele plays key role in support funding

CHELAN - Mike Steele (12th District Representative and ranking member of the Capital Budget Committee) announced the inclusion of \$1.723 million to support the continuing construction of The Community Center at Lake Chelan.

The funds will be available to the Seven Acres Foundation – nonprofit developers of the 46,000 square foot

facility – in Rep. Mike the com-Steele ing months. They will

ensure sustained momentum toward the anticipated opening of the center this fall.



"Thanks to **Ben Williams** Represen-

tative Mike Steele, this grant will enable 100% funding and construction to occupancy of the first phase of the Community Center at Lake Chelan, the core of this project. In addition, the grant will serve as a springboard for the completion of the rest of the project, so this funding is essential to our vision of bringing people together to enhance the quality of life in the Chelan Valley." Fundraising to complete the center continues, focusing on gym finishes, parking lot, and landscaping. The Community Center at Lake Chelan sits on a six-acre campus at 103 Big Horn Way between Chelan and Manson. Amenities and services within the facilities will include a fullsize gym/auditorium, indoor children's play area, meeting and event rooms, workspace center, coffee shop, commercial kitchen, and office spaces, which will be affordable and targeted to nonprofits, start-ups, and local businesses. The campus includes outdoor courts, an event lawn, and a 25-yard multi-lane swimming pool that provides the opportunity for aquatic therapy, fitness, and swimming lessons in the safety of a swimming pool.

Representative Steele said, "I am excited to provide additional funding for the Community Center at Lake Chelan. I want to see this project continue to progress, and I look forward to the community asset it will become'

CHELAN - Spring runoff has begun as temperatures rise into the 80s this weekend. If you're headed to enjoy local waterways, remember to check river and lake conditions often, and abide by the "no trespassing" signs along Chelan River Gorge.

Snowpack in the Lake Chelan Basin is about 81 percent of average, according to Chelan PUD's April 1 water supply forecast. Forecasts estimate about 18 feet of refill water remains in the snowpack, and there is about 7 feet of room in the lake. Any excess water will run through Lake Chelan Hydro Project for power generation or spilled into the Chelan River.

Chelan River Gorge is a narrow, rocky channel where changes in river flow can create hazardous conditions quickly and unpredictably, including higher water levels, fast currents, and potential entrapment. The area is marked with dozens of "no trespassing" signs.

Other safety reminders:

• Download the Current app free at chelanpud.org/app for the latest river and lake conditions, including Lake Chelan levels, boat launch water depth and real-time water flow.

• If you're out on the Columbia River, check boating conditions every 20-30 minutes as conditions may change quickly.

· When boating, look out for logs and other debris. Remember to stay at least 400 feet away from dams on the river.

· Be aware of your surroundings. The water is cold and swift this time of year. Don't wade out to sandbars as changing river conditions could leave you stranded.

For emergencies on the river or Lake Chelan, call 911.



Loren was preceded in death by his parents; wife; three sisters; and son, Randy Glessner. He is survived by daughter, Debbie Wilson (Bob, deceased); son, Kerry Glessner (Resa); along with six grandchildren and eight great-grandchildren.



Tournament bass fishing

Reservoir this month. Both events were hosted by MarDon Resort and put on by Russ Baker, the man behind Limit Out Performance Marine, a boat dealership specializing in bass boats with locations in Pacific and Spokane Valley. The first event was a two-

day Pro-Am tournament that attracted 94 boats, each with a professional angler (the boat owner) and an amateur angler (who fished from the back of the boat). This tournament attracted not only local anglers


big names like Luke Clausen, a former Bassmaster Classic champion and current Major League Fishing tournament angler.

I was excited to fish this tournament as an amateur



I got the chance to fish two bass tournaments at Potholes

but also anglers from Idaho and Oregon to include some pretty



angler. Of course, I wanted to cash a check but the main reason I wanted to fish this tournament was to learn from professional anglers who were more experienced than I was and to get dialed in for the Big Bass tournament taking place immediately after this event.

On day one I was paired with Ray Drinkwine, a relatively new but avid angler who went all in on the sport six years ago. We headed up the Winchester Arm to look for bass and found a good amount of the field had done the same thing. I caught one small bass on a topwater plug in the first five minutes but didn't catch another fish all day. Ray got into some two-to-threepound largemouth bass in flooded timber, boating two fish and losing another before the bite petered out. With no bites in over an hour we decided to head south towards O'Sullivan Dam to fill out our five fish limit with smallmouth bass. Arriving there, Ray quickly caught one but that was all we caught and we spent the next three hours trying in vain to hook up with other fish in this area. Weighing in at the end of the day, we only had a bag of 5.8 pounds with our three bass which put us in second to last place.

The next morning, I was paired with Jeremy LeCaire from Coeur de' Alene, Idaho. Jeremv had a good first day, weighing in over 16 pounds of largemouth bass and he had a pretty good second day as well, catching twelve quality fish while I reeled in a half dozen smaller bass. LeCaire caught a couple of bass casting a weedless frog in the morning but the bulk of his fish were caught using a "wacky worm" rigged Senko. LeCaire taught me to cast from a distance (as opposed to close in) to avoid spooking the bass that were

on spawning beds and to look for the bass not only on the flooded timber, but also on submerged sand dunes with exposed willow trees rising above the surface. LeCaire weighed in a limit of five bass weighing 15.3 pounds at the end of the day, putting him just below the cut for a check at the end of the two-day tournament. As for the winners of this event? That would be Luke Clausen on the pro side who weighed in a twoday bag of 40 pounds, earning him a new Phoenix bass boat valued at over \$45,000.

The top amateur angler was Abel Gomez from Othello, who took home a \$5,000 pay check. Russ Baker with Limit Out Marine was very happy with how this tournament turned out. It is exceedingly rare to have a Pro-Am tournament here in the Pacific Northwest but it was truly a quality event that Russ plans to bring back next year on May 1 and 2. You can find out more about this tournament and others he puts on at www. bigbasstrail.com.

Next week, we'll let you know how my friend Rusty Johnston and I did in the Big Bass tournament, why I love this particular format so much, and why I believe it is much better for the overall bass fishery at any lake you fish at.



Calcium does a lot more than just keeping our bones strong

Q: How much calcium should I take to prevent osteoporosis (thin bones)?

Several years ago, after stepping out of her front door, my 75-year-old neighbor Barbara turned around and, after losing her balance, fell down a flight of stairs, shattering her left ankle and breaking her right arm in 3 places. Barbara then endured 2 surgeries, one to reinforce her arm with a steel rod and pins and a second, grueling 5-hour marathon during which the surgeon collected and fit the multiple pieces of her ankle back together.

She had been taking prednisone daily to control her lupus, a painful inflammatory condition. After her emergency surgery, her doctor informed her she had osteoporosis, or "thin bones," and prescribed a bone-building medicine, plus a daily calcium and vitamin D supplement.

Calcium does a lot more for us than just keeping our bones strong. Our muscles, nerves, and blood vessels depend on calcium to work properly. For example, every time your heart beats or you breathe, your heart and chest muscles work for you, keeping you alive and well thanks to adequate amounts of calcium in your blood.

If you run low on calcium in your blood, your body will take the calcium it needs out of your bones. It's like an ATM (automated teller machine) but extracting calcium instead of \$20 bills.

If you sometimes run low on calcium, your body occasionally must grab some calcium from your bone cells. That's not considered a problem. But consider this: if your body needs to find additional calcium regularly, these withdrawals will eventually weaken your bones, increasing your risk of a hip fracture or worse.

How much calcium do you need?

The Institute of Medicine recommends 1000mg daily of calcium for men and women up to age 50 and 1200mg for adults older than 50. Most postmenopausal women get only 600-900mg of calcium daily through their food. This falls short of the 1000-1200mg daily calcium goal by 100-600mg daily. Some women make up that difference by taking a



painful kidney stones. For these reasons, bone and kidney specialists discourage their patients from relying on getting all of their recommended daily calcium by taking a calcium supplement.

Most forms of calcium sold as supplements are calcium carbonate or calcium citrate. Calcium carbonate is the most concentrated form of supplemental calcium. It is available as flavored chewable tablets (Tums) and large pills. Calcium carbonate causes constipation in some people.

You won't absorb calcium carbonate well when taking acid-blocking medicine like omeprazole (Prilosec®) or lansoprazole (Prevacid®). Instead, you should choose calcium citrate. Have trouble swallowing large tablets? Calcium supplements are also available as gummies.

Here are 5 Tips on Getting **Enough Calcium:**

1. Eat calcium-rich foods. Most people get 300mg of calcium daily from non-dairy sources. You also get 300mg of calcium per serving of dairy products like milk, yogurt, and cheese. Green vegetables, oranges, and figs also contain calcium.

2.Check out the Calcium Calculator app.

This app lets you keep track of your calcium intake. You can also check the lists of calciumrich foods on the International Osteoporosis Foundation website, www.iofbonehealth. org.

3. You need adequate calcium and vitamin D when taking bone-building medicine.

Medicines like alendronate (Fosamax®), risedronate (Actonel®), ibandronate (Boniva®), and teriparatide (Forteo®) strengthen your bones by adding calcium back into them. If you don't have enough calcium in your diet, they won't work.

4.Limit supplements of calcium to 500mg at a time.

Your body absorbs calcium better at lower doses. This avoids a potential "spike" in your calcium level that can increase your risk of heart attack or stroke.

5.Get at least 400 IU of Vitamin D every day. Vitamin D is necessary to help your body absorb calcium. Although you can get vitamin D from sun exposure, salmon (800 IU per 3 ounces), canned tuna (150 IU per 3 ounces), fortified milk (about 120 IU per

4 ounces), and fortified orange

juice (80 IU per 4 ounces) are

also good sources.
