Carla Everett
Carla (Johnson) Everett’s Lake Chelan and Manson Apple Blossom Festival roots run deep. She is a fourth generation descendant of the Little family and the daughter of orchardists. She grew up in Manson, marrying her classmate Dave. While Dave’s education and career in forestry took them all over the northwest, they returned to the area they will always call home for semi-retirement in 1996. Carla then became secretary at North Shore Bible Church affording her the opportunity to meet the few people in the

community that she wasn’t related to or hadn’t gone to school with.
In 1946, at just five years old, Carla was introduced to the Manson Apple Blossom Festival as a flower girl at Queen Basra (Peterson) Stevens’ coronation. This ignited her love for the pageantry and celebration that comes with the festival. She was a grade school classmate of fellow Grand Marshal Linda Blessin. The girls performed together in school operettas and the cast rode floats for several years in Manson’s parade.
Carla’s involvement in the festival grew from participant to organizer in her work for the Washington State Apple Blossom Festival in Wenatchee from 1960-1965. She also deco-

rated for Manson’s festival coronation during that time. Upon full retirement Carla invested her time as treasurer for the Manson Festival Board, and she recently transitioned to Historian. Her work collecting, preserving and displaying treasured memorabilia and information surrounding the 102-year life of the festival is truly a passion.
A current member of the Lake Chelan Historical Society Museum Board and volunteer, she loves the opportunity to share history with the community and research questions that visitors pose. Carla will be attending this year’s festivities with her two daughters and is touched by the honor of being designated as one of the grand marshals.

Patty Porter
I graduated from Snohomish High School on a Tuesday and married Hal Porter on Saturday in 1952. Then we were off to the Navy base to start our journey. Together we have four children, and now nine great-grandchildren. The Porters, Pittmans, Timmermans, and Perris are all my family, and they are great fans of the Manson Apple Blossom Festival. From working with friends in the Rock Club, marching with Habitat for Humanity Crew, and supporting the pancake breakfast, I have enjoyed all the events of the festival.
I have helped behind the scenes by creating scrapbooks, sewing royalty sashes, sewing fur capes and blankets, wash-

ing slips, selling t-shirts, making and selling fresh donuts, as well as storing the tuxes. When it is parade day, it is just so nice to see everyone have a great time.
Our families come together every year to assist the float designed by Diana Ellsworth and her family create and sometimes repair “Flora” our float. Between low tires, dead batteries, death of the old Volkswagon car that is the float, personally dragging the new trailer home from Utah, and the many trips to the Lilac Parade in Spokane with homemade cookies and muffins for the royalty and float crew, I have enjoyed being a small part of it all. It is time again for my favorite job, helping put the fringe on the float. The sparkle happens when the faces of the royalty light up - it is why we volunteer. Thank you for including me with Linda and Carla to be the Grand Marshals of the festival for 2023.

Linda Blessin
The Blessin family moved from Olympia to Manson in 1945, after Linda’s father purchased an orchard and home by the lake. Linda attended Manson Grade School which had a wonderful music teacher Mr. Petit. Each year he had an operetta, and the students rode on the float in the Manson Apple Blossom Parade.
One operetta Linda remembers is one where she plays the witch and Carla Everett portrays the princess. After her retirement to Manson, she always refers to Carla as ‘Princess’. As

Historian of all the Manson Apple Blossom memorabilia, Carla found that operetta’s program from all those years ago. She discovered Linda had actually played the roll of princess. So much for that.
Linda began playing the trumpet when she was in the third grade. As a fifth grader in 1952, she was the trumpeter for the coronation of the Manson Apple Blossom Royalty. Linda attended junior and senior high school in Chelan and marched in every Manson Apple Blossom parade until graduation from high school in 1959. Linda continued playing trumpet in Kodiak, Alaska where the community band helped produce a musical during the King Crab festivals. She also was a member of the British Brass Band in Wenatchee for a few years. It broke her heart, when out of necessity, she donated her trumpet to the music department at the Manson School District.
Linda went to college at Western Washington University, taught for a year in Edmonds, then married Bob Smith and moved to Anchorage, Alaska, where he was stationed in the U.S. Air Force. The next few years were filled with so much adventure.
Linda was a language development teacher at the Alaska Treatment Center for 13 years, during which she obtained her Masters Degree, she has

had a team, which went to the small villages for the Bureau of Indian Affairs, to evaluate children. This turned into a full-time position with the BIA.
In 1982, Linda moved to Kodiak Island where she worked as an Education Diagnostician. As a boater in Seward and later in Kodiak, she was very active in the Coast Guard Auxiliary, completing all Coast Guard courses and training. She eventually obtained the rank of Commodore for the 17th CG district all of Alaska. Her work resulted in two federal awards for savings lives.
When Linda retired from Aaska in 1996, she returned home to build a house on the Blessin family’s lakefront property. She began selling her crafts at the Manson Farmers Market, where she is now president. Each Thanksgiving Day weekend she also was a vendor at the Holiday Extravaganza Craft Show held at the Manson Grange Hall. Linda took on coordinating this event, as well as leading the Manson Apple Blossom Street Fair for many years.
Manson and the Lake Chelan Valley was a wonderful place to grow up. Although many changes are coming to the valley, Linda is very honored to be a Grand Marshal in the 2023 parade, Luau at the Lake. She feels a wonderful “Aloha” in her heart.

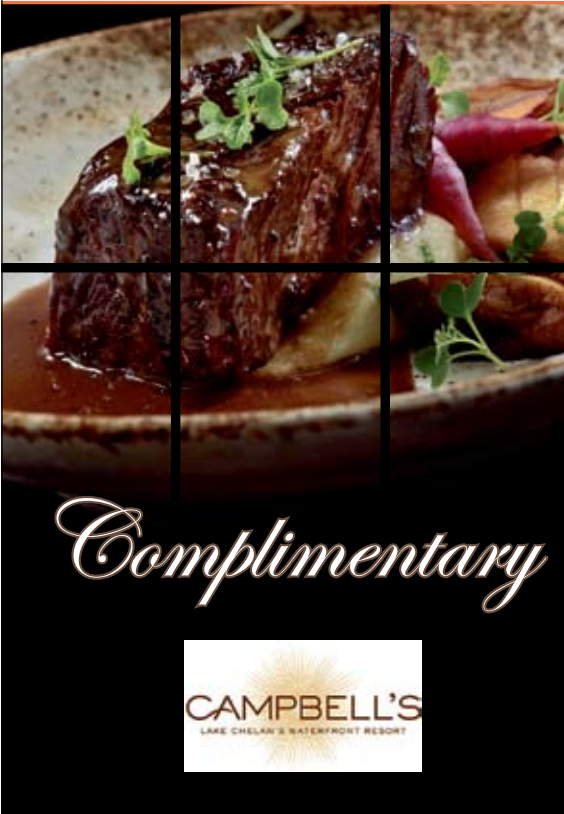

Inland Empire Results April 28-29

On Friday, April 28 and Saturday, April 29 the Chelan Goats traveled to Spokane for their annual battle in the Inland Empire tennis tournament. This tournament is the largest high school tennis tournament in the nation, with 50 plus schools, 600 plus players, and 11 sites with 80 plus courts utilized. Our Chelan kids came away with a lot of wins, valuable match experience against tough competition from large schools, some hardware and too many sunburns.

This tournament is a "guaranteed two matches" format as opposed to a true double elimination tournament (which would take 3-4 days). Essentially, to stay alive in the tournament, day one contestants on Friday needed to finish win-win-win or lose-win-win. Any loss in match #2 or match #3 means elimination. So, about 80% of the entrants are eliminated on day one. Chelan was able to push four out of our 10 entrants into day 2, and a couple other entrants only came up one match short.

On the girls' side:

#1 singles entry Arden Paglia played well in round one but lost 3-6, 3-6 to a tough LaSalle (Yakima) opponent. That forced Arden to battle back and win twice on Friday in the consolation bracket, which she did with wins over Southridge (Kennewick) 6-2, 7-5 and Wenatchee 7-6, 6-2. That put Arden in the medal round on the consolation side of the bracket on Saturday. In the consolation semifinal, she ended up losing a close match to eventual fifth place finisher from East Valley (Yakima), but finished the tournament with a 6-1, 6-1 win over Prosser to take 7th overall out of 43 players.

#2 singles entry Candice Ducroq got the short end of the stick in round one by having to face the #2 seed from Chewelah. However, she played outstanding against that eventual silver medalist, which gave Candice momentum into another well-played match vs East Valley (Spokane). She fell just short in a third set tiebreaker 8-10, but played some of the best tennis of her life on Friday.

#1 doubles team Piper Grossberg and Maya Cowan narrowly missed the medal round, but played excellent tennis. The duo won their opener 7-6, 6-3 over Post Falls, and bested another Idaho team (Sandpoint) 6-3, 6-3 in round two, but had their tournament cut shot in their final match on Friday with a narrow 4-6, 3-6 loss to Gonzaga Prep (G Prep would later go on to take 3rd overall in the bracket). Despite being a newly formed team without much experience together, they demonstrated that they were definitely one of the top doubles teams in the tournament.

#2 doubles team Olivia Strandberg and Caelan Rothlisberger ran the table on Saturday with wins over Cheney (6-1, 6-0), Ridgeline of Spokane Valley (6-0, 6-2) and Gonzaga Prep (6-4, 6-1). That streak put them into the Saturday morning semifinals vs. #1 seed University High (Spokane), where they came up short 2-6, 1-6. However, in the follow-up match for third/fourth, Liv and Caelan took down Ephrata 6-2, 6-3 to claim 3rd place out of 40 doubles teams.

#3 doubles Josie Garfoot and Ellie McLemore also were a perfect 3-0 on Friday, with wins over Toppenish (6-2, 6-1), Othello (6-2, 6-0), and Gonzaga Prep (6-4, 6-4) which put them in the semifinals vs #2 seed University HS on Saturday. Ellie and Josie battled that tough competition and difficult heat on Saturday to fend off UHigh 6-1, 5-7, 6-4, placing them in the championship match vs. #1 seed Mead. Garfoot and McLemore came up short against Mead, but finished in 2nd place out of 40 doubles teams!

It was an odd coincidence that all three Chelan girls doubles teams faced Gonzaga Prep in their quarterfinal matches this year. We felt it was a fairly large accomplishment to win two of those three quarterfinal matches against such a heralded 4A private school.

On the boys' side:

#1 singles entry Rylen Moody had a tough draw, losing to the overall tournament #1 seed and the eventual gold medalist from Southridge (Kennewick) in round one, and also came up short against Shadle Park's tough #1 singles player in Moody's do-or-die match 1-6, 5-7.

#2 singles entry Cray Silva lost a heartbreaker in his opener to Mead, falling in the 3rd set tiebreaker 10-12. Cray fought back to win two more matches on Friday over Cheney 6-2, 6-2 and Ellensburg 6-0, 6-3 to enter Saturday's medal round. In his first match on Saturday, Cray was beaten 6-4, 6-1 by Ferris, and unfortunately his seventh/eighth match ended up being a Chelan win by forfeit. Cray finished 7th overall out of 37 players.

#1 doubles entry Luke Christopherson and Sam Bordner had a rough day, dropping their opener to Coeur d'Alene 1-6, 3-6, and were eliminated in match #2 by Rogers 2-6, 6-7.

#2 doubles brothers Tristan and Wade Sanderson narrowly missed the medal round after a great showing on Friday. They won their opener 6-3, 6-3 over Prosser, and also their second round matchup 6-1, 6-4 over Ephrata. This young Chelan team fell just short in round 3 to Othello 4-6, 4-6. Othello would go on to medal by taking 3rd place in the bracket, so that's an outstanding showing by the Sandersons.

#3 doubles entry Ian Garfoot and Caleb Sanderson also narrowly missed the medal round. The tandem fell 6-7, 3-6 to Mt Spokane in the opening match but came back strong defeating Othello 6-3, 6-1. Ian and Caleb needed just one more win to medal, but lost the closest match of the day 6-2, 4-6, 6-7, with that 3rd set tiebreaker being 13-15.

OLYMPIA - This May, the Washington State Department of Natural Resources (DNR) and Commissioner of Public Lands Hilary Franz encourages Washington residents to smell the spring flowers, appreciate the re-

emerging sunshine, and take steps to make homes more resilient to wildfire.

Gov. Jay Inslee has proclaimed May 2023 as Wildfire Awareness Month, noting that Washington residents all share the responsibility to prevent and prepare for wildfires.

"At DNR, we often say that

no one is immune from the effects of wildfires," said Franz, who leads DNR. "But even the simplest measures, such as cleaning up pine needles and dry leaves, or moving firewood 30 feet away from your home, can make your home more resilient to the growing threat of wildfire."

This spring, DNR's Wild-

fire Ready Neighbors program has expanded to Mason, Thurston, and Pierce counties in Western Washington in addition to the six active Eastern Washington counties – Okanogan, Chelan, Spokane, Yakima, Kittitas, and Klickitat.

Residents in the nine counties listed above can also sign up for a free Wildfire Ready Home Visit from a wildfire professional who can give personalized advice and recommendations about wildfire

"Wherever you live in Washington, Wildfire Awareness Month and National Community Wildfire Preparedness Day is an excellent time for communities to work together to take simple actions to protect themselves from the threat of wildfire," Franz said.

National Nurses week history

National Nurses Week begins each year on May 6 and ends on May 12, Florence Nightingale's birthday. These permanent dates enhance planning and position National Nurses Week as an established recognition event. As of 1998, May 8 was designated as National Student Nurses Day, to be celebrated annually. And as of 2003, National School Nurse Day is celebrated on the Wednesday within National Nurses Week (May 6-12) each year.

The nursing profession has been supported and promoted by the American Nurses Association (ANA) since 1896. Each of ANA's state and territorial nurses' associations promotes the nursing profession at

the state and regional levels. Each conducts celebrations on these dates to recognize the contributions that nurses and nursing make to the community.

The ANA supports and encourages National Nurses Week recognition programs through the state and district nurses' associations, other specialty nursing organizations, educational facilities, and independent health care companies and institutions.

A Brief History of National Nurses Week
1953 Dorothy Sutherland of the U.S. Department of Health, Education, and Welfare sent a proposal to President Eisenhower to proclaim a "Nurse Day" in October of the following year. The proclamation was never made.

1954 National Nurse Week was observed from October 11 - 16. The year of the observance marked the 100th anniversary of Florence Nightingale's mission to Crimea. Representative Frances P. Bolton sponsored the bill for a nurse week. Apparently, a bill for a National Nurse Week was introduced in the 1955 Congress, but no action was taken. Congress discontinued its practice of joint resolutions for national weeks of various kinds.

1972 Again a resolution was presented by the House of Representatives for the President to proclaim, "National Registered Nurse Day." It did not occur.

1974 In January of that year, the International Council of Nurses (ICN) proclaimed that

May 12 would be "International Nurse Day." (May 12 is the birthday of Florence Nightingale.) Since 1965, the ICN has celebrated "International Nurse Day."

1974 In February of that year, a week was designated by the White House as National Nurse Week, and President Nixon issued a proclamation.

1978 New Jersey Governor Brendan Byrne declared May 6 as "Nurses Day." Edward Scanlan, of Red Bank, N.J., took up the cause to perpetuate the recognition of nurses in his state. Mr. Scanlan had this date listed in Chase's Calendar of Annual Events. He promoted the celebration on his own.

1981 ANA, along with various nursing organizations, rallied to support a resolu-

tion initiated by nurses in New Mexico, through their Congressman, Manuel Lujan, to have May 6, 1982, established as "National Recognition Day for Nurses."

1982 In February, the ANA Board of Directors formally acknowledged May 6, 1982 as "National Nurses Day." The action affirmed a joint resolution of the United States Congress designating May 6 as "National Recognition Day for Nurses."

1982 President Ronald Reagan signed a proclamation on March 25, proclaiming "National Recognition Day for Nurses" to be May 6, 1982.

1990 The ANA Board of Directors expanded the recognition of nurses to a week-long celebration, declaring May 6 - 12, 1991, as National

Nurses Week.

1993 The ANA Board of Directors designated May 6 - 12 as permanent dates to observe National Nurses Week in 1994 and in all subsequent years.

1996 The ANA initiated "National RN Recognition Day" on May 6, 1996, to honor the nation's indispensable registered nurses for their tireless commitment 365 days a year. The ANA encourages its state and territorial nurses' associations and other organizations to acknowledge May 6, 1996 as "National RN Recognition Day."

1997 The ANA Board of Directors, at the request of the National Student Nurses Association, designated May 8 as National Student Nurses Day.
